1 A BILL for an Act to amend and reenact section 39-04-19 of the North Dakota Century Code,
2 relating to vehicle registration fees; and to provide an effective date.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 39-04-19 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **39-04-19. (~~Effective until June 30, 2000~~) Motor vehicle registration fees and mile**
7 **tax.** Motor vehicles required to pay registration fees or a mile tax shall pay the following fees:

8 1. Nonresidents electing to pay mile tax in lieu of registration, when authorized to do
9 so by the department, shall pay a fee of twenty dollars for a trip permit which is
10 valid for a period of seventy-two hours. All fees collected under the provisions of
11 this subsection must be credited to the highway construction fund.

12 2. Motor vehicles required to be registered in this state must be furnished license
13 plates upon the payment of the following annual fees; however, if a motor vehicle
14 first becomes subject to registration other than at the beginning of the registration
15 period, such fees must be prorated on a monthly basis. The minimum fee charged
16 hereunder must be five dollars:

- 1 c. Motorcycles, fifteen dollars.
- 2 3. Motor vehicles acquired by disabled veterans under the provisions of Public Law
3 79-663 [38 U.S.C. 3901] are exempt from the payment of state sales or use tax
4 and, if paid, such veterans are entitled to a refund. This exemption also applies to
5 any passenger motor vehicle or pickup truck not exceeding ten thousand pounds
6 [4535.92 kilograms] gross weight but shall apply to no more than two such motor
7 vehicles owned by a disabled veteran at any one time.
- 8 4. Every trailer, semitrailer, and farm trailer required to be registered under this
9 chapter must be furnished registration plates upon the payment of a twenty dollar
10 annual fee. Every trailer, semitrailer, or farm trailer not required to be registered
11 under this chapter must be furnished an identification plate upon the payment of a
12 fee of five dollars.
- 13 5. Trucks or combinations of trucks and trailers weighing more than twenty thousand
14 but not more than one hundred five thousand five hundred pounds [more than
15 9071.84 but not more than 47854.00 kilograms] which are used as farm vehicles
16 only, are entitled to registration under the following fee schedule and the provisions
17 of this subsection. Farm vehicles are considered, for the purpose of this
18 subsection, as trucks or combinations of trucks and trailers weighing more than
19 twenty thousand but not more than one hundred five thousand five hundred
20 pounds [more than 9071.84 but not more than 47854.00 kilograms] owned, or
21 leased for at least one year by a bona fide resident farmer who uses the vehicles
22 exclusively for transporting the farmer's own property or other property on a farm
23 work exchange basis with other farmers between farms and the usual local trading
24 places but not in connection with any commercial retail or wholesale business
25 being conducted from those farms, nor otherwise for hire. In addition to the penalty
26 provided in section 39-04-41, any person violating this subsection shall license for
27 the entire license period the farm vehicle at the higher commercial vehicle rate in
28 accordance with the weight carried by the farm vehicle at the time of the violation.
