- A BILL for an Act to amend and reenact section 65-01-02, subsection 4 of section 65-05-28,
- 2 subsection 1 of section 65-05-28.2, and section 65-07-01 of the North Dakota Century Code,
- 3 relating to workers compensation definitions, medical treatment, coverage; to repeal section
- 4 65-07-04 of the North Dakota Century Code, relating to calculation of the wages of a
- 5 self-employed person; and to provide an effective date.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 65-01-02 of the 1997 Supplement to the North
 Dakota Century Code is amended and reenacted as follows:
- 9 **65-01-02. Definitions.** In this title:

- "Acute care" means a short course of intensive diagnostic and therapeutic services
 provided immediately following a work injury with a rapid onset of pronounced
 symptoms.
 - 2. "Adopted" or "adoption" refers only to a legal adoption effected prior to the time of the injury.
 - 3. "Artificial members" includes only such devices as are substitutes for, and not mere aids to, a natural part, organ, limb, or other part of the body. The term does not include eyeglasses or contact lenses unless the eye is, or eyes are, injured as a result of a compensable injury, and such injury causes a change in sight which requires fitting of eyeglasses or contact lenses not previously worn by the injured worker, or requires a change in existing prescription.
 - "Artificial replacements" means mechanical aids including braces, belts, casts, or crutches as may be reasonable and necessary due to compensable injury.
 - 5. "Average weekly wage" means the weekly wages the employee was receiving from all employments at the date of first disability. The average weekly wage as

1 determined under this section subsection must be rounded to the nearest dollar. 2 In cases where the employee's wages are not fixed by the week, they must be 3 determined by using the first applicable formula from the schedule below: 4 a. For seasonal employment, during the first consecutive days of disability up to 5 twenty-eight days the average weekly wage is calculated pursuant to the first 6 applicable formula in subdivisions b through g of this subsection, and after 7 that are calculated as one-fiftieth of the total wages from all occupations 8 during the twelve months preceding the injury date of first disability or during 9 the tax year preceding the injury date of first disability, or during an average 10 of the three tax years preceding the injury date of first disability, whichever is 11 highest and for which accurate, reliable, and complete records are readily available. 12 13 The "average weekly wage" of a self-employed employee is determined by b. 14 the following formula: one-fiftieth of the net profits based on the preceding 15 tax year or preceding fifty-two weeks whichever is higher if accurate, reliable, 16 and complete records for those fifty-two weeks are readily available, plus 17 depreciation, meal and travel expenses, and any expenses chargeable to use 18 of personal residence as allowed under the federal tax laws. 19 Hourly or daily rate multiplied by number of hours or days worked per C. 20 seven-day week. 21 d. Monthly rate multiplied by twelve months and divided by fifty-two weeks. 22 Biweekly rate divided by two. e. 23 f. The usual wage paid other employees engaged in similar occupations. 24 A wage reasonably and fairly approximating the weekly wage lost by the g. 25 claimant during the period of disability. 26 6. "Average weekly wage in the state" means the determination made of the average 27 weekly wage in the state by job service North Dakota on or before July first of each 28 year, computed to the next highest dollar. 29 7. "Board" means the North Dakota workers compensation board of directors.

- 8. "Brother" and "sister" include a stepbrother and a stepsister, a half brother and a half sister, and a brother and sister by adoption. The terms do not include a married brother or sister unless he or she actually is dependent.
 - 9. "Bureau" means the North Dakota workers compensation bureau, or the director, or any department heads, assistants, or employees of the bureau designated by the director, to act within the course and scope of their employment in administering the policies, powers, and duties of this title.
- 10. "Child", for determining eligibility for benefits under chapter 65-05, means a child under eighteen years of age residing in the employee's household or to whom the employee has a legal obligation of support; or a child eighteen years of age or over and physically or mentally incapable of self-support who is actually dependent upon the employee for support; or any child between eighteen and twenty-two years of age who is enrolled as a full-time student in any accredited educational institution who is actually dependent upon the employee for support. This term includes a legitimate child, a stepchild, adopted child, posthumous child, foster child, and acknowledged illegitimate child, but shall does not include a married child unless actually dependent.
- - a. The term includes:
 - (1) Disease caused by a hazard to which an employee is subjected in the course of employment. The disease must be incidental to the character of the business and not independent of the relation of employer and employee. Disease includes effects from radiation.
 - (2) An injury to artificial members.
 - (3) Injuries due to heart attack or other heart-related disease, stroke, and physical injury caused by mental stimulus, but only when caused by the employee's employment with reasonable medical certainty, and only when it is determined with reasonable medical certainty that unusual stress is at least fifty percent of the cause of the injury or disease as

1 compared with all other contributing causes combined. Unusual stress 2 means stress greater than the highest level of stress normally 3 experienced or anticipated in that position or line of work. 4 (4) Injuries arising out of employer-required or supplied travel to and from a 5 remote jobsite or activities performed at the direction or under the 6 control of the employer. 7 (5) An injury caused by the willful act of a third person directed against an 8 employee because of the employee's employment. 9 A mental or psychological condition caused by a physical injury, but (6)10 only when the physical injury is determined with reasonable medical 11 certainty to be at least fifty percent of the cause of the condition as 12 compared with all other contributing causes combined, and only when 13 the condition did not preexist the work injury. 14 The term does not include: b. 15 (1) Ordinary diseases of life to which the general public outside of 16 employment is exposed or preventive treatment for communicable 17 diseases. 18 (2) A willfully self-inflicted injury, including suicide or attempted suicide, or 19 an injury caused by the employee's willful intention to injure or kill 20 another. 21 (3)Any injury caused by the use of intoxicants or the illegal use of 22 controlled substances. 23 (4) An injury that arises out of an altercation in which the injured employee 24 is an aggressor. This paragraph does not apply to public safety 25 employees, including law enforcement officers, or private security 26 personnel who are required to engage in altercations as part of their job 27 duties if the altercation arises out of the performance of those job 28 duties. 29 An injury that arises out of an illegal act committed by the injured (5) 30 employee.

1 (6) An injury that arises out of an employee's voluntary nonpaid 2 participation in any recreational activity, including athletic events, 3 parties, and picnics, even though the employer pays some or all of the 4 cost of the activity. 5 (7) Injuries attributable to a preexisting injury, disease, or other condition, 6 including when the employment acts as a trigger to produce symptoms 7 in the preexisting injury, disease, or other condition unless the 8 employment substantially accelerates its progression or substantially 9 worsens its severity. 10 (8)A nonemployment injury that, although acting upon a prior 11 compensable injury, is an independent intervening cause of injury. 12 (9)A latent or asymptomatic degenerative condition, caused in substantial 13 part by employment duties, which is triggered or made active by a 14 subsequent injury. 15 (10)A mental injury arising from mental stimulus or a mental or emotional 16 injury arising principally out of a bona fide personnel action, including a 17 transfer, promotion, demotion, or termination except an action that is 18 the intentional infliction of emotional harm. 19 12. "Date of first disability" means the first date the employee was unable to work in 20 relation to because of a compensable injury. "Date of maximum medical improvement" or "date of maximum medical recovery" 21 13. 22 means the date after which further recovery from, or lasting improvement to, an 23 injury or disease can no longer reasonably be anticipated based upon reasonable 24 medical probability. 25 14. "Director" means the director of the bureau. 26 15. "Disability" means loss of earnings capacity and may be permanent total, 27 temporary total, or partial. 28 16. "Doctor" means doctor of medicine, chiropractor, or osteopathy, chiropractor, 29 dentist, optometrist, podiatrist, or psychologist acting within the scope of the 30 doctor's license.

1	17.	"Employee" means a person who performs services hazardous employment for		
2		another for remuneration unless the person is an independent contractor under the		
3		"common law" test , and: .		
4		a.	The t	term includes:
5			(1)	All elective and appointed officials of this state and its political
6				subdivisions, including municipal corporations and including the
7				members of the legislative assembly, all elective officials of the several
8				counties of this state, and all elective peace officers of any city.
9			(2)	Aliens.
10			(3)	County general assistance workers except those who are engaged in
11				repaying to counties moneys that the counties have been compelled by
12				statute to expend for county general assistance.
13			(4)	Minors, whether lawfully or unlawfully employed; a minor is deemed su
14				juris for the purposes of this title, and no other person has any claim for
15				relief or right to claim workers' compensation benefits for any injury to a
16				minor worker, but in the event of the award of a lump sum of benefits to
17				a minor employee, the lump sum may be paid only to the legally
18				appointed guardian of the minor.
19		b.	The t	term does not include:
20			(1)	Any person whose employment is both casual and not in the course of
21				the trade, business, profession, or occupation of that person's
22				employer.
23			(2)	Any person who is engaged in an illegal enterprise or occupation.
24			(3)	The spouse of an employer or a child under the age of twenty-two of
25				the an employer dwelling in the household of the employer. For
26				purposes of this paragraph and section 65-07-01, "child" means any
27				legitimate child, stepchild, adopted child, foster child, or acknowledged
28				illegitimate child.
29			(4)	Any real estate broker or real estate salesperson, provided the person
30				meets the following three requirements:

1 (a) The salesperson or broker must be a licensed real estate agent 2 under section 43-23-05. 3 (b) Substantially all of the salesperson's or broker's remuneration for 4 the services performed as a real estate agent must be directly 5 related to sales or other efforts rather than to the number of 6 hours worked. 7 (c) A written agreement must exist between the salesperson or 8 broker and the person or firm for whom the salesperson or broker 9 works, which agreement must provide that the salesperson or 10 broker will not be treated as an employee but rather as an 11 independent contractor. 12 (5) The members of the board of directors of a business corporation who 13 are not employed in any capacity by the corporation other than as 14 members of the board of directors. Any individual delivering newspapers or shopping news, if substantially 15 (6)16 all of the individual's remuneration is directly related to sales or other 17 efforts rather than to the number of hours worked and a written 18 agreement exists between the individual and the publisher of the 19 newspaper or shopping news which states that the individual is an 20 independent contractor. 21 (7) An employer. 22 Persons employed by a subcontractor, or by an independent contractor C. 23 operating under an agreement with the general contractor, for the purpose of 24 this chapter are deemed to be employees of the general contractor who is 25 liable and responsible for the payments of premium for the coverage of these 26 employees until the subcontractor or independent contractor has secured the 27 necessary coverage and paid the premium for the coverage. This subdivision 28 does not impose any liability upon a general contractor other than liability to 29 the bureau for the payment of premiums which are not paid by a 30 subcontractor or independent contractor.

1 18. "Employer" means a person who engages or received the services of another for 2 remuneration unless the person performing the services is an independent 3 contractor under the "common law" test. The term includes: 4 a. The state and all political subdivisions thereof. 5 b. All public and quasi-public corporations in this state. 6 C. Every person, partnership, limited liability company, association, and private 7 corporation, including a public service corporation. 8 d. The legal representative of any deceased employer. 9 The receiver or trustee of any person, partnership, limited liability company, e. 10 association, or corporation, having one or more employees as herein defined. 11 f. The president, vice presidents, secretary, or treasurer of a business 12 corporation, but not members of the board of directors of a business 13 corporation who are not also officers of the corporation. 14 The managers of a limited liability company. g. 15 h. The president, vice presidents, secretary, treasurer, or board of directors of 16 an association or cooperative organized under chapter 6-06, 10-12, 10-13, 17 10-15, 36-08, or 49-21. 18 i. The clerk, assessor, treasurer, or any member of the board of supervisors of 19 an organized township, if the person is not employed by the township in any 20 other capacity. "Fee schedule" means the relative value scale, conversion factors, fee schedules, 21 19. 22 and medical aid rules adopted by the bureau. 23 20. "Fund" means the North Dakota workers' compensation fund. 24 21. "Grandchild" and the terms defined in subsections 7 and 9 include only a person 25 who, at the time of the death of the deceased employee, is under eighteen years of 26 age, or if over that age, is incapable of self-support. 27 22. "Hazardous employment" means any employment in which one or more 28 employees are employed regularly in the same business or in or about the 29 establishment except: 30 a. Agricultural or domestic service. 31 b. Any employment of a common carrier by railroad.

1 Any employment for the transportation of property or persons by C. 2 nonresidents, where, in such transportation, the highways are not traveled 3 more than seven miles [11.27 kilometers] and return over the same route 4 within the state of North Dakota. 5 All members of the clergy and employees of religious organizations engaged d. 6 in the operation, maintenance, and conduct of the place of worship. 7 23. "Health care provider" means a doctor or any recognized practitioner providing 8 skilled services pursuant to the prescription of, or under the supervision or 9 direction of, a doctor. 10 "Orphan" means a child who has no lawful parent. 24. 11 25. "Parent" includes a stepparent and a parent by adoption. 12 26. <u>25.</u> "Permanent impairment" means the loss of or loss of use of a member of the body 13 existing after the date of maximum medical improvement or recovery, and includes 14 disfigurement resulting from an injury. The loss must be determined in accordance with and based upon the most current edition of the American medical 15 16 association's "Guides to the Evaluation of Permanent Impairment". Any 17 impairment award, not expressly contemplated within the American medical 18 association's "Guides to the Evaluation of Permanent Impairment", must be 19 determined by clear and convincing medical evidence. 20 27. 26. "Permanent total disability" means an employee is determined incapable of 21 rehabilitation of earnings capacity as determined by the: 22 Nature of injury. a. 23 b. Degree of physical impairment. 24 C. Education. 25 d. Work history. 26 Vocational rehabilitation potential. e. 27 28. 27. "Rehabilitation services" means nonmedical services reasonably necessary to 28 restore a disabled employee to substantial gainful employment as defined by 29 section 65-05.1-01 as near as possible. The term may include vocational 30 evaluation, counseling, education, workplace modification, and vocational

1 retraining including on-the-job training or training for alternative employment with 2 the same employer, and job placement assistance. 3 29. 28. "Seasonal employment" includes an occupation that has periods of forty-five 4 consecutive days of not receiving wages. 5 30. 29. "Spouse" includes only the decedent's husband or wife who was living with the 6 decedent or was dependent upon the decedent for support at the time of injury. 7 31. 30. "Utilization review" means the initial and continuing evaluation of appropriateness 8 in terms of both the level and the quality of health care and health services 9 provided a patient, based on medically accepted standards. The evaluation must 10 be accomplished by means of a system that identifies the utilization of medical 11 services, based on medically accepted standards, and which refers instances of 12 possible inappropriate utilization to the bureau to obtain opinions and 13 recommendations of expert medical consultants to review individual cases for 14 which administrative action may be deemed necessary. 15 32. 31. "Wages" means an employee's remuneration from all employment reportable to 16 the internal revenue service as earned income for federal income tax purposes. 17 For purposes of chapter 65-04, "wages" may not include dismissal or severance 18 pay. 19 SECTION 2. AMENDMENT. Subsection 4 of section 65-05-28 of the North Dakota 20 Century Code is amended and reenacted as follows: 21 If an employee, or the employee's representative, refuses to submit to, or in any 22 way intentionally obstructs, any examination or treatment, or refuses reasonably to 23 reasonably participate in medical or other treatments or examinations, the 24 employee's right to claim compensation under this title is suspended until the 25 refusal or obstruction ceases. No compensation is payable while the refusal or 26 obstruction continues, and the period of the refusal or obstruction must be 27 deducted from the period for which compensation is payable to the employee. 28 **SECTION 3. AMENDMENT.** Subsection 1 of section 65-05-28.2 of the North Dakota 29 Century Code is amended and reenacted as follows: 30 During the first sixty days after a compensable work injury, an employee of an 31 employer who has selected a preferred provider under this section may seek

1	medical treatment only from the preferred provider for the injury. Treatment by a			
2	provider other than the preferred provider is not compensable and the bureau may			
3	not pay for treatment by a provider who is not a preferred provider, unless a			
4	referral was made by the preferred provider. A provider who is not a preferred			
5	provider may not certify disability or render an opinion about any matter pertaining			
6	to the injury, including causation, compensability, impairment, or disability. This			
7	section does not apply to emergency care nor to any care the employee			
8	reasonably did not know was related to a compensable work injury.			
9	SECTION 4. AMENDMENT. Section 65-07-01 of the North Dakota Century Code is			
10	amended and reenacted as follows:			
11	65-07-01. Employer, spouse and children of employer, self-employed, and			
12	volunteers may secure coverage. Any employer, by special contract with the bureau, may			
13	secure insurance protection against workers' compensation coverage for injuries to the			
14	employer's own person or for the employer's own death when such injury or death occurs in the			
15	course of the employer's work in an industry in which the employer has secured such protection			
16	against injuries to the employer's employees. Any employer also may secure such coverage			
17	for that employer's spouse and children living in the same household as the employer.			
18	Self-employed persons may contract with the bureau for insurance protection workers'			
19	compensation coverage for themselves. In addition, any volunteer organization, not otherwise			
20	provided for under this title, may contract with the bureau for such insurance protection			
21	workers' compensation coverage for its own members while such its members are engaged in			
22	the specific activity provided for in such the contract.			
23	SECTION 5. REPEAL. Section 65-07-04 of the North Dakota Century Code is			
24	repealed.			
25	SECTION 6. EFFECTIVE DATE. Sections 1, 2, and 3 of this Act are effective for all			
26	claims, regardless of the date of the injury. Section 4 is effective for all employer accounts			

regardless of the date the account was established. Section 5 is effective August 1, 1999.
