- 1 A BILL for an Act to amend and reenact sections 39-04-21, 39-06.1-08, and paragraph 2 of
- 2 subdivision a of subsection 3 of section 39-06.1-10 of the North Dakota Century Code, relating
- 3 to the temporary registration of motor vehicles; and to provide a penalty.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 39-04-21 of the North Dakota Century Code is amended and reenacted as follows:

39-04-21. Fees for motor vehicles first registered in state <u>- Temporary</u> registration.

- 1. When a motor vehicle first becomes subject to registration during the calendar year, the registration fee must be for the remainder of the year prorated on a monthly basis, one-twelfth of the annual registration fee for each calendar month or fraction thereof. Penny adjustments must be carried to the next even dollar.
- 2. Temporary registrations must be issued in such a manner as is prescribed by the director of the department of transportation. The director shall collect a surcharge of fifty dollars for each application for a temporary registration. The director shall transmit this surcharge to the treasurer of the county in this state in which the application was made for deposit in the general fund of the county. The director shall issue evidence of registration in a distinguishing color to an applicant for a temporary registration. The applicant shall display the evidence of registration in a window of the motor vehicle. The fee imposed for a violation of this section as a result of not displaying the evidence of registration must be distributed to the treasurer of the governing body of the law enforcement officer who enforced the temporary registration requirement for deposit as determined by that governing body.
