- 1 A BILL for an Act to amend and reenact sections 18-12-25 and 54-21.3-03 of the North Dakota
- 2 Century Code, relating to the state building code; and to provide for transition.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 18-12-25 of the North Dakota Century Code is amended and reenacted as follows:

- SECTION 2. AMENDMENT. Section 54-21.3-03 of the 1999 Supplement to the North
 Dakota Century Code is amended and reenacted as follows:
- 16 **54-21.3-03. State building code Amendments.**
- The state building code consists of the Uniform Building Code with any existing
 supplements and the Uniform Mechanical Code with any existing supplements as
 referenced by the Uniform Building Code, except that section 504(f) of the Uniform
 Mechanical Code is amended to read as follows:
- 21 Section 504(f). LPG Appliances.
- 22 Liquefied petroleum gas burning appliances, both automatically and manually
 23 controlled, may be installed in basements or similar locations only if (a) the
 24 appliances are of an American gas association approved type and installed in

1 accordance with national fire protection association pamphlets 54 and 58, (b) 2 automatically controlled appliances are equipped with safety shutoff devices 3 of the complete shutoff type, and (c) gas piping has been pressure tested and 4 proven to be gastight. 5 The director of the office of management and budget, in cooperation with the state 6 building code advisory committee, shall adopt rules to implement, amend, and 7 periodically update the state building code and may adopt rules to amend the 8 eode, which must consist of the international building, residential, mechanical, and 9 fuel gas codes. 10 2. The state building code advisory committee consists of: 11 Two representatives appointed by the North Dakota building officials 12 association, one of whom must be from a jurisdiction of fewer than ten 13 thousand people. 14 One representative appointed by the North Dakota chapter of the American b. 15 institute of architects. 16 One representative appointed by the North Dakota society of professional C. 17 engineers. 18 One representative appointed by the North Dakota association of builders. <u>d.</u> 19 One representative appointed by the North Dakota association of mechanical e. 20 contractors. 21 <u>f.</u> One representative appointed by the associated general contractors. 22 A fire marshal appointed by the state fire marshal. g. 23 One individual appointed by the state electrical board. h. The state building code advisory committee shall meet with the director of the 24 3. 25 office of management and budget or a designee of the director at least once each 26 calendar year to address proposed amendments to the state building code. Representatives of eligible jurisdictions as established by administrative rule. 8 For the purposes of manufactured homes, the state building code consists of the <u>4.</u> 9 manufactured homes construction and safety standards under 24 CFR 3280 10 adopted pursuant to the Manufactured Housing Construction and Safety Standards 11 Act [42 U.S.C. 5401 et seq.]. 12 3. <u>5.</u> The governing body of a city, township, or county that elects to administer and 13 enforce a building code shall adopt and enforce the state building code. However, 14 the state building code may be amended by cities, townships, and counties to 15 conform to local needs. 16 **SECTION 3. TRANSITION.** The state building code in effect on January 1, 2001, must 17 remain in effect until publication of rules under section 54-21.3-03 to implement the 18 international building, residential, mechanical, and fuel gas codes as the state building code.
