BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. If House Bill No. 1045 does not become effective, section
 15-40.1-07.7 of the 1999 Supplement to the North Dakota Century Code is amended and
 reenacted as follows:
- 9 15-40.1-07.7. Per student payments Limited English proficient students.
 - 1. In addition to any other payments provided for by this chapter, each school district is entitled to receive four:
 - a. Five hundred dollars for each student who has been assessed by the student's school district and found to have negligible limited English language skills, as evidenced by a classification of level I using the Woodcock-Munoz language survey.
 - <u>b.</u> Four hundred dollars for each student who has been assessed by the student's school district and <u>determined found</u> to have <u>negligible or</u> very limited English language skills, as evidenced by a classification of level Lor II using the Woodcock-Munoz language survey.
 - c. Three hundred dollars for each student who has been assessed by the student's school district and found to have limited English language skills, as evidenced by a classification of level III using the Woodcock-Munoz language survey.
 - 2. In order to be eligible for assessment under this section, a student:

1 Must be at least five years of age but must not have reached the age of a. 2 twenty-two; 3 Must be enrolled in a school district in this state; b. 4 Must have a primary language other than English; and C. 5 d. Must have difficulty speaking, reading, writing, and understanding English. 6 In order to be eligible for the payment provided for in this section, a school district 3. 7 must provide an approved program of instruction for students who have negligible 8 limited English language skills, very limited English language skills, or limited 9 English language skills. In order to receive the full payment provided for in this 10 section, a school district must complete the student assessment required by 11 subsection 1 and forward the results to the superintendent of public instruction on 12 or before October twenty-fifth November first of each school year. The 13 superintendent shall distribute the payments no later than May thirtieth of each 14 school year. The superintendent shall prorate payments under this section for any 15 students registering in the school district after October first the start of the school 16 year or departing the school district prior to the completion of the school year. 17 SECTION 2. AMENDMENT. Section 15.1-27-12 of the North Dakota Century Code as 18 created by House Bill No. 1045, as approved by the fifty-seventh legislative assembly, is amended and reenacted as follows: 19 20 15.1-27-12. Per student payments - Limited English proficient students. 21 In addition to any other payments provided for by this chapter, each school district 22 is entitled to receive four: 23 Five hundred dollars for each student who has been assessed by the 24 student's school district and found to have negligible limited English language 25 skills, as evidenced by a classification of level I using the Woodcock-Munoz 26 language survey; 27 b.  - SECTION 3. APPROPRIATION. There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$800,000, or so much of the sum as may be necessary, to the superintendent of public instruction for the purpose of providing supplemental per student payments for limited English proficient students, for the biennium beginning July 1, 2001, and ending June 30, 2003.
