FIRST ENGROSSMENT with Senate Amendments

ENGROSSED HOUSE BILL NO. 1468

- 1 A BILL for an Act to create and enact a new subsection to section 20.1-03-12 of the North
- 2 Dakota Century Code, relating to nonresident hunting fees; to amend and reenact section
- 3 20.1-03-07.1 and subsections 2, 7, 8, 37, 38, and 39 of section 20.1-03-12 of the North Dakota
- 4 Century Code, relating to nonresident hunting and fishing licenses and fees; to provide an
- 5 effective date; and to declare an emergency.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 20.1-03-07.1 of the 1999 Supplement to the
 North Dakota Century Code is amended and reenacted as follows:
- 9 **20.1-03-07.1. Nonresident waterfowl hunting license required.** Except as provided
- 10 in sections 20.1-03-07.2 and 20.1-03-07.3, a nonresident may not hunt waterfowl unless that
- 11 person first obtains a nonresident waterfowl hunting license, in addition to a nonresident small
- 12 game hunting license. The nonresident waterfowl hunting license entitles the nonresident to
- 13 hunt waterfowl for any period of fourteen consecutive days, any period of seven consecutive
- 14 days, or any two periods of seven consecutive days each. A license authorizing the
- 15 fourteen-day hunting period allows hunting in a specified waterfowl hunting zone. A license
- 16 authorizing one 7-day hunting period allows hunting statewide. A license authorizing two 7-day
- 17 hunting periods allows hunting in a specified zone during each period. The governor, in the
- 18 governor's proclamation, shall specify various waterfowl hunting zones for which nonresident
- 19 waterfowl hunting licenses will be available, and may specify the number of licenses which may
- 20 be issued in each zone and the manner in which they are to be issued. A nonresident is
- 21 entitled to purchase only one nonresident waterfowl hunting license per year.
- SECTION 2. AMENDMENT. Subsections 2 and 37 of section 20.1-03-12 of the 1999
- 23 Supplement to the North Dakota Century Code are amended and reenacted as follows:
- 24 2. For a nonresident small game hunting license, seventy-five eighty-five dollars.

- 1 37. For a nonresident waterfowl hunting license, ten eighty-five dollars.
- 2 **SECTION 3. AMENDMENT.** Subsections 7, 8, 38, and 39 of section 20.1-03-12 of the
- 3 1999 Supplement to the North Dakota Century Code are amended and reenacted as follows:
- 4 7. For a nonresident fishing license, twenty-five thirty-two dollars.
- 5 8. For a nonresident short-term seven-day fishing license, fifteen twenty dollars.
- 6 38. For a nonresident husband and wife fishing license, thirty-five forty-five dollars.
- 7 39. For a nonresident short-term three-day fishing license, ten fifteen dollars.
- 8 **SECTION 4.** A new subsection to section 20.1-03-12 of the 1999 Supplement to the
- 9 North Dakota Century Code is created and enacted as follows:
- For a combination nonresident waterfowl and nonresident small game hunting
- 11 <u>license, one hundred thirty dollars.</u>
- 12 **SECTION 5. EFFECTIVE DATE.** Section 3 of this Act becomes effective on April 1,
- 13 2002.
- **SECTION 6. EMERGENCY.** Sections 1, 2, and 4 of this Act are declared to be an
- 15 emergency measure.
