- 1 A BILL for an Act to create and enact two new sections to chapter 15.1-12 of the North Dakota
- 2 Century Code, relating to approval criteria for school district reorganizations; and to amend and
- 3 reenact subsection 2 of section 15.1-12-10 of the North Dakota Century Code, relating to
- 4 school district reorganization plan requirements.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new section to chapter 15.1-12 of the North Dakota Century Code is created and enacted as follows:

8 Approval for reorganization - Criteria.

- Neither a county committee nor the state board may consider or approve a
 reorganization under this chapter unless the reorganization includes at least one
 high school district that has an enrollment of at least two hundred twenty-five
 students.
- 2. Neither a county committee nor the state board may consider or approve a reorganization under this chapter unless the reorganized district would:
 - a. Have a student enrollment that is in excess of six hundred;
 - b. Have a student enrollment that is in excess of five hundred twenty and cover a geographical area that is in excess of six hundred square miles [155398.8 hectares];
 - <u>c.</u> Have a student enrollment that is in excess of four hundred fifty and cover a
 geographical area that is in excess of eight hundred square miles [207198.4
 hectares]; or
 - d. Cover a geographical area that is in excess of one thousand square miles[258998 hectares].

3	Isolation - Waiver of reorganization criteria.		
4	<u>1.</u>	If th	e boards of two or more school districts vote to pursue a reorganization, but fail
5		bec	ause of isolation to meet the criteria of section 1 of this Act, the boards may
6		jointly petition the superintendent of public instruction for a waiver of those	
7		requirements. The superintendent may waive the requirements only if:	
8		<u>a.</u>	The proposed reorganized district will offer within its boundaries all grade
9			levels from one through twelve;
10		<u>b.</u>	The geographic location of the proposed reorganized district negates other
11			practical reorganization alternatives;
12		<u>C.</u>	The proposed reorganized district covers a geographical area of at least six
13			hundred square miles [155398.8 hectares];
14		<u>d.</u>	The proposed reorganized district will offer students academic opportunities
15			and other educational opportunities not otherwise available; and
16		<u>e.</u>	The proposed reorganized district appears able to sustain a viable financial
17			base into the foreseeable future.
18	<u>2.</u>	Any board aggrieved by a decision of the superintendent of public instruction under	
19		this	section may appeal the decision to the state board of public school education.
20		A de	ecision by the state board is final.
21	SECTION 3. AMENDMENT. Subsection 2 of section 15.1-12-10 of the 1999		
22	Supplement to the North Dakota Century Code is amended and reenacted as follows:		
23	2.	2. Upon receiving a reorganization plan that meets the requirements of section 1, the	
24		cou	nty superintendent shall schedule and give notice of a public hearing regarding
25		the	plan.
