- 1 A BILL for an Act to create and enact a new paragraph to subdivision a of subsection 3 of
- 2 section 39-06.1-10 and section 39-10-73 of the North Dakota Century Code, relating to
- 3 passengers in a vehicle; and to amend and reenact section 39-06.1-09 of the North Dakota
- 4 Century Code, relating to moving violations.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 39-06.1-09 of the North Dakota Century Code is amended and reenacted as follows: 39-06.1-09. Moving violation defined. For the purposes of sections 39-06.1-06 and
- 9 39-06.1-13, a "moving violation" means a violation of section 39-04-22; subsection 1 of section 10 39-04-37; section 39-04-55; 39-06-01; 39-06-14; 39-06-16; 39-09-04.1; 39-09-09; 39-12-04;
- 11 39-12-05; 39-12-06; 39-12-09; 39-24-02; or 39-24-09, except subdivisions b and c of
- 12 subsection 5, or equivalent ordinances; or a violation of the provisions of chapter 39-10,
- 13 39-10.2, or 39-21, or equivalent ordinances, except sections 39-10-73, 39-21-44, 39-21-45.1,
- 14 39-21-46, and those sections within those chapters which are specifically listed in subsection 1
- 15 of section 39-06.1-08.
- **SECTION 2.** A new paragraph to subdivision a of subsection 3 of section 39-06.1-10 of
- 17 the 1999 Supplement to the North Dakota Century Code is created and enacted as follows:
- 18 <u>Riding in prohibited area of vehicle</u> <u>1 point</u>
- 19 under section 39-10-73
- 20 **SECTION 3.** Section 39-10-73 of the North Dakota Century Code is created and
- 21 enacted as follows:
- 22 **39-10-73.** Location of passengers.

- 1. The operator of a vehicle that is being operated on a highway may not allow an
  2 individual under eighteen years of age to ride on any portion of the vehicle not
  3 designed for transporting passengers.
  - 2. This section does not apply to an employee engaged in the necessary discharge of that employee's duties, to an individual riding in an official parade, nor to an individual being transported in an emergency situation.
