## ENGROSSED SENATE CONCURRENT RESOLUTION NO. 4027

1	A concurrent resolution directing the Legislative Council to study the prices for prescription
2	drugs and possible mechanisms to lower those costs to consumers and the state, and whether
3	the state should establish a program to assist in the purchase of prescription drugs based upon
4	income.
5	WHEREAS, a study by the Center for Studying Health System Change reports that
6	prescription drugs are responsible for 44 percent of the increase in health care costs; and
7	WHEREAS, Medicaid drug expenditures for the 1997-99 biennium totaled \$47.1 million,
8	of which \$12.3 million were from the general fund; for the 1999-2001 biennium, the department
9	of human services budgeted \$50.4 million, of which \$15 million are state funds; and the latest
10	estimates indicate that the department of human services will expend \$63.5 million, of which
11	\$18.9 million are state funds while the department of human services is anticipating
12	expenditures in the next biennium to exceed \$80 million; and
13	WHEREAS, escalating prescription drug prices is an especially important issue to
14	seniors because studies indicate the cost of the top 50 drugs used by elderly citizens in this
15	country has been increasing at a rate that has outpaced inflation nearly two to one; and
16	WHEREAS, escalating prescription drug prices is an especially important issue to rural
17	residents because rural residents typically have lower incomes, limited access to pharmacies,
18	and pay more for prescription drugs than their urban counterparts; and
19	WHEREAS, studies indicate that inadequate access to affordable prescription drugs
20	results in increased medical expenses such as increased emergency mental health services
21	and increased nursing home admissions; and
22	WHEREAS, several states have initiated programs to address the affordability of
23	prescription drugs, including Maine's Maine Rx program and Indiana's HoosierRx; and
24	WHEREAS, several states have introduced legislation to address the issue of
25	affordability of prescription drugs, including Illinois, Michigan, Minnesota, and Ohio;
