4	SECTION 1. APPROPRIATION. There is appropriated out of any moneys in the			
5	general fund in the state treasury, not otherwise appropriated, and from special funds derived			
6	from federal funds and other income, the sums as hereinafter provided or so much of the sums			
7	as may be necessary. These sums increase the general fund authority enacted by the			
8	fifty-sixth legislative assembly to the stated departments and institutions of the state of North			
9	Dakota for the purpose of defraying their expenses, for the period beginning January 1, 2001,			
10	and ending June 30, 2001, as follows:
