5	general fund in the state treasury, not otherwise appropriated, and from special funds derived				
6	from other income, the sums as hereinafter provided or so much of the sums as may be				
7	necessary. These sums increase the appropriation authority enacted by the fifty-sixth				
8	legislative assembly to the stated departments and institutions of the state of North Dakota for				
9	the purpose of defraying their expenses, for the period beginning January 1, 2001, and ending
