A school or a school district for which a waiver has been approved under 5 this section, may apply for extensions of the waiver. Each extension may not 6 exceed one year. If the superintendent of public instruction, after receipt and consideration of an application for a waiver of a rule governing the accreditation of schools under this section approves the waiver, the superintendent shall file a report with a committee designated by the legislative council. The report must cite the accreditation rule that was waived, provide a detailed account of the reasons for which the rule was waived, and state the time period for which the rule was waived. If the superintendent of public instruction denies an application for a waiver under this section, the superintendent shall file a notice of denial with the committee designated by the legislative council.
 - 4. The superintendent of public instruction shall adopt rules governing the submission of applications, the evaluation of applications, and any other matters necessary for the administration of waivers under this section.
