1 Develop a biennial budget request and submit that request to the state board of 2 higher education on or before March first of each even-numbered year; 3 **SECTION 3. AMENDMENT.** Subsection 1 of section 4-05.1-21 of the 1999 4 Supplement to the North Dakota Century Code is amended and reenacted as follows: 5 1. The state board of agricultural research and education may use the proceeds of 6 the agricultural research fund for reasonable administrative expenses and annually 7 shall apportion the remaining proceeds of the agricultural research fund as follows: 8 Seventy percent to research activities affecting North Dakota agricultural 9 commodities that account for at least two percent of the gross sales of all 10 agricultural commodities grown or produced in the state. The percentage of 11 the dollars available for each agricultural commodity under this section may 12 not exceed the percentage that the gross sales of the agricultural commodity 13 bear to the North Dakota gross sales of all agricultural commodities grown or 14 produced during the previous year, as determined by the agricultural statistics 15 service: 16 Eighteen percent to research activities affecting North Dakota animal b. 17 agriculture; and 18 Twelve percent to research activities affecting new and emerging crops in C.
