**Bismarck, February 15, 2001**

**HB 1356:** A BILL for an Act to amend and reenact section 20.1-06-08 of the North Dakota Century Code, relating to the governor's proclamation concerning spearfishing from dark houses.

Was read the first time and referred to the **Natural Resources Committee**.

**HB 1370:** A BILL for an Act to amend and reenact section 16.1-08.1-04 of the North Dakota Century Code, relating to supplemental campaign contribution statements.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

**HB 1374:** A BILL for an Act relating to honorary high school diplomas for veterans; and to declare an emergency.

Was read the first time and referred to the **Education Committee**.

**HB 1396:** A BILL for an Act to create and enact a new subsection to section 61-02-14 of the North Dakota Century Code, relating to the powers and duties of the state water commission; and to amend and reenact subsections 4 and 5 of section 61-01-26 of the North Dakota Century Code and section 10 of chapter 535 of the 1999 Session Laws, relating to the sharing of costs for water quality protection programs and the statewide water development program.

Was read the first time and referred to the **Natural Resources Committee**.

**HB 1404:** A BILL for an Act to create and enact a new section to chapter 5-01 of the North Dakota Century Code, relating to farm winery licenses.

Was read the first time and referred to the **Agriculture Committee**.

**HB 1409:** A BILL for an Act to create and enact a new section to chapter 23-27 and two new sections to chapter 57-40.6 of the North Dakota Century Code, relating to the dispatching of ambulances and standards and guidelines for 911 telephone systems; and to provide an effective date.

Was read the first time and referred to the **Political Subdivisions Committee**.

**HB 1467:** A BILL for an Act to transfer funds from the environment and rangeland protection fund to the minor use pesticide fund.

Was read the first time and referred to the **Agriculture Committee**.

**HB 1472:** A BILL for an Act to create and enact a new section to chapter 50-24.1 of the North Dakota Century Code, relating to medical assistance for breast and cervical cancer; and to provide an appropriation.

Was read the first time and referred to the **Human Services Committee**.

#### **FIRST READING OF HOUSE CONCURRENT RESOLUTIONS**

**HCR 3020:** A concurrent resolution urging the United States Army Corps of Engineers to promote private access to, private ownership of, and private development on lands it owns and manages around Lake Sakakawea, including the return of lakeshore lands that are contiguous to current tribal-owned land to the Three Affiliated Tribes and development and implementation of a water level policy that establishes and assures that Lake Sakakawea will have a stable water level.

Was read the first time and referred to the **Natural Resources Committee**.

**HCR 3021:** A concurrent resolution expressing appreciation for passage of the Dakota Water Resources Act and urging Congress to fully fund the federal share of the water projects in that Act.

Was read the first time and referred to the **Natural Resources Committee**.

**HCR 3022:** A concurrent resolution directing the Legislative Council to study the use of incentive programs in North Dakota as a way of keeping elk in the state and providing increased opportunities for landowners, hunters, and the general public.

Was read the first time and referred to the **Natural Resources Committee**.

**HCR 3043:** A concurrent resolution directing the Legislative Council to study the fiscal note process.

Was read the first time and referred to the **Appropriations Committee**.
