## ENGROSSED HOUSE BILL NO. 1234

1 A BILL for an Act to amend and reenact sections 28-24-02, 28-24-04, and 32-19-18 of the  
2 North Dakota Century Code, relating to redemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 28-24-02 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **28-24-02. Payment on and period of redemption.** The judgment debtor or  
7 redemptioner may redeem the property from the purchaser ~~within one year (six months in~~  
8 ~~redemptions under subsection 1 of section 32-19.1-04)~~ after the sale on by paying the  
9 purchaser the amount of the purchase with interest at the rate provided in the original  
10 instrument on which the judgment is based, plus the amount of any insurance premiums,  
11 assessments, taxes, utilities, or other items paid by the purchaser in protection of the title or the  
12 premises, which the purchaser may have paid after the purchase, and interest at the same rate  
13 on that amount, and, if the purchaser is also a creditor having a lien superior to that of the  
14 redemptioner other than the judgment under which the purchase was made, the amount of that  
15 lien with interest. The period of redemption must be six months for a redemption under  
16 subsection 1 of section 32-19.1-04 or one year. The period of redemption begins at the time of  
17 the filing of the summons and complaint in the office of the clerk of district court or at the time of  
18 the first publication of the notice before foreclosure by advertisement, unless it is determined by  
19 the court that the mortgagee is not entitled to judgment. The final date for redemption may not  
20 be earlier than sixty days after the sheriff's sale.

21 **SECTION 2. AMENDMENT.** Section 28-24-04 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23 **28-24-04. Successive redemptions - Time.** If property is redeemed by a  
24 redemptioner, another redemptioner, even after the expiration of ~~one year from the day of sale~~

1 the period of redemption, may redeem from the last redemption if the redemption is made  
2 within sixty days after ~~such~~ the last redemption. This sixty-day limitation does not apply to any  
3 redemption made within ~~one year after the sale~~ the period of redemption by whomsoever or  
4 from whomsoever ~~such~~ the redemption is made, but all persons entitled to redeem in all cases  
5 have the entire period of ~~one year from the day of sale~~ redemption in which to redeem. The  
6 property, as often as a redemptioner is so disposed, may be redeemed again from any  
7 previous redemptioner within sixty days after the last redemption.

8 **SECTION 3. AMENDMENT.** Section 32-19-18 of the North Dakota Century Code is  
9 amended and reenacted as follows:

10 **32-19-18. Redemption.** All real property sold upon foreclosure of a mortgage by  
11 order, judgment, or decree of court may be redeemed ~~at any time within one year after such~~  
12 ~~sale~~ as prescribed by chapter 28-24.
