1 A BILL for an Act to amend and reenact subsection 5 of section 39-04-19 of the North Dakota  
2 Century Code, relating to motor vehicle registration fees for farm vehicles.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Subsection 5 of section 39-04-19 of the North Dakota  
5 Century Code is amended and reenacted as follows:

6 5. Trucks or combinations of trucks and trailers weighing more than twenty thousand  
7 but not more than one hundred five thousand five hundred pounds [more than  
8 9071.84 but not more than 47854.00 kilograms] which are used as farm vehicles  
9 only and for which no more than seven thousand five hundred miles [12472.41  
10 kilometers] are driven, are entitled to registration under the following fee schedule  
11 and the provisions of this subsection. Farm vehicles are considered, for the  
12 purpose of this subsection, as trucks or combinations of trucks and trailers  
13 weighing more than twenty thousand but not more than one hundred five thousand  
14 five hundred pounds [more than 9071.84 but not more than 47854.00 kilograms]  
15 owned, or leased for at least one year by a bona fide resident farmer who uses the  
16 vehicles exclusively for transporting the farmer's own property or other property on  
17 a farm work exchange basis with other farmers between farms and the usual local  
18 trading places but not in connection with any commercial retail or wholesale  
19 business being conducted from those farms, nor otherwise for hire. In addition to  
20 the penalty provided in section 39-04-41, any person violating this subsection shall  
21 license for the entire license period the farm vehicle at the higher commercial  
22 vehicle rate in accordance with the weight carried by the farm vehicle at the time of  
23 the violation.
