22	SECTION 2. VETERANS' CEMETERY MAINTENANCE FUND - APPROPRIATION.	

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the

The veterans' cemetery line item in section 1 of this Act includes the sum of \$70,770 from the

veterans' cemetery maintenance fund for the operation of the veterans' cemetery. Any

- 1 additional funds received by the adjutant general and deposited in the veterans' cemetery
- 2 maintenance fund pursuant to sections 37-03-14 and 39-04-10.10 for the operation of the North
- 3 Dakota veterans' cemetery are appropriated to the adjutant general for that purpose, for the
- 4 biennium beginning July 1, 2003, and ending June 30, 2005.
- 5 SECTION 3. LINE ITEM TRANSFER AUTHORITY MAINTENANCE AND REPAIRS.
- 6 The adjutant general may transfer to the operating expenses and capital assets line items
- 7 contained in section 1 of this Act up to the sum of \$800,000 from the various other line items
- 8 contained in section 1 of this Act, as determined necessary by the department to provide for the
- 9 maintenance and repair of state-owned armories in this state during the biennium beginning
- 10 July 1, 2003, and ending June 30, 2005. Any amounts transferred pursuant to this section
- 11 must be reported to the director of the office of management and budget.
- 12 **SECTION 4. EXEMPTION.** The appropriation contained in section 1 of chapter 17 of
- 13 the 2001 Session Laws is not subject to the provisions of section 54-44.1-11. Any unexpended
- 14 funds from this appropriation must be transferred to the emergency fund of the office of the
- adjutant general during the biennium beginning July 1, 2003, and ending June 30, 2005.
