1 A BILL for an Act to amend and reenact subsection 3 of section 4-14.2-03, subsection 1 of

1 Century Code, relating to changing the name of "state board for vocational and technical
2 education" to "state board for career and technical education", changing the name of "area
3 vocational and technology centers" to "area career and technology centers", authorizing area
4 vocational and technology centers to accept property and grants from the federal government,
5 and designating a department of career and technical education; and to repeal section
6 15-20.1-10 of the North Dakota Century Code, relating to the powers of the school board of a
7 vocational school district.

8 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

9 **SECTION 1. AMENDMENT.** Subsection 3 of section 4-14.2-03 of the North Dakota
10 Century Code is amended and reenacted as follows:

11 3. Educational and ~~vocational~~ career and technical education training programs in
12 milling, processing, manufacturing, purchasing methods, marketing procedures,
13 product sales techniques, and other related subjects to be conducted for users of
14 northern crops.

15 **SECTION 2. AMENDMENT.** Subsection 1 of section 4-24-11.1 of the North Dakota
16 Century Code is amended and reenacted as follows:

- 17 1. The North Dakota agricultural hall of fame committee consists of the following
18 individuals, each of whom must be selected by the governing body of the entity or
19 the official to be represented:
- 20 a. A representative of the North Dakota winter show;
 - 21 b. A representative of agricultural media;
 - 22 c. A representative of ~~vocational~~ agriculture in the area of career and technical
23 education;
 - 24 d. A representative of the North Dakota stockmen's association;
 - 25 e. A representative of the North Dakota grain growers association;
 - 26 f. A representative of the North Dakota oilseed council;
 - 27 g. A representative of county extension agents;
 - 28 h. A representative of the agriculture commissioner;
 - 29 i. A representative of the North Dakota pork producers;
 - 30 j. A representative of the North Dakota sheep producers;

- 1 k. A representative of the national agricultural marketing association;
- 2 l. A representative of the North Dakota implement dealers association;
- 3 m. A representative of the North Dakota farm bureau;
- 4 n. A representative of the North Dakota farmers union; and
- 5 o. A representative of the national farmers organization.

6 **SECTION 3. AMENDMENT.** Section 4-37-03 of the North Dakota Century Code is
7 amended and reenacted as follows:

8 **4-37-03. Purpose - Powers and duties.** The agriculture in the classroom council shall
9 develop agricultural curriculum activities and train teachers in these agricultural curriculum
10 activities for grades kindergarten through twelve in this state's public school system. The
11 council shall work with all educators, including the superintendent of public instruction, the ~~state~~
12 ~~board for vocational~~ department of career and technical education, the United States
13 department of agriculture, and the state agriculture commissioner in accomplishing its purpose.
14 The council shall render services consistent with this purpose which include:

- 15 1. Consultations with the state superintendent of public instruction, the ~~state board for~~
16 ~~vocational~~ department of career and technical education, the state agriculture
17 commissioner, and the United States department of agriculture.
- 18 2. Preparation of instructional, informational, and reference publications on the North
19 Dakota agricultural economy and rural lifestyles.
- 20 3. Provide training programs for public school teachers in developed agricultural
21 curriculum activities.
- 22 4. Encourage research on and identification of new instructional, informational, and
23 reference publications relating to this state's agricultural economy and rural
24 lifestyles.
- 25 5. Monitor the quality and condition of the agriculture in the classroom program.

26 **SECTION 4. AMENDMENT.** Subsections 3 and 4 of section 6-09.10-02.1 of the North
27 Dakota Century Code are amended and reenacted as follows:

- 28 3. Recommend policies and procedures regarding the adult farm management
29 program to the state board for ~~vocational~~ career and technical education.
- 30 4. Participate in a farm management delivery system coordinated by the state board
31 for ~~vocational~~ career and technical education among the adult farm management

1 program, agricultural mediation service, and North Dakota state university. The
2 system must be available to any farmer and may be funded from moneys available
3 in the fund described in this chapter, fees paid by farmers, or other sources.

4 **SECTION 5. AMENDMENT.** Subsection 1 of section 6-09.10-06 of the North Dakota
5 Century Code is amended and reenacted as follows:

6 1. A revolving fund must be maintained at the Bank of North Dakota for the subsidy of
7 interest rates on home-quarter purchases and coordination and operation of a farm
8 management delivery system, as provided in this chapter. All moneys transferred
9 into the fund, interest upon moneys in the fund, and payments to the fund are
10 hereby appropriated for the purposes of this chapter. Any moneys generated by
11 the farm management delivery system must be transferred to the state board for
12 ~~vocational~~ career and technical education and allocated by the state board for
13 ~~vocational~~ career and technical education to the adult farm management program,
14 the agricultural mediation services, and North Dakota state university for expenses
15 related to the jointly developed and implemented farm management delivery
16 system.

17 **SECTION 6. AMENDMENT.** Subsection 2 of section 12-44.1-01 of the North Dakota
18 Century Code is amended and reenacted as follows:

19 2. "Correctional facility" means a city or county jail or detention center, regional
20 corrections center, or juvenile detention center for the detention or confinement of
21 persons in accordance with law. The use of the term does not imply and may not
22 be used to require the provision of services including treatment, counseling,
23 ~~vocational~~ career and technical education, or other educational services, except as
24 may otherwise be required or provided for under this chapter.

25 **SECTION 7. AMENDMENT.** Section 12-44.1-17 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **12-44.1-17. Inmate educational and counseling programs.** A correctional facility
28 may utilize the resources of the community to provide inmates with available educational,
29 ~~vocational~~ career and technical education, counseling, and work release opportunities. A
30 correctional facility may, if possible, and subject to reasonable safety, security, discipline, and
31 correctional facility administration requirements, provide opportunities for access to available

1 religious, mental health, alcoholism, and addiction counseling by inmates desirous of such
2 counseling.

3 **SECTION 8. AMENDMENT.** Section 12-46-25 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **12-46-25. Youth correctional center ~~vocational~~ career and technical education**
6 **shop revolving fund.** There must be maintained in the Bank of North Dakota by the North
7 Dakota youth correctional center a ~~vocational~~ career and technical education shop revolving
8 fund to purchase required parts and supplies for student ~~vocational~~ career and technical
9 education training projects. The amounts taken from the fund must be paid back to the fund
10 from collections made on these projects. The provisions of section 54-27-10 do not apply to
11 this fund and no part of the fund reverts at the expiration of any biennium.

12 **SECTION 9. AMENDMENT.** Subsection 4 of section 12.1-32-07 of the North Dakota
13 Century Code is amended and reenacted as follows:

- 14 4. When imposing a sentence to probation, probation in conjunction with
15 imprisonment, or probation in conjunction with suspended execution or deferred
16 imposition of sentence, the court may impose such conditions as it deems
17 appropriate and may include any one or more of the following:
- 18 a. Work faithfully at a suitable employment or faithfully pursue a course of study
19 or of ~~vocational~~ career and technical education training that will equip the
20 defendant for suitable employment.
 - 21 b. Undergo available medical or psychiatric treatment and remain in a specified
22 institution if required for that purpose.
 - 23 c. Attend or reside in a facility established for the instruction, recreation, or
24 residence of persons on probation.
 - 25 d. Support the defendant's dependents and meet other family responsibilities.
 - 26 e. Make restitution or reparation to the victim of the defendant's conduct for the
27 damage or injury which was sustained or perform other reasonable assigned
28 work. When restitution, reparation, or assigned work is a condition of
29 probation, the court shall proceed as provided in subsection 1 or 2, as
30 applicable, of section 12.1-32-08.

- 1 f. Pay a fine imposed after consideration of the provisions of section 12.1-32-05,
- 2 except when imposition of sentence is deferred.
- 3 g. Refrain from excessive use of alcohol or any use of narcotics or of another
- 4 dangerous or abusable drug without a prescription.
- 5 h. Permit the probation officer to visit the defendant at reasonable times at the
- 6 defendant's home or elsewhere.
- 7 i. Remain within the jurisdiction of the court, unless granted permission to leave
- 8 by the court or the probation officer.
- 9 j. Answer all reasonable inquiries by the probation officer and promptly notify
- 10 the probation officer of any change in address or employment.
- 11 k. Report to a probation officer at reasonable times as directed by the court or
- 12 the probation officer.
- 13 l. Submit to a medical examination or other reasonable testing for the purpose
- 14 of determining the defendant's use of narcotics, marijuana, or other controlled
- 15 substance whenever required by a probation officer.
- 16 m. Refrain from associating with known users or traffickers in narcotics,
- 17 marijuana, or other controlled substances.
- 18 n. Submit the defendant's person, place of residence, or vehicle to search and
- 19 seizure by a probation officer at any time of the day or night, with or without a
- 20 search warrant.
- 21 o. Serve a term of imprisonment of up to one-half of the maximum term
- 22 authorized for the offense of which the defendant was convicted or one year,
- 23 whichever is less.
- 24 p. Reimburse the costs and expenses determined necessary for the defendant's
- 25 adequate defense when counsel is appointed for the defendant. When
- 26 reimbursement of indigent defense costs and expenses is imposed as a
- 27 condition of probation, the court shall proceed as provided in subsection 3 of
- 28 section 12.1-32-08.
- 29 q. Provide community service for the number of hours designated by the court.
- 30 r. Refrain from any subscription to, access to, or use of the internet.

1 **SECTION 10. AMENDMENT.** Section 14-06.1-07 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **14-06.1-07. Program goals.** Each of the service centers shall develop a goal to serve
4 a stated number of urban and rural displaced homemakers. In addition, the service centers
5 shall develop plans for including displaced homemakers in existing job training and placement
6 programs offered by job service, colleges, ~~vocational~~ career and technical education, or other
7 suitable agencies.

8 **SECTION 11. AMENDMENT.** Section 14-06.1-09 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **14-06.1-09. Service programs.** The service centers shall, in cooperation with other
11 existing service programs, ensure that displaced homemakers receive information and referral
12 services which include:

- 13 1. A health counseling and referral clinic based on principles of preventive health care
14 and consumer health education.
- 15 2. Money management courses, including information and assistance in dealing with
16 insurance programs (life, health, home, and automobile), taxes, mortgages, loans,
17 and probate problems.
- 18 3. Information about other assistance programs, including concrete information and
19 assistance with supplemental security income, social security, veterans
20 administration benefits, welfare, food stamps, housing, unemployment insurance,
21 medical assistance, and educational financial assistance.
- 22 4. Educational programs, including courses offered for credit through universities,
23 colleges, or ~~vocational~~ career and technical education training programs, or
24 leading toward a high school equivalency degree. These courses must be
25 designed to supplement the usual academic course offerings with classes geared
26 toward older persons to improve their self-image and abilities.

27 **SECTION 12. AMENDMENT.** Subsection 2 of section 14-08.1-05.1 of the North
28 Dakota Century Code is amended and reenacted as follows:

- 29 2. For purposes of this section, "work activities" may include:
 - 30 a. Unsubsidized employment;
 - 31 b. Subsidized private sector employment;

- 1 c. Subsidized public sector employment;
- 2 d. Work experience, including work associated with the refurbishing of publicly
- 3 assisted housing, if sufficient private sector employment is not available;
- 4 e. On-the-job training;
- 5 f. Job search and job readiness assistance;
- 6 g. Community service programs;
- 7 h. ~~Vocational-educational~~ Career and technical education training, not to exceed
- 8 twelve months with respect to any individual;
- 9 i. Job skills training directly related to employment;
- 10 j. Education directly related to employment, in the case of an individual who has
- 11 not received a high school diploma or a certificate of high school equivalency;
- 12 k. Satisfactory attendance at secondary school or in a course of study leading to
- 13 a certificate of general equivalence, in the case of an individual who has not
- 14 completed secondary school or received such a certificate;
- 15 l. The provision of child care services to an individual who is participating in a
- 16 community service program; and
- 17 m. Postsecondary education and any other activity treated by the federal
- 18 government as work for purposes of calculating a work participation rate
- 19 under 42 U.S.C. 607(b).

20 **SECTION 13. AMENDMENT.** Subsection 1 of section 14-10.2-01 of the North Dakota
21 Century Code is amended and reenacted as follows:

- 22 1. "Educational institution" means a university, college, community college, junior
- 23 college, high school, technical, ~~vocational~~ career and technical education or
- 24 professional school, or similar institution, wherever located, approved or accredited
- 25 by the appropriate official, department, or agency of this state for the purposes of
- 26 this chapter, or by the appropriate official, department, or agency of the state in
- 27 which the institution is located.

28 **SECTION 14. AMENDMENT.** Section 15-10-18.3 of the North Dakota Century Code is
29 amended and reenacted as follows:

30 **15-10-18.3. Free tuition in North Dakota institutions of higher education.** Any
31 dependent, as defined in section 15-10-18.2 upon being duly accepted for enrollment into any

1 North Dakota state-supported institution of higher education or state-supported career and
2 ~~technical or vocational~~ education school, must be allowed to obtain a bachelor's degree or
3 certificate of completion, for so long as the dependent is eligible, free of any tuition and fee
4 charges, except those charged to retire outstanding bonds; provided, however, that the
5 bachelor's degree or certificate of completion is earned within a thirty-six-month or
6 eight-semester period or its equivalent; and further provided that tuition and fee charges shall
7 not include costs for aviation flight charges or expenses. Once a person qualifies as a
8 dependent under sections 15-10-18.2 and 15-10-18.3, there shall be no removal from the
9 benefits of this section due to such an occurrence as the return of the prisoner of war or person
10 missing in action.

11 **SECTION 15. AMENDMENT.** Section 15-10-18.5 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **15-10-18.5. Free tuition in North Dakota institutions of higher education for**
14 **survivor of firefighter or peace officer.** Should a firefighter or peace officer die as a direct
15 result of injuries received while engaged in the performance of official duties under
16 circumstances dangerous to human life, the survivor, upon being duly accepted for enrollment
17 into any North Dakota state-supported institution of higher education or state-supported career
18 and technical or vocational education school, must be allowed to obtain a bachelor's degree or
19 certificate of completion, for so long as the dependent is eligible, free of any tuition and fee
20 charges, except those charged to retire outstanding bonds; provided, however, that the
21 bachelor's degree or certificate of completion is earned within a thirty-six-month or
22 eight-semester period or its equivalent; and further provided that tuition and fee charges may
23 not include costs for aviation flight charges or expenses.

24 **SECTION 16. AMENDMENT.** Section 15-20.1-01 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **15-20.1-01. Definitions.** In this chapter, unless the context otherwise requires:

- 27 1. "Career and technical education" includes vocational education.
28 2. "Department" means the department of career and technical education, which
29 consists of the director and other persons appointed or designated by the state
30 board or the director to carry out the duties of the state board.
31 3. "Director" means the director of ~~vocational~~ career and technical education.

1 ~~2- 4.~~ "Regulations" means regulations made by the director with the approval of the
2 state board.

3 ~~3- 5.~~ "State board" means the state board for ~~vocational~~ career and technical education.

4 **SECTION 17. AMENDMENT.** Section 15-20.1-02 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **15-20.1-02. State board for ~~vocational~~ career and technical education - Director of**
7 **~~vocational~~ career and technical education - Appointment, qualifications, assistants,**
8 **duties.** The state board for ~~vocational~~ career and technical education consists of the members
9 of the state board of public school education, the executive director of job service North Dakota,
10 and the commissioner of higher education or the commissioner's designee. The state board
11 shall oversee the department and appoint a director and executive officer of ~~vocational~~ career
12 and technical education who are charged with the administration, under the direction and
13 supervision of the board, of the provisions of this chapter relating to ~~vocational~~ career and
14 technical education. The state board shall designate such assistants to the director as may be
15 necessary to carry out the provisions of this chapter. The duties, terms of office, and
16 compensation of the director and of ~~his~~ the director's assistants must be determined by the
17 state board. The director shall hold as a minimum a baccalaureate degree received from a
18 recognized college or university. The director shall enforce such rules and regulations as the
19 state board may adopt and shall prepare such reports concerning ~~vocational~~ career and
20 technical education as the state board may require.

21 **SECTION 18. AMENDMENT.** Section 15-20.1-03 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **15-20.1-03. Powers and duties of state board relating to ~~vocational~~ career and**
24 **technical education.** The state board shall have all authority necessary to cooperate with the
25 United States department of education, or other department or agency of the United States of
26 America in the administration of acts of Congress relating to ~~vocational~~ career and technical
27 education, including the following powers and duties:

28 1. To administer any legislation enacted by the legislative assembly of this state
29 pursuant to or in conformity with acts of Congress relating to ~~vocational~~ career and
30 technical education.

- 1 2. To administer the funds provided by the federal government and by this state for
2 the promotion of ~~vocational~~ career and technical education, and to contract with:
 - 3 a. Any public or private institution or agency, board of trustees of any agricultural
4 and training school, or school district of this state; or
 - 5 b. Any public or private institution or agency, or political subdivision, of another
6 state.
- 7 3. To formulate plans for the promotion of ~~vocational~~ career and technical education
8 in such subjects as are an essential and integral part of the public school system of
9 education in this state.
- 10 4. To provide for the preparation of teachers.
- 11 5. To fix the compensation of such officers and assistants as may be necessary to
12 administer the federal acts and the provisions of this chapter relating to ~~vocational~~
13 career and technical education and to pay the same and other necessary
14 expenses of administration from any funds appropriated for such purpose.
- 15 6. To make studies and investigations relating to ~~vocational~~ career and technical
16 education.
- 17 7. To promote and aid in the establishment of schools, departments, or classes, and
18 to cooperate with local communities in the maintenance of ~~vocational~~ career and
19 technical education schools, departments, or classes.
- 20 8. To prescribe the qualifications and provide for the certification of teachers,
21 directors, and supervisors.
- 22 9. To cooperate with governing bodies of school districts and with organizations and
23 communities in the maintenance of classes for the preparation of teachers,
24 directors, and supervisors of ~~vocational~~ career and technical education, to maintain
25 classes for such purposes under its own direction and control, and to establish and
26 control, by general regulations, the qualifications to be possessed by persons
27 engaged in the training of ~~vocational~~ career and technical education teachers.
- 28 10. To coordinate new and existing farm management programs offered by any state
29 agency or entity.
- 30 11. To create and expand marketing clubs as adjuncts to new and existing farm
31 management programs.

1 **SECTION 19. AMENDMENT.** Section 15-20.1-03.1 of the North Dakota Century Code
2 is amended and reenacted as follows:

3 **15-20.1-03.1. Postsecondary ~~vocational~~ career and technical education**
4 **reciprocity with Minnesota.** The state board may enter into agreements with the Minnesota
5 higher education coordinating board or with the governing board of any public postsecondary
6 ~~vocational career and~~ technical institute in that state to enable, on a reciprocal basis, any
7 resident of North Dakota to attend an approved ~~vocational career and technical~~ education
8 program in Minnesota and to permit any resident of Minnesota to attend an approved
9 ~~vocational career and technical~~ education program in North Dakota without being required to
10 pay nonresident tuition fees. For the purposes of this section, "approved ~~vocational career and~~
11 technical education program" means any postsecondary ~~vocational or career and~~ technical
12 program offered by a Minnesota area ~~vocational career and~~ technical institute or a
13 district-operated junior college in North Dakota. Any agreement made pursuant to this section
14 may provide for the transfer of funds between the states and any payment to Minnesota by
15 North Dakota must be within the limitations of the payment due North Dakota from Minnesota
16 under the authority contained in chapter 15-10.1. Any payment to North Dakota by Minnesota
17 must be deposited in the state's general fund.

18 **SECTION 20. AMENDMENT.** Section 15-20.1-04 of the North Dakota Century Code is
19 amended and reenacted as follows:

20 **15-20.1-04. Acceptance of benefits of federal acts in ~~vocational~~ career and**
21 **technical education - Cooperation with federal government.** The state of North Dakota
22 hereby accepts all of the provisions and benefits of the acts of Congress to assist states to
23 maintain, extend, and improve existing programs and develop new programs in ~~vocational~~
24 career and technical education.

25 **SECTION 21. AMENDMENT.** Section 15-20.1-05 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **15-20.1-05. Custody and payment of ~~vocational~~ career and technical education**
28 **funds.** The state board is charged with the duty of administering all funds that are received
29 from federal and state sources and shall accept and use gifts made unconditionally by will or
30 otherwise for purposes of carrying out this chapter for ~~vocational career and technical~~
31 education. All such moneys received must be placed in the custody of the state treasurer, and

1 must be paid in accordance with legislative appropriations by the office of management and
2 budget as directed by the director of ~~vocational~~ career and technical education.

3 **SECTION 22. AMENDMENT.** Section 15-20.1-06 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **15-20.1-06. Reimbursement of schools teaching subjects in ~~vocational~~ career**
6 **and technical education.** The state board may reimburse approved public or private
7 institutions or agencies, or political subdivisions of this state or of another state, giving
8 instruction in ~~vocational~~ career and technical education from funds allocated for that purpose.
9 The state board may prorate the sums available if funds are insufficient to reimburse at the rate

11 **SECTION 23. AMENDMENT.** Section 15-20.1-07 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **15-20.1-07. Cooperation of school boards in ~~vocational~~ career and technical**
14 **education.** The governing body of any school district may cooperate with the state board in the
15 establishment and maintenance of schools, departments, or classes giving instruction in
16 ~~vocational~~ career and technical education as approved by the state board, and may use any
17 moneys raised by public taxation for such purposes in the same manner as the moneys for
18 other school purposes are used for the maintenance and support of public schools. When any
19 school, department, or class giving instruction in ~~vocational~~ career and technical education has
20 been approved by the state board, it may be entitled to share in any federal and state funds
21 available for ~~vocational~~ career and technical education.

22 **SECTION 24. AMENDMENT.** Section 15-20.1-11 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **15-20.1-11. Curriculum - General powers and duties.** The curriculum offered
25 students by ~~a vocational school~~ an area career and technology center must be as determined
26 by the school board; provided, that such curriculum must be submitted annually to the state
27 board for approval, and only an approved curriculum may be offered.

28 **SECTION 25. AMENDMENT.** Section 15-20.1-21 of the North Dakota Century Code is
29 amended and reenacted as follows:

30 **15-20.1-21. Biennial report.** The state board may submit a biennial report to the
31 governor and the secretary of state in accordance with section 54-06-04. If submitted, the

1 report must set forth the condition of ~~vocational~~ career and technical education in the state, a
2 list of the schools to which federal and state aid for ~~vocational~~ career and technical education
3 has been given, and a detailed statement of the expenditures of federal and state funds for that
4 purpose.

5 **SECTION 26. AMENDMENT.** Section 15-20.2-01 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **15-20.2-01. Area centers - Definition of terms.** In this chapter, unless the context
8 otherwise requires:

- 9 1. "Area ~~vocational~~ career and technology center" means a program of ~~vocational~~
10 career and technical education conducted at one or more attendance centers by
11 three or more participating public school districts.
- 12 2. "Center board" means the governing board of an area ~~vocational~~ career and
13 technology center.
- 14 3. "Participating district" means a public school district whose students are attending
15 an area ~~vocational~~ career and technology center.
- 16 4. "School board" means a participating public school district board.
- 17 5. "State board" means the state board for ~~vocational~~ career and technical education.

18 **SECTION 27. AMENDMENT.** Section 15-20.2-02 of the North Dakota Century Code is
19 amended and reenacted as follows:

20 **15-20.2-02. Submission of plan for area center - Approval by state board.** The
21 school boards of three or more school districts may submit to the state board a proposed plan
22 to establish an area ~~vocational~~ career and technology center. Such proposal must be
23 consistent with the state plan for ~~vocational~~ career and technical education and meet the
24 requirements, rules, standards, and procedures as adopted by the state board. The state board
25 upon receipt of a proposed plan to establish an area ~~vocational~~ career and technology center
26 shall examine such plan and receive testimony for the purpose of examining supporting and
27 nonsupporting evidence submitted therewith. The state board shall process the proposed plan
28 according to procedures consistent with the state plan. Nothing in this chapter may be
29 interpreted to prohibit school districts from entering into other kinds of administrative structures
30 for ~~vocational~~ career and technology centers approved by the state board pursuant to other
31 provisions of law.

1 **SECTION 28. AMENDMENT.** Section 15-20.2-03 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **15-20.2-03. Agreement of participation in area center - Resolution of agreement.**

4 After approval of a plan pursuant to this chapter, all participating school districts of an area
5 ~~vocational~~ career and technology center shall enter into an agreement of participation which
6 must receive a vote of approval of the school board of each participating school district. Prior to
7 the effective date of an approved plan, a resolution of agreement must be adopted by a majority
8 vote of each participating school board and such resolution must be published once in the
9 official newspaper of each county or counties of the participating school districts.

10 **SECTION 29. AMENDMENT.** Section 15-20.2-04 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **15-20.2-04. Center boards - Appointment of members - Terms - Compensation -**

13 **Vacancies.** An area ~~vocational~~ career and technology center must be operated by a center
14 board of not less than five members nor more than a total of one member for each participating
15 district; provided, however, that each participating school district with three hundred or more
16 high school students must be allowed one member for each three hundred high school students
17 or fraction thereof with a limitation of not more than three members from any one school district.
18 Center board members must be members of the school boards. The terms of office of the
19 members of center boards must be for at least one year and terminate upon the expiration of
20 their terms on their respective school boards. Members are eligible for reappointment to center
21 boards. Center board members shall receive the same compensation and expenses for
22 attending center board meetings or for otherwise engaging in official business for the center as
23 provided in section 15.1-09-06 for members of school boards. Compensation and expenses of
24 center board members must be paid out of center funds.

25 Vacancies on a center board must be filled by the school board whose representation
26 was lost when the vacancy occurred.

27 **SECTION 30. AMENDMENT.** Section 15-20.2-05 of the North Dakota Century Code is
28 amended and reenacted as follows:

29 **15-20.2-05. Special board plan for small center.** If four or fewer school districts
30 comprise an area ~~vocational~~ career and technology center and if enrollment within such school
31 district is insufficient to provide five members in accordance with section 15-20.2-04, the boards

1 of such school district shall agree upon the number and manner of selection of members of the
2 center board and shall submit their plan of selection for approval by the state board pursuant to
3 section 15-20.2-02.

4 **SECTION 31. AMENDMENT.** Section 15-20.2-07 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **15-20.2-07. Powers and duties of center boards.** The powers and duties of a center
7 board are as follows:

- 8 1. To supervise, manage, and control an area ~~vocational~~ career and technology
9 center established by the cooperating school districts pursuant to this chapter.
- 10 2. To provide ~~vocational~~ career and technical education programs approved by the
11 state board.
- 12 3. To contract with, employ, and pay personnel to administer the affairs and to teach
13 in the area ~~vocational~~ career and technology center, and to remove for cause any
14 personnel when the interests of the area ~~vocational~~ career and technology center
15 may require it; provided, that personnel employed by a center board shall have the
16 same statutory rights as provided by law for personnel employed by public school
17 districts.
- 18 4. To lease, acquire, or purchase ~~vocational~~ career and technical education
19 equipment for an area ~~vocational~~ career and technology center.
- 20 5. To lease, acquire, purchase, or sell ~~vocational~~ career and technical education
21 facilities, including real property, for an area ~~vocational~~ career and technology
22 center; provided, that any purchase or sale of real property must first be approved
23 by two-thirds of the school boards of the participating school districts.
- 24 6. To receive and administer any private, local, state, or federal funds provided for the
25 operation and maintenance of an area ~~vocational~~ career and technology center.
- 26 7. To enter into contracts consistent with the other powers and duties provided for by
27 this chapter.
- 28 8. To accept real or personal property available for distribution by the United States or
29 any of its departments or agencies and also to accept federal grants that may be
30 made available in the field of career and technical education.

1 **SECTION 32. AMENDMENT.** Section 15-20.2-08 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **15-20.2-08. Assessment of participating districts for proportionate share of**
4 **center expenses - Allocation of students - Civil penalty for failure to remit payment.** A
5 center board shall, for the purpose of paying any administrative, planning, operating, or capital
6 expenses incurred or to be incurred, assess each participating school district its proportionate
7 share based upon its high school enrollment as compared to the total high school enrollment of
8 all participating school districts in the area ~~vocational~~ career and technology center and shall
9 assess each nonparticipating school district receiving services its proportionate share based
10 upon its utilization of programs. A center board shall, as nearly as possible, allocate the
11 number of students from each participating district to be served in an area ~~vocational~~ career
12 and technology center on the same proportionate basis as is used for the assessment of
13 expenses.

14 A center board utilizing mobile units solely shall, for the purpose of paying any
15 administrative, planning, operating, or capital expenses incurred or to be incurred, assess each
16 participating school district its proportionate share based upon its utilization of programs as
17 compared to total program utilization of all participating school districts in such center. A center
18 board utilizing mobile units solely shall, as nearly as possible, determine the program utilization
19 of each participating school district to be served based upon its high school enrollment as
20 compared to the total high school enrollment of all participating school districts in such center
21 and the school's accessibility to those programs.

22 Each participating school district shall remit payment of the assessment of its share of
23 expenses to the center board promptly after receipt of the assessment notice, or within a period
24 of time determined by the center board, but no later than sixty days after the official date of
25 receipt as noted on the assessment notice. A civil penalty of one percent per month must
26 accrue on all assessments not paid when due.

27 **SECTION 33. AMENDMENT.** Section 15-20.2-09 of the North Dakota Century Code is
28 amended and reenacted as follows:

29 **15-20.2-09. Distribution of state funds to area centers - Rules and regulations.**
30 Funds which may be made available to the state board for distribution to area ~~vocational~~ career
31 and technology centers must be apportioned and distributed by the state board to the area

1 ~~vocational~~ career and technology centers to assist such centers in defraying the cost involved
2 in maintaining and operating such centers. The use of such funds is subject to such rules and
3 regulations as may be prescribed by the state board, and must be in accordance with the
4 approved state plan for ~~vocational~~ career and technical education.

5 **SECTION 34. AMENDMENT.** Section 15-20.2-10 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **15-20.2-10. Appropriated and federal funds used for distribution.** The funds
8 distributed to the area ~~vocational~~ career and technology centers under the provisions of section
9 15-20.2-09 must be paid out of moneys appropriated to the state board for ~~vocational~~ career
10 and technical education, including federal funds allotted to the state to promote and attain the
11 purposes of state and federal legislation on ~~vocational~~ career and technical education.

12 **SECTION 35. AMENDMENT.** Section 15-20.2-11 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **15-20.2-11. District becoming participant in established center - Procedure.** After
15 an area ~~vocational~~ career and technology center has been established, any other school district
16 may become a participant in the center and may be governed by the provisions of this chapter
17 upon following a process similar to that pursued by the school districts originally forming the
18 center, including approval of the vote of the district board, the center board, and the state board
19 according to the procedure set forth in sections 15-20.2-12 and 15-20.2-13.

20 **SECTION 36. AMENDMENT.** Section 15-20.2-12 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **15-20.2-12. District board resolution to participate in established center -**
23 **Publication.** A school district board may request that the state board and the center board
24 approve such school district as a participating district in an established area ~~vocational~~ career
25 and technology center upon approval of a resolution by the school district board. When such
26 resolution has been adopted by the school district board, it must be published once in the
27 official newspaper of the county or counties in which the district is located.

28 **SECTION 37. AMENDMENT.** Section 15-20.2-13 of the North Dakota Century Code is
29 amended and reenacted as follows:

30 **15-20.2-13. Referendum on district participation in area center - Majority required**
31 **for approval.** A school district board may not proceed to obtain approval as a participating

1 district in an area ~~vocational~~ career and technology center if a petition for referendum of the
2 question of said school district participating in an area ~~vocational~~ career and technology center
3 signed by twenty percent of the qualified electors of said school district voting at the last annual
4 school election is filed with the school board within sixty days of the publication of the resolution
5 provided for in section 15-20.2-12. When such petition is filed, the school board may not obtain
6 approval as a participating district in an area ~~vocational~~ career and technology center until the
7 question of whether the district shall enter into an area ~~vocational~~ career and technology center
8 has been submitted to the qualified electors of the district. If a majority of the total number of
9 votes cast on the question within the school district is in favor of the question, the school board
10 may proceed to obtain approval as a participating district in an area ~~vocational~~ career and
11 technology center.

12 **SECTION 38. AMENDMENT.** Section 15-20.2-14 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **15-20.2-14. Withdrawal of district from participation in center - Submission to**
15 **voters - Effect of withdrawals.** The procedure for withdrawal is the same as for joining as
16 provided for in sections 15-20.2-11 through 15-20.2-13, except that when a participating district
17 is unable to obtain an approval of withdrawal from the center board, or the state board, or both,
18 the participating district may submit the question to withdraw from the area ~~vocational~~ career
19 and technology center to the voters of the school district. If a majority of the total number of
20 votes cast on the question is in favor of withdrawal, the participating school district must be
21 released from the area ~~vocational~~ career and technology center. Such withdrawal may become
22 effective at the end of the next school year or on such a date as determined by the state board,
23 but such withdrawal does not affect the liability of the withdrawing school district for obligations
24 incurred during its participation.

25 **SECTION 39. AMENDMENT.** Section 15-20.2-15 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **15-20.2-15. Dissolution of established center.** An established area ~~vocational~~ career
28 and technology center may be dissolved in accordance with rules and procedures adopted by
29 the state board.

30 **SECTION 40. AMENDMENT.** Section 15-20.2-16 of the North Dakota Century Code is
31 amended and reenacted as follows:

1 **15-20.2-16. Rules, regulations, and standards for area centers.** The state board is
2 hereby authorized and empowered to establish and adopt rules, regulations, standards, and
3 procedures set forth in the state plan pertaining to the creation, operation, control, supervision,
4 and approval of area ~~vocational~~ career and technology centers.

5 **SECTION 41. AMENDMENT.** Subsections 2 and 6 of section 15-20.4-01 of the North
6 Dakota Century Code are amended and reenacted as follows:

- 7 2. "Board" means the state board for ~~vocational~~ career and technical education.
8 6. "Executive officer" means the director of ~~vocational~~ career and technical education.

9 **SECTION 42. AMENDMENT.** Subsection 11 of section 15-39.1-04 of the North Dakota
10 Century Code is amended and reenacted as follows:

- 11 11. "Teacher" means:
- 12 a. All persons licensed by the education standards and practices board who are
13 contractually employed in teaching, supervisory, administrative, or
14 extracurricular services by a state institution, special education unit, school
15 board, or other governing body of a school district of this state, including
16 superintendents, assistant superintendents, business managers, principals,
17 assistant principals, and special teachers. For purposes of this subdivision,
18 "teacher" includes persons contractually employed by one of the above
19 employers to provide teaching, supervisory, administrative, or extracurricular
20 services to a separate state institution, state agency, special education unit,
21 school board, or other governing body of a school district of this state under a
22 third-party contract.
- 23 b. The superintendent of public instruction, assistant superintendents of public
24 instruction, county superintendents, assistant superintendents, supervisors of
25 instruction, the professional staff of the ~~state board for vocational~~ department
26 of career and technical education, the professional staff of the division of
27 independent study, the executive director and professional staff of the North
28 Dakota education association who are members of the fund on July 1, 1995,
29 the professional staff of an interim school district, and the professional staff of
30 the North Dakota high school activities association who are members of the
31 fund on July 1, 1995.

1 c. The executive director and professional staff of the North Dakota council of
2 school administrators who are members of the fund on July 1, 1995, and
3 licensed staff of teachers centers, but only if the person was previously a
4 member of and has credits in the fund.

5 d. Employees of institutions under the control and administration of the state
6 board of higher education who are members of the fund on July 16, 1989.

7 **SECTION 43. AMENDMENT.** Section 15-63-02 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **15-63-02. Duties of board.** The state board for Indian scholarships shall:

- 10 1. Award scholarship grants as provided in this chapter.
- 11 2. Make necessary rules and establish standards, requirements, and procedures for
12 the administration of this chapter.
- 13 3. Encourage members of Indian tribes to attend and be graduated from any
14 institution of higher learning or state ~~vocational~~ career and technical education
15 program within this state, and to make application for scholarships.

16 **SECTION 44. AMENDMENT.** Section 15-63-03 of the North Dakota Century Code is
17 amended and reenacted as follows:

18 **15-63-03. Number and nature of scholarships.** The state board for Indian
19 scholarships shall provide scholarships each year for resident members of federally recognized
20 Indian tribes to entitle persons so selected to enter and attend any institution of higher learning
21 or state ~~vocational~~ career and technical education program within this state upon compliance
22 with all requirements for admission and to pursue any course or courses offered in such
23 institutions or programs.

24 **SECTION 45. AMENDMENT.** Section 15-63-04 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **15-63-04. Eligibility of candidates - Determination.** The initial and continuing
27 scholarship eligibility of state residents who are enrolled members of federally recognized
28 Indian tribes must be determined by the state board for Indian scholarships after the candidate
29 has gained admission to any institution of higher learning or state ~~vocational~~ career and
30 technical education program within this state and has had this fact certified to the board.

1 Factors to be considered in the award of these scholarships are the candidate's financial need
2 and probable and continuing success as a student.

3 **SECTION 46. AMENDMENT.** Section 15-63-05 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **15-63-05. Scholarship payments - Conditions.** Upon the granting of a scholarship
6 and acceptance thereof, the recipient is eligible for a credit in fees in the enrolling institution of
7 higher learning or state ~~vocational~~ career and technical education program to apply toward the
8 cost of registration, health, activities, board, books, and other necessary items of not to exceed
9 six hundred sixty-seven dollars per quarter for three quarters, or one thousand dollars per
10 semester for two semesters, in any academic year. The board for Indian scholarships may
11 reduce the amount of any scholarship to accord with individual financial need or funds
12 available. After the enrolling institution or program has deducted the amount due such
13 institution, the remaining balance must be given to the recipient for necessary expenses during
14 the quarter or semester. At the beginning of each quarter or semester of a regular academic
15 year, the board for Indian scholarships shall certify to the director of the office of management
16 and budget the name of each recipient and the amount payable, and the director of the office of
17 management and budget shall issue ~~his~~ a warrant to the state treasurer who shall pay the
18 amount of the scholarship to the institution of higher learning or state ~~vocational~~ career and
19 technical education program in which the recipient is enrolled. Renewal of the scholarship
20 award is subject to the maintenance of a minimum grade average of "C" in the courses taken.

21 **SECTION 47. AMENDMENT.** Section 15.1-01-02 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **15.1-01-02. Joint meetings - State board of public school education - State board**
24 **of higher education - Education standards and practices board - State board for**
25 **~~vocational~~ career and technical education.** The state board of public school education, the
26 state board of higher education, the education standards and practices board, and the state
27 board for ~~vocational~~ career and technical education shall meet together at least once each year
28 at the call of the superintendent of public instruction, the commissioner of higher education, the
29 executive director of the education standards and practices board, and the director of
30 ~~vocational~~ career and technical education for the purposes of:

- 1 1. Coordinating elementary and secondary education programs, ~~vocational career~~
2 and technical education programs, and higher education programs.
- 3 2. Cooperating in the provision of professional growth and development opportunities
4 for elementary and secondary teachers and administrators.
- 5 3. Ensuring cooperation in any other jointly beneficial project or program.

6 **SECTION 48. AMENDMENT.** Subsection 4 of section 15.1-02-13 of the North Dakota
7 Century Code is amended and reenacted as follows:

- 8 4. For purposes of this section:
 - 9 a. "Administrator" means an individual employed by a school district in an
10 administrative position and includes a school district superintendent, an
11 assistant or associate superintendent, a principal, an assistant principal, a
12 special education director, a ~~vocational career and technical~~ education
13 director, and any other individual whose position requires an administrator's
14 credential.
 - 15 b. "Teacher" means an individual, other than an administrator, who is licensed to
16 teach by the education standards and practices board or approved to teach by
17 the education standards and practices board and who is employed by the
18 board of a school district in a position classified by the superintendent of
19 public instruction as of July 1, 2001, as:
 - 20 (1) A class 22 coordinator;
 - 21 (2) A class 37 guidance counselor or school counselor;
 - 22 (3) A class 38 guidance counselor designate;
 - 23 (4) A class 40 instructional programmer;
 - 24 (5) A class 41 library media specialist;
 - 25 (6) A class 56 pupil personnel service provider;
 - 26 (7) A class 59 school psychologist;
 - 27 (8) A class 62 speech-language pathologist;
 - 28 (9) A class 68 supervisor;
 - 29 (10) A class 70 teacher or special education teacher; or
 - 30 (11) A class 72 tutor in training.

1 **SECTION 49. AMENDMENT.** Subsection 7 of section 15.1-09-33 of the North Dakota
2 Century Code is amended and reenacted as follows:

3 7. Lease real property for a maximum of one year except in the case of a ~~vocational~~
4 career and technical education facility constructed in whole or in part with financing
5 acquired under chapter 40-57, which may be leased for up to twenty years.

6 **SECTION 50. AMENDMENT.** Subsection 1 of section 15.1-09-36 of the North Dakota
7 Century Code is amended and reenacted as follows:

- 8 1. A school board may:
- 9 a. Require that a student pay a security deposit for the return of textbooks,
10 materials, supplies, or equipment.
 - 11 b. Assess a student a use charge if a textbook or other item covered under
12 subsection 1 has received undue wear.
 - 13 c. Require that a student furnish personal or consumable items.
 - 14 d. Require that a student pay an admission fee or other charges for
15 extracurricular or noncurricular activities if the student's attendance is
16 optional.
 - 17 e. Require that a student pay a fee or a premium for any authorized student
18 health and accident benefit plan.
 - 19 f. Require that a student pay a fee for personal athletic equipment and apparel;
20 provided the board shall allow a student to use the student's own equipment
21 and apparel if it meets reasonable health and safety standards established by
22 the board.
 - 23 g. Require that a student pay a fee in any program which generates a product
24 that becomes the personal property of the student.
 - 25 h. Require that a student pay a fee for behind-the-wheel driver's education
26 instruction.
 - 27 i. Require that a student pay a fee for goods, including textbooks, and services
28 provided in connection with any postsecondary level program or any program
29 established outside regular elementary, middle school, or secondary school
30 programs, including ~~vocational~~ career and technical programs, and adult or
31 continuing education programs.

1 j. Require that a student pay any other fees and charges permitted by statute.

2 **SECTION 51. AMENDMENT.** Subsection 1 of section 15.1-12-10 of the North Dakota
3 Century Code is amended and reenacted as follows:

4 1. The reorganization plan required by section 15.1-12-09 must:

5 a. Include a map showing the boundaries of each participating district and of the
6 proposed new district;

7 b. Include the demographic characteristics of each participating district, including
8 the population per age group;

9 c. Include the number of students enrolled in each participating district during
10 the current school year and during the ten preceding school years;

11 d. Include projected student enrollments for the ensuing ten years;

12 e. Include the location and condition of all school buildings and facilities in each
13 participating district and intended uses for the buildings and facilities;

14 f. Address planned construction, modification, or improvement of school
15 buildings and facilities located within the boundaries of the new district;

16 g. Address planned course offerings by the new district;

17 h. Include the planned administrative structure of the new district and the
18 number of full-time equivalent personnel to be employed by the new district;

19 i. Include the planned number of members who will constitute the board of the
20 new district and the manner in which the members are to be elected;

21 j. Address plans regarding student transportation;

22 k. Identify other governmental entities, including multidistrict special education
23 units and area ~~vocational~~ career and technology centers, which may provide
24 services to the new district;

25 l. Include the taxable valuation and per student valuation of each participating
26 district and the taxable valuation and per student valuation of the new district;

27 m. Include the amount of all bonded and other indebtedness incurred by each
28 participating district;

29 n. Address the planned disposition of all property, assets, debts, and liabilities of
30 each participating district, taking into consideration section 15.1-12-18;

- 1 o. Include a proposed budget for the new district and a proposed general fund
2 levy and any other levies, provided that tax levies submitted to and approved
3 by the state board as part of a reorganization plan are not subject to mill levy
4 limitations otherwise provided by law; and
- 5 p. Include any other information that the participating school districts wish to
6 have considered by the county committee or the state board.

7 **SECTION 52. AMENDMENT.** Subsection 1 of section 15.1-13-01 of the North Dakota
8 Century Code is amended and reenacted as follows:

- 9 1. "Administrator" means an individual who holds an administrator's credential and
10 who is employed by the board of a school district for the primary purpose of
11 providing administrative services to the schools of the district. The term includes a
12 school district superintendent, an assistant or associate school district
13 superintendent, a school principal, an assistant or associate school principal, a
14 special education director, a director of a multidistrict special education unit, a

5 eighteen, the defendant must be sentenced to imprisonment for at least eight
6 years. It is not a defense that the defendant did not know the age of a person
7 protected under this subdivision.
- 8 6. It is unlawful for any person to willfully, as defined in section 12.1-02-02, possess a
9 controlled substance unless the substance was obtained directly from, or pursuant
10 to, a valid prescription or order of a practitioner while acting in the course of the
11 practitioner's professional practice, or except as otherwise authorized by this
12 chapter, but any person who violates section 12-46-24 or 12-47-21 may not be
13 prosecuted under this subsection. Except as provided in this subsection, any
14 person who violates this subsection is guilty of a class C felony. If the person is in
15 or on, or within one thousand feet [300.48 meters] of the real property comprising a
16 public or private elementary or secondary school or a public ~~vocational~~ career and
17 technical education school, the person is guilty of a class B felony. Any person
18 who violates this subsection regarding possession of one-half ounce
19 [14.175 grams] to one ounce [28.35 grams] of marijuana is guilty of a class A
20 misdemeanor. Any person, except a person operating a motor vehicle, who
21 violates this subsection regarding possession of less than one-half ounce
22 [14.175 grams] of marijuana is guilty of a class B misdemeanor. Any person who

15 isomers;
- 16 (c) Ecgonine, its derivatives, their salts, isomers, and salts of
17 isomers; or
- 18 (d) Any compound, mixture, or preparation that contains any quantity

- 20 (3) Five grams or more of a mixture or substance described in paragraph 2
21 which contains cocaine base;
- 22 (4) Ten grams or more of phencyclidine or one hundred grams or more of a
23 mixture or substance containing a detectable amount of phencyclidine;
- 24 (5) One gram, one hundred dosage units, or one-half liquid ounce or more
25 of a mixture or substance containing a detectable amount of lysergic
26 acid diethylamide;
- 27 (6) Forty grams or more of a mixture or substance containing a detectable
28 amount of N-phenyl-N-[1-(2-phenylethyl)-4-piperidinyl] propanamide or
29 ten grams or more of a mixture or substance containing a detectable
30 amount of any analog of N-phenyl-N-[1-(2-phenylethyl)-4-piperidinyl]
31 propanamide;

- 1 (7) Fifty grams or more of a mixture or substance containing a detectable
2 amount of methamphetamine;
- 3 (8) Ten grams, one hundred dosage units, or one-half liquid ounce or more
4 of a mixture of substance containing a detectable amount of
5 3,4-methylenedioxy-N-methylamphetamine, $C_{11}H_{15}NO_2$;
- 6 (9) One hundred dosage units or one-half liquid ounce of a mixture or
7 substance containing a detectable amount of gamma-hydroxybutyrate
8 or gamma-butyrolactone or 1,4 butanediol or any substance that is an
9 analog of gamma-hydroxybutyrate;
- 10 (10) One hundred dosage units or one-half liquid ounce of a mixture or
11 substance containing a detectable amount of flunitrazepam; or
- 12 (11) Five hundred grams or more of marijuana.

13 **SECTION 72. AMENDMENT.** Section 25-06-02 of the North Dakota Century Code is

15 **25-06-02. Duties and responsibilities of North Dakota vision services - school for**
16 **the blind.** Within the limits of legislative appropriation, North Dakota vision services - school for
17 the blind shall:

- 18 1. Provide vision-specific services that include consultations, evaluations, information,
19 training, and educational services, including instruction in orientation, mobility,
20 braille, braille music, daily living skills, technology, ~~vocational~~ career and technical
21 education training, and recreation.
- 22 2. Collect and distribute information on vision services and resources available in the
23 state.
- 24 3. Coordinate loans of adaptive devices, equipment, and materials.
- 25 4. Maintain a data base of residents who are blind or have a visual impairment.
- 26 5. Facilitate collaboration with agencies and programs providing services to
27 individuals who are blind or have a visual impairment.
- 28 6. Assist residents to access appropriate services, including services available from
29 the vocational rehabilitation division, independent living centers, infant
30 development programs, developmental disabilities programs, the state library, local
31 education programs, and advocacy programs.

1 **SECTION 73. AMENDMENT.** Section 25-07-04 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **25-07-04. Qualifications for admission to school for deaf - Residents of state**
4 **entitled to free education.** Each applicant who is a resident of this state and who, because of
5 hearing impairment, is unable to receive an education in the public schools, is entitled to
6 receive an education in the school for the deaf at the expense of the state. The North Dakota
7 school for the deaf serves deaf or hearing-impaired children from birth through age twenty-one.
8 The North Dakota school for the deaf shall furnish application blanks upon request and no child
9 will be admitted until application is completed and approved. Students enrolled must be
10 furnished transportation by the school for the deaf as indicated in the student's individual
11 education plan. All deaf or hearing-impaired children who are residents of the state are entitled
12 to receive special education and related services based on a completed individual education
13 program, which considers the academic, independent living skills, ~~vocational~~ career and
14 technical education, recreational, and leisure needs of each child.

15 **SECTION 74. AMENDMENT.** Section 27-21-02 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **27-21-02. Division of juvenile services - Powers and duties.** The division of juvenile
18 services is the administrative agency which shall take custody of delinquent and unruly children
19 committed to its care by the juvenile courts. Upon committing a child to the custody of the
20 division of juvenile services, the juvenile court, law enforcement officers, and other public
21 officials shall make available to the division of juvenile services all pertinent data in their
22 possession with respect to the child. Upon taking custody or if authorized by the court prior to
23 receiving custody of a child, the division of juvenile services shall process the child through
24 such diagnostic testing and evaluation programs as may be necessary to determine the
25 treatment and rehabilitation which is in the best interest of the child and in the best interest of
26 the state. In doing so, the division of juvenile services may utilize the psychological, addiction,
27 psychiatric, ~~vocational~~ career and technical education, medical, and other diagnostic and
28 testing services that are available, examine all the pertinent circumstances, and review the
29 reasons for the child's commitment. Upon completion of the diagnostic testing and evaluation
30 of a child committed to its custody, the division shall make disposition under subsection 1, 2,
31 or 3 and inform the court of its disposition. Upon completion of the diagnostic testing and

1 evaluation of a child not in its custody, the division shall develop and recommend to the juvenile
2 court an individualized treatment and rehabilitation plan for the child. This plan must include
3 recommendations for the disposition of the child as follows:

- 4 1. Placement in the care of the child's parent, relative, guardian, or in a foster home
5 or suitable private institution licensed by the state for the care or treatment and
6 rehabilitation of children;
- 7 2. Placement in the care of the North Dakota youth correctional center or in a
8 ~~vocational~~ career and technical education, training, or other treatment and
9 rehabilitation institution for children or young adults within this state; or
- 10 3. Placement in the care of a ~~vocational~~ career and technical education, training, or
11 other treatment and rehabilitation institution for children or young adults in another
12 state in the event that adequate facilities for the child's treatment and rehabilitation
13 are not available within this state and the committing juvenile court concurs in the
14 placement.

18 unavailable, place a child committed to its custody in the temporary care of the North Dakota

21 than sixty days, in order to provide for diagnostic testing and evaluation and other assessments
22 pending disposition under section 27-21-02.

24 Century Code is amended and reenacted as follows:

- 25 1. The division of juvenile services ~~is hereby empowered to~~ may contract and make
26 placements with the appropriate agencies or departments of other states in order

28 technical education, training, or other treatment and rehabilitation purposes
29 contemplated by this chapter. Before contracting with any agency or department of
30 another state, the director of the division, or the director's designee, shall assess
31 the facilities that are offered by such department or agency, and, after contracting,

1 forward to the committing juvenile court a summary on the facilities that are
2 furnished by such agency or department and such other information pertaining
3 thereto as may reasonably be requested.

13 prescribe, any interim report of the progress of the child that the director deems
14 necessary in the interest of the child.

15 Quarterly and interim reports must be made available to the committing juvenile court.

21 the department of public instruction, the ~~board for vocational~~ department of career and
22 technical education, the juvenile courts, the state department of health, and such other
23 agencies and departments of the state as may be necessary to carry out the objectives of this
24 chapter. The division of juvenile services may inspect at all reasonable times the facilities of
25 those institutions within the state it is authorized to utilize under this chapter, and may examine
26 any child it has placed in the care of such institution, and may contract with public and private
27 agencies to provide services for them or to retain from them required services to meet the
28 purpose and objective of this chapter.

29 **SECTION 79. AMENDMENT.** Section 34-05-01.3 of the North Dakota Century Code is
30 amended and reenacted as follows:

31 **34-05-01.3. Duties of commissioner of labor.** The commissioner of labor shall:

- 1 1. Improve working conditions and living conditions of employees and advance their
2 opportunities for profitable employment.
- 3 2. Foster, promote, and develop the welfare of both wage earners and industries in
4 North Dakota.
- 5 3. Promote friendly and cooperative relations between employers and employees.
- 6 4. Cooperate with other state agencies to encourage the development of new
7 industries and the expansion of existing industries.
- 8 5. Represent the state of North Dakota in dealings with the United States department
9 of labor, with the federal mediation and conciliation service, and with the United
10 States veterans' administration with respect to job training programs.
- 11 6. Acquire and disseminate information on the subjects connected with labor,
12 relations between employers and employees, hours of labor, and working
13 conditions.
- 14 7. Encourage and assist in the adoption of practical methods of ~~vocational~~ career and
15 technical education training, retraining, and ~~vocational-guidance~~ career
16 development counseling.
- 17 8. Report biennially to the governor and to the legislative assembly concerning
18 activities of the department of labor, including in such report recommendations for
19 legislation deemed necessary or desirable to effectuate the purposes of this
20 chapter.
- 21 9. Administer the provisions of chapter 34-06 relating to wages and hours, chapter
22 34-07 relating to child labor, and the provisions of chapter 34-12 relating to
23 labor-management relations.
- 24 10. Perform such other duties as may be required by law.

25 **SECTION 80. AMENDMENT.** Section 34-06-15 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **34-06-15. Special license to employ at less than minimum wage.** The
28 commissioner may issue to an employee whose productive capacity for the work to be
29 performed is impaired by physical or mental disability, or to any student or learner enrolled in a
30 ~~vocational~~ career and technical education or related program, a special license authorizing the
31 employment of that licensee at less than the minimum wage. The commissioner may also

1 issue special licenses to community rehabilitation programs for the handicapped which engage
2 in the occupation and responsibility of representing and placing for the purpose of training,
3 learning, or employment of those employees whose productive capacity for the work to be
4 performed is impaired by physical or mental disability. The commissioner shall issue such
5 licenses under rules adopted by the commissioner.

6 **SECTION 81. AMENDMENT.** Subsection 1 of section 37-07.1-02 of the North Dakota
7 Century Code is amended and reenacted as follows:

8 1. "School" means any university, college, ~~vocational~~ career and technical education
9 school, technical school, or postsecondary educational institution.

10 **SECTION 82. AMENDMENT.** Section 40-57-02 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **40-57-02. "Project" and "municipality" defined.** As used in this chapter, unless a
13 different meaning clearly appears from the context, the term "municipality" includes counties as
14 well as municipalities of the types listed in subsection 4 of section 40-01-01 and, in the case of
15 parking projects, municipal parking authorities created pursuant to section 40-61-02; and the
16 term "project" means any real property, buildings, and improvements on real property or the
17 buildings thereon, and any equipment located on such real property or in such buildings, or
18 elsewhere, or personal property which is used or useful in connection with a revenue-producing
19 enterprise, or any combination of two or more such enterprises, engaged or to be engaged in:

- 20 1. Assembling, fabricating, manufacturing, mixing, or processing of any agricultural,
21 mineral, or manufactured products, or any combination thereof.
- 22 2. Storing, warehousing, distributing, or selling any products of agriculture, mining, or
23 manufacture.
- 24 3. Providing hospital, nursing home, or other health care facilities and service.
- 25 4. Improvements or equipment used or to be used for the abatement or control of
26 environmental pollution in connection with any new or existing revenue-producing
27 enterprise.
- 28 5. Public ~~vocational~~ career and technical education.
- 29 6. Any other industry or business not prohibited by the constitution or laws of the state
30 of North Dakota.

1 In no event, however, does the term "project" include those undertakings defined in chapter
2 40-35, with the exception of projects referred to in subsections 3, 4, and 5.

3 **SECTION 83. AMENDMENT.** Subsection 3 of section 40-57-03 of the North Dakota
4 Century Code is amended and reenacted as follows:

5 3. Lease projects to any industrial or commercial enterprise or nonprofit corporation
6 or to any school district for ~~vocational~~ career and technical education purposes, in
7 such manner that rents to be charged for the use of such projects shall be fixed,
8 and revised from time to time as necessary, so as to produce income and revenue
9 sufficient to provide for the prompt payment of interest upon all bonds issued
10 hereunder, to create a sinking fund to pay the principal of such bonds when due,
11 and to provide for the operation, maintenance, insurance on, and depreciation of
12 such projects, and any taxes thereon.

13 **SECTION 84. AMENDMENT.** Section 40-57.2-01 of the North Dakota Century Code is
14 amended and reenacted as follows:

15 **40-57.2-01. Cities and counties may enter into agreements for surveys for**
16 **industrial development and ~~vocational~~ career and technical education and on-the-job**
17 **training.** The governing body of any city or county of this state is authorized in accordance
18 with the provisions of this chapter to enter into contracts with any person, firm, association,
19 corporation, or limited liability company for the purpose of obtaining site surveys and site
20 development plans, structural and mechanical plans and surveys, market surveys, and similar
21 plans and surveys relating to industrial development and plant location, design, construction,
22 equipment, and operation. Similar contracts may be entered into by such political subdivisions
23 in accordance with the provisions of this chapter for the providing of ~~vocational~~ career and
24 technical education and on-the-job training for residents of this state in industries located within
25 this state. Such agreements shall be entered into only with a financially and educationally
26 reliable person, firm, association, corporation, or limited liability company that has been
27 approved for such agreement by a local development organization located in such city or
28 county and organized to encourage industrial and commercial development and growth.

29 **SECTION 85. AMENDMENT.** Section 40-57.2-04 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **40-57.2-04. City or county may make tax levy.** Any city or county, after resolution by
2 its governing body that the question be submitted to its electors shall upon approval of the
3 question at a regular or special election by sixty percent of the qualified electors of the city or
4 county voting in the election may levy a tax not exceeding the limitations in subsection 16 of
5 section 57-15-06.7 and subsection 15 of section 57-15-10 for the purpose of providing funds for
6 ~~vocational~~ career and technical education and on-the-job training services and surveys and
7 otherwise implementing this chapter. No levy for a specific year shall be made if the balance in
8 the fund remaining from levies in prior years is in excess of ten thousand dollars.

9 **SECTION 86. AMENDMENT.** Section 43-35-13 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **43-35-13. Certificate - How obtained - Fee - Bond.** Any person desiring to take the
12 examination to become a certified water well contractor shall first have completed a minimum of
13 one-year apprenticeship or experience in water well drilling and construction under the direct
14 supervision of a certified water well contractor or have completed a ~~vocational school~~ career
15 and technical education program of at least one year in water well construction and shall make
16 application to the board. Any person desiring to take the examination to become a certified
17 water well pump and pitless unit installer shall first have completed a minimum of one-year
18 apprenticeship or experience in water well pump and pitless unit installation under the direct
19 supervision of a certified water well pump and pitless unit installer or have completed a
20 ~~vocational school~~ career and technical education program of at least one year in water well
21 pump and pitless unit installation. Any person desiring to take the examination to become a
22 certified monitoring well contractor shall first have completed a minimum of one-year
23 apprenticeship or experience in monitoring well construction under the direct supervision of a
24 certified water well contractor or a certified monitoring well contractor or have completed a
25 ~~vocational school~~ career and technical education program of at least one year in water well
26 construction or hold a bachelor's degree in engineering or geology from an approved school
27 and shall make application to the board. A person applying to take a certification examination
28 shall pay to the board treasurer a nonrefundable examination fee in the amount of ten dollars.
29 If upon examination the applicant is found to be qualified as a water well contractor or a water
30 well pump and pitless unit installer, the board shall issue to that person an appropriate
31 certificate upon the applicant's executing and filing with the board a bond as required in this

1 chapter. The board may offer a combined examination for certification of a person as a water
2 well contractor and a water well pump and pitless unit installer and may issue a single
3 certificate for successful completion of the combined examination. Certificates issued under
4 this chapter are not transferable.

5 **SECTION 87. AMENDMENT.** Section 50-09-02.2 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **50-09-02.2. Assistance for adopted children with special needs.** Assistance
8 provided under this chapter or chapter 50-24.1 after adoption to a child with special needs must
9 be provided without regard to the income or resources of the adopting parents. Except as
10 provided in this section, such assistance continues until the adopted child becomes eighteen
11 years of age, is emancipated, or dies; the adoption is terminated; or a determination of
12 ineligibility is made by the county agency, whichever occurs earlier. If sufficient funds are
13 available, the county agency may continue assistance for an adopted child until the child
14 reaches twenty-one years of age if the agency determines that the adopted child is a student
15 regularly attending a secondary, postsecondary, or ~~vocational~~ career and technical education
16 school in pursuance of a course of study leading to a diploma, degree, or gainful employment.
17 Assistance provided to an adopted child must continue regardless of the residence of the
18 adopting parents. A state or county agency may require, as a condition of receiving assistance
19 under this chapter or chapter 50-24.1, that the adopting parents enter into a contract or
20 agreement regarding the type of assistance to be received; the amount of assistance; the
21 identity of the physical, mental, or emotional condition for which medical assistance is received;
22 or any conditions for continued receipt of assistance. A child with special needs is a child
23 legally available for adoptive placement whose custody has been awarded to the department or
24 a county social service board and who is five years of age or older; under eighteen years of age
25 with a physical, emotional, or mental handicap; a member of a minority; or a member of a
26 sibling group.

27 **SECTION 88. AMENDMENT.** Section 50-11-01 of the North Dakota Century Code is
28 amended and reenacted as follows:

29 **50-11-01. Foster care for children - License required.** No person may furnish foster
30 care for children for more than thirty days during a calendar year without first procuring a

1 license to do so from the department. The mandatory provisions of this section requiring
2 licensure do not apply when the care is provided in:

- 3 1. The home of a person related to the child by blood or marriage.
- 4 2. A home or institution under the management and control of the state or a political
5 subdivision.
- 6 3. A home or facility furnishing room and board primarily to accommodate the child's
7 educational or ~~vocational~~ career and technical education needs.

8 **SECTION 89. AMENDMENT.** Section 52-02-02.1 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **52-02-02.1. Adult education and training - Grants to students.** Job service North
11 Dakota may make grants of up to five hundred dollars per person to Job Training Partnership
12 Act eligible students enrolled in adult basic and secondary education programs and training
13 programs for adults approved by job service North Dakota. No grants may be made unless
14 federal funds received by the state for job training services as defined in the Job Training
15 Partnership Act [Pub. L. 97-300; 96 Stat. 1361; 29 U.S.C. 1604] have been obligated. Job
16 service may collect an administrative fee not to exceed ten percent of the amount of grants
17 made under this section. Job service North Dakota shall, in cooperation with the
18 superintendent of public instruction, the ~~board for vocational~~ department of career and technical
19 education, and any other state agency providing or administering adult education services,
20 coordinate the grant program established under this section. Job service North Dakota shall
21 adopt rules to implement the grant program established under this section including rules
22 regarding eligibility requirements and use of grant proceeds.

23 **SECTION 90. AMENDMENT.** Section 52-02-08 of the North Dakota Century Code is
24 amended and reenacted as follows:

25 **52-02-08. Bureau and advisory councils to take steps to stabilize employment.**

26 The bureau, with the advice and aid of its advisory councils, and through its appropriate
27 divisions, shall take appropriate steps to:

- 28 1. Reduce and prevent unemployment.
- 29 2. Encourage and assist in the adoption of practical methods of ~~vocational~~ career and
30 technical education training, retraining, and ~~vocational guidance~~ career
31 development counseling.

- 1 3. Investigate, recommend, advise, and assist in the establishment and operation, by
- 2 municipalities, counties, school districts, and the state, of reserves for public works
- 3 to be used in times of business depression and unemployment.
- 4 4. Promote the reemployment of unemployed workers throughout the state in every
- 5 other way that may be feasible.
- 6 5. Carry on and publish the results of investigations and research studies.

7 **SECTION 91. AMENDMENT.** Section 52-08-12 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **52-08-12. (Effective July 1, 2003) Workforce training funds - Distribution.** Within
10 the limits of legislative appropriations, workforce training funds must be distributed by the state
11 board for ~~vocational~~ career and technical education as follows:

- 12 1. During the first fiscal year of each biennium, the state board for ~~vocational~~ career
13 and technical education shall distribute up to one-half of the total amount
14 appropriated for the biennium. The funds must be divided among the institutions of
15 higher education assigned primary responsibility for workforce training pursuant to
16 business plans approved by the state board of higher education and filed annually
17 with the state board for ~~vocational~~ career and technical education and the division
18 of workforce development of the department of commerce.
- 19 2. To be eligible to receive state funding for the second fiscal year of each biennium,
20 each institution of higher education assigned primary responsibility for workforce
21 training must provide certification to the workforce development division of the
22 department of commerce that at least fifty percent of the regional funds included in
23 the approved business plan for the biennium have been received, or are pledged to
24 be received, prior to the end of the biennium. These funds may not be distributed
25 to an institution of higher education assigned primary responsibility for workforce
26 training until the workforce development division notifies the state board for
27 ~~vocational~~ career and technical education that the institution has met the
28 requirements of this subsection.

29 **SECTION 92. AMENDMENT.** Subsection 2 of section 52-08.1-04 of the North Dakota
30 Century Code is amended and reenacted as follows:

1 2. Programs must be conducted in cooperation with appropriate state board for
2 ~~vocational~~ career and technical education approved training providers and
3 institutions.

4 **SECTION 93. AMENDMENT.** Section 52-09-08 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **52-09-08. Default in taxes - Interest - Action to collect - Levy of tax by political**
7 **subdivisions.** Taxes unpaid on the date on which they are due and payable, as prescribed by
8 the bureau, must bear interest at the rate of one-half of one per centum per month from and
9 after that date until payment plus accrued interest is received by the bureau; provided, that the
10 bureau may prescribe fair and reasonable regulations pursuant to which interest does not
11 accrue with respect to taxes required. The amount of interest imposed may not be less than
12 five dollars. Interest collected pursuant to this section must be paid into the old-age and
13 survivors' fund. A political subdivision, except a school district, a multidistrict special education
14 board, or a center board of an area ~~vocational~~ career and technology center, shall levy a tax
15 sufficient to meet its obligations under this chapter, up to a maximum levy not exceeding the
16 limitation in section 57-15-28.1 or, for counties, the limitation in subsection 36 of section
17 57-15-06.7. Within the levy limitations set out in subsection 6 of section 57-15-28.1 and
18 subsection 36 of section 57-15-06.7, the governing body of a county may levy a tax for
19 comprehensive health care insurance employee benefit programs duly established by the
20 governing body. Any obligations under this chapter over and above the amount raised by the
21 maximum levy permitted in this section must be paid out of the general fund of the political
22 subdivision. All payments by a school district for obligations incurred under this chapter must
23 be made out of the school district's general fund established pursuant to section 57-15-14.2.

24 **SECTION 94. AMENDMENT.** Subsection 12 of section 54-10-14 of the North Dakota
25 Century Code is amended and reenacted as follows:

26 12. Area ~~vocational~~ career and technology centers.

27 **SECTION 95. AMENDMENT.** Section 54-56-01 of the North Dakota Century Code is
28 amended and reenacted as follows:

29 **54-56-01. Children's services coordinating committee - Membership.** The
30 children's services coordinating committee consists of the governor or a designee of the
31 governor, the superintendent of public instruction, a representative of juvenile courts appointed

1 by the chief justice of the supreme court, the executive director of the department of human
2 services, the state health officer, the director of the department of corrections and rehabilitation,
3 or a designee of the director of the department of corrections and rehabilitation, the director of
4 ~~vocational~~ career and technical education, and a representative of the Indian affairs
5 commission. The governor or the governor's designee shall act as chairperson.

6 **SECTION 96. AMENDMENT.** Subsection 2 of section 54-59-17 of the North Dakota
7 Century Code is amended and reenacted as follows:

- 8 2. The educational technology council consists of:
- 9 a. The chief information officer.
 - 10 b. The superintendent of public instruction or the superintendent's designee.
 - 11 c. The commissioner of higher education or the commissioner's designee.
 - 12 d. A representative appointed by the state board for ~~vocational~~ career and
13 technical education.
 - 14 e. A representative appointed by the governor from a list of three nominees
15 submitted by the North Dakota association of technology leaders.
 - 16 f. A representative appointed by the governor from a list of three nominees
17 submitted by the North Dakota council of educational leaders.
 - 18 g. A representative appointed by the governor from a list of three nominees
19 submitted by the North Dakota school boards association.
 - 20 h. A representative appointed by the governor from a list of three nominees
21 submitted by the North Dakota association of special education directors.
 - 22 i. Two representatives of school districts, one of which has an enrollment in
23 kindergarten through grade twelve of fewer than four hundred, appointed by
24 the governor.
 - 25 j. The director of technology for the department of public instruction.
 - 26 k. A representative appointed by the governor from a list of three nominees
27 submitted by the state association of non public schools.

28 **SECTION 97. AMENDMENT.** Section 54-60-06 of the North Dakota Century Code is
29 amended and reenacted as follows:

30 **54-60-06. Commerce cabinet.** The North Dakota commerce cabinet is created. The
31 cabinet is composed of the directors of each of the department divisions and of the executive

1 heads, or other authorized representatives, of the state board for ~~vocational~~ career and
2 technical education, the state board of higher education, the Bank of North Dakota, the
3 department of agriculture, the workers compensation bureau, the department of transportation,
4 job service North Dakota, the game and fish department, and of any other state agency
5 appointed by the commissioner. The commissioner is the chairman of the cabinet and shall
6 determine which agencies are members of the cabinet. The cabinet shall:

- 7 1. Coordinate and communicate economic development and tourism efforts of the
8 agencies represented.
- 9 2. Meet at times determined by the commissioner.
- 10 3. Develop and make available before each regular session of the legislative
11 assembly a list that identifies economic development moneys included in budget
12 requests of cabinet agencies.

13 **SECTION 98. AMENDMENT.** Subsection 16 of section 57-15-06.7 of the North Dakota
14 Century Code is amended and reenacted as follows:

- 15 16. A county levying a tax to provide for ~~vocational~~ career and technical education and
16 on-the-job training services as provided in section 40-57.2-04 may levy a tax not
17 exceeding one mill.

18 **SECTION 99. AMENDMENT.** Subsection 15 of section 57-15-10 of the North Dakota
19 Century Code is amended and reenacted as follows:

- 20 15. Taxes levied for the purpose of ~~vocational~~ career and technical education and
21 on-the-job training services in accordance with section 40-57.2-04 may be levied in
22 an amount not exceeding one mill.

23 **SECTION 100. AMENDMENT.** Subsections 1 and 2 of section 57-15-14.2 of the North
24 Dakota Century Code are amended and reenacted as follows:

- 25 1. A school board of any school district may levy an amount sufficient to cover
26 general expenses including the costs of the following:
 - 27 a. Board and lodging for high school students as provided in section 15.1-30-04.
 - 28 b. The teachers' retirement fund as provided in section 15-39.1-28.
 - 29 c. Tuition for students in grades seven through twelve as provided in section
30 15.1-29-15.
 - 31 d. Special education program as provided in section 15.1-32-20.

- 1 e. The establishment and maintenance of an insurance reserve fund for
2 insurance purposes as provided in section 32-12.1-08.
- 3 f. A final judgment obtained against a school district.
- 4 g. The district's share of contribution to the old-age survivors' fund and matching
5 contribution for the social security fund as provided by chapter 52-09 and to
6 provide the district's share of contribution to the old-age survivors' fund and
7 matching contribution for the social security fund for contracted employees of
8 a multidistrict special education board.
- 9 h. The rental or leasing of buildings, property, or classroom space. Minimum
10 state standards for health and safety applicable to school building
11 construction shall apply to any rented or leased buildings, property, or
12 classroom space.
- 13 i. Unemployment compensation benefits.
- 14 j. The removal of asbestos substances from school buildings or the abatement
15 of asbestos substances in school buildings under any method approved by
16 the United States environmental protection agency and any repair,
17 replacement, or remodeling that results from such removal or abatement, any
18 remodeling required to meet specifications set by the Americans with
19 Disabilities Act accessibility guidelines for buildings and facilities as contained
20 in the appendix to 28 CFR 36, any remodeling required to meet requirements
21 set by the state fire marshal during the inspection of a public school, and for
22 providing an alternative education program as provided in section 57-15-17.1.
- 23 k. Participating in cooperative ~~vocational~~ career and technical education
24 programs approved by the state board.
- 25 l. Maintaining a ~~vocational~~ career and technical education program approved by
26 the state board and established only for that school district.
- 27 m. Paying the cost of purchasing, contracting, operating, and maintaining
28 schoolbuses.
- 29 n. Establishing and maintaining school library services.

- 1 o. Equipping schoolbuses with two-way communications and central station
2 equipment and providing for the installation and maintenance of such
3 equipment.
4 p. Establishing free public kindergartens in connection with the public schools of
5 the district for the instruction of resident children below school age during the
6 regular school term.
7 q. Establishing, maintaining, and conducting a public recreation system.
8 r. The district's share of contribution to finance an interdistrict cooperative
9 agreement authorized by section 15.1-09-40.
10 2. This limitation does not apply to mill levies pursuant to subdivisions a, c, f, and j of
11 subsection 1. If a school district maintained a levy to finance either its participation
12 in a cooperative ~~vocational~~ career and technical education program or its
13 sponsorship of single-district ~~vocational~~ career and technical education programs
14 prior to July 1, 1983, and the district discontinues its participation in or sponsorship
15 of those ~~vocational~~ career and technical education programs, that district must
16 reduce the proposed aggregated expenditure amount for which its general fund
17 levy is used by the dollar amount raised by its prior levy for the funding of those
18 programs.

19 **SECTION 101. AMENDMENT.** Section 57-15-17 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **57-15-17. Disposition of building fund tax.** Revenue raised for building purposes
22 shall be disposed of as follows:

- 23 1. a. All revenue accruing from appropriations or tax levies for a school building
24 fund together with such amounts as may be realized for building purposes
25 from all other sources must be placed in a separate fund known as a school
26 building fund and must be deposited, held, or invested in the same manner as
27 the sinking funds of such school district or in the purchase of shares or
28 securities of federal or state-chartered savings and loan associations within
29 the limits of federal insurance.
30 b. The funds may only be used for the following purposes:

- 1 (1) The erection of new school buildings or facilities, or additions to old
2 school buildings or facilities, or the making of major repairs to existing
3 buildings or facilities, or improvements to school land and site. For
4 purposes of this paragraph, facilities may include parking lots, athletic
5 complexes, or any other real property owned by the school district.
- 6 (2) The payment of rentals upon contracts with the state board of public
7 school education.
- 8 (3) The payment of rentals upon contracts with municipalities for ~~vocational~~
9 career and technical education facilities financed pursuant to
10 chapter 40-57.
- 11 (4) Within the limitations of school plans as provided in subsection 2 of
12 section 57-15-16.
- 13 (5) The payment of principal, premium, if any, and interest on bonds issued
14 pursuant to subsection 7 of section 21-03-07.
- 15 (6) The payment of premiums for fire and allied lines, liability, and multiple
16 peril insurance on any building and its use, occupancy, fixtures, and
17 contents.
- 18 c. The custodian of the funds may pay out the funds only upon order of the
19 school board, signed by the president and the business manager of the
20 school district. The order must recite upon its face the purpose for which
21 payment is made.
- 22 2. Any moneys remaining in a school building fund after the completion of the
23 payments for any school building project which has cost seventy-five percent or
24 more of the amount in such building fund at the time of letting the contracts therefor
25 shall be returned to the general fund of the school district upon the order of the
26 school board.
- 27 3. The governing body of any school district may pay into the general fund of the
28 school district any moneys which have remained in the school building fund for a
29 period of ten years or more, and such district may include the same as a part of its
30 cash on hand in making up its budget for the ensuing year. In determining what
31 amounts have remained in said fund for ten years or more, all payments which

1 have been paid from the school building fund for building purposes shall be
2 considered as having been paid from the funds first acquired.

3 4. Whenever collections from the taxes levied for the current budget and other
4 income are insufficient to meet the requirements for general operating expenses, a
5 majority of the governing body of a school district may transfer unobligated funds
6 from the school building fund into the general fund of the school district if the
7 school district has issued certificates of indebtedness equal to fifty percent of the
8 outstanding uncollected general fund property tax. No school district may transfer
9 funds from the school building fund into the general fund for more than two years.

10 **SECTION 102. AMENDMENT.** Subdivision m of subsection 1 of section 57-38-01.2 of
11 the North Dakota Century Code is amended and reenacted as follows:

12 m. Reduced by the amount of interest received during that taxable year on a
13 contract for deed on the sale of eighty or more acres [32.37 or more hectares]
14 of agricultural land to a beginning farmer. The contract for deed must extend
15 for not less than ten years and have an annual interest rate equal to or less
16 than the minimum rate allowed by the internal revenue service before interest
17 is imputed. In order for an individual, estate, or trust to qualify for this
18 reduction, the taxpayer must obtain a statement from the buyer stating that
19 the buyer meets all requirements of the beginning farmer definition, together
20 with such other information as the state tax commissioner may require. The
21 value placed on any real property located in North Dakota and owned by the
22 buyer must be the amount listed as the true and full value on the most recent
23 real estate tax statement for that particular piece of property. In determining
24 the net worth of any person, including the person's dependents and spouse, if
25 any, for purposes of this subdivision, the value of their equity in their principal
26 residence, the value of one personal or family motor vehicle, and the value of
27 their household goods, including furniture, appliances, musical instruments,
28 clothing, and other personal belongings may not be included. This statement
29 must be filed along with the income tax return. For the purposes of this
30 subdivision, "beginning farmer" means any person who is:

31 (1) A resident of this state.

- 1 (2) Receiving more than one-half of that person's gross annual income
2 from farming, unless the person initially commences farming during the
3 tax year for which an adjustment will be claimed under this subdivision.
4 (3) Intending to use any farmland to be purchased or rented for agricultural
5 purposes.
6 (4) Except for contracts for deed entered into prior to July 1, 1985, having
7 adequate training by education in the type of farming operation which
8 the person wishes to begin through satisfactory participation in the adult
9 farm management education program of the state board for ~~vocational~~
10 career and technical education or an equivalent program approved by
11 the agriculture commissioner.
12 (5) Having, including the net worth of any dependents and spouse, a net
13 worth of less than one hundred thousand dollars.

14 **SECTION 103. AMENDMENT.** Subsection 2 of section 57-38-67 of the North Dakota
15 Century Code is amended and reenacted as follows:

- 16 2. "Beginning farmer" means any person who is:
17 a. A resident of this state;
18 b. Receiving more than half of that person's gross annual income from farming,
19 unless the person initially commences farming during the tax year for which a
20 deduction will be claimed under sections 57-38-67 through 57-38-70;
21 c. Intending to use any farmland to be purchased or rented for agricultural
22 purposes;
23 d. Except for tax-exempt transactions entered into prior to July 1, 1985, having
24 adequate training by education in the type of farming operation which the
25 person wishes to begin on the purchased or rented land referred to in
26 subdivision c through satisfactory participation in the adult farm management
27 education program of the state board for ~~vocational~~ career and technical
28 education or an equivalent program approved by the agriculture
29 commissioner; and
30 e. Having, including the net worth of any dependents and spouse, a net worth of
31 less than one hundred thousand dollars, not including the value of their equity

1 in their principal residence, the value of one personal or family motor vehicle,
2 and the value of their household goods, including furniture, appliances,
3 musical instruments, clothing, and other personal belongings.

4 **SECTION 104. REPEAL.** Section 15-20.1-10 of the North Dakota Century Code is
5 repealed.
