

HOUSE BILL NO. 1085

(At the request of the Department of Human Services)

1 A BILL for an Act to amend and reenact sections 50-11.1-04 and 50-11.1-06.2 of the North
2 Dakota Century Code, relating to consideration of reports of child abuse or neglect in licensing
3 or registering child care providers.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 50-11.1-04 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **50-11.1-04. Application for license - Prerequisites for issuance - License granted -**

8 **Term.** Applications for early childhood facility licenses must be made on forms provided, in the
9 manner prescribed, by the department. The county agency shall investigate the applicant's
10 activities and proposed standards of care and shall make an inspection of all facilities applying
11 for a license. The applicant for a license and the applicant's employees, and, if the license is
12 for an occupied private residence, every person living or working in that residence, may be
13 investigated in accordance with the rules adopted by the department to determine whether any
14 of them has a criminal record or has had a finding of ~~probable cause~~ services required for child
15 abuse or neglect filed against them. Except as otherwise provided, the department shall grant
16 a license for the operation of an early childhood facility upon a showing that:

- 17 1. The premises to be used are in fit sanitary condition and properly equipped to
18 provide for the health and safety for all children who may be received;
- 19 2. The persons in charge of the facility and their assistants are qualified to fulfill the
20 duties required of them according to the provisions of this chapter and standards
21 prescribed for their qualifications by the rules and regulations of the department;
- 22 3. The facility will be maintained according to the standards prescribed for its conduct
23 by the rules and regulations of the department;

- 1 4. The facility has not had a previous license revoked within the one hundred eighty
2 days prior to the date of the current application;
- 3 5. The facility has paid its license fees and any penalties assessed against the facility
4 as required by section 50-11.1-03; and
- 5 6. The group child care or child care center facility maintains at all times during which
6 early childhood services is provided at least one person who has received training
7 and is currently certified in rescuer cardiopulmonary resuscitation by the American
8 heart association, American red cross, or other similar cardiopulmonary
9 resuscitation training programs that are approved by the department.
- 10 The license issued to the operator of an early childhood facility must be in force and effect for a
11 period of not more than two years.

12 **SECTION 2. AMENDMENT.** Section 50-11.1-06.2 of the North Dakota Century Code
13 is amended and reenacted as follows:

14 **50-11.1-06.2. Carecheck registry - Child care providers - Background**
15 **investigations - Fees.** Placement in the carecheck registry is voluntary. To apply for
16 placement in the carecheck registry, an in-home provider, a family child care home exempt from
17 licensure, or a licensed early childhood services provider shall obtain two sets of that person's
18 own fingerprints from a law enforcement agency or other local agency authorized to take
19 fingerprints and shall request the agency to submit the fingerprints and a completed fingerprint
20 card for each set to the division of children and family services of the department or to any
21 division as determined appropriate by the department. If the division has no record of a
22 determination of ~~probable cause services required~~ for child abuse or neglect, the division shall
23 submit one set of fingerprints to the federal bureau of investigation and one set to the bureau of
24 criminal investigation to determine if there is any criminal history record information regarding
25 the applicant for carecheck. The results of the investigations must be forwarded to the division
26 of children and family services of the department or to any other division as determined
27 appropriate by the department. The applicant for placement in the carecheck registry, after
28 satisfying requirements imposed by the department, must be placed in the carecheck registry if
29 no relevant criminal history record information is found and no report of a determination of
30 ~~probable cause services required~~ for child abuse or neglect filed pursuant to section
31 50-25.1-05.2 is found which would disqualify the person. The division may charge the applicant

1 a fee not to exceed thirty dollars for the purpose of processing the application. The division is
2 not subject to the fee imposed under section 12-60-16.9 when requesting criminal history
3 record information from the bureau of criminal investigation. The division, within one hundred
4 eighty days after July 1, 1991, shall provide, through a toll-free telephone line maintained by the
5 department, a means to allow interested parents or guardians, employment agencies, or child
6 care referral groups to determine if a person has met the requirements for placement in the
7 carecheck registry. The division shall undertake a public awareness effort to explain the
8 existence and purpose of the carecheck toll-free telephone line. An agency that takes
9 fingerprints as provided under this section may charge a reasonable fee to offset the costs of
10 the fingerprinting.
