## ENGROSSED SENATE BILL NO. 2085

Introduced by

Human Services Committee

(At the request of the Office of Management and Budget)

1 A BILL for an Act to create and enact section 50-24.3-03.1 of the North Dakota Century Code,  
2 relating to the powers and duties of the department of human services regarding assessment  
3 services; to amend and reenact sections 50-24.3-01 and 50-24.3-03 of the North Dakota  
4 Century Code, relating to the establishment of targeted case management and assessment  
5 services for persons being admitted to a skilled nursing facility or hospital swing-bed facility; to  
6 repeal section 50-24.3-02 of the North Dakota Century Code, relating to professional  
7 involvement in the assessment process; and to declare an emergency.

8 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

9 **SECTION 1. AMENDMENT.** Section 50-24.3-01 of the North Dakota Century Code is  
10 amended and reenacted as follows:

11 **50-24.3-01. ~~(Effective through June 30, 2003)~~ Targeted case management.** The  
12 department of human services shall establish a targeted case management service for disabled  
13 and elderly individuals eligible for benefits under chapter 50-24.1 who are at risk of requiring  
14 long-term care services to ensure that an individual is informed of alternatives available to  
15 address the individual's long-term care needs.

16 **~~(Effective after June 30, 2003) Assessment mechanism—Establishment.~~** The  
17 department of human services shall establish a mechanism to assess, prior to admission to a  
18 skilled nursing facility, intermediate care facility, or a hospital swing-bed facility approved to  
19 furnish skilled or intermediate care services, the health and social needs of each person  
20 making application for admission to the facility.

21 **SECTION 2. AMENDMENT.** Section 50-24.3-03 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23 **50-24.3-03. ~~(Effective through June 30, 2003)~~ Department of human services -**  
24 **Targeted case management - Powers and duties.** The department of human services has

1 the following powers and duties which it may delegate to any entity ~~which~~ that provides  
2 targeted case management services approved by the department:

- 3 1. To seek cooperation from other public and private entities in the community ~~which~~  
4 that offer services to individuals with disabilities or the elderly.
- 5 2. To provide information and education to the general public regarding availability of  
6 targeted case management.
- 7 3. To accept referrals from an interested party including individuals, families, human  
8 services program professionals, nursing facility personnel, and acute care facility  
9 personnel.
- 10 4. To assess the health and social needs of, and provide targeted case management  
11 to, referred individuals who wish to receive this service.
- 12 5. To identify available noninstitutional services to meet the needs of referred  
13 individuals.
- 14 6. To prepare an individual care plan for each individual receiving targeted case  
15 management services.
- 16 7. To inform referred individuals of the extent to which long-term care services are  
17 available, including institutional and community-based services, and of the  
18 individual's opportunity to choose, in consultation with an attending physician,  
19 family members, and other interested parties, among the appropriate alternatives  
20 that may be available.
- 21 8. To monitor the results of targeted case management and report to each legislative  
22 assembly on these results and the cost-effectiveness of these services.

11           **SECTION 3.** Section 50-24.3-03.1 of the North Dakota Century Code is created and  
12 enacted as follows:

13           **50-24.3-03.1. Department of human services - Assessment services - Powers and**  
14 **duties.** The department of human services has the following powers and duties which it may  
15 delegate to any entity that provides assessment services approved by the department:

- 16           1. To seek cooperation from other public and private agencies in the community
- 17           which offer services to disabled and elderly persons.
- 18           2. To provide information and education to the general public regarding availability of
- 19           the assessment program.
- 20           3. To accept referrals from individuals, families, human services program
- 21           professionals, nursing facility personnel, and acute care facility personnel.
- 22           4. To assess the health and social needs of referred individuals.

- 25           6. To prepare recommendations for individuals receiving assessment program

- 28           7. To inform referred individuals of the extent to which home and community-based
- 29           services are available and of their opportunity to choose, in consultation with an
- 30           attending physician and family member, among the appropriate alternatives that
- 31           may be available.

1           **SECTION 4. REPEAL.** Section 50-24.3-02 of the North Dakota Century Code is  
2 repealed.

3           **SECTION 5. EMERGENCY.** This Act is declared to be an emergency measure.
