The House convened at 12:30 p.m., with Speaker Wentz presiding.

The prayer was offered by Pastor Chris Hallanger, St. John and Bethany Lutheran Churches, Hatton.

Today is the opening day of the 66th Annual North Dakota Winter Show located in Valley City. The North Dakota Winter Show had its beginning in the middle 30's as a Winter exposition of the agriculture industry in North Dakota with an emphasis on family and youth. Starting as a livestock show through the years it was supported by every major purebred breeder throughout the state. From its humble beginning using garage and warehouse space in down town Valley City it was expanded into its current four acres of indoor display area and an arena with 3500 seating capacity for many different types of agricultural exhibits and entertainment features. In the late 70's the livestock shows were opening to the world. Since then, livestock from 27 other states and four countries have been on display or entered into competition. In addition to livestock, the show is noted for its seed show, known to be the largest in the world. Each year, FFA and 4-H members by the hundreds participate in the many judging and showmanship contests. Add activities of special interest for the ladies and you have an all around family fun and educational event second to none.

As times change, so does the Winter Show. It started as a three day show, expanded to a seven day show, advanced to an eleven day show and currently runs for ten days starting the first Friday of March each year. The North Dakota Winter Show is responsive to the needs of the state as an additional livestock show was added in the first week of December and is known as the North Star Classic. This year more than 20 horse events will be held. Every major horse association in the area will be holding shows and contests in the Winter Show building, probably the finest horse show facility within a four state area. In addition several 4-H shows have been scheduled together with beef herd production sales and show horse clinics and seminars. The Winter Show is also the home for the North Dakota Agriculture Hall of Fame, where many of our leaders are recognized for their contribution to the development and expansion of the agriculture community as we know it today.

All North Dakotans and their friends are invited to become a part of the show by coming to Valley City to experience the history and learn the future of agriculture of this Great State as presented by the North Dakota Winter Show.

**WHEREAS**, the Public Service Commission estimates that there may be between 8,000 and 10,000 acres of land that have been reclaimed for 10 years but for which no related final bond release requests by mining companies have been filed with the Public Service Commission; and

**WHEREAS**, the mining companies, regulatory agencies, and farmers and ranchers have mutual interests in obtaining timely bond release; and

**WHEREAS**, there are circumstances in which the land has been reclaimed for 10 years and is in full agricultural production where mining companies have not applied for final bond release due to the irregular shape of tracts, proximity to active operations, need for future access, and safety concerns for the landowners or tenants;

**NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF NORTH DAKOTA, THE SENATE CONCURRING THEREIN:**

That the Legislative Council study and identify federal and state statutory and regulatory policies that discourage or prevent final bond release applications from being filed and study and identify Public Service Commission regulatory policies that could be implemented to encourage flexibility in proving reclamation success and reducing administrative and regulatory burdens necessary for bond release applications; and study and identify activities being undertaken by the mining companies to achieve final bond release; and

**BE IT FURTHER RESOLVED**, that the Legislative Council report its findings and recommendations, together with any legislation required to implement the recommendations, to the Fifty-ninth Legislative Assembly."

Before October 2, 2004, the director of the office of management and budget shall present a report to the legislative council regarding actual lodging expense reimbursement by state entities between the effective date of this Act and September 1, 2004, which has been authorized by the head of a state agency or entity under paragraph 2 of subdivision d of subsection 2 of section 44-08-04. The report must include information regarding:

1. The number of nights for which lodging reimbursement was provided by a state agency or entity.
2. The number of lodging reimbursements and the dollar amount per night provided by a state agency or entity which was above the rate provided for in paragraph 1 of subdivision d of subsection 2 of section 44-08-04.
3. The city in which the state agency or entity provided actual lodging expenses which were above the rate provided for under paragraph 1 of subdivision d of subsection 2 of section 44-08-04.

**SECTION 3. EXPIRATION DATE.** This Act is effective through July 31, 2005, and after that date is ineffective."

Upon approval by a majority of electors voting on the question at a regular or special county election, a county levying a tax for a job development authority as provided in section 11-11.1-04 or for the support of an industrial development organization as provided in section 11-11.1-06 may levy a separate and additional tax for promotion of tourism in an amount not exceeding one mill on the taxable valuation of property within the county. However, if any city within the county is levying a tax for support of a job development authority or for support of an industrial development organization and the total of the county and city levies exceeds ~~four~~ five mills, the county tax levy within the city levying under subsection 28 of section 57-15-10 must be reduced so the total levy in the city does not exceed ~~four~~ five mills."
