

**FIRST ENGROSSMENT
with Conference Committee Amendments**

ENGROSSED SENATE BILL NO. 2200

1 A BILL for an Act to create and enact a new section to chapter 51-07 of the North Dakota
2 Century Code, relating to recording devices on motor vehicles; and to provide for application.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1.** A new section to chapter 51-07 of the North Dakota Century Code is
5 created and enacted as follows:

6 **Recording devices on motor vehicles - Disclosure - Removal.**

7 1. A manufacturer of a new motor vehicle sold or leased in this state which is
8 equipped with a recording device commonly referred to as an event data recorder
9 shall disclose by model year 2007 the presence, capacity, and capabilities of the
10 event data recorder in the owner's manual for the vehicle. A motor vehicle dealer
11 shall include within the purchase contract in a clear and conspicuous manner
12 information on the possibility of a recording device. As used in this section, an
13 event data recorder means a feature that is installed by the manufacturer of the
14 vehicle and does any of the following for the purpose of retrieving data:

- 15 a. Records the speed of the vehicle and the direction the motor vehicle is
- 16 traveling.
- 17 b. Records vehicle location data.
- 18 c. Records steering performance.
- 19 d. Records brake performance, including whether brakes were applied before an
- 20 accident.
- 21 e. Records the driver's safety belt status.
- 22 f. Has the ability to transmit information concerning an accident in which the
- 23 vehicle has been involved to a central communications system when an
- 24 accident occurs.

- 1 2. Data recorded on an event data recorder may not be downloaded or otherwise
2 retrieved by a person other than the owner of the motor vehicle at the time the data
3 is recorded, or through consent by the owner's agent or legal representative,
4 except under any of the following circumstances:
- 5 a. The data is retrieved for the purpose of improving motor vehicle safety,
6 including for medical research of the human body's reaction to motor vehicle
7 accidents, and the identity of the registered owner or driver is not disclosed in
8 connection with that retrieved data. The disclosure of the vehicle
9 identification number, with the last four digits deleted, for the purpose of
10 improving vehicle safety, including for medical research of the human body's
11 reaction to motor vehicle accidents, does not constitute the disclosure of the
12 identity of the registered owner or driver. A person authorized to download or
13 otherwise retrieve data from a recording device under this subdivision may
14 not release that data, except to share the data among the motor vehicle
15 safety and medical research communities to advance motor vehicle safety,
16 and only if the identity of the registered owner or driver is not disclosed.
- 17 b. The data is retrieved by a licensed motor vehicle dealer or by an automotive
18 technician for the purpose of diagnosing, servicing, or repairing the motor
19 vehicle.
- 20 c. By stipulation of the parties to the proceeding or by order of the court.
- 21 3. "Owner" means a person having all the incidents of ownership, including the legal
22 title of a vehicle regardless of whether the person lends, rents, or creates a
23 security interest in the vehicle; a person entitled to the possession of a vehicle as
24 the purchaser under a security agreement; or the person entitled to possession of
25 the vehicle as lessee pursuant to a written lease agreement, if the agreement at
26 inception is for a period in excess of three months.
- 27 4. A person, including a service or data processor operating on behalf of the person,
28 authorized to download or otherwise retrieve data from an event data recorder
29 pursuant to subdivision a of subsection 2 may not release that data except for the
30 purposes of motor vehicle safety and medical communities to advance motor
31 vehicle safety, security, or traffic management; or to a data processor solely for the

1 purposes permitted by this subsection and only if the identity of the owner or driver
2 of the vehicle is not disclosed.

3 5. If a motor vehicle is equipped with a recording device that is capable of recording
4 or transmitting information relating to vehicle location data or concerning an
5 accident to a central communications system and that capability is part of a
6 subscription service, the fact that the information may be recorded or transmitted
7 must be disclosed in the terms and conditions of the subscription service.

8 Subsection 2 does not apply to a subscription service that meets the requirements
9 of this subsection.

10 6. An insurer may not require as a condition of insurability consent of the owner for
11 access to data that may be stored within an event data recorder and may not use
12 data retrieved with the owners consent before or after an accident for the purpose
13 of rate assessment.

14 **SECTION 2. APPLICATION.** This Act applies to all motor vehicles manufactured after
15 July 31, 2005.
