- 1 A BILL for an Act to create and enact a new section to chapter 14-09, a new section to chapter
- 2 14-18, and chapter 14-20 of the North Dakota Century Code, relating to the termination of
- 3 parental rights, gestational carriers, and the Uniform Parentage Act; to amend and reenact
- 4 section 12.1-31-05, subsection 1 of section 14-15-05, subsection 1 of section 14-15-11,
- sections 14-18-01, 14-18-05, and 14-19-05, and subsection 5 of section 23-02.1-13 of the 5
- 6 North Dakota Century Code, relating to gestational carriers and parentage determinations; to
- 7 repeal sections 14-09-01, 14-09-02, and 14-09-03, chapter 14-17, and sections 14-18-02.1,
- 8 14-18-03, 14-18-04, 14-18-06, 14-18-07, 14-19-02, 14-19-03, 14-19-04, 14-19-09, and
- 9 14-19-10 of the North Dakota Century Code, relating to the legitimacy of children, the Uniform
- 10 Parentage Act, the Uniform Status of Children of Assisted Conception Act, and paternity
- 11 acknowledgment; and to provide for transition.

## 12 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 13 SECTION 1. AMENDMENT. Section 12.1-31-05 of the North Dakota Century Code is amended and reenacted as follows: 14
- 15 12.1-31-05. Child procurement - Penalty. Except with respect to fees and charges
- 16 authorized by law or approved by a court in a proceeding related to the placement of a minor
- 17 child for adoption or related to the adoption of a minor child, a person is guilty of child
- 18 procurement, a class C felony, if the person knowingly offers, gives, or agrees to give to
- 19 another or solicits, accepts, or agrees to accept from another, a thing of value as consideration
- 20 for the recipient's furnishing or aiding another to furnish a minor child for the purposes of
- 21 adoption. This section does not apply to parties to any agreement in which a woman agrees to
- 22 become a surrogate, as defined in section 14-18-01, or to relinquish her rights and duties as
- 23 parent of a child conceived through assisted enception reproduction, as defined in section
- 24 <del>14-18-01</del> 14-20-01.

- **SECTION 4. AMENDMENT.** Subsection 1 of section 14-15-11 of the North Dakota Century Code is amended and reenacted as follows:
  - 1. a. After the filing of a petition to adopt a minor, the court shall fix a time and place for hearing the petition. At least twenty days before the date of hearing, notice of the filing of the petition and of the time and place of hearing must be given by the petitioner to the department; any agency or individual whose consent to the adoption is required by this chapter but who has not consented; an individual whose consent is dispensed with upon any ground mentioned in subdivisions a, b, f, h, i, and j of subsection 1 of section 14-15-06 but who has not consented; and any individual identified by the court as a biological parent or a possible biological parent of the minor, upon making inquiry to the extent necessary and appropriate, as in proceedings under sections section 27-20-45 and 14-17-24, unless the individual has relinquished parental rights or the individual's parental rights have been previously terminated by a court. The notice to the department must be accompanied by a copy of the petition.
    - b. Notice of the filing of a petition to adopt an adult must be given by the petitioner at least twenty days before the date of the hearing to each living parent of the adult to be adopted.
- **SECTION 5. AMENDMENT.** Section 14-18-01 of the North Dakota Century Code is amended and reenacted as follows:

## **14-18-01. Definitions.** As used in this chapter:

- "Assisted conception" means a pregnancy resulting from insemination of an egg of a woman with sperm of a man by means other than sexual intercourse or by removal and implantation of an embryo after sexual intercourse but does not include a pregnancy resulting from the insemination of an egg of a wife using her husband's sperm.
- "Donor" means an individual whose body produces sperm or egg used for the
  purpose of assisted conception, whether or not a payment is made for the sperm
  or egg used, but does not include an individual whose body produces sperm or
  egg used for the purpose of conceiving a child for that individual.

1 "Gestational carrier" means an adult woman who enters into an agreement to have 2 an embryo implanted in her and bear the resulting child for intended parents, 3 where the embryo is conceived by using the egg and sperm of the intended 4 parents. 5 <del>4.</del> 3. "Surrogate" means an adult woman who enters into an agreement to bear a child 6 conceived through assisted conception for intended parents. 7 SECTION 6. AMENDMENT. Section 14-18-05 of the North Dakota Century Code is 8 amended and reenacted as follows: 9 **14-18-05.** Surrogate agreements. Any agreement in which a woman agrees to 10 become a surrogate or to relinquish that woman's rights and duties as parent of a child 11 conceived through assisted conception is void. The surrogate, however, is the mother of a 12 resulting child and the surrogate's husband, if a party to the agreement, is the father of the 13 child. If the surrogate's husband is not a party to the agreement or the surrogate is unmarried, 14 paternity of the child is governed by chapter 14-17 14-20. 15 SECTION 7. A new section to chapter 14-18 of the North Dakota Century Code is 16 created and enacted as follows: 17 **Gestational carrier agreements.** A child born to a gestational carrier is a child of the 18 intended parents for all purposes and is not a child of the gestational carrier and the gestational 19 carrier's husband, if any. 20 **SECTION 8. AMENDMENT.** Section 14-19-05 of the North Dakota Century Code is 21 amended and reenacted as follows: 22 **14-19-05.** Filing of acknowledgment. An acknowledgment of paternity made under 23 this chapter 14-20 must be filed with the state department of health on a form approved by the 24 department, which must include the social security number of the parents and any other 25 information required by the secretary of the United States department of health and human 26 services. Upon request of the department, the state department of health shall furnish a 27 certified copy of an acknowledgment of paternity to the department. 28 SECTION 9. Chapter 14-20 of the North Dakota Century Code is created and enacted 29 as follows: 30 **14-20-01. (101) Short title.** This chapter may be cited as the Uniform Parentage Act.

**14-20-02. (102) Definitions.** In this chapter:

"Determination of parentage" means the establishment of the parent-child 22 7. 23 relationship by the signing of a valid acknowledgment of paternity under sections 24 14-20-11 through 14-20-24 or adjudication by the court. 25 8. "Donor" means an individual who produces eggs or sperm used for assisted 26 reproduction, whether or not for consideration. The term does not include: 27 A husband who provides sperm, or a wife who provides eggs, to be used for a. 28 assisted reproduction by the wife; 29 A woman who gives birth to a child by means of assisted reproduction; b. 30 A parent under sections 14-20-59 through 14-20-65; or C.

1 An individual whose body produces sperm or egg used for the purpose of d. 2 conceiving a child for that individual. 3 "Ethnic or racial group" means, for purposes of genetic testing, a recognized group 9. 4 that an individual identifies as all or part of the individual's ancestry or that is so 5 identified by other information. "Genetic testing" means an analysis of genetic markers to exclude or identify a 6 10. 7 man as the father or a woman as the mother of a child. The term includes an 8 analysis of one or a combination of the following: 9 Deoxyribonucleic acid; and a. 10 b. Blood-group antigens, red-cell antigens, human-leukocyte antigens, serum 11 enzymes, serum proteins, or red-cell enzymes. 12 <u>11.</u> "Gestational carrier" means an adult woman who enters into an agreement to have 13 an embryo implanted in her and bear the resulting child for intended parents, 14 where the embryo is conceived by using the egg and sperm of the intended 15 parents. 16 12. "Man" means a male individual of any age. 17 13. "Parent" means an individual who has established a parent-child relationship under 18 section 14-20-07. 19 14. "Parent-child relationship" means the legal relationship between a child and a 20 parent of the child. The term includes the mother-child relationship and the 21 father-child relationship. "Paternity index" means the likelihood of paternity calculated by computing the 22 15. 23 ratio between: 24 The likelihood that the tested man is the father, based on genetic markers of a. 25 the tested man, mother, and child, conditioned on the hypothesis that the 26 tested man is the father of the child; and 27 <u>b.</u> The likelihood that the tested man is not the father, based on the genetic 28 markers of the tested man, mother, and child, conditioned on the hypothesis 29 that the tested man is not the father of the child and that the father is of the 30 same ethnic or racial group as the tested man.

"Presumed father" means a man who, by operation of law under section 14-20-10, 2 is recognized as the father of a child until that status is rebutted or confirmed in a 3 judicial proceeding. 4 "Probability of paternity" means the measure, for the ethnic or racial group to which 17. 5 the alleged father belongs, of the probability that the man in question is the father 6 of the child, compared with a random, unrelated man of the same ethnic or racial 7 group, expressed as a percentage incorporating the paternity index and a prior 8 probability. 9 "Record" means information that is inscribed on a tangible medium or that is stored 18. in an electronic or other medium and is retrievable in perceivable form. 10 11 <u>19.</u> "Signatory" means an individual who authenticates a record and is bound by its 12 terms. 13 20. "State" means a state of the United States, the District of Columbia, Puerto Rico, 14 the United States Virgin Islands, or any territory or insular possession subject to 15 the jurisdiction of the United States. "Support enforcement agency" means a public official or agency authorized to 16 21. 17 seek: 18 Enforcement of support orders or laws relating to the duty of support; <u>a.</u> 19 Establishment or modification of child support; b. 20 Determination of parentage; or <u>C.</u> 21 Location of child support obligors and their income and assets. d. 22 14-20-03. - Legislative Assembly 1 An acknowledgment of paternity and a denial of paternity may be contained in a 2 single document or may be signed in counterparts, and may be filed separately or 3 simultaneously. If the acknowledgment and denial are both necessary, neither is 4 valid until both are filed. 5 An acknowledgment of paternity or a denial of paternity may be signed before the <u>2.</u> 6 birth of the child. 7 Subject to subsection 1, an acknowledgment of paternity or denial of paternity 3. 8 takes effect on the birth of the child or the filing of the document with the state 9 department of health, whichever occurs later. 10 An acknowledgment of paternity or denial of paternity signed by a minor is valid if it <u>4.</u> 11 is otherwise in compliance with this chapter. 12 <u>5.</u> An acknowledgment of paternity or denial of paternity may be completed for a child 13 who was not born in this state. 14 14-20-15.
