## ENGROSSED HOUSE BILL NO. 1423

1 A BILL for an Act to create and enact a new section to chapter 15-04, a new section to chapter  
2 15-07, a new subsection to section 20.1-02-04, and a new subsection to section 20.1-03-39 of  
3 the North Dakota Century Code, relating to public access on original grant lands and nongrant  
4 lands, duties of the director of the game and fish department, and regulation of guides; to  
5 amend and reenact section 15-07-20 of the North Dakota Century Code, relating to nongrant  
6 land leases; and to provide an appropriation.

7 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

8 **SECTION 1.** A new section to chapter 15-04 of the North Dakota Century Code is  
9 created and enacted as follows:

10 **Lease of grant lands - Public access.** Notwithstanding any other provision of law, a  
11 lessee of grant lands under this chapter may not post those lands to prohibit public access or  
12 hunting on the lands. The board of university and school lands shall include a provision in each  
13 lease executed after July 31, 2005, that the lessee may not post the leased land to prohibit  
14 hunting during any open hunting season.

15 **SECTION 2.** A new section to chapter 15-07 of the North Dakota Century Code is  
16 created and enacted as follows:

17 **Lease of nongrant lands - Public access.** Notwithstanding any other provision of  
18 law, a lessee of nongrant lands under this chapter may not post those lands to prohibit public  
19 access or hunting on the lands. The board of university and school lands shall include a  
20 provision in each lease executed after July 31, 2005, that the lessee may not post the leased  
21 land to prohibit hunting during any open hunting season.

22 **SECTION 3. AMENDMENT.** Section 15-07-20 of the North Dakota Century Code is  
23 amended and reenacted as follows:

1           **15-07-20. Leasing of nongrant lands.** The board of university and school lands may  
2 lease nongrant lands under reasonable rules as it may establish. The rules may provide for  
3 leasing with or without advertisement or competitive bidding. Leases made under this section  
4 must be for cash only, and the rental must be collected in advance except that the board may  
5 collect a share of a conservation reserve program payment paid by the federal government. A  
6 lease of nongrant lands may not extend for a period of more than five years, except any land  
7 accepted into the conservation reserve program may have a lease term that coincides with the  
8 term of the conservation reserve program contract if so provided in the lease. Leases may be  
9 renewed at the discretion of the board. When nongrant lands are leased without advertisement  
10 or competitive bidding, the board shall determine the rental by taking into consideration the  
11 nature and adaptability of the lands and the improvements thereon. Leases made under this  
12 section after July 31, 2005, must include a provision that the lessee may not post the land to  
13 prohibit public access or hunting.

14           **SECTION 4.** A new subsection to section 20.1-02-04 of the North Dakota Century  
15 Code is created and enacted as follows:

16           Identify by signage and publication all grant and nongrant lands under the control  
17 of the board of university and school lands which are open to hunting. The director  
18 shall implement the signage provisions of this subsection as leases are issued or  
19 renewed by the board of university and school lands.

20           **SECTION 5.** A new subsection to section 20.1-03-39 is created and enacted as  
21 follows:

22           A guide or outfitter may not guide on any lands belonging to the state, including  
23 grant lands, nongrant lands, and lands known as school lands and public institution  
24 lands.

25           **SECTION 6. APPROPRIATION.** There is appropriated out of any moneys in the game  
26 and fish fund in the state treasury, not otherwise appropriated, the sum of \$100,000, or so  
27 much of the sum as may be necessary, to the game and fish department for the purpose of  
28 defraying the expenses of identifying by signage and publication all grant and nongrant lands  
29 that are open to hunting, for the biennium beginning July 1, 2005, and ending June 30, 2007.
