

Introduced by

1 A BILL for an Act to amend and reenact subsection 11 of section 65-05-12.2 of the North
2 Dakota Century Code, relating to workers' compensation permanent partial impairment awards
3 for loss of vision; to provide for application; and to declare an emergency.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Subsection 11 of section 65-05-12.2 of the North Dakota
6 Century Code is amended and reenacted as follows:

7 11. An amputation of a finger or toe at the level of the distal interphalangeal joint or
8 proximal to that joint, or the thumb or the great toe at the interphalangeal joint or
9 proximal to that joint, which is determined to result in a whole body impairment of
10 less than sixteen percent and which is not identified in the following schedule, is
11 payable as a sixteen percent impairment. If an evaluation for the loss of an eye or
12 for an amputation results in an award that is less than the permanent impairment
13 multiplier identified in the following schedule, the organization shall pay an award
14 equal to the permanent impairment multiplier set out in the following schedule:

22 The award for the amputation of more than one finger of one hand may not exceed
23 an award for the amputation of a hand. The award for the amputation of more than
24 one toe of one foot may not exceed an award for the amputation of a foot. If any of
25 the amputations or losses set out in this subsection combine with other
26 impairments for the same work-related injury or condition, the organization shall
27 issue an impairment award based on the greater of the permanent impairment
28 multiplier allowed for the combined rating established under the fifth edition of the
29 American medical association's "Guides to the Evaluation of Permanent
30 Impairment" or the permanent impairment multiplier set forth in this subsection.

1 **SECTION 2. APPLICATION.** This Act applies to injuries that occur on or after the
2 effective date of this Act.

3 **SECTION 3. EMERGENCY.** This Act is declared to be an emergency measure.
