1 A BILL for an Act to provide an appropriation for state agency and institution extraordinary  
2 repairs; to provide for budget section tour group review; and to provide for a report.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the  
5 funds as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the agencies listed below for the purpose of funding extraordinary repairs of  
8 the various agencies, for the biennium beginning July 1, 2007, and ending June 30, 2009.

20           **SECTION 2. BUDGET SECTION TOUR GROUP REVIEW.** Institutions shall report to  
 21 any budget section tour group that visits the institution during the 2007-08 interim on the status  
 22 of the extraordinary repairs funded in section 1 of this Act and the tour groups shall review the  
 23 repairs as part of the tour of the institution.

24           **SECTION 3. EXTRAORDINARY REPAIR PROJECT STATUS - REPORT TO THE**  
 25 **SIXTY-FIRST LEGISLATIVE ASSEMBLY.** State agencies and institutions shall provide  
 26 information to the appropriations committees of the sixty-first legislative assembly regarding the  
 27 status of the extraordinary repairs funded in section 1 of this Act.
