

HOUSE BILL NO. 1126

Introduced by

Judiciary Committee

(At the request of the North Dakota Racing Commission)

1 A BILL for an Act to create and enact a new subsection to section 53-06.2-01 of the North
2 Dakota Century Code, relating to the definition of the racing promotion fund; and to amend and
3 reenact section 53-06.2-11 of the North Dakota Century Code, relating to taxes on parimutuel
4 wagering.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1.** A new subsection to section 53-06.2-01 of the North Dakota Century Code
7 is created and enacted as follows:

8 "Racing promotion fund" means a fund administered by the commission
9 established to assist in improving and upgrading racetracks in the state, promoting
10 horse racing in the state, developing new racetracks in the state as necessary and
11 approved by the commission, and paying the commission's operating expenses.

12 **SECTION 2. AMENDMENT.** Section 53-06.2-11 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **53-06.2-11. (~~Effective through June 30, 2007~~) Bet payoff formulas - Uses by**
15 **licensee of funds in excess of expenses - Payment to general fund.**

16 1. a. ~~For each day of a live race meet or a simulcast day in this state on win, place,~~
17 ~~and show parimutuel pools, the licensee shall deduct up to twenty percent of~~
18 ~~the total win, place, and show pool. On the first eleven million dollars of total~~
19 ~~wagering handle in each biennium, two percent must be paid to the state~~
20 ~~treasurer to be deposited in the general fund. One half of one percent must~~
21 ~~be paid to the North Dakota racing commission to be used for the North~~
22 ~~Dakota purse fund. One half of one percent must be paid to the North Dakota~~
23 ~~racing commission to be used for the North Dakota breeders' fund for the~~

1 ~~respective breed of horses racing at that meet. Breakage must be paid to the~~
2 ~~North Dakota racing commission to be deposited in the promotion fund.~~

3 b. ~~On the wagering handle on win, place, and show wagering pools in excess of~~
4 ~~eleven million dollars in each biennium, one sixteenth of one percent must be~~
5 ~~paid to the commission to be deposited in the purse fund; one sixteenth of~~
6 ~~one percent must be paid to the commission to be deposited in the promotion~~
7 ~~fund; one sixteenth of one percent must be paid to the commission to be~~
8 ~~deposited in the breeders' fund; and one sixteenth of one percent must be~~
9 ~~paid to the state treasurer to be deposited in the general fund.~~

10 For wagering on live horse racing and simulcast wagering:

11 a. In win, place, and show parimutuel polls, the licensee may deduct no more
12 than twenty percent of the amount wagered. Of the amount wagered, the
13 licensee shall pay:

14 (1) Two percent to the state treasurer to be deposited in the general fund.

15 (2) One-half of one percent to the commission to be deposited in the
16 breeders' fund.

17 (3) One-half of one percent to the commission to be deposited in the purse
18 fund.

19 (4) One-half of one percent to the commission to be deposited in the racing
20 promotion fund.

21 b. In daily double, quinella, exacta, trifecta, or other combination parimutuel
22 pools, the licensee may deduct no more than twenty-five percent of the
23 amount wagered. Of the amount wagered, the licensee shall pay:

24 (1) Two and one-half percent to the state treasurer to be deposited in the
25 general fund.

26 (2) One-half of one percent to the commission to be deposited in the
27 breeders' fund.

28 (3) One-half of one percent to the commission to be deposited in the purse
29 fund.

30 (4) One-half of one percent to the commission to be deposited in the racing
31 promotion fund.

1 2. ~~For each day of a live race meet or a simulcast day in this state for each daily~~
2 ~~double, quinella, exacta, trifecta, or other wager combining two or more horses for~~
3 ~~winning payoffs, the licensee shall deduct up to twenty five percent of each~~
4 ~~wagering pool. Of each wagering dollar, the amounts to be deposited in the~~
5 ~~general fund and other funds are as follows:~~

6 a. ~~On the first eleven million dollars of wagering handle in each biennium,~~
7 ~~one half of one percent must be paid to the commission to be deposited in the~~
8 ~~purse fund; one half of one percent must be paid to the commission to be~~
9 ~~deposited in the promotion fund; one half of one percent must be paid to the~~
10 ~~commission to be deposited in the breeders' fund; and two and one half~~
11 ~~percent must be paid to the state treasurer to be deposited in the general~~
12 ~~fund.~~

13 b. ~~On the wagering handle in excess of eleven million dollars in each biennium,~~
14 ~~one sixteenth of one percent must be paid to the commission to be deposited~~
15 ~~in the purse fund; one sixteenth of one percent must be paid to the~~
16 ~~commission to be deposited in the promotion fund; one sixteenth of one~~
17 ~~percent must be paid to the commission to be deposited in the breeders' fund;~~
18 ~~and one sixteenth of one percent must be paid to the state treasurer to be~~
19 ~~deposited in the general fund.~~

20 For account wagering:

21 a. In win, place, and show parimutuel pools, the licensee may deduct no more
22 than twenty percent of the amount wagered.

23 (1) Before eleven million dollars is wagered in all parimutuel wagering in
24 each biennium, of the amount wagered by account wagering in win,
25 place, and show parimutuel pools, the licensee shall pay:

26 (a) Two percent to the state treasurer to be deposited in the general
27 fund;

28 (b) One-half of one percent to the commission to be deposited in the
29 breeders' fund.

30 (c) One-half of one percent to the commission to be deposited in the
31 purse fund.

- 1 (d) One-half of one percent to the commission to be deposited in the
2 racing promotion fund.
- 3 (2) After eleven million dollars is wagered in all parimutuel wagering in
4 each biennium, of the amount wagered by account wagering in win,
5 place, and show parimutuel pools, the licensee shall pay:
- 6 (a) One-sixteenth of one percent to the state treasurer to be
7 deposited in the general fund.
- 8 (b) One-sixteenth of one percent to the commission to be deposited
9 in the breeders' fund.
- 10 (c) One-sixteenth of one percent to the commission to be deposited
11 in the purse fund.
- 12 (d) One-sixteenth of one percent to the commission to be deposited
13 in the racing promotion fund.
- 14 b. In daily double, quinella, exacta, trifecta, or other combination parimutuel
15 pools, the licensee may deduct no more than twenty-five percent of the
16 amount wagered.
- 17 (1) Before eleven million dollars is wagered in each biennium, of the
18 amount wagered by account wagering in daily double, quinella, exacta,
19 trifecta, or other combination parimutuel pools, the licensee shall pay:
- 20 (a) Two and one-half percent to the state treasurer to be deposited
21 in the general fund.
- 22 (b) One-half of one percent to the commission to be deposited in the
23 breeders' fund.
- 24 (c) One-half of one percent to the commission to be deposited in the
25 purse fund.
- 26 (d) One-half of one percent to the commission to be deposited in the
27 racing promotion fund.
- 28 (2) After eleven million dollars is wagered in all parimutuel wagering in
29 each biennium, of the amount wagered by account wagering in daily
30 double, quinella, exacta, trifecta, or other combination parimutuel pools,
31 the licensee shall pay:

- 1 (a) One-sixteenth of one percent to the state treasurer to be
2 deposited in the general fund.
- 3 (b) One-sixteenth of one percent to the commission to be deposited
4 in the breeders' fund.
- 5 (c) One-sixteenth of one percent to the commission to be deposited
6 in the purse fund.
- 7 (d) One-sixteenth of one percent to the commission to be deposited
8 in the racing promotion fund.
- 9 3. ~~Unclaimed tickets and breakage from each live race meet and simulcast program~~
10 ~~as defined by the commission and the percentage of the wagering pool to be paid~~
11 ~~to the racing promotion fund under subsections 1 and 2 must be retained by the~~
12 ~~commission in a special fund to assist in improving and upgrading racetracks in the~~
13 ~~state, for the promotion of horse racing within the state, and in developing new~~
14 ~~racetracks in the state as necessary and approved by the commission.~~
15 ~~Notwithstanding this section, the commission may receive no more than twenty five~~
16 ~~percent of this fund for the purpose of payment of operating expenses of the~~
17 ~~commission. For wagering handle in excess of eleven million dollars in each~~
18 ~~biennium, breakage must be divided, one third to the North Dakota racing~~
19 ~~commission to be deposited in the promotion fund, one third to the charity~~
20 ~~operating the site where the wagers are placed, and one third to the service~~
21 ~~provider. For all parimutuel wagering the licensee shall pay to the commission the~~
22 ~~amount due for all unclaimed tickets and all breakage to be deposited in the racing~~
23 ~~promotion fund.~~
- 24 4. The licensee conducting a wagering on live race meet or racing, simulcast
25 ~~program~~ wagering, or account wagering shall retain all other money in the
26 parimutuel pool and pay it to bettors holding winning tickets as provided by rules
27 adopted by the commission.
- 28 5. A licensee may not use any of the portion deducted for expenses under
29 subsections 1 and 2 for expenses not directly incurred by the licensee in
30 conducting parimutuel racing under the certificate system. After paying qualifying
31 expenses, the licensee shall use the remainder of the amount so withheld only for

3 6. The ~~racing~~ commission shall deposit the moneys received pursuant to
4 subsections 1, 2, and 3 and from the North Dakota horse racing foundation
5 pursuant to subsection 5 of section 53-06.2-05 in ~~three special funds in the state~~
6 ~~treasury. These funds must be known as the breeders' fund, the purse fund, and~~
7 ~~the racing promotion fund. Moneys, and any earnings on the moneys, in the~~
8 ~~breeders' fund, purse fund, and racing promotion fund are appropriated to the~~
9 ~~commission on a continuing basis to carry out the purposes of those funds under~~
10 ~~this chapter and must be administered and disbursed in accordance with rules~~
11 ~~adopted by the commission. The commission may receive no more than~~
12 ~~twenty-five percent of the racing promotion fund for the payment of the~~
13 ~~commission's operating expenses.~~

16 1. ~~For each day of a live race meet or a simulcast day in this state on win, place, and~~
17 ~~show parimutuel pools, the licensee shall deduct up to twenty percent of the total~~
18 ~~win, place, and show pool. One half of one percent must be paid to the North~~
19 ~~Dakota racing commission to be used for the North Dakota purse fund. One half of~~
20 ~~one percent must be paid to the North Dakota racing commission to be used for~~
21 ~~the North Dakota breeders' fund for the respective breed of horses racing at that~~
22 ~~meet. On the first thirty five million five hundred thousand dollars of total wagering~~
23 ~~handle in each biennium, two percent must be paid to the state treasurer to be~~
24 ~~deposited in the general fund. On the total wagering handle in excess of thirty five~~
25 ~~million five hundred thousand dollars in each biennium, one half of one percent~~
26 ~~must be paid to the state treasurer to be deposited in the general fund.~~

27 2. ~~For each day of a live race meet or a simulcast day in this state for each daily~~
28 ~~double, quinella, exacta, trifecta, or other wager combining two or more horses for~~
29 ~~winning payoffs, the licensee shall deduct up to twenty five percent of each~~
30 ~~wagering pool. Of each wagering dollar, the amounts to be deposited in the~~
31 ~~general fund and other funds are as follows:~~

- 1 a. ~~On the first one hundred two million four hundred thousand dollars of~~
2 ~~wagering handle in each biennium, one half of one percent must be paid to~~
3 ~~the commission to be deposited in the purse fund; one half of one percent~~
4 ~~must be paid to the commission to be deposited in the promotion fund;~~
5 ~~one half of one percent must be paid to the commission to be deposited in the~~
6 ~~breeders' fund; and two and one half percent must be paid to the state~~
7 ~~treasurer to be deposited in the general fund.~~
- 8 b. ~~On the wagering handle in excess of one hundred two million four hundred~~
9 ~~thousand dollars in each biennium, one half of one percent must be paid to~~
10 ~~the commission to be deposited in the purse fund; one half of one percent~~
11 ~~must be paid to the commission to be deposited in the promotion fund;~~
12 ~~one half of one percent must be paid to the commission to be deposited in the~~
13 ~~breeders' fund; and one fourth of one percent must be paid to the state~~
14 ~~treasurer to be deposited in the general fund.~~
- 15 3. ~~Unclaimed tickets and breakage from each live race meet and simulcast program~~
16 ~~as defined by the commission and the percentage of the wagering pool to be paid~~
17 ~~to the racing promotion fund under subsections 1 and 2 must be retained by the~~
18 ~~commission in a special fund to assist in improving and upgrading racetracks in the~~
