

HOUSE BILL NO. 1068

Introduced by

1 A BILL for an Act to amend and reenact section 39-06.2-06, subsections 8, 10, and 12 of
2 section 39-06.2-10, and section 39-06.2-16 of the North Dakota Century Code, relating to
3 commercial driver's licenses.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 39-06.2-06 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **39-06.2-06. Commercial driver's license required.**

8 1. Except when driving under a commercial driver's instruction permit and
9 accompanied by the holder of a commercial driver's license valid for the vehicle
10 being driven, no person may drive a commercial motor vehicle on the highways of
11 this state unless the person holds and is in immediate possession of a commercial
12 driver's license with applicable endorsements valid for the vehicle the person is
13 driving. This subsection does not apply:

14 a. When the vehicle being driven is a house car or a vehicle towing a travel
15 trailer being used solely for personal rather than commercial purposes.

16 b. When the vehicle being driven constitutes emergency or firefighting
17 equipment necessary to the preservation of life or property.

18 c. When the vehicle is being driven for military purposes, subject to any
19 limitations imposed by 49 CFR part 383.3(c).

20 2. No person may drive a commercial motor vehicle on the highways of this state
21 while the person's driving privilege is suspended, revoked, or canceled, while
22 subject to a disqualification.

23 3. The provisions of this chapter are waived, as to farm-to-market operations by
24 farmers, but limited to those operators of a farm vehicle that is:

- 1 a. Controlled and operated by a farmer.
- 2 b. Used to transport either agricultural products, farm machines, farm supplies,
3 or both, to or from a farm.
- 4 c. Not used in the operations of a common or contract carrier.
- 5 d. Used within one hundred fifty miles [241.40 kilometers] of the person's farm.
- 6 4. The provisions of this chapter are waived as to an individual employed by and
7 operating a vehicle at the request of and within a political subdivision, with a
8 population of less than three thousand, during an emergency declared by that
9 political subdivision for the removal of snow and ice. This waiver only applies
10 when the regularly employed driver is unavailable or the employing political
11 subdivision determines that additional assistance is required.
- 12 5. Pursuant to the limitations imposed by 49 CFR, part 383.3, the required knowledge
13 and skills tests may be waived and a restricted commercial driver's license issued
14 to employees of agrichemical businesses, custom harvesters, farm retail outlets
15 and suppliers, and livestock feeders.

16 **SECTION 2. AMENDMENT.** Subsections 8, 10, and 12 of section 39-06.2-10 of the
17 North Dakota Century Code are amended and reenacted as follows:

- 18 8. For a second or subsequent conviction of driving while under the influence or being
19 under the influence of a controlled substance or refusal to be tested while
20 operating a noncommercial motor vehicle, a commercial driver's licenseholder
21 must be disqualified from operating a commercial motor vehicle for life.
- 22 10. For a second or subsequent conviction for leaving the scene of an accident while
23 operating a noncommercial motor vehicle, a commercial driver's licenseholder
24 must be disqualified from operating a commercial motor vehicle for life.
- 25 12. For a second or subsequent conviction for using a vehicle to commit a felony while
26 operating a noncommercial motor vehicle, a commercial driver's licenseholder
27 must be disqualified from operating a commercial motor vehicle for life.

28 **SECTION 3. AMENDMENT.** Section 39-06.2-16 of the North Dakota Century Code is
29 amended and reenacted as follows:

30 **39-06.2-16. Reciprocity.**

- 1 1. Notwithstanding any other provision of law, a person may drive a commercial
2 motor vehicle in this state if the person has a valid commercial driver's license or
3 commercial driver's license instruction permit issued by any state, or province or
4 territory of Canada, in accordance with the minimum federal standards for the
5 issuance of a commercial motor vehicle driver's license, if the person's license or
6 permit is not suspended, revoked, or canceled, and if the person is not disqualified
7 from driving a commercial motor vehicle.
- 8 2. The director must give all out-of-state convictions full faith and credit if the driver is
9 licensed by this state at the time of the conviction or becomes licensed by this state
10 at a later time and treat them for sanctioning purposes under this chapter as if they
11 occurred in this state. For purposes of this section, originals, photostatic copies, or
12 electronic transmissions of the records of the driver's licensing or other authority of
13 the other jurisdiction are sufficient evidence whether or not they are certified
14 copies.
