7	Century Code is amended and reenacted as follows:					
8	3.	The	appointments and terms of committee members are as follows:			
9		a.	The governor shall appoint two committee members for two-year terms,			
10			beginning on August first in each odd-numbered even-numbered year.			
11		b.	The legislative council shall appoint one member from each house of the			
12			legislative assembly for two-year terms, beginning on August first in each			
13			odd-numbered year.			
14		c.	The governing board of the association for retarded citizens arc of North			
15			Dakota shall appoint one committee member for a three-year term, beginning			
16			on August first in each year that is evenly divisible by three.			
17		d.	The governing board of people first of a North Dakota nonprofit advocacy			
18			group for people with disabilities shall appoint one committee member for a			

19three-year term, beginning on August first in each year that is evenly divisible20by three with a remainder of one. Whenever an appointment to this position

- 21 is to be made, the other members of the committee shall select a North
- 22 Dakota nonprofit advocacy group for people with disabilities to make this
  23 appointment.
