**HCR 3035:** A concurrent resolution proclaiming February 12, 2008, through February 12, 2010, the official observance of the bicentennial of Abraham Lincoln's birth.

Reps. S. Kelsh, Gulleson, Owens and Sens. Anderson, Mathern introduced:

**HCR 3036:** A concurrent resolution urging Congress and the President of the United States to enact federal legislation to deny unintended tax benefits to foreign subsidiaries of United States companies which are set up in tax haven countries.

Reps. Berg, Boucher, Delzer and Sens. Stenehjem, J. Lee, O'Connell introduced:

**HCR 3039:** A concurrent resolution urging the United States Secretary of Commerce to complete a Taiwan-United States free trade agreement.

**HCR 3043:** A concurrent resolution proclaiming January 29, 2007, as American Cancer Society Awareness Day.
