1 A BILL for an Act to amend and reenact section 1-02-06.1, subsection 2 of section 1-02-09,
2 sections 1-02-09.2, 4-05.1-19, 15-10-42, 15-10-43, and 15-11-39, subsection 5 of section
3 15-39.1-05.2, subsection 3 of section 15.1-02-13, section 15.1-02-15, subsection 3 of section
4 15.1-06-08, subsection 4 of section 15.1-06-08.1, sections 15.1-21-10 and 16.1-01-17,
5 subsection 5 of section 18-11-15, section 24-02-46, subsection 3 of section 25-01.3-02,

21 agency of the legislative branch; to repeal section 49-21-22.2 of the North Dakota Century
22 Code, relating to the regulatory reform review commission; and to authorize replacement of
23 obsolete terms.

1 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

2 **SECTION 1. AMENDMENT.** Section 1-02-06.1 of the North Dakota Century Code is
3 amended and reenacted as follows:

4 **1-02-06.1. Journal entry rule - Presumption of validity of legislation.** A bill or
5 resolution passed by the senate and the house of representatives of the legislative assembly as
6 evidenced by the journals of the senate and house is presumed to be the bill or resolution that
7 is signed by the presiding officers of the senate and house, presented to the governor, and filed
8 with the secretary of state. If there is a difference between versions of a bill, the legislative
9 council ~~staff~~ shall direct the publisher of the code to publish the law according to this section.
10 The law as published must be presumed valid until determined otherwise by an appropriate
11 court.

12 **SECTION 2. AMENDMENT.** Subsection 2 of section 1-02-09 of the North Dakota
13 Century Code is amended and reenacted as follows:

14 2. Whenever two or more concurrent resolutions, adopted during the same session of
15 the legislative assembly, propose to create or amend, or amend and repeal, the
16 same section of the Constitution of North Dakota, the secretary of state, in
17 consultation with the attorney general, shall determine if the proposals are
18 irreconcilable, and if they are irreconcilable, the resolution last adopted by the
19 legislative assembly, as determined by the legislative council ~~or its designee~~ must
20 be placed on the ballot for the appropriate election for approval or disapproval by
21 the electorate.

22 **SECTION 3. AMENDMENT.** Section 1-02-09.2 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **1-02-09.2. Reconciliation of conflicting proposed amendments to the**
25 **constitution.** If two or more concurrent resolutions propose to amend or create the same
26 section of the Constitution of North Dakota, and the proposed sections are reconcilable, the
27 legislative council, ~~or its designee~~, shall prepare a reconciled text and submit it to the secretary
28 of state for inclusion in the appropriate ballot.

29 **SECTION 4. AMENDMENT.** Section 4-05.1-19 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **4-05.1-19. State board of agricultural research and education - Duties.** Within the
2 policies of the state board of higher education, the state board of agricultural research and
3 education is responsible for budgeting and policymaking associated with the agricultural
4 experiment station and the North Dakota state university extension service. The state board of
5 agricultural research and education shall:

- 6 1. Determine the causes of any adverse economic impacts on crops and livestock
7 produced in this state;
- 8 2. Develop ongoing strategies for the provision of research solutions and resources
9 to negate adverse economic impacts on crops and livestock produced in this state;
- 10 3. Develop ongoing strategies for the dissemination of research information through
11 the extension service;
- 12 4. Implement the strategies developed under subsections 2 and 3, subject to
13 approval by the state board of higher education;
- 14 5. Develop, with the agricultural experiment station and the North Dakota state
15 university extension service, an annual budget for the operations of these entities;
- 16 6. Develop a biennial budget request and submit that request to the president of
17 North Dakota state university and the state board of higher education;
- 18 7. Maximize the use of existing financial resources, equipment, and facilities to
19 generate the greatest economic benefit from research and extension efforts and to
20 promote efficiency;
- 21 8. Annually evaluate the results of research and extension activities and expenditures
22 and report the findings to the legislative ~~council~~ executive committee and the state
23 board of higher education;
- 24 9. Advise the president of North Dakota state university regarding the recruitment,
25 selection, and performance of the vice president of agricultural affairs, the
26 extension service director, and the station director; and
- 27 10. Present a status report to the budget section of the legislative ~~council~~ executive
28 committee.

29 **SECTION 5. AMENDMENT.** Section 15-10-42 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **15-10-42. Faculty - English pronunciation - Policy - Report.** The state board of
2 higher education shall create a policy for all institutions under its control, relating to the
3 assessment of faculty and teaching assistant communication skills, including the ability to
4 speak English clearly and with good pronunciation, the notification to students of opportunities
5 to file complaints, the process for responding to student complaints, and the resolution of
6 reported communication problems. ~~Before July 1, 2006, the state board of higher education~~
7 ~~shall report to the legislative council regarding implementation of the policy.~~

8 **SECTION 6. AMENDMENT.** Section 15-10-43 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **15-10-43. Veterinary medical education program - Kansas state university -**
11 **Contract.**

- 12 1. In addition to any contracts under section 15-10-28.2, the state board of higher
13 education may contract with Kansas state university to provide an opportunity for
14 up to five eligible students to enroll in the veterinary medical education program at
15 Kansas state university.
- 16 2. Eligible students must be residents of this state and must have been selected for
17 enrollment by an admissions committee consisting of one faculty member from the
18 department of veterinary and microbiological sciences at North Dakota state
19 university, one veterinarian practicing in this state, one member of the legislative
20 assembly, and one livestock producer, all of whom must be appointed by the
21 legislative ~~council~~ executive committee, and the chairman of the admissions
22 committee at the Kansas state university school of veterinary medicine. The
23 legislative ~~council~~ executive committee and the chairman of the admissions
24 committee at the Kansas state university school of veterinary medicine may select
25 an alternative for each of the designated positions to serve as necessary.
- 26 3. The admissions committee shall determine the criteria to be used in the selection
27 of eligible students, with eligible students interested in large animal veterinary
28 medicine receiving a priority.

29 **SECTION 7. AMENDMENT.** Section 15-11-39 of the North Dakota Century Code is
30 amended and reenacted as follows:

31 **15-11-39. Nursing education consortium - Continuing appropriation.**

- 1 1. The university of North Dakota college of nursing shall establish and administer a
2 nursing education consortium for the purpose of addressing common concerns in
3 nursing education which produce obstacles in meeting the state's current and
4 future nursing needs, with a focus on the specific needs of rural communities.
- 5 2. The consortium membership must include representation of the university of North
6 Dakota college of nursing, the university of North Dakota center for rural health,
7 and the board of nursing. In addition, each nursing program in this state which is
8 approved by the board of nursing and each nursing program with approval pending
9 which is located in this state must be invited to have representation in the
10 consortium. The consortium members may invite interested persons to join the
11 consortium membership or to participate in consortium activities. Interested
12 persons may include the North Dakota nurses association nursing practice council
13 leadership team; North Dakota hospital association; workforce partners, including
14 job service North Dakota, the department of commerce division of workforce
15 development, rural leadership of North Dakota, and the North Dakota workforce
16 development council; employer partners; and other interested public and private
17 parties. The dean of the university of North Dakota college of nursing shall serve
18 as chairman of the consortium from July 1, 2007, through December 31, 2009,
19 during which the dean shall report to the legislative ~~council~~ executive committee.
20 After 2009, the chairman must be chosen by the members.
- 21 3. If the consortium secures nonstate funds to cover the capital costs of a mobile
22 clinical nursing simulation laboratory program, the consortium may establish a
23 mobile clinical nursing simulation laboratory program to travel the state and
24 provide clinical education for nursing students of nursing education programs in
25 the state and provide clinical education on current and emerging approaches to
26 nursing excellence to medical facility staff.
- 27 4. If the consortium establishes a mobile clinical nursing simulation laboratory
28 program, the consortium shall establish a strategic plan for the ongoing activities of
29 the simulation laboratory program, including goals and benchmarks for the
30 implementation of the simulation laboratory program.

1 5. The consortium may contract with a third party in conducting the duties of the
2 consortium and may seek, receive, and accept from any source aid or
3 contributions of money, property, labor, or other things of value to be held, used,
4 and applied to carry out the purposes of the consortium. Any money received by
5 the consortium as gifts, grants, or donations is appropriated as a continuing
6 appropriation for the purpose of funding the simulation laboratory program and the
7 activities of the consortium.

8 **SECTION 8. AMENDMENT.** Subsection 5 of section 15-39.1-05.2 of the North Dakota
9 Century Code is amended and reenacted as follows:

10 5. Shall submit to the legislative ~~council's~~ executive committee's employee benefits
11 programs committee any necessary or desirable changes in statutes relating to the
12 administration of the fund.

13 **SECTION 9. AMENDMENT.** Subsection 3 of section 15.1-02-13 of the North Dakota
14 Century Code is amended and reenacted as follows:

15 3. The superintendent of public instruction shall:
16 a. Compile the information required by this section in a manner that allows for
17 accurate comparisons; and
18 b. Forward a copy of the compiled information to the governor and the ~~chairman~~
19 of the legislative council.

20 **SECTION 10. AMENDMENT.** Section 15.1-02-15 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **15.1-02-15. No Child Left Behind Act - Information required.** Whenever the
23 superintendent of public instruction determines that any bill or amendment under consideration
24 by an interim committee of the legislative ~~council~~ executive committee or by a standing
25 committee or a conference committee of the legislative assembly contains a provision required
26 by the No Child Left Behind Act of 2001 [Pub. L. 107-110; 115 Stat. 1425; 20 U.S.C. 6301,
27 et seq.] or by federal regulations promulgated to implement that Act, the superintendent shall
28 provide the members of the appropriate committee with the specific language of the No Child
29 Left Behind Act which sets forth the requirement, together with the statutory citation for that
30 language, or the specific language of the federal regulations which sets forth the requirement,
31 together with the citation for the regulations.

1 **SECTION 11. AMENDMENT.** Subsection 3 of section 15.1-06-08 of the North Dakota
2 Century Code is amended and reenacted as follows:

3 3. If the superintendent of public instruction, after receipt and consideration of an
4 application for a waiver of a rule governing the accreditation of schools under this
5 section approves the waiver, the superintendent shall file a report with ~~a committee~~
6 ~~designated by the legislative council.~~ The report must cite the accreditation rule
7 that was waived, provide a detailed account of the reasons for which the rule was
8 waived, and state the time period for which the rule was waived. If the
9 superintendent of public instruction denies an application for a waiver under this
10 section, the superintendent shall file a notice of denial with the ~~committee~~
11 ~~designated by the legislative council.~~ If requested ~~by the chairman of the~~
12 ~~committee,~~ the superintendent shall appear ~~before the committee~~ and respond to
13 questions regarding the approval or denial of any application for a waiver.

14 **SECTION 12. AMENDMENT.** Subsection 4 of section 15.1-06-08.1 of the North
15 Dakota Century Code is amended and reenacted as follows:

16 4. If the superintendent of public instruction, after receipt and consideration of an
17 application for a waiver under this section, approves the waiver, the superintendent
18 shall file a report with ~~a committee designated by the legislative council.~~ The
19 report must provide a detailed account of the reasons for which the waiver was
20 granted and the specific time period for the waiver. If the superintendent of public
21 instruction denies an application for a waiver under this section, the superintendent
22 shall file a notice of denial with the ~~committee designated by the legislative council.~~
23 If requested ~~by the chairman of the committee,~~ the superintendent shall appear
24 ~~before the committee~~ and respond to questions regarding the approval or denial of
25 any application for a waiver under this section.

26 **SECTION 13. AMENDMENT.** Section 15.1-21-10 of the North Dakota Century Code is
27 amended and reenacted as follows:

28 **15.1-21-10. Test scores - Publication.** Upon receiving notice that the compilation of
29 test scores has been completed, the superintendent of public instruction shall inform the
30 legislative council. The superintendent shall present the test scores publicly for the first time at
31 a meeting of a legislative committee designated by the legislative ~~council~~ executive committee.

1 At the meeting, the superintendent and representatives of the testing service that created the
2 tests shall provide detailed testimony regarding the testing instrument, the methodology used to
3 test and assess the students, the established cut scores, the methodology used to determine
4 the cut scores, the validation of all test products, and the significance of the test scores.

5 **SECTION 14. AMENDMENT.** Section 16.1-01-17 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **16.1-01-17. Estimated fiscal impact of an initiated measure.** At least ninety days
8 before a statewide election at which an initiated measure will be voted upon, the legislative
9 council shall coordinate the determination of the estimated fiscal impact of the initiated
10 measure. Upon notification from the secretary of state that signed petitions have been
11 submitted for placement of an initiated measure on the ballot, the legislative ~~council~~ executive
12 committee shall hold hearings, receive public testimony, and gather information on the
13 estimated fiscal impact of the measure. Each agency, institution, or department shall provide
14 information requested in the format and timeframe prescribed by the legislative council ~~or its~~
15 ~~designated committee~~ for identifying the estimated fiscal impact of an initiated measure. At
16 least thirty days ~~prior to~~ before the public vote on the measure, the legislative council shall
17 submit a statement of the estimated fiscal impact of the measure to the secretary of state.
18 Upon receipt, the secretary of state shall include a notice within the analysis required by section
19 16.1-01-07 specifying where copies of the statement of the estimated fiscal impact can be
20 obtained. Within thirty days of the close of the first complete fiscal year after the effective date
21 of an initiated measure approved by the voters, the agencies, institutions, or departments that
22 provided the estimates of the fiscal impact of the measure to the legislative ~~council~~ executive
23 committee under this section shall submit a report to the legislative council on the actual fiscal
24 impact for the first complete fiscal year resulting from provisions of the initiated measure and a
25 comparison to the estimates provided to the legislative ~~council~~ executive committee under this
26 section and the legislative council shall issue a report of the actual fiscal impact of the initiated
27 measure.

28 **SECTION 15. AMENDMENT.** Subsection 5 of section 18-11-15 of the North Dakota
29 Century Code is amended and reenacted as follows:

30 5. With the consent of the governing body of the city involved, upon the advice of its
31 actuary that the pension schedule can be implemented on an actuarially sound

1 basis and notification to the legislative council's executive committee's employee
2 benefits programs committee, and in substitution for the pension payment
3 schedule provided in subsection 1, 3, or 4, a firefighters relief association shall pay
4 a monthly service pension to members of the association with the following
5 qualifications, the following amount:

1 **SECTION 16. AMENDMENT.** Section 24-02-46 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **24-02-46. Multistate highway transportation agreement.** The director may join the
4 multistate highway transportation agreement to promote uniformity among participating
5 jurisdictions in vehicle size and weight standards. The legislative council shall review the
6 guidelines for eligible voting members of the cooperating committee formed by the agreement
7 and the legislative executive committee shall appoint a member of the house standing
8 transportation committee and a member of the senate standing transportation committee or
9 their designees as the legislative members representing this state to the cooperating committee
10 formed by the agreement.

11 **SECTION 17. AMENDMENT.** Subsection 3 of section 25-01.3-02 of the North Dakota
12 Century Code is amended and reenacted as follows:

- 13 3. The appointments and terms of committee members are as follows:
- 14 a. The governor shall appoint two committee members for two-year terms,
15 beginning on August first in each even-numbered year.
 - 16 b. The legislative ~~council~~ executive committee shall appoint one member from
17 each house of the legislative assembly for two-year terms, beginning on
18 August first in each odd-numbered year.
 - 19 c. The governing board of the arc of North Dakota shall appoint one committee
20 member for a three-year term, beginning August first in each year that is
21 evenly divisible by three.
 - 22 d. The governing board of a North Dakota nonprofit advocacy group for people
23 with disabilities shall appoint one committee member for a three-year term,
24 beginning on August first in each year that is divisible by three with a
25 remainder of one. Whenever an appointment to this position is to be made,
26 the other members of the committee shall select a North Dakota nonprofit
27 advocacy group for people with disabilities to make this appointment.
 - 28 e. The governing board of the mental health association in North Dakota shall
29 appoint one committee member for a three-year term, beginning on
30 August first in each year that is divisible by three with a remainder of two.

1 **SECTION 18. AMENDMENT.** Subsection 3 of section 25-02-01.1 of the North Dakota
2 Century Code is amended and reenacted as follows:

3 3. The governing body must be composed of the executive director of the department
4 of human services; the director of the division of mental health services of the
5 department, who shall serve as chairman of the governing body; the state hospital
6 superintendent; the state hospital medical director; a representative of the fiscal
7 management of the state hospital; a mental health services consumer selected by
8 the mental health association; and a legislator selected by the legislative ~~council~~
9 executive committee. The governing body may include other persons as
10 appointed by the governing body.

11 **SECTION 19. AMENDMENT.** Section 26.1-36.4-06 of the North Dakota Century Code
12 is amended and reenacted as follows:

13 **26.1-36.4-06. Modified community rating.** Premium rates for individual policies are
14 subject to the following:

- 15 1. For any class of individuals, the premium rates charged during a rating period to
16 the individuals in that class for the same or similar coverage may not vary by a
17 ratio of more than six to one after August 1, 1995, and by a ratio of more than five
18 to one after August 1, 1996, when age, industry, gender, and duration of coverage
19 of the individuals are considered. Gender and duration of coverage may not be
20 used as a rating factor for policies issued after January 1, 1997.
- 21 2. An insurer, in addition to the factors set forth in subsection 1, may use geography,
22 family composition, healthy lifestyles, and benefit variations to determine premium
23 rates.
- 24 3. The commissioner shall design and adopt reporting forms to be used by an insurer
25 to report information as to insurer's experience as to insurance provided under this
26 chapter on a periodic basis to determine the impact of the reforms and
27 implementation of modified community rating contained in this chapter and the
28 commissioner shall report to the legislative assembly or ~~a committee designated~~
29 ~~by the legislative council~~ the findings of the commissioner.

30 **SECTION 20. AMENDMENT.** Section 28-32-03 of the North Dakota Century Code is
31 amended and reenacted as follows:

1 **28-32-03. Emergency rules.**

- 2 1. If the agency, with the approval of the governor, finds that emergency rulemaking
3 is necessary, the agency may declare the proposed rule to be an interim final rule
4 effective on a date no earlier than the date of filing with the legislative council of
5 the notice required by section 28-32-10.
- 6 2. A proposed rule may be given effect on an emergency basis under this section if
7 any of the following grounds exists regarding that rule:
- 8 a. Imminent peril threatens public health, safety, or welfare, which would be
9 abated by emergency effectiveness;
- 10 b. A delay in the effective date of the rule is likely to cause a loss of funds
11 appropriated to support a duty imposed by law upon the agency;
- 12 c. Emergency effectiveness is reasonably necessary to avoid a delay in
13 implementing an appropriations measure; or
- 14 d. Emergency effectiveness is necessary to meet a mandate of federal law.
- 15 3. A final rule adopted after consideration of all written and oral submissions
16 respecting the interim final rule, which is substantially similar to the interim final
17 rule, is effective as of the declared effective date of the interim final rule.
- 18 4. The agency's finding, and a brief statement of the agency's reasons for the finding,
19 must be filed with the ~~office of the~~ legislative council with the final adopted
20 emergency rule.
- 21 5. The agency shall take appropriate measures to make interim final rules known to
22 every person who may be affected by them.
- 23 6. An interim final rule is ineffective one hundred eighty days after its declared
24 effective date unless first adopted as a final rule.

25 **SECTION 21. AMENDMENT.** Section 28-32-06 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **28-32-06. Force and effect of rules.** Upon becoming effective, rules have the force
28 and effect of law until amended or repealed by the agency, declared invalid by a final court
29 decision, suspended or found to be void by the administrative rules committee, or determined
30 repealed by the ~~office of the~~ legislative council because the authority for adoption of the rules is
31 repealed or transferred to another agency.

1 **SECTION 22. AMENDMENT.** Section 28-32-07 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **28-32-07. Deadline for rules to implement statutory change.** Any rule change,
4 including a creation, amendment, or repeal, made to implement a statutory change must be
5 adopted and filed with the ~~office of the~~ legislative council within nine months of the effective
6 date of the statutory change. If an agency needs additional time for the rule change, a request
7 for additional time must be made to the legislative council. The legislative council may extend
8 the time within which the agency must adopt the rule change if the request by the agency is
9 supported by evidence that the agency needs more time through no deliberate fault of its own.

10 **SECTION 23. AMENDMENT.** Subsection 1 of section 28-32-10 of the North Dakota
11 Century Code is amended and reenacted as follows:

- 12 1. An agency shall prepare a full notice and an abbreviated notice of rulemaking.
- 13 a. The agency's full notice of the proposed adoption, amendment, or repeal of a
14 rule must include a short, specific explanation of the proposed rule and the
15 purpose of the proposed rule, a determination of whether the proposed
16 rulemaking is expected to have an impact on the regulated community in
17 excess of fifty thousand dollars, identify at least one location where interested
18 persons may review the text of the proposed rule, provide the address to
19 which written comments concerning the proposed rule may be sent, provide
20 the deadline for submission of written comments, provide a telephone number
21 at which a copy of the rules and regulatory analysis may be requested, and,
22 in the case of a substantive rule, provide the time and place set for each oral
23 hearing. The agency's full notice must be filed with the ~~office of the~~ legislative
24 council, and the agency shall request publication of an abbreviated
25 newspaper publication notice at least once in each official county newspaper
26 published in this state. The notice filed with the ~~office of the~~ legislative council
27 must be accompanied by a copy of the proposed rules.
- 28 b. The abbreviated newspaper publication of notice must be in a display-type
29 format with a minimum width of one column of approximately two inches
30 [5.08 centimeters] and a depth of from three inches [7.62 centimeters] to four
31 inches [10.16 centimeters] with a headline describing the general topic of the

1 proposed rules. The notice must also include the telephone number or
2 address to use to obtain a copy of the proposed rules, the address to use and
3 the deadline to submit written comments, and the location, date, and time of
4 the public hearing on the rules.

5 **SECTION 24. AMENDMENT.** Section 28-32-15 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **28-32-15. Filing of rules for publication - Effective date of rules.**

8 1. A copy of each rule adopted by an administrative agency, a copy of each written
9 comment and a written summary of each oral comment on the rule, and the
10 attorney general's opinion on the rule must be filed by the adopting agency with the
11 ~~office of the~~ legislative council for publication of the rule in the North Dakota
12 Administrative Code.

13 2. a. Nonemergency rules approved by the attorney general as to legality, adopted
14 by an administrative agency, and filed with the ~~office of the~~ legislative council
15 and not voided or held for consideration by the administrative rules committee
16 become effective according to the following schedule:

17 (1) Rules filed with the legislative council from August sixteenth through
18 November fifteenth become effective on the immediately succeeding
19 January first.

20 (2) Rules filed with the legislative council from November sixteenth through
21 February fifteenth become effective on the immediately succeeding
22 April first.

23 (3) Rules filed with the legislative council from February sixteenth through
24 May fifteenth become effective on the immediately succeeding July
25 first.

26 (4) Rules filed with the legislative council from May sixteenth through
27 August fifteenth become effective on the immediately succeeding
28 October first.

29 b. If publication is delayed for any reason other than action of the administrative
30 rules committee, nonemergency rules, unless otherwise provided, become
31 effective when publication would have occurred but for the delay.

1 c. A rule held for consideration by the administrative rules committee becomes
2 effective on the first effective date of rules under the schedule in subdivision a
3 following the meeting at which that rule is reconsidered by the committee.

4 **SECTION 25. AMENDMENT.** Section 28-32-17 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **28-32-17. Administrative rules committee objection.** If the legislative council's
7 ~~executive committee's~~ administrative rules committee objects to all or any portion of a rule
8 because the committee deems it to be unreasonable, arbitrary, capricious, or beyond the
9 authority delegated to the adopting agency, the committee may file that objection in certified
10 form ~~in the office of~~ with the legislative council. The filed objection must contain a concise
11 statement of the committee's reasons for its action.

12 1. The ~~office of the~~ legislative council shall attach to each objection a certification of
13 the time and date of its filing and, as soon as possible, shall transmit a copy of the
14 objection and the certification to the agency adopting the rule in question. The
15 ~~office of the~~ legislative council also shall ~~also~~ maintain a permanent register of all
16 committee objections.

17 2. The ~~office of the~~ legislative council shall publish an objection filed pursuant to this
18 section in the next issue of the code supplement. In case of a filed committee
19 objection to a rule subject to the exceptions of the definition of rule in section
20 28-32-01, the agency shall indicate the existence of that objection adjacent to the
21 rule in any compilation containing that rule.

22 3. Within fourteen days after the filing of a committee objection to a rule, the adopting
23 agency shall respond in writing to the committee. After receipt of the response, the
24 committee may withdraw or modify its objection.

25 4. After the filing of a committee objection, the burden of persuasion is upon the
26 agency in any action for judicial review or for enforcement of the rule to establish
27 that the whole or portion thereof objected to is within the procedural and
28 substantive authority delegated to the agency. If the agency fails to meet its
29 burden of persuasion, the court shall declare the whole or portion of the rule
30 objected to invalid and judgment must be rendered against the agency for court

1 costs. These court costs must include a reasonable attorney's fee and must be
2 payable from the appropriation of the agency which adopted the rule in question.

3 **SECTION 26. AMENDMENT.** Section 28-32-18 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **28-32-18. Administrative rules committee may void rule - Grounds - Amendment**
6 **by agreement of agency and committee.**

7 1. The legislative ~~council's~~ executive committee's administrative rules committee may
8 find that all or any portion of a rule is void if that rule is initially considered by the
9 committee not later than the fifteenth day of the month before the date of the
10 administrative code supplement in which the rule change is scheduled to appear.
11 The administrative rules committee may find a rule or portion of a rule void if the
12 committee makes the specific finding that, with regard to that rule or portion of a
13 rule, there is:

- 14 a. An absence of statutory authority.
15 b. An emergency relating to public health, safety, or welfare.
16 c. A failure to comply with express legislative intent or to substantially meet the
17 procedural requirements of this chapter for adoption of the rule.
18 d. A conflict with state law.
19 e. Arbitrariness and capriciousness.
20 f. A failure to make a written record of its consideration of written and oral
21 submissions respecting the rule under section 28-32-11.

22 2. The administrative rules committee may find a rule void at the meeting at which the
23 rule is initially considered by the committee or may hold consideration of that rule
24 for one subsequent meeting. Within three business days after the administrative
25 rules committee finds that a rule is void, the ~~office of the~~ legislative council shall
26 provide written notice of that finding and the committee's specific finding under
27 subdivisions a through f of subsection 1 to the adopting agency and to the
28 chairman of the legislative ~~council~~ executive committee. Within fourteen days after
29 receipt of the notice, the adopting agency may file a petition with the chairman of
30 the legislative ~~council~~ executive committee for review by the legislative ~~council~~
31 executive committee of the decision of the administrative rules committee. If the

1 adopting agency does not file a petition for review, the rule becomes void on the
2 fifteenth day after the notice from the ~~office of the~~ legislative council to the adopting
3 agency. If within sixty days after receipt of the petition from the adopting agency
4 the legislative ~~council~~ executive committee has not disapproved by motion the
5 finding of the administrative rules committee, the rule is void.

- 6 3. An agency may amend or repeal a rule or create a related rule if, after
7 consideration of rules by the administrative rules committee, the agency and
8 committee agree that the rule amendment, repeal, or creation is necessary to
9 address any of the considerations under subsection 1. A rule amended, repealed,
10 or created under this subsection is not subject to the other requirements of this
11 chapter relating to adoption of administrative rules and may be published by the
12 legislative council as amended, repealed, or created. If requested by the agency
13 or any interested party, a rule amended, repealed, or created under this subsection
14 must be reconsidered by the administrative rules committee at a subsequent
15 meeting at which public comment on the agreed rule change must be allowed.

16 **SECTION 27. AMENDMENT.** Section 28-32-19 of the North Dakota Century Code is
17 amended and reenacted as follows:

18 **28-32-19. Publication of administrative code and code supplement.**

- 19 1. The ~~office of the~~ legislative council shall compile, index, and publish all rules filed
20 pursuant to this chapter in a publication which must be known as the North Dakota
21 Administrative Code, in this chapter referred to as the code. The code also must
22 ~~also~~ contain all objections filed with the ~~office of the~~ legislative council by the
23 administrative rules committee pursuant to section 28-32-17. ~~The code must be~~
24 ~~printed or otherwise duplicated in looseleaf form.~~ The ~~office of the~~ legislative
25 council shall revise all or part of the code as often as the legislative council ~~deems~~
26 determines necessary.
- 27 2. The ~~office of the~~ legislative council may prescribe a format, style, and arrangement
28 for rules which are to be published in the code and may refuse to accept the filing
29 of any rule that is not in substantial compliance therewith. In arranging rules for
30 publication, the ~~office of the~~ legislative council may make such corrections in
31 spelling, grammatical construction, format, and punctuation of the rules as ~~deemed~~

- 1 determined proper. The ~~office of the~~ legislative council shall keep and maintain a
2 permanent code of all rules filed, including superseded and repealed rules, which
3 must be open to public inspection during office hours.
- 4 3. The ~~office of the~~ legislative council shall compile and publish the North Dakota
5 Administrative Code supplement according to the schedule of effective dates of
6 rules in section 28-32-15.
- 7 a. The code supplement must contain all rules that have been filed with the
8 ~~office of the~~ legislative council or which have become effective since the
9 compilation and publication of the preceding issue of the code supplement.
- 10 b. The code supplement must contain all objections filed with the ~~office of the~~
11 legislative council by the administrative rules committee pursuant to section
12 28-32-17.
- 13 e. ~~The code supplement must be printed or duplicated in the same style as the~~
14 ~~code so as to permit changes to be inserted as pages in the code in lieu of~~
15 ~~the pages containing superseded material and to permit additions to the code.~~
- 16 4. The ~~office of the~~ legislative council, with the consent of the adopting agency, may
17 omit from the code or code supplement any rule the publication of which would be
18 unduly cumbersome, expensive, or otherwise inexpedient, if the rule in printed or
19 duplicated form is made available on application to the agency, and if the code or
20 code supplement contains a notice stating the general subject matter of the
21 omitted rule and stating how a copy may be obtained.
- 22 5. The code must be arranged, indexed, and printed or duplicated in a manner to
23 permit separate publication of portions thereof relating to individual agencies. An
24 agency may print as many copies of such separate portions of the code as it may
25 require. If the ~~office of the~~ legislative council does not publish the code
26 supplement due to technological problems or lack of funds, the agency whose
27 rules would have been published in the code supplement shall provide a copy of
28 the rules to any person upon request. The agency may charge a fee for a copy of
29 the rules as allowed under section 44-04-18.

30 **SECTION 28. AMENDMENT.** Section 28-32-20 of the North Dakota Century Code is
31 amended and reenacted as follows:

- 1 **28-32-20. Printing, sales, and distribution of code and code supplement.**
- 2 1. The secretary of state shall distribute the code and code supplement and shall
- 3 distribute copies of the code, revisions, and the code supplement without charge to
- 4 the following:
- 5 a. Governor, one copy.
- 6 b. Attorney general, one copy.
- 7 c. Each supreme court judge, one copy.
- 8 d. Each district court judge, one copy.
- 9 e. Each county auditor of this state, for the use of county officials and the public,
- 10 one copy.
- 11 f. Supreme court library, one copy.
- 12 g. State library, one copy.
- 13 h. Law library of the university of North Dakota, one copy.
- 14 i. Each of the five depository libraries in this state, one copy, upon request.
- 15 j. Secretary of state, one copy.
- 16 k. Legislative council, four copies.
- 17 l. Each member of the legislative assembly, one copy, upon request.
- 18 2. The ~~office of the~~ legislative council, each county auditor in the state, and the
- 19 librarians for the supreme court library, the state library, the university of North
- 20 Dakota law library, and the five depository libraries as designated according to
- 21 subsection 1 and section 54-24-09 shall maintain a complete, current set of the
- 22 code, including revisions and the code supplement.
- 23 3. The secretary of state shall make copies of and subscriptions to the code and code
- 24 supplement available to any person upon payment of the appropriate subscription
- 25 fee.
- 26 4. The ~~office of the~~ legislative council shall determine the appropriate fee for
- 27 subscribing to the code and code supplement.
- 28 5. All fees collected by the secretary of state must be deposited in the general fund of
- 29 the state treasury.

1 6. ~~The~~ If applicable, the administrative code, revisions to the administrative code, and
2 the code supplement must be considered sixth-class printing under sections
3 46-02-04 and 46-02-09.

4 **SECTION 29. AMENDMENT.** Subsection 3 of section 34-11.1-01 of the North Dakota
5 Century Code is amended and reenacted as follows:

6 3. "Employee" means any person, whether employed, appointed, or under contract,
7 providing services for the state, county, city, or other political subdivision, for which
8 compensation is paid. "Employee" also includes a person subject to the civil
9 service or merit system or civil service laws of the state government, governmental
10 agency, or a political subdivision. "Employee" does not include:

- 11 a. A person elected to public office in the state or in a political subdivision.
- 12 b. A member of the legislative council ~~staff~~.
- 13 c. A person holding an appointive statutory office.
- 14 d. One deputy or principal assistant for each elected official or appointive
15 statutory official.
- 16 e. One secretary for each elected or appointive statutory official.
- 17 f. All members of the governor's staff.

18 **SECTION 30. AMENDMENT.** Subsection 2 of section 40-63-03 of the North Dakota
19 Century Code is amended and reenacted as follows:

- 20 2. The department of commerce division of community services shall:
 - 21 a. Review all applications for renaissance zone designation against the criteria
22 established in this section and designate zones.
 - 23 b. Approve or reject the duration of renaissance zone status as submitted in an
24 application.
 - 25 c. Approve or reject the geographic boundaries and total area of the
26 renaissance zone as submitted in an application.
 - 27 d. Promote the renaissance zone program.
 - 28 e. Monitor the progress of the designated renaissance zones against submitted
29 plans in an annual plan review.

1 f. Report on renaissance zone progress to the governor and the legislative
2 council ~~executive committee~~ on an annual basis until all designated zones
3 expire.

4 **SECTION 31. AMENDMENT.** Section 44-04-18.6 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **44-04-18.6. Access to legislative records and information.** The following records,
7 regardless of form or characteristic, of or relating to the legislative council, the legislative
8 executive committee, the legislative assembly, the house of representatives, the senate, or a
9 member of the legislative assembly are not subject to section 44-04-18 and section 6 of article
10 XI of the Constitution of North Dakota: a record of a purely personal or private nature, a record
11 that is ~~attorney~~ legislative council work product or is ~~attorney-client~~ legislative council-client
12 communication, a record that reveals the content of private communications between a
13 member of the legislative assembly and any person, and, except with respect to a
14 governmental entity determining the proper use of telephone service, a record of telephone
15 usage which identifies the parties or lists the telephone numbers of the parties involved. This
16 section does not apply to any record distributed at a meeting subject to section 44-04-19 and
17 section 5 of article XI of the Constitution of North Dakota.

18 **SECTION 32. AMENDMENT.** Section 48-08-04 of the North Dakota Century Code is
19 amended and reenacted as follows:

20 **48-08-04. Use of legislative assembly rooms and halls.** During the interim between
21 legislative sessions, the committee rooms, halls, passageways, and other space in the capitol
22 used by the legislative assembly may not be used without authorization of the legislative
23 council ~~or its designee~~.

24 **SECTION 33. AMENDMENT.** Section 48-10-01 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **48-10-01. Capitol grounds planning commission.** The capitol grounds planning
27 commission consists of the lieutenant governor as chairman and eight other members selected
28 biennially as provided in this section. The governor shall appoint two citizens, one licensed
29 architect, and one representative from the state historical society as members, the president of
30 the senate shall appoint two senators as members, and the speaker of the house of
31 representatives shall appoint two representatives as members. Appointment to the commission

1 is for a term of two years. Legislative and citizen members of the planning commission are
2 entitled to per diem payments and expenses in such amount and in the same manner as
3 provided by law for members of the legislative ~~council~~ executive committee.

4 **SECTION 34. AMENDMENT.** Subsection 4 of section 49-23-03 of the North Dakota
5 Century Code is amended and reenacted as follows:

- 6 4. A nonprofit corporation shall govern the notification center. The initial
7 incorporators of the corporation may solicit bids for any services provided for the
8 operation of the center. The corporation shall provide advance notice of the first
9 organizational meeting by publication in qualified legal newspapers and in
10 appropriate trade journals and by written notice to all appropriate trade
11 associations.
- 12 a. The nonprofit corporation must be incorporated by seventeen initial
13 incorporators, with one member representing the house of representatives
14 and one member representing the senate appointed by the legislative ~~council~~
15 executive committee, one member representing telecommunications
16 companies offering local exchange service to fewer than fifty thousand
17 subscribers, one member representing telecommunications companies
18 offering local exchange service to fifty thousand or more subscribers, one
19 member representing rural water systems, one member representing rural
20 electric cooperatives, one member representing investor-owned electric
21 utilities, one member representing investor-owned natural gas utilities, one
22 member representing cable television systems, one member representing
23 cities with a population of fewer than five thousand, one member representing
24 cities with a population of at least five thousand, one member representing
25 counties, one member representing underground interstate carriers of gas,
26 one member representing interstate carriers of petroleum, one member
27 representing interstate carriers of telecommunications services, one member
28 representing contractors who perform excavation services, and one member
29 representing the production sector of the American petroleum institute. The
30 initial incorporators must represent and be designated by operators,
31 excavators, and other persons eligible to participate in the center. The

1 legislative members are entitled to the same compensation and expenses as
2 provided for members of committees of the legislative council. The legislative
3 council shall pay the compensation for the legislative members.

4 b. The initial incorporators shall establish, before August 1, 1996, a board of
5 directors of the nonprofit corporation which consists of eight members
6 representing the participants in the center. The board shall establish a
7 competitive bidding procedure to select a vendor to provide the notification
8 service, establish a procedure by which members of the center share the
9 costs of the center on a fair, reasonable, and nondiscriminatory basis, and do
10 all other things necessary to implement the purpose of the center. Any
11 agreement between the center and a vendor for the notification service may
12 be modified from time to time by the board, and any agreement shall be
13 reviewed by the board at least once every three years, with an opportunity to
14 receive new bids, if desired, by the board. An operator may submit a bid and
15 be selected to contract to provide the notification center service.

16 c. Members of the board and any of its agents are immune from any liability of
17 any kind based on any acts or omissions in the course of the performance of
18 responsibilities in an official capacity except for bodily injury arising out of
19 accidents caused by or contributed to by the negligence of the board member
20 or agent.

21 d. The board shall aid the state's attorneys of the various counties in the
22 enforcement of this chapter and the prosecution of any violations. The board
23 may institute a civil action for an injunction to enjoin violations of this chapter
24 without proof that anyone suffered actual damages.

25 e. The notification center must be in operation by March 1, 1998.

26 **SECTION 35. AMENDMENT.** Subsections 3 and 4 of section 50-09-29 of the North
27 Dakota Century Code are amended and reenacted as follows:

28 3. If the department of human services determines, subject to the approval of the
29 legislative ~~council~~ executive committee, that there is insufficient worker
30 opportunity, due to increases in the unemployment rate, to participate in work

1 activities, the department may administer the temporary assistance for needy
2 families program in a manner different than provided in subsection 1.
3 4. If the department of human services determines, subject to the approval of the
4 legislative ~~council~~ executive committee, that administration of the temporary
5 assistance for needy families program, in the manner provided by subsection 1,
6 causes otherwise eligible individuals to become a charge upon the counties under
7 chapter 50-01, the department may administer the program in a manner that
8 avoids that result.

9 **SECTION 36. AMENDMENT.** Section 52-02-18 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **52-02-18. Independent performance audit.** The state auditor ~~shall~~, upon request of
12 the legislative audit and fiscal review committee, shall cause a performance audit of job service
13 North Dakota to be conducted within twelve months after receipt of the request. The state
14 auditor may appoint an independent audit firm, with extensive expertise in job service practices
15 and standards, to complete a performance audit or the state auditor may conduct the
16 performance audit. If the state auditor completes the audit, the state auditor may contract with
17 a consulting firm to aid in the state audit or to complete the audit and shall charge job service
18 North Dakota for the audit, including the services of the consulting firm. The executive director
19 of job service North Dakota and the auditor shall present the audit report and any action taken
20 as a result of the audit to the ~~legislative council's~~ legislative audit and fiscal review committee
21 and to the house and senate industry, business and labor standing committees during the next
22 regular session of the legislative assembly following the audit.

23 **SECTION 37. AMENDMENT.** Section 54-03-02 of the North Dakota Century Code is
24 amended and reenacted as follows:

25 **54-03-02. When legislative assembly meets.**

26 1. The legislative assembly shall meet at the seat of government in the month of
27 December following the election of the members thereof for organizational and
28 orientation purposes and shall thereafter recess until the time provided in
29 subsection 2.
30 2. The legislative assembly shall reconvene at twelve noon on the first Tuesday after
31 the third day in January of the year following the organizational session as

1 provided in subsection 1 or at twelve noon on a date selected by the legislative
2 ~~council~~ executive committee but not earlier than January second nor later than
3 January eleventh of the year following the organizational session and, following the
4 close of business of the regular session, shall adjourn subject to subsection 3.

5 3. Notwithstanding a motion to adjourn sine die, the legislative assembly shall
6 reconvene as determined by the legislative ~~council~~ executive committee. The
7 number of natural days used may not exceed the number of natural days available
8 under the constitution which have not been previously used by that legislative
9 assembly in regular session under subsection 2.

10 **SECTION 38. AMENDMENT.** Section 54-03-04 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **54-03-04. Organizational session - Calling to order - Officers - Term of office -**
13 **Officers and chairmen to remain in office during special session.** The secretary and
14 officers of the senate and chief clerk and officers of the house serving at the close of a regular
15 session, unless otherwise removed, shall remain in office until the first day of the organizational
16 session. On the first day of the organizational session, at a time scheduled by the legislative
17 ~~council~~ executive committee pursuant to section 54-03.1-02, the president of the senate and
18 the speaker of the house from the previous session, if reelected, or in the speaker's absence a
19 member of the majority party of the house with seniority based upon terms of service in the
20 house, shall call the members of their respective houses so enrolled to order. In the absence
21 of the president of the senate, the president pro tempore shall call the members of the senate
22 to order. In the absence of both the president of the senate and the president pro tempore,
23 then some member or other person selected by the members present shall call the members of
24 the senate to order. If the speaker of the house from the previous session is not reelected and
25 if no party has a majority in the house, the member of the house with seniority based upon
26 terms of service in the house shall call the house to order. If two or more members of the
27 house are tied for seniority and seniority is a factor in determining who shall call the house to
28 order, the persons so tied for seniority shall draw lots to determine who shall call the house to
29 order. The members of the respective houses then may proceed to the election of the
30 necessary officers. The secretary and officers of the senate and chief clerk and officers of the
31 house of representatives, and the chairmen of all procedural and substantive standing

1 legislative committees shall continue to serve in those positions during any special legislative
2 session which may be called, except in case of the death, resignation, or removal of one of
3 those persons, whereupon the position must be filled, upon the convening of the special
4 session, in the manner provided by law or legislative rule. Members serving on procedural or
5 substantive standing committees of the senate or house during a regular session shall continue
6 to serve on those committees during any special legislative session which may be called
7 following that regular session.

8 **SECTION 39. AMENDMENT.** Section 54-03-19.2 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **54-03-19.2. Meetings - Powers and duties - Expenses.** The commission shall meet
11 at the call of the chairman as often as may be necessary, but at least once during each
12 biennium. The commission shall determine levels of legislative compensation, expense
13 allowance, and insurance benefits to be paid for service upon interim committees and during
14 legislative sessions, which permit citizens to hold legislative office without undue financial
15 sacrifice or disadvantage. In formulating recommendations, the commission may consult with
16 the leadership of the legislative assembly, and review compensation, expense allowance, and
17 insurance benefits for legislative service in other states and in other areas of state and federal
18 service and private industry. The commission shall report its findings and recommendations
19 regarding legislative compensation policy to the legislative assembly. The commission may file
20 with the legislative council a bill incorporating its recommendations. Members of the legislative
21 compensation commission must be compensated for time spent in attendance at meetings of
22 the commission and for other travel as approved by the chairman of the legislative ~~council~~
23 executive committee at the rate of sixty-two dollars and fifty cents per day and must be
24 reimbursed for their actual and necessary expenses incurred in the same manner as other
25 state officials. The expense allowance must be paid from appropriations then in effect for the
26 legislative assembly. The commission may solicit the assistance of the ~~staff of the legislative~~
27 council to provide information, aid, and assistance in carrying out its duties.

28 **SECTION 40. AMENDMENT.** Subsection 2 of section 54-03-20 of the North Dakota
29 Century Code is amended and reenacted as follows:

30 2. a. Each member of the legislative assembly is entitled to receive reimbursement
31 for lodging, which may not exceed a maximum of nine hundred dollars per

1 calendar month for lodging in state, at the rates and in the manner provided in
2 section 44-08-04 for each calendar day during the period of any
3 organizational, special, or regular session.

4 b. Notwithstanding subdivision a:

5 (1) A member of the legislative assembly may elect to be reimbursed for
6 less than the amount to which the legislator is entitled under this
7 subsection by claiming the lesser amount on a voucher submitted with
8 the receipt required by section 44-08-04.

9 (2) The legislative ~~council~~ executive committee may establish guidelines
10 that may result in a reduced maximum reimbursement for a single
11 dwelling in which two or more legislators share lodging and the total
12 rent for that dwelling exceeds the amount to which a legislator is
13 entitled under subdivision a.

14 **SECTION 41. AMENDMENT.** Section 54-03-26 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **54-03-26. Personal computers and associated software used by legislators - Fee -**
17 **Continuing appropriation.** Notwithstanding any other provision of law, a member of the
18 legislative assembly who is assigned a computer may use that computer and its associated
19 equipment and software for any use that is not in violation of section 16.1-10-02 upon payment
20 of a computer usage fee established by the legislative ~~council~~ executive committee.

21 **SECTION 42. AMENDMENT.** Section 54-03-27 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **54-03-27. Service in the legislative assembly - Leave of absence from**
24 **employment.** The executive officer in charge of a state agency, department, or institution or
25 the governing body of any political subdivision or any other employer in this state may grant a
26 leave of absence from employment to a full-time employee of that governmental entity or of that
27 employer who is a member of the legislative assembly for service during any regular or special
28 session of the legislative assembly and for attendance at a meeting of the legislative ~~council~~
29 executive committee or any of its committees. The leave of absence may be without pay, and
30 the employer may reduce or eliminate the payment of any additional benefits normally due the
31 employee while the employee is performing legislative service. If the leave of absence is

1 granted, the employer may not terminate the employment of an employee solely due to the fact
2 that the employee is absent from employment as the result of service in the legislative
3 assembly.

4 **SECTION 43. AMENDMENT.** Section 54-03.1-02 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **54-03.1-02. Time and place of meeting - Who must attend.** In each even-numbered
7 year on the first Monday in the month of December or on a date selected by the legislative
8 ~~council~~ executive committee but not earlier than December first nor later than December
9 fifteenth, all persons elected at the previous November general election as members of the
10 succeeding legislative session, and members whose terms do not expire until the first day of
11 December following the next November general election, shall meet in the state capitol in the
12 city of Bismarck, or at such other place as may be designated, at a time designated by the
13 legislative ~~council~~ executive committee for the purpose of conducting an organizational
14 session. The legislative ~~council~~ executive committee shall call the organizational session and
15 the legislative council shall make such arrangements as may be necessary for ~~its~~ operation of
16 the session.

17 **SECTION 44. AMENDMENT.** Section 54-03.2-02 of the North Dakota Century Code is
18 amended and reenacted as follows:

19 **54-03.2-02. Definitions.** As used in this code:

- 20 1. "Hearing" means any meeting in the course of an investigatory proceeding, other
21 than a preliminary conference or interview at which no testimony is taken under
22 oath, conducted by an investigating committee for the purpose of taking testimony
23 or receiving other evidence. A hearing may be open to the public or closed to the
24 public.
- 25 2. "Investigating committee" means any of the following:
 - 26 a. A standing or select committee of either house of the legislative assembly.
 - 27 b. A joint committee of both houses.
 - 28 c. An authorized subcommittee of a legislative committee.
 - 29 d. The legislative ~~council~~ executive committee and any interim committee of the
30 ~~council~~ legislative executive committee if specifically designated by the

1 ~~council~~ legislative executive committee as an investigating committee with
2 subpoena powers.

3 e. Any other body created by law, the members of which may include
4 nonlegislators.

5 Investigating committees ~~shall~~ have the power to issue subpoenas and subpoenas
6 duces tecum in the manner provided for in section 54-03.2-08. Nothing in this
7 chapter may be construed as in derogation of any power to issue subpoenas which
8 is inherent in the legislative assembly or any of its committees.

9 3. "Public hearing" means any hearing open to the public or the proceedings of which
10 are made available to the public.

11 **SECTION 45. AMENDMENT.** Section 54-05.1-02 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **54-05.1-02. Applicability - Meaning of lobbyist.**

14 1. This chapter applies to any person who, in any manner whatsoever, directly or
15 indirectly, performs any of the following activities:

16 a. Attempts to secure the passage, amendment, or defeat of any legislation by
17 the legislative assembly or the approval or veto of any legislation by the
18 governor of the state.

19 b. Attempts to influence decisions made by the legislative ~~council~~ executive
20 committee or by an interim committee of the legislative ~~council~~ executive
21 committee.

22 2. This chapter does not apply to any person who is:

23 a. A legislator.

24 b. A private citizen appearing on the citizen's own behalf.

25 c. An employee, officer, board member, volunteer, or agent of the state or its
26 political subdivisions whether elected or appointed and whether or not
27 compensated, who is acting in that person's official capacity.

28 d. Invited by the chairman of the legislative ~~council~~ executive committee, an
29 interim committee of the legislative ~~council~~ executive committee, or a
30 standing committee of the legislative assembly to appear before the ~~council~~

1 legislative executive committee, interim committee, or standing committee for
2 the purpose of providing information.

3 e. An individual who appears before a legislative committee for the sole purpose
4 of presenting testimony on behalf of a trade or professional organization or a
5 business or industry if the individual is introduced to the committee by the
6 registered lobbyist for the trade or professional organization or the business
7 or industry.

8 3. For the purposes of this chapter, persons required to register under this chapter
9 because of the performance of the activities described in subsection 1 must be
10 known as "lobbyists".

11 **SECTION 46. AMENDMENT.** Subsections 3 and 4 of section 54-06-25 of the North
12 Dakota Century Code are amended and reenacted as follows:

13 3. The commission shall meet at the call of the chairman as often as may be
14 necessary, but at least once during each year of the biennium. The commission
15 shall consider proper levels of compensation and fringe benefits for state
16 employees and make its recommendations on these issues to the governor in time
17 for consideration in preparation of the executive budget to be submitted to the next
18 legislative assembly. The commission shall also submit its recommendations to
19 the legislative ~~council~~ executive committee at the biennial meeting at which the
20 legislative ~~council~~ executive committee receives the reports of its interim
21 committees.

22 4. The members of the legislative assembly who are commission members are
23 entitled to receive compensation from the legislative council for each day in
24 attendance at commission meetings in the same manner as provided for members
25 of the legislative ~~council~~ executive committee and reimbursement from the
26 legislative council for travel and other necessary expenses incurred in performing
27 commission duties in the amounts provided for state employees under section
28 54-06-09. The state employee members of the commission are entitled to receive
29 reimbursement for necessary expenses incurred in attending commission
30 meetings at the rates provided for state employees under section 54-06-09 and
31 may not be assessed any annual leave or loss of salary for attendance at meetings

1 of the commission. The employing agency of state employee members shall pay
2 their expenses.

3 **SECTION 47. AMENDMENT.** Section 54-06-31 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **54-06-31. State employee recruitment and retention bonus programs - Criteria -**
6 **Limitations.** State agencies may develop programs to provide bonuses to recruit or retain
7 employees in hard-to-fill occupations.

8 1. State agencies may pay recruitment and retention bonuses under this section only
9 if:

10 a. The agency has a written policy in place identifying eligible positions or
11 occupations and provisions for providing and receiving bonuses;

12 b. The agency has filed a copy of the written policy with the North Dakota
13 human resource management services; and

14 c. The agency reports to the North Dakota human resource management
15 services each bonus provided to an employee under the program.

16 2. State agencies must fund bonus programs from within the agency salaries and
17 wages budget.

18 3. The North Dakota human resource management services shall report periodically
19 ~~report to a legislative committee designated by the legislative council~~ executive
20 committee on the implementation, progress, and bonuses provided under agency
21 recruitment and retention bonus programs.

22 4. Bonuses paid under this section are not fiscal irregularities under section
23 54-14-03.1.

24 **SECTION 48. AMENDMENT.** Section 54-35-01 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **54-35-01. ~~Council~~ Legislative executive committee - Created - Members -**

27 **Vacancy - Terms.** The North Dakota legislative ~~council, in this chapter referred to as the~~
28 ~~legislative council or the council,~~ executive committee consists of the majority and minority

29 leaders of the house and of the senate plus six senators and seven representatives chosen

30 biennially before the close of each regular legislative session. In the house of representatives

31 the speaker of the house shall appoint to the ~~council~~ legislative executive committee four

1 members recommended by the majority leader and three members recommended by the
2 minority leader, except that the speaker must by virtue of office be one of the four members
3 appointed from the speaker's faction. In the senate the lieutenant governor shall appoint to the
4 ~~council~~ legislative executive committee four members recommended by the majority leader and
5 two members recommended by the minority leader. Any vacancy occurring when the
6 legislative assembly is not in session must be filled by the selection of another member of the
7 legislative assembly belonging to the same faction as the member originally appointed, the
8 selection to be made by the remaining senate or house members of the ~~council~~ legislative
9 executive committee, depending upon which body has the vacancy. Each senator and each
10 representative chosen to serve on the ~~council~~ legislative executive committee shall serve until a
11 new ~~council~~ legislative executive committee has been selected at the next regular legislative
12 session; provided, however, that no senator, not a holdover, who is not reelected to the senate,
13 and no representative, who is not reelected to the house of representatives, may serve as a
14 member of the ~~council~~ legislative executive committee beyond the closing day of the term to
15 which elected. Any vacancy occurring because any member of the ~~council~~ legislative executive
16 committee is not reelected must be filled for the period from the beginning of the session until a
17 new ~~council~~ legislative executive committee is selected, in the same manner as the original
18 ~~council~~ legislative executive committee is selected.

19 **SECTION 49. AMENDMENT.** Section 54-35-02 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **54-35-02. Powers and duties.** In addition to the other applicable provisions of this
22 chapter, the ~~council~~ legislative executive committee has the following powers and duties:

- 23 1. To study, consider, accumulate, compile, and assemble information on any subject
24 upon which the legislative assembly may legislate, and upon such subjects as the
25 legislative assembly may by concurrent or joint resolution authorize or direct, or
26 any subject requested by a member of the legislative assembly; provided, that the
27 ~~council~~ legislative executive committee may screen and prioritize studies assigned
28 by concurrent or joint resolution to maintain its workload within the limitations of
29 time and legislative appropriations.
- 30 2. To collect information concerning the government and general welfare of the state
31 and of its political subdivisions.

- 1 3. To study and consider important issues of public policy and questions of general
2 interest.
- 3 4. To study and promote uniformity of legislation in the United States upon subjects
4 upon which uniformity is desirable and to ~~confer with the commissioners or similar~~
5 ~~groups appointed for the same purpose by any other state in drafting uniform laws~~
6 ~~to be submitted for the approval and adoption by the several states and through~~
7 ~~such member or members or council staff persons as the council may appoint to~~
8 ~~meet annually with the conference of commissioners on uniform state laws for the~~
9 ~~promotion of uniformity of legislation in the United States and join with it in such~~
10 ~~measures as may be deemed most expedient to advance the objects of such~~
11 ~~conference. The council shall~~ receive, review, and make recommendations on
12 uniform and model laws recommended to it by the state commission on uniform
13 state laws.
- 14 5. To prepare proposed bills and resolutions for consideration of the succeeding
15 legislative assembly.
- 16 6. To call to its assistance other members of the legislative assembly, and it may
17 create committees consisting of its own members, or one or more of its own
18 members and one or more other members of the legislative assembly and
19 delegate by written resolution to such committees such of its powers and rights as
20 it may deem advisable. Committees of the ~~council~~ legislative executive committee
21 may also include nonlegislator members. Any member of the legislative assembly
22 has the right to attend any meeting of the ~~council~~ legislative executive committee
23 and may present that member's views on any subject which the ~~council~~ legislative
24 executive committee may at any particular time be considering.
- 25 7. To issue subpoenas or subpoenas duces tecum in the manner provided in
26 sections 54-03.2-08 and 54-03.2-09. Committees of the ~~council~~ legislative
27 executive committee may issue subpoenas and subpoenas duces tecum in the
28 same manner if specifically authorized by the ~~council~~ legislative executive
29 committee. Failure to obey a subpoena issued by the ~~council~~ legislative executive
30 committee, or one of its committees, is contempt.

1 8. To control the use of the legislative chambers and permanent displays in memorial
2 hallway. Guidelines may be established pursuant to this subsection and the
3 legislative council, or its designee, shall administer any guidelines ~~which~~ that are
4 established.

5 9. To determine access to legislative information services and impose fees for
6 providing legislative information services and copies of legislative documents. This
7 authority may not be exercised in a manner that contravenes access to legislative
8 documents as otherwise provided by law.

9 **SECTION 50. AMENDMENT.** Section 54-35-02.1 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **54-35-02.1. Legislative audit and fiscal review committee.** For the purposes of
12 studying and reviewing the financial transactions of this state; to assure the collection and
13 expenditure of its revenues and moneys in compliance with law and legislative intent and sound
14 financial practices; and to provide the legislative assembly with formal, objective information on
15 revenue collections and expenditures for a basis of legislative action to improve the fiscal
16 structure and transactions of this state, the legislative ~~council~~ executive committee shall ~~create~~
17 ~~a division of the budget section of the legislative council entitled~~ appoint the legislative audit
18 and fiscal review committee. The members of the committee must be appointed in the same
19 manner as other members of ~~legislative council~~ interim committees of the legislative executive
20 committee.

21 **SECTION 51. AMENDMENT.** Section 54-35-02.2 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **54-35-02.2. Powers and duties of the legislative audit and fiscal review**
24 **committee.** ~~It is the duty of the~~ The legislative audit and fiscal review committee ~~to~~ shall study
25 and review audit reports as selected by the committee from those submitted by the state
26 auditor, confer with the auditor and deputy auditors in regard to such reports, and when
27 necessary, ~~to~~ confer with representatives of the department, agency, or institution audited in
28 order to obtain full and complete information in regard to any and all fiscal transactions and
29 governmental operations of any department, agency, or institution of the state. Each
30 department, agency, or institution shall furnish to the committee such aid, information, and
31 assistance in regard to fiscal transactions and governmental operations as it may from time to

1 time request. Whenever the committee may determine or have reason to believe that there
2 may have been a violation of law relating to the receipt, custody, or expenditure of public funds
3 by any state officer or employee, the committee shall present such evidence or information as
4 may be in its possession to the attorney general. The attorney general shall receive and accept
5 such evidence or information and shall immediately commence such additional investigation as
6 the attorney general ~~deems~~ determines necessary. Upon completion of the investigation, if the
7 evidence supplied by the committee and through the investigation indicates the probability of a
8 violation of law by any state official or employee, the attorney general ~~shall~~ immediately shall
9 prosecute such official or employee as provided by law. The legislative ~~council~~ executive
10 committee, through its committee on legislative audit and fiscal review, or such persons as may
11 be directed or employed by ~~the legislative council~~, is authorized, within the limits of legislative
12 appropriations, to make such audits, examinations, or studies of the fiscal transactions or
13 governmental operations of departments, agencies, or institutions of the state as ~~the~~
14 legislative executive committee may ~~deem~~ determine necessary.

15 **SECTION 52. AMENDMENT.** Section 54-35-02.3 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **54-35-02.3. Employee benefits programs committee - Appointment - Selection of**
18 **chairman.** The legislative ~~council~~ executive committee, during each biennium, shall appoint an
19 employee benefits programs committee in the same manner as the ~~council~~ legislative executive
20 committee appoints other interim committees. The ~~council~~ legislative executive committee
21 shall appoint five members of the house of representatives and four members of the senate to
22 the committee. The ~~council~~ legislative executive committee shall designate the chairman of the
23 committee. The committee shall operate according to the statutes and procedure governing
24 the operation of other legislative ~~council~~ executive committee interim committees.

25 **SECTION 53. AMENDMENT.** Section 54-35-02.4 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **54-35-02.4. Employee benefits programs committee - Powers and duties.**

28 1. The employee benefits programs committee shall consider and report on those
29 legislative measures and proposals over which it takes jurisdiction and which
30 affect, actuarially or otherwise, the retirement programs of state employees or
31 employees of any political subdivision, and health and retiree health plans of state

- 1 employees or employees of any political subdivision. The committee shall make a
2 thorough review of any measure or proposal which it takes under its jurisdiction,
3 including an actuarial review. The committee shall take jurisdiction over any
4 measure or proposal that authorizes an automatic increase or other change in
5 benefits beyond the ensuing biennium which would not require legislative approval.
6 The committee must include in the report of the committee a statement that the
7 proposal would allow future changes without legislative involvement. The
8 committee shall report its findings and recommendations, along with any
9 necessary legislation, to the legislative ~~council~~ executive committee and to the
10 legislative assembly.
- 11 2. To carry out its responsibilities, the committee, or its designee, may:
- 12 a. Enter ~~into~~ contracts, including retainer agreements, with an actuary or
13 actuarial firm for expert assistance and consultation. Each retirement,
14 insurance, or retiree insurance program shall pay, from its retirement,
15 insurance, or retiree health benefits fund, as appropriate, and without the
16 need for a prior appropriation, the cost of any actuarial report required by the
17 committee which relates to that program.
- 18 b. Call on personnel from state agencies or political subdivisions to furnish such
19 information and render such assistance as the committee may from time to
20 time request.
- 21 c. Establish rules for its operation, including the submission and review of
22 proposals and the establishing of standards for actuarial review.
- 23 3. The committee may solicit draft measures and proposals from interested persons
24 during the interim between legislative sessions, and may also study measures and
25 proposals referred to it by the legislative assembly or the legislative ~~council~~
26 executive committee.
- 27 4. A copy of the committee's report concerning any legislative measure shall, if that
28 measure is introduced for consideration by a legislative assembly, be appended to
29 the copy of that measure which is referred to a standing committee.
- 30 5. A legislative measure affecting a public employees retirement program, public
31 employees health insurance program, or public employee retiree health insurance

1 program may not be introduced in either house unless it is accompanied by a
2 report from the committee. A majority of the members of the committee, acting
3 through the chairman, has sole authority to determine whether any legislative
4 measure affects a program.

5 6. Any amendment made during a legislative session to a legislative measure
6 affecting a public employees retirement program, public employees health
7 insurance program, or public employee retiree health insurance program may not
8 be considered by a standing committee unless it is accompanied by a report from
9 the employee benefits programs committee.

10 7. Any legislation enacted in contravention of this section is invalid and of no force
11 and effect, and any benefits provided under such legislation must be reduced to
12 the level current prior to enactment.

13 **SECTION 54. AMENDMENT.** Section 54-35-02.5 of the North Dakota Century Code is
14 amended and reenacted as follows:

15 **54-35-02.5. Administrative rules committee.** The legislative ~~council~~ executive
16 committee, during each biennium, shall appoint an administrative rules committee in the same
17 manner as the ~~council~~ legislative executive committee appoints other interim committees. The
18 legislative ~~council~~ executive committee shall designate the chairman of the committee. The
19 committee shall operate according to the statutes and procedure governing the operation of
20 other legislative ~~council~~ executive committee interim committees. The membership of the
21 administrative rules committee must include at least one of the members who served during the
22 most recently completed regular session of the legislative assembly from each of the standing
23 committees of either the house of representatives or the senate.

24 **SECTION 55. AMENDMENT.** Section 54-35-02.6 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **54-35-02.6. Rules reviewed by administrative rules committee - Committee**
27 **responsibility.** The administrative rules committee shall review administrative rules adopted
28 under chapter 28-32. The committee shall consider oral and written comments received
29 concerning administrative rules. The committee shall study and review administrative rules and
30 related statutes to determine whether:

31 1. Administrative agencies are properly implementing legislative purpose and intent.

1 2. There is dissatisfaction with administrative rules or with statutes relating to
2 administrative rules.

3 3. There are unclear or ambiguous statutes relating to administrative rules.
4 The committee may make rule change recommendations to the adopting agency and may
5 make recommendations to the legislative ~~council~~ executive committee for the amendment or
6 repeal of statutes relating to administrative rules. The committee's failure to review proposed
7 rules prior to publication in the North Dakota Administrative Code does not prevent rules from
8 taking effect. Except for action pursuant to section 28-32-17 or 28-32-18, the
9 recommendations or opinions of the committee do not affect the legality of any rule as
10 determined by the attorney general.

11 **SECTION 56. AMENDMENT.** Section 54-35-02.7 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **54-35-02.7. Garrison diversion overview.** The legislative ~~council~~ executive
14 committee is responsible for legislative overview of the Garrison diversion project and related
15 matters and for any necessary discussions with adjacent states on water-related topics.

16 **SECTION 57. AMENDMENT.** Section 54-35-02.8 of the North Dakota Century Code is
17 amended and reenacted as follows:

18 **54-35-02.8. Legislative ethics committee.** The legislative ~~council~~ executive
19 committee, during each biennium, shall appoint an ethics committee to consider or prepare a
20 legislative code of ethics. The committee may recommend legislation relating to legislative
21 ethics. The committee shall operate according to the laws and procedures governing the
22 operation of other legislative ~~council~~ executive committee interim committees.

23 **SECTION 58. AMENDMENT.** Section 54-35-03 of the North Dakota Century Code is
24 amended and reenacted as follows:

25 **54-35-03. State departments, officers, and employees to cooperate.** Each
26 department, board, commission, agency, officer, or employee in the state government shall
27 furnish such information and render such assistance to the legislative council and to the
28 legislative executive committee as the legislative council or the legislative executive committee
29 or its committees; may from time to time request.

30 **SECTION 59. AMENDMENT.** Section 54-35-04 of the North Dakota Century Code is
31 amended and reenacted as follows:

1 **54-35-04. Meetings - When held - How called - Quorum.** The ~~council~~ legislative
2 executive committee or committee appointed by it, may sit at such time and place as it may
3 deem advisable, but the ~~council~~ legislative executive committee shall meet at least once in
4 each year and shall meet at any time upon the call of the chairman or a call signed by seven
5 members of the ~~council~~ legislative executive committee. At any meeting of the ~~council~~
6 legislative executive committee, seven members constitute a quorum and a majority of such
7 quorum has the authority to act in any matter falling within the jurisdiction of the ~~council~~
8 legislative executive committee.

9 **SECTION 60. AMENDMENT.** Section 54-35-05 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **54-35-05. Governor sending messages to meetings.** The governor may send
12 messages to such meetings of the ~~council~~ legislative executive committee as the governor
13 ~~deems~~ determines advisable.

14 **SECTION 61. AMENDMENT.** Section 54-35-06 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **54-35-06. Officers - Accept funds - Expenditures.** The ~~council~~ legislative executive
17 committee shall select a chairman and a vice chairman from its own members and may
18 prescribe its own rules of procedure. ~~‡~~ The legislative executive committee may appoint a
19 secretary who need not be a member, and shall appoint a director who must be in charge of the
20 ~~offices and staff of the~~ legislative council and who must be paid such salary as the ~~council~~
21 legislative executive committee may determine. The ~~council~~ director may employ such ~~other~~
22 persons and obtain the assistance of such research agencies as ~~it may deem~~ determined
23 necessary. The legislative executive committee and the legislative council ~~is authorized to~~ may
24 accept and use any funds made available ~~to it~~ through the terms of any agreement ~~that it may~~
25 ~~make~~ made with any agency whatsoever for the accomplishment of the purpose of this chapter.
26 Expenditures of funds made available ~~to the council~~ by legislative appropriation must be made
27 in accordance with rules or motions duly approved by the ~~council~~ legislative executive
28 committee.

29 **SECTION 62. AMENDMENT.** Section 54-35-07 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **54-35-07. Records - Reports.** The ~~council~~ legislative executive committee shall keep
2 minutes of its meetings and a record of all its transactions and shall at the beginning of each
3 biennial legislative session, and may at any other time, make a report of its activities and
4 recommendations to the members of the legislative assembly and to the governor.

5 **SECTION 63. AMENDMENT.** Section 54-35-08 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **54-35-08. Recommended legislation may be required in advance.** The ~~council~~
8 legislative executive committee may require that any recommendation for legislation, which is
9 to be presented by any department, board, commission, agency, officer, official, or employee of
10 the state desiring the consideration of the ~~council~~ legislative executive committee, be presented
11 to it at least sixty days in advance of any regular legislative session.

12 **SECTION 64. AMENDMENT.** Section 54-35-09 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **54-35-09. Recommendations - When made public - Distribution.** The

16 public prior to any session of the legislative assembly at which such recommendations are to
17 be submitted; and a copy of ~~said~~ the recommendations must be ~~mailed~~ distributed to each
18 member-elect of the legislative assembly, to each elective state officer, and to the state law
19 library.

20 **SECTION 65. AMENDMENT.** Section 54-35-10 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **54-35-10. (Effective through June 30, 2009) Compensation of members and**
23 **leadership.**

24 1. The members of the ~~council~~ legislative executive committee and the members of
25 any committee of the ~~council~~ legislative executive committee are entitled to be
26 compensated for the time spent in attendance at sessions of the ~~council~~ legislative
27 executive committee and of its committees at the rate of one hundred eight dollars
28 per day and must also be paid for expenses incurred in attending said meetings
29 and in the performance of their official duties in the amounts provided by law for
30 other state officers.

1 2. In addition to the compensation provided in subsection 1, the chairman of the
2 ~~council shall~~ legislative executive committee is entitled to receive an additional five
3 dollars for each day spent in attendance at sessions of the ~~council~~ legislative
4 executive committee and of its committees, and the chairman of each of the
5 ~~council's~~ legislative executive committee's committees ~~shall~~ is entitled to receive
6 five dollars for each day spent in attendance at sessions of the ~~council~~ legislative
7 executive committee or of the committee which the person chairs.

8 **(Effective after June 30, 2009) Compensation of members and leadership.**

9 1. The members of the ~~council~~ legislative executive committee and the members of
10 any committee of the ~~council~~ legislative executive committee are entitled to be
11 compensated for the time spent in attendance at sessions of the ~~council~~ legislative
12 executive committee and of its committees at the rate of one hundred thirty-five
13 dollars per day and must also be paid for expenses incurred in attending said
14 meetings and in the performance of their official duties in the amounts provided by
15 law for other state officers.

16 2. In addition to the compensation provided in subsection 1, the chairman of the
17 ~~council shall~~ legislative executive committee is entitled to receive an additional five
18 dollars for each day spent in attendance at sessions of the ~~council~~ legislative
19 executive committee and of its committees, and the chairman of each of the
20 ~~council's~~ legislative executive committee's committees ~~shall~~ is entitled to receive
21 five dollars for each day spent in attendance at sessions of the ~~council~~ legislative
22 executive committee or of the committee which the person chairs.

23 **SECTION 66. AMENDMENT.** Section 54-35-11 of the North Dakota Century Code is
24 amended and reenacted as follows:

25 **54-35-11. Preparation for and assistance to legislative assembly - Custody of**
26 **equipment - Approval of delayed vouchers.** The legislative council ~~is hereby authorized,~~ on
27 behalf of the legislative assembly, ~~to~~ may make all necessary arrangements ~~prior to~~ before
28 each legislative session; for the procurement of necessary supplies, equipment, services;
29 ~~excluding other than~~ the employment of legislative employees, building space, or any other
30 preparations or arrangements ~~it deems~~ the legislative council determines necessary or
31 desirable to be made ~~prior to~~ before the commencement of each legislative session in order to

1 facilitate the proper convening and operation of the legislative assembly. The legislative
2 council shall act as the custodial agency to ensure the proper storage and safekeeping of
3 legislative supplies and equipment during the interim periods between legislative sessions, and
4 ~~is authorized to~~ may approve vouchers on behalf of the legislative assembly, ~~or may authorize~~
5 ~~its director to do so~~, for the payment from legislative appropriations of delayed billings or other
6 billings for legislative expenses during periods when the legislative assembly is not in session.
7 ~~† The legislative council shall, through its own actions or through its staff,~~ carry out such duties
8 or projects and provide such service and assistance to the legislative assembly or its
9 committees, the legislative executive committee or its committees, and members of the
10 legislative assembly as may be requested by concurrent resolution of the legislative assembly
11 or ~~deemed~~ determined necessary or desirable in assisting the legislative assembly or the
12 legislative executive committee in meeting its responsibilities and carrying out its duties during
13 the legislative session or the interim between sessions.

14 **SECTION 67. AMENDMENT.** Section 54-35-12 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **54-35-12. Legislative budget analyst and auditor.** The legislative ~~council~~ executive
17 committee shall appoint a legislative budget analyst and auditor. A person is not eligible for the
18 appointment unless the person holds a baccalaureate degree from a recognized institution of
19 higher learning, is a certified public accountant, or has had five years' experience in
20 government accounting. The appointment of the legislative auditor must be based upon
21 qualifications of eligible persons without reference to partisan politics. The salary of the
22 legislative budget analyst and auditor must be determined by the legislative council and it may
23 employ additional persons as necessary to carry out sections 54-35-12 through 54-35-14.

24 **SECTION 68. AMENDMENT.** Section 54-35-15 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **54-35-15. Information technology program - Staff - Powers and duties.**

27 1. The legislative council, ~~or its designee~~, shall provide information technology
28 research and staff services to the legislative branch. The services must be
29 provided in accordance with the existing statutory authority of the legislative
30 council and within the framework of its other staff services.

1 2. The legislative council ~~staff office~~ shall provide information technology services,
2 and ~~the council, or its designee,~~ may hire such ~~additional~~ staff as are necessary,
3 and set compensation for any additional staff within the limits of legislative
4 appropriations.

5 3. The legislative council, ~~or its designee,~~ shall structure the provision of information
6 technology services and assistance to the legislative assembly and shall receive
7 such cooperation and assistance from other state agencies as ~~it may~~ the council
8 reasonably may request.

9 **SECTION 69. AMENDMENT.** Section 54-35-15.1 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **54-35-15.1. Information technology committee - Appointment.** The legislative
12 ~~council~~ executive committee, during each biennium, shall appoint an information technology
13 committee in the same manner as the ~~council~~ legislative executive committee appoints other
14 interim committees. The ~~council~~ legislative executive committee shall appoint six members of
15 the house of representatives and five members of the senate to the committee. The chief
16 information officer of the state is an ex officio, nonvoting member of the committee. The ~~council~~
17 legislative executive committee shall designate the chairman of the committee. The committee
18 shall operate according to the statutes and procedure governing the operation of other
19 legislative ~~council~~ executive committee interim committees.

20 **SECTION 70. AMENDMENT.** Section 54-35-16 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **54-35-16. Authority to determine if legislative assembly meets.** The ~~council~~
23 legislative executive committee may issue a call for the legislative assembly to convene after it
24 has adjourned under subsection 2 of section 54-03-02. The length of a legislative session
25 called under this section may not exceed the number of natural days available under the
26 constitution which have not been used by that legislative assembly. The ~~council~~ legislative
27 executive committee may exercise this authority, and the legislative assembly shall meet,
28 regardless of whether the motion to close the regular session of the legislative assembly was to
29 recess to a time certain, adjourn to a time certain, or adjourn sine die.

30 **SECTION 71. AMENDMENT.** Section 54-35-17 of the North Dakota Century Code is
31 amended and reenacted as follows:

1 **54-35-17. Retention of legal counsel.** When the legislative assembly is in session,
2 either house by resolution may authorize, or both houses by concurrent resolution may direct,
3 the legislative council to appoint or retain legal counsel to appear in, commence, prosecute,
4 defend, or intervene in any action, suit, matter, cause, or proceeding in any court or agency
5 when ~~deemed~~ determined necessary or advisable to protect the official interests of the
6 legislative branch. When the legislative assembly is not in session, the legislative ~~council~~
7 executive committee, by a majority vote, may authorize the legislative council to appoint or
8 retain legal counsel to appear in, commence, prosecute, defend, or intervene in any action,
9 suit, matter, cause, or proceeding in any court or agency when ~~deemed~~ determined necessary
10 or advisable to protect the official interests of the legislative branch. Section 54-12-08 does not
11 apply to a person appointed or retained under this section.

12 **SECTION 72. AMENDMENT.** Section 54-35-18 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **54-35-18. (Effective through August 1, 2011) Energy development and**
15 **transmission committee.** The legislative ~~council~~ executive committee, during each biennium,
16 shall appoint an energy development and transmission committee in the same manner as the
17 ~~council~~ legislative executive committee appoints other interim committees. The ~~council~~
18 legislative executive committee shall appoint six members of the house of representatives, four
19 of whom must be from the majority political party and two of whom must be from the minority
20 political party, and six members of the senate, four of whom must be from the majority political
21 party and two of whom must be from the minority political party. The chairman of the legislative
22 ~~council~~ executive committee shall designate the chairman of the committee. The committee
23 shall operate according to the statutes and procedure governing the operation of other
24 legislative ~~council~~ executive committee interim committees. The committee shall study the
25 impact of a comprehensive energy policy for the state and the development of each facet of the
26 energy industry, from the obtaining of the raw natural resource to the sale of the final product in
27 this state, other states, and other countries. The study may include the review of and
28 recommendations relating to policy affecting extraction, generation, processing, transmission,
29 transportation, marketing, distribution, and use of energy, and the taxation of shallow gas to
30 reduce energy costs for all North Dakota residents.

1 **SECTION 73. AMENDMENT.** Section 54-35-22 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **54-35-22. Workers' compensation review committee.**

- 4 1. During each interim, a legislative ~~council~~ executive committee's interim workers'
5 compensation review committee must be appointed as follows: two members of
6 the senate appointed by the majority leader of the senate of the legislative
7 assembly; one member of the senate appointed by the minority leader of the
8 senate of the legislative assembly; two members of the house of representatives
9 appointed by the majority leader of the house of representatives; and one member
10 of the house of representatives appointed by the minority leader of the house of
11 representatives. The chairman of the legislative ~~council~~ executive committee shall
12 designate the chairman of the committee. The committee shall operate according
13 to the laws and procedures governing the operation of other legislative ~~council~~
14 executive committee interim committees. The committee may recommend
15 legislation relating to workers' compensation. The committee shall meet once
16 each calendar quarter or less often if the committee chairman determines a
17 meeting that quarter is not necessary because there are no claims to review.
- 18 2. The committee shall review workers' compensation claims that are brought to the
19 committee by injured workers for the purpose of determining whether changes
20 should be made to the laws relating to workers' compensation. A claim may not be
21 reviewed by the committee unless workforce safety and insurance has issued a
22 final determination and either the injured worker has exhausted the administrative
23 and judicial appeals process or the period for appeal has expired. In order for the
24 committee to review a claim, the injured worker must first sign a release of
25 information for constituent authorization to allow the committee and legislative
26 council ~~staff~~ to review the injured worker's workforce safety and insurance records
27 and to allow the committee members and workforce safety and insurance
28 representatives to discuss the records in an interim committee hearing.
29 Notwithstanding any open meeting requirements, except as otherwise provided
30 under this section, the workforce safety and insurance records of an injured worker
31 whose case is reviewed by the committee are confidential. However, pursuant to

1 the constituent's authorization, information contained in the records may be
2 discussed by the committee members and workforce safety and insurance
3 representatives in an interim committee hearing.

4 3. The committee shall accept testimony of an injured worker and of a representative
5 designated by the injured worker. After the committee has received the testimony
6 of the injured worker and the injured worker's representative, the committee shall
7 request that workforce safety and insurance provide testimony.

8 **SECTION 74. AMENDMENT.** Section 54-35-23 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **54-35-23. (Effective through July 31, 2009) Committee on tribal and state**
11 **relations - Membership - Duties.**

12 1. The committee on tribal and state relations is composed of seven members as
13 follows:

14 a. The chairman of the legislative ~~council~~ executive committee or the chairman's
15 designee;

16 b. Three members of the house of representatives, two of whom must be
17 selected by the leader representing the majority faction of the house of
18 representatives and one of whom must be selected by the leader
19 representing the minority faction of the house of representatives; and

20 c. Three members of the senate, two of whom must be selected by the leader
21 representing the majority faction of the senate and one of whom must be
22 selected by the leader representing the minority faction of the senate.

23 2. The chairman of the legislative ~~council~~ executive committee or the chairman's
24 designee, shall serve as chairman of the committee.

25 3. The committee shall meet at such times and places as determined by the
26 chairman. The legislative council shall provide staffing for the committee.

27 4. The committee shall conduct joint meetings with the native American tribal citizens'
28 task force to study tribal-state issues, including government-to-government
29 relations, the delivery of services, case management services, child support
30 enforcement, and issues related to the promotion of economic development. After
31 the joint meetings have concluded, the committee shall meet to prepare a report

- 1 on its findings and recommendations, together with any legislation required to
2 implement those recommendations, to the legislative ~~council~~ executive committee.
- 3 5. The members of the committee are entitled to compensation from the legislative
4 council for attendance at committee meetings at the rate provided for members of
5 the legislative assembly for attendance at interim committee meetings and are
6 entitled to reimbursement for expenses incurred in attending the meetings in the
7 amounts provided by law for other state officers.
- 8 6. a. The native American tribal citizens' task force is composed of six members as
9 follows:
- 10 (1) The executive director of the Indian affairs commission, or the
11 executive director's designee;
- 12 (2) The chairman of the Standing Rock Sioux Tribe, or the chairman's
13 designee;
- 14 (3) The chairman of the Spirit Lake Tribe, or the chairman's designee;
- 15 (4) The chairman of the Three Affiliated Tribes, or the chairman's
16 designee;
- 17 (5) The chairman of the Turtle Mountain Band of Chippewa Indians, or the
18 chairman's designee; and
- 19 (6) The chairman of the Sisseton-Wahpeton Sioux Tribe, or the chairman's
20 designee.
- 21 b. If the executive director of the Indian affairs commission or any of the tribal
22 chairmen appoint a designee to serve on the task force, only one individual
23 may serve as that designee during the biennium. A substitute designee may
24 be appointed by the executive director of the Indian affairs commission or a
25 tribal chairman in the event of the death, incapacity, resignation, or refusal to
26 serve of the initial designee.

27 **SECTION 75. AMENDMENT.** Section 54-35.2-01 of the North Dakota Century Code is
28 amended and reenacted as follows:

29 **54-35.2-01. Advisory commission on intergovernmental relations - Membership -**
30 **Terms - Meetings.**

- 1 1. The advisory commission on intergovernmental relations consists of twelve
- 2 members:
- 3 a. The North Dakota league of cities executive committee shall appoint two
- 4 members of the commission.
- 5 b. The North Dakota association of counties executive committee shall appoint
- 6 two members of the commission.
- 7 c. The North Dakota township officers association executive board of directors
- 8 shall appoint one member of the commission.
- 9 d. The North Dakota recreation and park association executive board shall
- 10 appoint one member of the commission.
- 11 e. The North Dakota school boards association board of directors shall appoint
- 12 one member of the commission.
- 13 f. The governor or the governor's designee is a member of the commission.
- 14 g. The legislative ~~council~~ executive committee shall appoint four members of the
- 15 legislative assembly as members of the commission.
- 16 2. The legislative ~~council~~ executive committee shall designate the chairman and vice
- 17 chairman of the commission.
- 18 3. All members of the commission shall serve for a term of two years, beginning July
- 19 first of each odd-numbered year, and may be reappointed for additional terms.
- 20 4. If any member of the commission resigns or ceases to be a member of the class
- 21 the member represents, that person's membership on the commission ceases
- 22 immediately and the appropriate appointing authority may appoint a new member
- 23 for the remainder of the term.
- 24 5. The commission shall meet at least semiannually.

25 **SECTION 76. AMENDMENT.** Section 54-35.2-02 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **54-35.2-02. Functions and duties.** The advisory commission on intergovernmental
28 relations shall:

- 29 1. Serve as a forum for the discussion of resolution of intergovernmental problems.
- 30 2. Engage in activities and studies relating to the following subjects:
 - 31 a. Local governmental structure.

- 1 b. Fiscal and other powers and functions of local governments.
- 2 c. Relationships between and among local governments and the state or any
- 3 other government.
- 4 d. Allocation of state and local resources.
- 5 e. Interstate issues involving local governments, including cooperation with
- 6 appropriate authorities of other states.
- 7 f. Statutory changes required to implement commission recommendations.
- 8 3. Present reports and recommended legislative bills to the legislative ~~council~~
- 9 executive committee for consideration in the same manner as ~~interim~~ legislative
- 10 ~~council~~ executive committee interim committees.
- 11 4. Prepare model ordinances or resolutions for consideration by officials of political
- 12 subdivisions.

13 **SECTION 77. AMENDMENT.** Section 54-35.2-04 of the North Dakota Century Code is
14 amended and reenacted as follows:

15 **54-35.2-04. Finances.**

- 16 1. A member of the advisory commission on intergovernmental relations who is a
- 17 member of the legislative assembly is entitled to receive, from funds available to
- 18 the commission, compensation per day for each day spent in attendance at
- 19 commission meetings in the same amount as provided for members of the
- 20 legislative ~~council~~ executive committee and reimbursement for travel and other
- 21 necessary expenses incurred in the performance of official duties in the amounts
- 22 provided by law for other state officers. Members of the advisory commission on
- 23 intergovernmental relations who are appointed by an organization representing
- 24 political subdivisions may be reimbursed for attendance at commission meetings
- 25 by the organization by which they were appointed.
- 26 2. The commission may apply for, contract for, receive, and expend for its purposes
- 27 any appropriation or grant from any public or private source.
- 28 3. Political subdivisions of the state may appropriate funds to the commission to
- 29 share in the cost of its operations.

30 **SECTION 78. AMENDMENT.** Section 54-35.2-05 of the North Dakota Century Code is
31 amended and reenacted as follows:

1 **54-35.2-05. Reports.** The advisory commission on intergovernmental relations shall
2 report its findings and recommendations and any proposed legislation necessary to implement
3 the recommendations to the legislative ~~council~~ executive committee at the time and in the
4 manner reports are made by interim committees of the legislative ~~council~~ executive committee.
5 The legislative ~~council~~ executive committee may accept, reject, or amend the report of the
6 advisory commission on intergovernmental relations. The legislative ~~council~~ executive
7 committee shall include the report, or any portion of it, as accepted, rejected, or amended, in
8 the ~~council's~~ legislative executive committee's final report. Copies of the report of the advisory
9 commission on intergovernmental relations, as accepted, rejected, or amended by the
10 legislative ~~council~~ executive committee, must be available to counties, cities, townships,
11 appropriate state departments and agencies, and the public.

12 **SECTION 79. AMENDMENT.** Subsection 3 of section 54-40-01 of the North Dakota
13 Century Code is amended and reenacted as follows:

14 3. An agency, department, or institution of this state may enter an agreement with the
15 state of South Dakota to form a bistate authority to jointly exercise any function
16 that the entity is authorized by law to perform. Any agreement entered under this
17 subsection must be submitted to the legislative assembly or, if the legislative
18 assembly is not in session, to the legislative ~~council~~ or a executive committee
19 ~~designated by the legislative council~~ for approval or rejection and may not become
20 effective until approved by the legislative assembly or the legislative ~~council~~
21 executive committee.

22 **SECTION 80. AMENDMENT.** Section 54-44.1-12.1 of the North Dakota Century Code
23 is amended and reenacted as follows:

24 **54-44.1-12.1. Implementation of legislative intent - Legislative objection to**
25 **execution of budget - Effect of objection.**

26 1. The budget section of the legislative ~~council~~ executive committee may object to
27 any allotment made under section 54-44.1-12, any expenditure of a budget unit, or
28 any failure to make an allotment or expenditure if the budget section ~~deems~~
29 determines that the allotment or expenditure or the failure to make an allotment or
30 expenditure is contrary to legislative intent as recorded in any reliable legislative
31 records. The budget section shall file that objection in certified form ~~in the office of~~

1 with the legislative council. The filed objection must contain a concise statement of
2 the budget section's reasons for the objection.

3 2. The ~~office of the~~ legislative council shall attach to each objection a certification of
4 the time and date of the filing of the objection and, as soon as possible, shall
5 transmit a copy of the objection and the certification to the director of the budget
6 and the affected budget unit. The ~~office of the~~ legislative council shall maintain a
7 permanent register of all objections under this section.

8 3. Within fourteen days after the filing of an objection, the affected budget unit shall
9 respond in writing to the budget section. After receipt of that response, the budget
10 section may withdraw or modify its objection.

11 4. After the filing of an objection, the burden of persuasion is upon the budget unit in
12 any action for judicial review of whether the allotment or expenditure or the failure
13 to make an allotment or expenditure is contrary to law. If the budget unit fails to
14 meet its burden of persuasion, the court shall render judgment against the budget
15 unit for court costs. These court costs must include reasonable attorney's fees and
16 must be payable from the appropriation of the budget unit.

17 **SECTION 81. AMENDMENT.** Section 54-52.1-08.2 of the North Dakota Century Code
18 is amended and reenacted as follows:

19 **54-52.1-08.2. Uniform group insurance program - Compliance with federal**
20 **requirements - Group purchasing arrangements.** If the board determines that any section
21 or the phraseology of any section of this chapter does not comply with applicable federal
22 statutes or rules, the board shall adopt appropriate terminology with respect to that section to
23 comply with the federal statutes or rules, subject to the approval of the legislative ~~council's~~
24 executive committee's employee benefits programs committee. The board may assume
25 responsibility for group purchasing arrangements as provided by federal law. Any plan
26 modifications made by the board under this section are effective until the effective date of any
27 measure enacted by the legislative assembly providing the necessary amendments to this
28 chapter to ensure compliance with the federal statutes or rules.

29 **SECTION 82. AMENDMENT.** Section 54-55-01 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **54-55-01. Commission on uniform state laws - Membership.** The commission on
2 uniform state laws consists of an individual engaged in the practice of law in this state, the dean
3 or a full-time member of the faculty of the law school of the university of North Dakota, a
4 law-trained judge of a court of record in this state, a member of the house of representatives
5 and a member of the senate of the legislative assembly, and a member of the legislative
6 council ~~staff~~. The commission also consists of any residents of this state who, because of long
7 service in the cause of uniformity of state legislation, have been elected life members of the
8 national conference of commissioners on uniform state laws, and may also consist of any
9 residents of this state who have been previously appointed to at least five years of service on
10 the commission. Commissioners, except the members of the legislative assembly, the member
11 of the legislative council staff, and life members, must be appointed by the governor for terms
12 of four years each, commencing on the first day of September following each presidential
13 election, and shall serve until their respective successors are appointed. The members of the
14 legislative assembly on the commission must be appointed by the legislative ~~council~~ executive
15 committee for a term not to exceed four years as prescribed by the legislative ~~council~~ executive
16 committee, and the member of the legislative council ~~staff~~ must be appointed by the chairman
17 of the legislative ~~council~~ executive committee.

18 **SECTION 83. AMENDMENT.** Section 54-55-04 of the North Dakota Century Code is
19 amended and reenacted as follows:

20 **54-55-04. Duties of commissioners and commission.** Each commissioner shall
21 attend the annual meeting of the national conference of commissioners on uniform state laws
22 and shall promote uniformity in state laws on those subjects where uniformity may be deemed
23 desirable and practicable. The commission shall also promote as far as practicable the uniform
24 judicial application and construction of all uniform state laws. During the interim between
25 legislative sessions, the commission may submit its recommendations for enactment of uniform
26 and model laws to the legislative ~~council~~ executive committee for its review and
27 recommendation. Commissioners shall provide such assistance to the legislative ~~council~~
28 executive committee as the legislative ~~council~~ executive committee requests with respect to its
29 review of uniform and model laws. During each biennial legislative session, and at any other
30 time as the commission may deem proper, the commission shall report to the legislative
31 assembly an account of its transactions and its advice and recommendations for legislation.

1 The report must include the recommendations of the legislative ~~council~~ executive committee
2 with respect to uniform and model laws recommended by the commission.

3 **SECTION 84. AMENDMENT.** Section 54-58-03 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **54-58-03. Tribal-state gaming compact - Creation, renewals, and amendments.**

6 The governor or the governor's designee may represent the state in any gaming negotiation in
7 which the state is required to participate pursuant to 25 U.S.C. 2701 et seq. by any federally
8 recognized Indian tribe and, on behalf of the state, may execute a gaming compact between
9 the state and a federally recognized Indian tribe, subject to the following:

- 10 1. If the legislative assembly is not in session at the time gaming negotiations are
11 being conducted, the chairman and vice chairman of the legislative ~~council~~
12 executive committee or the designee of the chairman or vice chairman may attend
13 all negotiations and brief the legislative ~~council~~ executive committee on the status
14 of the negotiations.
- 15 2. If the legislative assembly is in session at the time negotiations are being
16 conducted, the majority and minority leaders of both houses, or their designees,
17 may attend all negotiations and brief their respective houses on the status of the
18 negotiations.
- 19 3. The compact may authorize an Indian tribe to conduct gaming that is permitted in
20 the state for any purpose by any person, organization, or entity.
- 21 4. For the purposes of this chapter, the term "gaming that is permitted in the state for
22 any purpose by any person, organization, or entity" includes any game of chance
23 that any Indian tribe was permitted to conduct under a tribal-state gaming compact
24 that was in effect on August 1, 1997.
- 25 5. The compact may not authorize gaming to be conducted by an Indian tribe at any
26 off-reservation location not permitted under a tribal-state gaming compact in effect
27 on August 1, 1997, except that in the case of the tribal-state gaming compact
28 between the Turtle Mountain Band of Chippewa and the state, gaming may be
29 conducted on land within Rolette County held in trust for the Band by the United
30 States government which was in trust as of the effective date of the Indian Gaming
31 Regulatory Act of 1988 [Pub. L. 100-497; 102 Stat. 2467; 25 U.S.C. 2701 et seq.].

- 1 6. The compact may not obligate the state to appropriate state funds; provided,
2 however, the state may perform services for reimbursement.
- 3 7. The negotiations between the tribe and the state must address the possibility of a
4 mutual effort of the parties to address the issue of compulsive gambling.
- 5 8. If the legislative assembly is not in session when the negotiations are concluded,
6 the governor shall forward a copy of the compact as finally negotiated to each
7 member of the legislative ~~council~~ executive committee at least twenty-one days
8 before the compact is signed.
- 9 9. If the legislative assembly is in session when the negotiations are concluded, the
10 governor shall forward a copy of the compact as finally negotiated to each member
11 of the legislative assembly at least twenty-one days before the compact is signed.
- 12 10. Before execution of any proposed tribal-state gaming compact or amendment
13 thereto, the governor shall conduct one public hearing on the proposed compact or
14 amendment.

15 **SECTION 85. AMENDMENT.** Section 54-59-07 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **54-59-07. State information technology advisory committee.** The state information
18 technology advisory committee consists of the chief information officer; the commissioner of
19 higher education or the commissioner's designee; the attorney general or the attorney general's
20 designee; the secretary of state or the secretary of state's designee; the tax commissioner or
21 the commissioner's designee; the chief justice of the supreme court or the chief justice's
22 designee; two members of the legislative assembly appointed by the legislative ~~council~~
23 executive committee; a minimum of eight members representing state agencies, appointed by
24 the governor; and two members with technology management expertise representing private
25 industry, appointed by the governor. The appointees of the governor serve at the pleasure of
26 the governor. The governor shall designate the chairman of the committee. Additional
27 members may be asked to participate at the request of the chairman. The department shall
28 provide staff services to the committee. The members of the committee representing private
29 industry are entitled to be compensated for time spent in attendance at meetings of the
30 committee and for other travel as approved by the chairman of the committee at the rate of
31 sixty-two dollars and fifty cents per day and are entitled to reimbursement for actual and

1 necessary expenses incurred in the same manner as other state officials. The compensation
2 and expenses are to be paid from appropriations for the department. The committee shall
3 advise the department regarding statewide information technology planning and budgeting,
4 services of the information technology department, and statewide information technology
5 initiatives and policy and shall review reports on major information technology projects as
6 required by this chapter and policies, standards, and guidelines developed by the department.
7 The chief information officer shall submit recommendations of the committee regarding
8 information technology issues to the information technology committee for its consideration.

9 **SECTION 86. AMENDMENT.** Section 54-59-11 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **54-59-11. Information technology plans.** Each executive branch state agency or
12 institution, excluding the institutions under the control of the board of higher education, shall
13 prepare an information technology plan, subject to acceptance by the department. The plan
14 must be submitted to the department by July fifteenth of each even-numbered year. The plan
15 must be prepared based on guidelines developed by the department; must provide the
16 information technology goals, objectives, and activities of the entity for the current biennium
17 and the next two bienniums; and must include an asset management plan relating to the
18 inventory of information technology assets owned, leased, or employed by the entity. Each
19 entity required to file a plan shall provide interim updates to its plan if major information
20 technology changes occur which affect its plan. The department shall review each entity's plan
21 for compliance with statewide information technology policies and standards and may require
22 an entity to change its plan to comply with statewide policies or standards or to resolve
23 conflicting directions among plans. Agencies of the judicial and legislative branches shall file
24 their information technology plans with the department by July fifteenth of each even-numbered
25 year. Each entity required to file a plan shall prepare its budget request for the next biennium
26 based on its information technology plan. The agency's budget request and the governor's
27 budget recommendation must include supporting information describing in detail how the
28 information technology plan relates to the budget request and recommendation. Any budget
29 adjustment by the budget office must include the corresponding change to the plan. Based on
30 the plans, the department shall prepare a statewide information technology plan and distribute
31 copies of that plan to members of the legislative assembly as requested by the legislative

1 council ~~or its designee~~. The statewide information technology plan must be developed with
2 emphasis on long-term strategic goals, objectives, and accomplishments. The statewide
3 information technology plan must contain:

- 4 1. A list of major projects started, ongoing, and completed during the biennium,
5 including related budgeted and actual costs and the estimated implementation
6 date for each project as well as the actual implementation date for completed
7 projects.
- 8 2. Information regarding evaluations of cost-benefit analyses for completed projects.
- 9 3. Information regarding the information technology plans, including the department's
10 plan review process, the number of plans reviewed, and the number of plans
11 accepted.
- 12 4. A description of the benefits to the state resulting from its investment in information
13 technology.

14 **SECTION 87. AMENDMENT.** Section 54-59-12 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **54-59-12. Coordination of activities - Reports.** The department shall cooperate with
17 each state entity providing access to any computer data base or electronically filed or stored
18 information under subsection 4 of section 44-04-18 to assist in providing economical, efficient,
19 and compatible access. The chief information officer shall conduct conferences and meetings
20 with political subdivisions to review and coordinate information technology. The chief
21 information officer and the commissioner of the board of higher education shall meet at least
22 twice each year to plan and coordinate their information technology. The chief information
23 officer and commissioner shall consider areas in which joint or coordinated information
24 technology may result in more efficient and effective state government operations. Upon
25 request, the chief information officer shall report to the legislative ~~council or its designated~~
26 executive committee regarding the coordination of services with political subdivisions, and the
27 chief information officer and commissioner shall report to the legislative ~~council or its~~
28 ~~designated~~ executive committee regarding their findings and recommendations.

29 **SECTION 88. AMENDMENT.** Section 54-59-23 of the North Dakota Century Code is
30 amended and reenacted as follows:

31 **54-59-23. Information technology projects - Reports.**

- 1 1. An executive, legislative, or judicial branch agency, except for institutions under
2 the control of the state board of higher education, shall report to the state
3 information technology advisory committee according to guidelines developed by
4 the department and reviewed by the state information technology advisory
5 committee regarding the plan for and status of any information technology project
6 that is estimated to cost more than two hundred fifty thousand dollars.
- 7 2. During the life of the project, the agency shall notify the state information
8 technology advisory committee if:
 - 9 a. At a project milestone, the amount expended on project costs exceeds the
10 planned budget for that milestone by twenty percent or more; or
 - 11 b. At a project milestone, the project schedule extends beyond the planned
12 schedule to attain that milestone by twenty percent or more.
- 13 3. A report under subsection 2 must specify corrective measures being undertaken to
14 address any cost or time of completion issue. If the agency has not taken
15 adequate corrective measures within ninety days after the report, the agency shall
16 submit a report to the legislative ~~council's~~ executive committee's information
17 technology committee regarding the project.
- 18 4. Upon completion of the project, the agency shall notify the state information
19 technology advisory committee if:
 - 20 a. The budget for the project exceeded the original budget by twenty percent or
21 more; or
 - 22 b. The final project completion date extended beyond the original project
23 scheduled completion date by twenty percent or more.

24 **SECTION 89. AMENDMENT.** Subsection 10 of section 54-60-03 of the North Dakota
25 Century Code is amended and reenacted as follows:

- 26 10. Shall report between the first and tenth legislative days of each regular legislative
27 session to a standing committee of each house of the legislative assembly as
28 determined by the legislative ~~council~~ executive committee and shall report annually
29 to the foundation:
 - 30 a. On the department's goals and objectives since the last report;
 - 31 b. On the department's goals and objectives for the period until the next report;

- 1 c. On the department's long-term goals and objectives;
- 2 d. On the department's activities and measurable results occurring since the last
- 3 report; and
- 4 e. On commerce benchmarks, including the average annual wage in the state,
- 5 the gross state product exclusive of agriculture, and the number of primary
- 6 sector jobs in the state;

7 **SECTION 90. AMENDMENT.** Section 54-60-11 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **54-60-11. Target industries - Report ~~to legislative council~~.** The commissioner shall
10 identify target industries on which the commissioner shall focus economic development efforts.
11 The commissioner shall designate one of these target industries as a special focus target
12 industry. In identifying and updating target industries, the commissioner shall solicit the advice
13 of the foundation and the North Dakota university system. The commissioner may contract for
14 the services of a third party in identifying target industries. The commissioner shall report
15 biennially to the legislative ~~council~~ executive committee. This report must include information
16 regarding the process used and factors considered in identifying and updating the target
17 industries, the specific tactics the department has used to specifically address the needs of the
18 target industries, the unique tactics and the specific incentives the department has used to
19 support the growth of the special focus target industry, and any recommended legislative
20 changes necessary to better focus economic development services on these industries.

21 **SECTION 91. AMENDMENT.** Section 54-62-03 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **54-62-03. Advisory commission.** The advisory commission on faith-based and
24 community initiatives is composed of seven members to include the following: the executive
25 director of the department of human services or the director's designee; the director of the
26 department of corrections and rehabilitation or the director's designee; two members of the
27 legislative assembly, one of whom must be selected by the members of the legislative ~~council~~
28 executive committee representing the majority faction and one of whom must be selected by
29 the members of the legislative ~~council~~ executive committee representing the minority faction;
30 and three public members appointed by the governor, one of whom must represent a minority
31 population. The term of office for the public members is three years. Of the first public

1 members appointed, one must be appointed for a term of one year, one must be appointed for
2 a term of two years, and one must be appointed for a term of three years. No public member
3 may be appointed to more than two consecutive terms. A chairman of the commission must
4 be chosen annually from the membership of the commission by a majority of its members at the
5 first meeting of the advisory commission each year. The advisory commission shall advise the
6 director of the office of faith-based and community initiatives in the establishment of policy
7 regarding matters affecting the faith-based and community organizations, including making
8 recommendations concerning the future of existing state programs and initiatives. The advisory
9 commission on faith-based and community initiatives shall report periodically to the governor
10 and provide the governor with information and recommendations for the governor's
11 consideration. The members of the advisory commission are entitled to mileage and expenses
12 as provided by law for state officers and employees.

13 **SECTION 92. AMENDMENT.** Section 57-40.6-12 of the North Dakota Century Code is
14 amended and reenacted as follows:

15 **57-40.6-12. Emergency services communications coordinating committee -**
16 **Membership - Duties.**

- 17 1. The governing body of a city or county, which adopted a fee on assessed
18 communications services under this chapter, shall make an annual report of the
19 income, expenditures, and status of its emergency services communication
20 system. The annual report must be submitted to the emergency services
21 communications coordinating committee. The committee is composed of three
22 members, one appointed by the North Dakota 911 association, one appointed by
23 the North Dakota association of counties, and one appointed by the adjutant
24 general to represent the division of state radio.
- 25 2. The committee shall:
- 26 a. Recommend to the legislative ~~council~~ executive committee changes to the
27 operating standards for emergency services communications, including
28 training or certification standards for dispatchers;
- 29 b. Develop guidelines regarding the allowable uses of the fee revenue collected
30 under this chapter;

- 1 c. Request, receive, and compile reports from each governing body on the use
2 of the proceeds of the fee imposed under this chapter, analyze the reports
3 with respect to the guidelines, file its report with the legislative council by
4 November first of each even-numbered year regarding the use of the fee
5 revenue, and recommend to the legislative assembly the appropriate
6 maximum fee allowed by section 57-40.6-02; and
- 7 d. Periodically evaluate chapter 57-40.6 and recommend changes to the
8 legislative ~~council~~ executive committee.
- 9 3. The committee may initiate and administer statewide agreements among the
10 governing bodies of the local governmental units with jurisdiction over an
11 emergency 911 telephone system to coordinate the procurement of equipment and
12 services, fund the research, administration, and activities of the committee, and
13 contract for the necessary staff support for committee activities.

14 **SECTION 93. AMENDMENT.** Section 61-24-04 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **61-24-04. Compensation of directors.** Each member of the board of directors of the
17 district is entitled to receive as compensation from the district an amount determined by the
18 board of directors not to exceed the amount provided for members of the legislative ~~council~~
19 executive committee under section 54-35-10 per day and must be reimbursed for the member's
20 expenses in the amounts provided in sections 44-08-04 and 54-06-09 while attending meetings
21 of the board or otherwise engaged in the official business of the district.

22 **SECTION 94. AMENDMENT.** Section 61-24.5-04 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **61-24.5-04. Board of directors - Officers - Meetings - Compensation.** The authority
25 must be governed by a board of directors who must be chosen in accordance with this chapter.
26 One director must be elected from each county within the authority, and two directors must be
27 elected in the city of Dickinson. The director from Stark County may not be a resident of the
28 city of Dickinson. The board shall elect from the directors a chairman, vice chairman, and
29 secretary. A majority of the directors constitutes a quorum for the purpose of conducting the
30 business of the board. The board shall meet at the time and place designated by the secretary.
31 Board members are entitled to receive as compensation an amount determined by the board

1 not to exceed the amount per day provided members of the legislative ~~council~~ executive
2 committee under section 54-35-10 and must be reimbursed for their mileage and expenses in
3 the amount provided for by sections 44-08-04 and 54-06-09.

4 **SECTION 95. AMENDMENT.** Section 65-02-30 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **65-02-30. Independent performance evaluation - Organization development of**
7 **performance measurements - Continuing appropriation.** Biennially, the director shall
8 request the state auditor to select a firm with extensive expertise in workforce safety and
9 insurance practices and standards to complete a performance evaluation of the functions and
10 operations of the organization during that biennium. This may not be construed to require the
11 firm to be a certified public accounting firm. As determined necessary by the state auditor, but
12 at least once every other biennium, the biennial independent performance evaluation must
13 evaluate departments of the organization to determine whether the organization is providing
14 quality service in an efficient and cost-effective manner; evaluate the effectiveness of safety
15 and loss prevention programs under section 65-03-04; and evaluate the board to determine
16 whether the board is operating within section 65-02-03.3 and within the board's bylaws. The
17 firm's report must contain recommendations for departmental improvement or an explanation of
18 why no recommendations are being made. The director, the chairman of the board, and a
19 representative of the firm shall present the evaluation report and any action taken to the
20 legislative ~~council's~~ executive committee's legislative audit and fiscal review committee and to
21 the house and senate industry, business and labor standing committees during the next regular
22 session of the legislative session following the performance evaluation. The director shall
23 provide a copy of the performance evaluation report to the state auditor. The organization shall
24 develop and maintain comprehensive, objective performance measurements. These
25 measurements must be evaluated as part of the independent performance evaluation
26 performed under this section. Money in the workforce safety and insurance fund is
27 appropriated on a continuing basis for the payment of the expense of conducting the
28 performance evaluation.

29 **SECTION 96. AMENDMENT.** Section 65-06.2-09 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **65-06.2-09. Safety and performance audit.** The organization shall perform a safety
2 audit of the roughrider industries work programs covered under this chapter and a performance
3 audit of the program of modified workers' compensation coverage. The organization shall
4 submit a report with recommendations based on the safety and performance audit to ~~an interim~~
5 ~~committee designated by~~ the legislative council no later than thirty days before the
6 commencement of each regular session of the legislative assembly.

7 **SECTION 97.** The legislative council may replace "chairman of the legislative council"
8 or "legislative council chairman" with "chairman of the legislative executive committee" in North
9 Dakota Century Code sections 4-05.1-16, 4-35-30, 14-09-09.7, 15-10.2-02, 15-52-03,
10 15.1-27-41, 16.1-13-10, 20.1-16-02, 24-02-37.2, 27-05.2-09, 44-02-02, 53-12.1-04, 54-03-20,
11 54-06-25, 54-35-20, 54-35-24, 54-61-01, and 57-39.4-31 and in any other provisions of the
12 code.

13 **SECTION 98.** The legislative council may replace "budget section of the legislative
14 council" or "legislative council's budget section" with "budget section of the legislative executive
15 committee" in North Dakota Century Code sections 15-03-04, 15-10-12.1, 15-10-12.3,
16 15-69-02, 15-69-05, 17-02-01, 20.1-02-05.1, 25-04-02.2, 40-23-22.1, 40-63-07, 47-30.1-24.1,
17 48-01.2-25, 50-06-05.1, 54-14-03.1, 54-16-04, 54-16-04.1, 54-16-04.2, 54-16-09, 54-23.3-09,
18 54-27-22, 54-27-23, 54-27.2-03, 54-44-04, 54-44-16, 54-44.1-13.1, 54-59-05, 57-38-01.29,
19 57-38-01.30, 65-04-03.1, and 65-08.1-02 and in any other provisions of the code.

20 **SECTION 99. REPEAL.** Section 49-21-22.2 of the North Dakota Century Code, is
21 repealed.
