

**HOUSE BILL NO. 1053**

1 A BILL for an Act to amend and reenact sections 37-17.1-06 and 37-17.1-07 of the North  
2 Dakota Century Code, relating to the department of emergency services division of homeland  
3 security and local and regional emergency management organizations; and to provide an  
4 appropriation.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. AMENDMENT.** Section 37-17.1-06 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8 **37-17.1-06. State division of homeland security.**

- 9 1. The division of homeland security must have professional, technical, secretarial,  
10 and clerical employees as necessary for the performance of its functions. The  
11 director of the division shall fix the compensation of the staff in conformity with  
12 state merit system regulations and may make such expenditures within the  
13 appropriations therefor, or from other funds made available to the director for  
14 purposes of emergency management, as may be necessary to carry out the  
15 purposes of this chapter.
- 16 2. The division of homeland security shall prepare and maintain a state disaster plan  
17 and keep it current, which plan may include provisions for:
- 18 a. Averting or minimizing the injury and damage caused by disasters or  
19 emergencies.
- 20 b. Prompt and effective response to a disaster or emergency.
- 21 c. Emergency relief.
- 22 d. Identification of areas particularly vulnerable to a disaster or emergency.

- 1 e. Recommendations for zoning, building, and other land use controls, safety
- 2 measures for securing mobile homes or other nonpermanent or
- 3 semipermanent structures, and other mitigation and preparedness measures.
- 4 f. Assistance to local officials in developing and maintaining local and regional
- 5 emergency management systems.
- 6 g. Authorization and procedures for the erection or other construction of
- 7 temporary works designed to protect against or mitigate danger, damage, or
- 8 loss from any disaster or emergency.
- 9 h. Preparation and distribution of emergency management assistance program
- 10 guidance to the appropriate state and local officials.
- 11 i. Organization of manpower and chains of command.
- 12 j. Coordination of federal, state, regional, and local emergency management
- 13 activities.
- 14 k. Coordination of state disaster or emergency operations plans with the disaster
- 15 or emergency plans of the federal government.
- 16 l. Other necessary matters.
- 17 3. The division of homeland security shall provide technical assistance for the
- 18 development and revision of local and regional disaster or emergency operations
- 19 plans prepared under section 37-17.1-07.
- 20 4. In preparing and revising state disaster or emergency plans, the division of
- 21 homeland security shall seek the advice and assistance of local government,
- 22 business, labor, industry, agriculture, civic, and volunteer organizations and
- 23 community leaders. In advising local and regional emergency management
- 24 organizations, the division shall encourage them also to seek advice from these
- 25 sources.
- 26 5. State disaster or emergency plans or any parts thereof have the force of law upon
- 27 implementation by the governor.
- 28 6. The division of homeland security, in coordination with lead and support agencies,
- 29 shall:
- 30 a. Coordinate the procurement of supplies, materials, and equipment during
- 31 disaster or emergency operations.

- 1           b. Provide guidance and standards for local and regional disaster or emergency  
2           operational plans.
- 3           c. Periodically review local and regional disaster or emergency operational  
4           plans.
- 5           d. Coordinate state or state and federal assistance to local and regional  
6           emergency management organizations.
- 7           e. Establish and operate or assist local and regional emergency management  
8           organizations to establish and operate training programs and programs for  
9           emergency public information.
- 10          f. Make surveys of industries, resources, and facilities, within the state, both  
11          public and private, as are necessary to carry out the purposes of this chapter.  
12          The use of sensitive and proprietary logistical data submitted to the state in  
13          confidence by individual industries and suppliers must be accorded full  
14          confidentiality and will be released only in aggregate form.
- 15          g. Plan and make arrangements for the availability and use of any private  
16          facilities, services, and property, and, if necessary and if in fact used,  
17          coordinate payment for that use under terms and conditions agreed upon.
- 18          h. Establish access to a register of persons with types of training and skills  
19          important in prevention, mitigation, preparedness, response, and recovery.
- 20          i. Establish access to a register of equipment and facilities available for use in a  
21          disaster or emergency.
- 22          j. Prepare, for issuance by the governor, executive orders, proclamations, and  
23          guidance as necessary or appropriate in managing a disaster or emergency.
- 24          k. Coordinate and may enter agreements with the federal government and any  
25          public or private agency or entity in achieving any purpose of this chapter and  
26          in implementing programs for disaster mitigation, preparation, response, and  
27          recovery.
- 28          l. Be the state search and rescue coordinating agency, establish access to a  
29          register of search and rescue equipment and personnel in the state, and plan  
30          for its effective utilization.

1 m. Do other things necessary, incidental, or appropriate for the implementation of  
2 this chapter.

3 **SECTION 2. AMENDMENT.** Section 37-17.1-07 of the North Dakota Century Code is  
4 amended and reenacted as follows:

5 **37-17.1-07. Local or regional emergency management organizations.**

- 6 1. All areas of the state are within the jurisdiction of and must be served by the  
7 division of homeland security and by a local or regional emergency management  
8 organization.
- 9 2. Each county shall maintain an emergency management organization which serves  
10 the entire county or must be a member of a regional emergency management  
11 organization that serves more than one county.
- 12 3. Each city shall provide an emergency management organization of its own, or it  
13 shall participate in the countywide emergency management organization. Each  
14 governing board of a city shall make its determination on the basis of the city's  
15 emergency management requirements, hazards, capabilities, and resources. If a  
16 city provides an emergency management organization of its own, the city and  
17 county shall coordinate the city and county emergency plans.
- 18 4. The mayor of or the president of the board of city commissioners in a city with an  
19 emergency management organization and the chairman of the board of county  
20 commissioners shall notify the division of homeland security of the manner in which  
21 the city and the county are providing or securing emergency management  
22 activities, identify each individual who will coordinate the activities of the local  
23 emergency management organization, and furnish additional information relating  
24 thereto as the division requires.
- 25 5. Each local or regional emergency management organization shall prepare and  
26 keep current a local disaster or emergency operational plan for its area.
- 27 6. ~~The~~ Each local or regional emergency management organization shall prepare and  
28 distribute to all appropriate officials in written form a clear and complete statement  
29 of the disaster or emergency responsibilities of their local agencies and officials.

30 **SECTION 3. APPROPRIATION.** There is appropriated out of any moneys in the  
31 general fund in the state treasury, not otherwise appropriated, the sum of \$1,500,000, or so

- 1 much of the sum as may be necessary, to the adjutant general for the purpose of providing
- 2 grants to counties who merge emergency management efforts, for the biennium beginning
- 3 July 1, 2009, and ending June 30, 2011.
