ENGROSSED SENATE BILL NO. 2067

1 A BILL for an Act to amend and reenact subsection 1 of section 39-06-03.1 and subsection 1 of
2 section 39-06-14 of the North Dakota Century Code, relating to the online registration of
3 donors.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Subsection 1 of section 39-06-03.1 of the North Dakota
6 Century Code is amended and reenacted as follows:

7 1. The director shall issue a nondriver color photo identification card to any North
8 Dakota resident who fulfills the requirements of this section. An application for an
9 identification card must be made on a form furnished by the director. Within thirty
10 days from receipt of a complete application that includes the applicant's social
11 security number, the director shall determine whether to issue and, if appropriate,
12 issue a nondriver photo identification card to an applicant. The application must
13 provide for the voluntary identification of the applicant as a donor under ~~the~~
14 ~~provisions of~~ chapter 23-06.6. If requested on the identification card application,
15 the identification card issued by the director must include a statement making an
16 anatomical gift under chapter 23-06.6. Voluntary identification of the applicant as
17 a donor under chapter 23-06.6 also may be completed by an online registry
18 approved by the director. If the applicant's donor intention is made by the online
19 registry, the intention must be recorded on the applicant's record. The intention is
20 not required on the identification card unless a duplicate card is obtained or at the
21 time of renewal. The department may not be held civilly or criminally liable for any
22 act or omission in implementing and maintaining the online registration of donors.
23 If the person is under the age of eighteen or at least the age of eighteen and under
24 the age of twenty-one, the photo must be against the same color background

1 required on a motor vehicle operator's license for an operator of that age. Subject
2 to ~~the provisions of~~ subsection 1 of section 39-06-19, identification cards expire
3 eight years from the date of issue and may be renewed.

4 **SECTION 2. AMENDMENT.** Subsection 1 of section 39-06-14 of the North Dakota
5 Century Code is amended and reenacted as follows:

6 1. The director, upon payment of a ten dollar fee, shall issue to every qualified
7 applicant an operator's license as applied for in the form prescribed by the director.
8 The license must bear a distinguishing number assigned to the licensee, a color
9 photograph of the licensee, the full name, date of birth, residence address, and a
10 brief description of the licensee, and either a facsimile of the signature of the
11 licensee or a space upon which the licensee shall write the licensee's usual
12 signature. The director may not issue a distinguishing number that is, contains,
13 can be converted to, or is an encrypted version of the applicant's social security
14 number. If the licensee is under the age of eighteen, the photograph must be
15 against a color border or background that is different from the color used for other
16 licensees. If the licensee is at least the age of eighteen and is under the age of
17 twenty-one, the photograph must be against a color border or background that is
18 different from the color used for other licensees. If requested on the license
19 application, the license issued by the director must include a statement making an
20 anatomical gift under chapter 23-06.6. Voluntary identification of the applicant as
21 a donor under chapter 23-06.6 also may be completed by an online registry
22 approved by the director. If the applicant's donor intention is made by the online
23 registry, the intention must be recorded on the applicant's record. The intention is
24 not required on the license unless a duplicate license is obtained or at the time of
25 renewal. The department may not be held civilly or criminally liable for any act or
26 omission in implementing and maintaining the online registration of donors. No
27 license is valid until it has been signed by the licensee with the licensee's usual
28 signature. ~~The department shall develop a system to require each applicant for an~~
29 ~~operator's license or renewal of an operator's license to determine whether or not~~
30 ~~the applicant wishes to be a donor under chapter 23-06.6.~~ For purposes of
31 verification, an officer may require the licensee to write the licensee's signature in

1 the presence of the officer. The director may adopt rules, pursuant to chapter
2 28-32, relating to the manner in which photographs are to be obtained and placed
3 on operator's licenses. The photograph may be produced by digital imaging or
4 other electronic means and is not a public record.
