1 A BILL for an Act to create and enact a new section to chapter 43-12.1 of the North Dakota  
2 Century Code, relating to discipline of an unlicensed assistive person practicing without  
3 registration; to amend and reenact section 43-12.1-14 of the North Dakota Century Code,  
4 relating to discipline of an unlicensed assistive person practicing without registration; and to  
5 provide for a legislative council study.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. AMENDMENT.** Section 43-12.1-14 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9 **43-12.1-14. Grounds for discipline - Penalties.** The board may deny, limit, revoke,  
10 encumber, or suspend any license or registration to practice nursing issued by the board or  
11 applied for in accordance with this chapter; reprimand, place on probation, or otherwise  
12 discipline a licensee, registrant, or applicant; deny admission to licensure or registration  
13 examination; provide an alternative to discipline in situations involving impairments of chemical  
14 dependency or psychiatric or physical disorders; ~~or~~ require evidence of evaluation and  
15 treatment; or issue a nondisciplinary letter of concern to a licensee, registrant, or applicant,  
16 upon proof that the person:

- 17 1. Has been arrested, charged, or convicted by a court, or has entered a plea of  
18 nolo contendere to a crime in any jurisdiction that relates adversely to the practice  
19 of nursing and the licensee or registrant has not demonstrated sufficient  
20 rehabilitation under section 12.1-33-02.1;
- 21 2. Has been disciplined by a board of nursing in another jurisdiction, or has had a  
22 license or registration to practice nursing or to assist in the practice of nursing or to  
23 practice in another health care occupation or profession denied, revoked,  
24 suspended, or otherwise sanctioned;

- 1           3. Has engaged in any practice inconsistent with the standards of nursing practice;
- 2           4. Has obtained or attempted to obtain by fraud or deceit a license or registration to
- 3           practice nursing, or has submitted to the board any information that is fraudulent,
- 4           deceitful, or false;
- 5           5. Has engaged in a pattern of practice or other behavior that demonstrates
- 6           professional misconduct;
- 7           6. Has diverted or attempted to divert supplies, equipment, drugs, or controlled
- 8           substances for personal use or unauthorized use;
- 9           7. Has practiced nursing or assisted in the practice of nursing in this state without a
- 10          current license or registration or as otherwise prohibited by this chapter;
- 11          8. Has failed to report any violation of this chapter or rules adopted under this
- 12          chapter; or
- 13          9. Has failed to observe and follow the duly adopted standards, policies, directives,
- 14          and orders of the board, or has violated any other provision of this chapter.

15           **SECTION 2.** A new section to chapter 43-12.1 of the North Dakota Century Code is  
16 created and enacted as follows:

17           **Unlicensed assistive person - Practice without a registration.** If the board  
18 determines an unlicensed assistive person, whose registration has expired, violated subsection  
19 7 of section 43-12.1-14 by practicing without a current registration for a period of up to four  
20 months from the initial date of employment, the action of the board in the case of a first violation  
21 is limited to the issuance of a letter of concern.

22           **SECTION 3. LEGISLATIVE COUNCIL STUDY.** During the 2009-10 interim, the  
23 legislative council shall study any steps necessary to enable the state department of health to  
24 administer the registry for certified nurse assistants, nurse assistants, and unlicensed assistive  
25 persons, and examine the possibility of one registry and a potential location for that registry.  
26 The legislative council shall report its findings and recommendations, together with any  
27 legislation required to implement the recommendations, to the sixty-second legislative  
28 assembly.
