1 A BILL for an Act to create and enact a new subsection to section 16.1-01-04 of the North  
2 Dakota Century Code, relating to qualifications of electors; and to amend and reenact  
3 subsection 1 of section 15.1-09-11, sections 16.1-01-09, 16.1-01-09.1, 16.1-02-01, 16.1-02-02,  
4 and 16.1-02-05, subsection 2 of section 16.1-02-06, sections 16.1-02-07, 16.1-02-10,  
5 16.1-02-13, 16.1-03-03, 16.1-03-19, 16.1-05-01, and 16.1-05-02, subsection 3 of section  
6 16.1-05-04, sections 16.1-05-06, 16.1-09-02, 16.1-10-04.1, 16.1-11-06, 16.1-13-32, 16.1-15-15,  
7 16.1-15-16, 16.1-15-34, 16.1-16-01, and 40-09-03, subsection 1 of section 40-21-02, sections  
8 40-21-07 and 44-08-21, and subsection 2 of section 57-40.6-02 of the North Dakota Century  
9 Code, relating to absentee ballot deadlines for schools, initiative petitions, recall petitions,  
10 central voter file, political party organization, appointment of election judges and poll clerks,  
11 voter affidavits, statement of interests, political advertising disclaimers, certificates of  
12 endorsement, candidate petitions, spoiled ballot retention, canvassing boards, recounts, and  
13 city elections.

14 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

15 **SECTION 1. AMENDMENT.** Subsection 1 of section 15.1-09-11 of the North Dakota  
16 Century Code is amended and reenacted as follows:

17 1. At least ~~twenty~~ forty days before the election, the business manager shall prepare  
18 and cause to be printed, or otherwise uniformly reproduced, an official ballot  
19 containing the names of all individuals who have indicated their intent to be  
20 candidates by meeting the provisions of section 15.1-09-08. The business  
21 manager shall notify the candidates as to the time and place of the drawing for  
22 position on the ballot.

23 **SECTION 2.** A new subsection to section 16.1-01-04 of the North Dakota Century Code  
24 is created and enacted as follows:

1           For purposes of this title, a qualified elector may not authorize an attorney in fact,  
2           guardian, or other individual to apply for any ballot or to vote in any election on  
3           behalf of or in the place of the qualified elector.

4           **SECTION 3. AMENDMENT.** Section 16.1-01-09 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6           **16.1-01-09. Initiative or referendum petitions - Signature - Form - Circulation.**

- 7           1. a. A request of the secretary of state for approval of a petition to initiate or refer  
8           a measure may be presented over the signatures of the sponsoring  
9           committee on individual signature forms that have been notarized. The  
10           secretary of state shall prepare a signature form that includes provisions for  
11           identification of the measure; the printed name, signature, and address of the  
12           committee member; and notarization of the signature. The filed signature  
13           forms must be originals.
- 14           b. Upon receipt of a petition to initiate or refer a measure, the secretary of state  
15           shall draft a short and concise statement that fairly represents the measure.  
16           The statement must be submitted to the attorney general for approval or  
17           disapproval. An approved statement must be affixed to the petition before it is  
18           circulated for signatures, must be called the "~~ballot~~ petition title", and must be  
19           placed immediately before the full text of the measure.
- 20           c. The secretary of state and the attorney general shall complete their review of  
21           a petition in not less than five, nor more than seven, business days, excluding  
22           Saturdays.
- 23           2. ~~No person~~ An individual may not sign any initiative or referendum petition  
24           circulated pursuant to article III of the Constitution of North Dakota unless the  
25           ~~person~~ individual is a qualified elector. ~~No person~~ An individual may not sign any  
26           petition more than once, and each signer shall add the signer's complete  
27           residential address or rural route or general delivery address and the date of  
28           signing. Every qualified elector signing a petition shall do so in the presence of the  
29           ~~person~~ individual circulating the petition. A referendum or initiative petition must  
30           be on a form prescribed by the secretary of state containing the following  
31           information:

17 necessary to accommodate other required textual matter. In this section for  
18 referral petitions "full text of the measure" means the bill as passed by the  
19 legislative assembly excluding the session and sponsor identification. In this  
20 section for initiative petitions "full text of the measure" means an enacting  
21 clause which must be: "BE IT ENACTED BY THE PEOPLE OF THE STATE  
22 OF NORTH DAKOTA" and the body of the bill. If the measure amends the  
23 law, all new statutory material must be underscored and all statutory material  
24 to be deleted must be overstruck by dashes. When repealing portions of the

20 4. No petition ~~shall~~ may be circulated under the authority of article III of the  
21 Constitution of North Dakota by ~~a person~~ an individual who is less than eighteen  
22 years of age, nor ~~shall~~ may the affidavit called for by subsection 3 be executed by  
23 ~~a person~~ an individual who is less than eighteen years of age at the time of  
24 signing. All petitions circulated under the authority of the constitution and of this  
25 section must be circulated in their entirety. A petition may not include a statement  
26 of intent or similar explanatory information.

27 5. When signed petitions are delivered to the secretary of state, the chairperson of  
28 the sponsoring committee shall submit to the secretary of state an affidavit stating  
29 that to the best of that ~~person's~~ individual's knowledge, the petitions contain at  
30 least the required number of signatures. An elector's name may not be removed

2 sponsoring the recall.
- 3 5. Circulators have one year to gather the required number of signatures of qualified  
4 electors on the recall petition from the date the secretary of state approves the  
5 recall petition for circulation.
- 6 6. A petition may not be circulated under the authority of article III of the Constitution  
7 of North Dakota or section 44-08-21 by ~~a person~~ an individual who is less than  
8 eighteen years of age, nor may the affidavit called for by subsection 3 be executed  
9 by ~~a person~~ an individual who is less than eighteen years of age at the time of  
10 signing. All petitions circulated under the authority of the constitution and of this  
11 section must be circulated in their entirety.
- 12 ~~6.~~ 7. When recall petitions are delivered to the secretary of state or other filing officer  
13 with whom a petition for nomination to the office in question is filed, the chairman of  
14 the sponsoring committee shall submit to the secretary of state or other filing officer  
15 an affidavit stating that to the best of that ~~person's~~ individual's knowledge, the  
16 petitions contain at least the required number of signatures. An elector's name  
17 may not be removed by the elector from a recall petition that has been submitted to  
18 and received by the appropriate filing officer.
- 19 ~~7.~~ 8. The filing officer has a reasonable period, not to exceed thirty days, in which to  
20 pass upon the sufficiency of a recall petition. The filing officer may conduct a  
21 representative random sampling of the signatures contained in the petitions by the  
22 use of questionnaires, postcards, telephone calls, personal interviews, or other  
23 accepted information-gathering techniques, or any combinations thereof, to  
24 determine the validity of the signatures. Signatures determined by the filing officer  
25 to be invalid may not be counted and all violations of law discovered by the filing  
26 officer must be reported to the state's attorney for possible prosecution.
- 27 9. The filing officer shall call a special recall election to be held no sooner than ninety  
28 days nor later than one hundred days following the date the filing officer certifies  
29 the petition valid and sufficient. No special recall election may be called if that date  
30 would be within ninety days of the next scheduled election.

1        10. A notice of the recall election must be posted in the official newspaper thirty days  
2            before the candidate filing deadline, which is by four p.m. on the sixtieth day before  
3            the election. The official notice must include the necessary information for a  
4            candidate to file and have the candidate's name included on the ballot.

5        11. An official may not be recalled if the recall special election would be held during the  
6            same year in which the official's office would be included on the ballot.

7            **SECTION 5. AMENDMENT.** Section 16.1-02-01 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9            **16.1-02-01. Permanent central voter file.** A permanent, centralized electronic data  
10 base of voters, to be known as the central voter file, is established with the offices of the  
11 secretary of state and county auditors linked together by a centralized statewide system. The  
12 county auditor is chief custodian of the central voter file records in each county. The secretary  
13 of state ~~is responsible for maintaining~~ shall maintain the central voter file. The central voter file  
14 must be accessible by the secretary of state and all county auditors for purposes of preventing  
15 and determining voter fraud, making changes and ~~updating the central voter file~~ updates, and  
16 generating information, including pollbooks, reports, inquiries, forms, and voter lists.

17            **SECTION 6. AMENDMENT.** Section 16.1-02-02 of the North Dakota Century Code is  
18 amended and reenacted as follows:

19            **16.1-02-02. Costs of creating and maintaining a central voter file.** The creation of  
20 the central voter file and its maintenance through June 30, 2011, must be paid for with funds  
21 from the state's election fund, provided the election fund contains adequate funding to create  
22 and maintain the central voter file. The creation of the central voter file and its maintenance  
23 through June 30, 2011, may not be paid for from funds in the secretary of state's budget, the  
24 state's general fund, or from county funds. Beginning July 1, 2011, the offices required to  
25 perform the functions and duties of this chapter shall bear the costs incurred in performing  
26 those duties and the secretary of state shall pay the costs of operating and maintaining the  
27 central voter file. As used in this section, costs of maintaining the central voter file mean costs  
28 of annual software licenses, hosting costs for the software in the state data center, costs of  
29 necessary enhancements to the software, and the costs for implementing the duties and  
30 responsibilities of the secretary of state's office relating to the central voter file.

1           **SECTION 7. AMENDMENT.** Section 16.1-02-05 of the North Dakota Century Code is  
2 amended and reenacted as follows:

3           **16.1-02-05. Entry of new voters into the central voter file - Query of the central**  
4 **voter file for double voting - ~~Verification by mail~~ - Challenges - Postelection verification.**

- 5           1. Within ~~sixty~~ forty-five days following an election, the county auditor shall enter the  
6 name and required information of each individual who voted at the last election  
7 who is not already contained in the central voter file and update any required  
8 information requested and obtained at the last election for any individual contained  
9 in the central voter file.
- 10          2. The secretary of state, with the assistance of the county auditors, within ~~seventy~~  
11 eighty-five days following an election, shall query the central voter file to determine  
12 if any individual voted more than once during the preceding election. The  
13 secretary of state shall immediately notify the county auditor and state's attorney in  
14 each affected county for further investigation.
- 15          3. ~~The county auditor shall mail to a random sampling of individuals contained in the~~  
16 ~~central voter file a notice stating the individual's name and address as the name~~  
17 ~~and address appear in the central voter file. The random sampling must be~~  
18 ~~determined in the manner established by the secretary of state. The notice must~~  
19 ~~request the individual to notify the county auditor if there is any mistake in the~~  
20 ~~information.~~
- 21          4. Upon return of any nonforwardable mail from an election official, the county auditor  
22 shall ascertain the name and address of that individual. If the individual is no  
23 longer at the address recorded in the central voter file, the county auditor shall  
24 designate the individual as "challenged" transfer the voter to the correct precinct in  
25 the central voter file or notify the county of the voter's new residence so the voter  
26 record can be transferred to the correct county. An individual designated as  
27 "challenged" shall comply with section 16.1-05-06 before being allowed to vote at  
28 the next election in that precinct. If a notice mailed at least sixty days after the  
29 return of the first nonforwardable mail is also returned by the postal service, the  
30 county auditor shall designate the individual as "inactive" in the central voter file.

1       5- 4.    Within ~~ninety~~ forty-five days after an election, the county auditor shall send ~~the a~~  
2            notice ~~provided for under subsection 3~~ to each individual who was challenged on  
3            election day according to section 16.1-05-06. If a notice is returned as not  
4            deliverable, the county auditor shall attempt to determine the reason for the return.  
5            A county auditor who does not receive or obtain satisfactory proof of an individual's  
6            eligibility to vote shall notify immediately ~~notify~~ the state's attorney to conduct an  
7            investigation of the individual's eligibility to vote in that election.

8            **SECTION 8. AMENDMENT.** Subsection 2 of section 16.1-02-06 of the North Dakota  
9    Century Code is amended and reenacted as follows:

10           2.    The state health officer shall provide for the regular reporting to the secretary of  
11            state the name, address, date of birth, and county of residence, if available, of  
12            each individual eighteen years of age or older whose name was changed by  
13            marriage since the last report. ~~Within sixty days after receiving a report, the~~  
14            ~~secretary of state shall make the name changes in the central voter file and notify~~  
15            ~~by mail each individual whose name was changed that the individual's name has~~  
16            ~~been changed accordingly in the central voter file.~~ The secretary of state shall  
17            prepare and distribute a list of those individuals to each county auditor.

18            **SECTION 9. AMENDMENT.** Section 16.1-02-07 of the North Dakota Century Code is  
19    amended and reenacted as follows:

20            **16.1-02-07. Reporting changes of names - Changes to records in the central voter**  
21    **file.** The state court administrator shall provide for the regular reporting to the secretary of state  
22    the name, address, date of birth, and county of residence, if available, of each individual  
23    eighteen years of age or older whose name was changed by divorce or any order or decree of  
24    the court since the last report. ~~Within sixty days after receiving the report, the secretary of state~~  
25    ~~shall make the name changes in the central voter file and notify by mail each individual whose~~  
26    ~~name was changed that the individual's name has been changed accordingly in the central~~  
27    ~~voter file.~~ The secretary of state shall prepare and distribute a list of those individuals to each  
28    county auditor. Any individual who has obtained a protection order under section 14-07.1-03 or  
29    who is protected by a disorderly conduct restraining order under section 12.1-31.2-01 must be  
30    listed in the central voter file with a "secured active" designation. A "secured active"  
31    designation means a record maintained as an active voter for pollbook purposes, but otherwise

1 is an exempt record. The state court administrator or the bureau of criminal investigation shall  
2 make available upon request of the secretary of state the name of each individual who has  
3 obtained such an order.

4 **SECTION 10. AMENDMENT.** Section 16.1-02-10 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **16.1-02-10. Posting voting history - Failure to vote - Individuals designated**  
7 **inactive.** Within ~~ninety~~ seventy-five days after each election, each county auditor shall post the  
8 voting history for each individual who voted in the election. After the close of the 2010 calendar  
9 year, the secretary of state shall determine if any individual has not voted during the preceding  
10 four years and shall change the status of each such individual to "inactive" in the central voter  
11 file. The secretary of state shall prepare a report to each county auditor which contains the  
12 name of each individual who has been designated as "inactive" in the central voter file.  
13 Although not counted in an election, a late absentee ballot from an individual may not be used  
14 to designate an individual as "inactive" in the central voter file.

15 **SECTION 11. AMENDMENT.** Section 16.1-02-13 of the North Dakota Century Code is  
16 amended and reenacted as follows:

17 **16.1-02-13. Information contained in pollbooks generated from the central voter**  
18 **file.** The county auditor shall generate a pollbook for each precinct in the county from the  
19 central voter file by the day before an election. With the exception of a record designated  
20 "secured active" and the unique identifier, which are exempt records, the precinct pollbooks are  
21 open records under section 44-04-18. ~~Between the fifteenth day before the election and the~~  
22 ~~day of the election, no changes or updates to records of individuals contained in the central~~  
23 ~~voter file or a pollbook generated from the central voter file may be made, other than changes~~  
24 ~~related to the status of an individual voting early or an individual requesting and returning an~~  
25 ~~absent voter's ballot.~~ The secretary of state shall prescribe procedures for generating pollbooks  
26 and for transporting the pollbooks to the election judges for use on election day. Pollbooks  
27 generated from the central voter file must contain the following information for each individual  
28 contained therein:

- 29 1. The complete legal name of the individual.  
30 2. The complete residential address of the individual.

- 1           3.    The complete mailing address of the individual, if different from the individual's
- 2                residential address.
- 3           4.    The unique identifier generated and assigned to the individual.
- 4           5.    The county, legislative district, city or township, school district, county
- 5                commissioner district, if applicable, precinct name, and precinct number in which
- 6                the individual resides. A ballot-style code identifying this information may be used
- 7                in place of the information required by this subsection.
- 8           6.    Any other information requested of and obtained from the individual deemed
- 9                necessary by the secretary of state for the proper administration of the pollbook.

10           **SECTION 12. AMENDMENT.** Section 16.1-03-03 of the North Dakota Century Code is  
11 amended and reenacted as follows:

12           **16.1-03-03. Caucus business and elections - Political parties entitled to elect**  
13 **committeemen.**

- 14           1.    Each precinct caucus shall elect a chairman, committeemen as provided in
- 15                subsection 3, and other officers as may be provided by party rules. The caucus
- 16                may also discuss party policies, candidates, and any other business as prescribed
- 17                by party rules.
- 18           2.    No political organization is entitled to elect a precinct committeeman at its precinct
- 19                caucus unless:
  - 20                a.    The organization nominated and had printed on the ballot at the last
  - 21                    preceding ~~presidential~~ general election the names of a set of presidential
  - 22                    electors pledged to the election of the party's candidates for president and
  - 23                    vice president or a candidate for governor, attorney general, or secretary of
  - 24                    state; and
  - 25                    b.    The candidates provided for in subdivision a received at least five percent of
  - 26                    the total vote cast for presidential electors or for governor, attorney general, or
  - 27                    secretary of state within this state at that election.
- 28           3.    Each political party in each voting precinct of this state, otherwise qualifying under
- 29                subsection 2, is entitled to elect one precinct committeeman for each two hundred
- 30                fifty votes, or fraction thereof, cast for the party's presidential electors, governor,
- 31                attorney general, or secretary of state in the precinct in the last ~~presidential~~ general

1 election. Each precinct is entitled to at least one precinct committeeman for each  
2 party which qualifies under subsection 2. Each precinct committeeman must be an  
3 elector of the precinct in which the committeeman resides and must be elected for  
4 a two-year term.

5 **SECTION 13. AMENDMENT.** Section 16.1-03-19 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **16.1-03-19. Organizations allowed to nominate statewide and legislative**  
8 **candidates.** A political organization may not endorse candidates or have candidates petition  
9 for president, vice president, Congress, statewide office, or legislative office as set forth in  
10 chapter 16.1-11, unless the organization, ~~political or otherwise~~:

- 11 1. Had printed on the ballot at the last preceding ~~presidential~~ general election the  
12 names of a set of presidential electors pledged to the election of the party's  
13 candidate for president and vice president ~~or~~, a candidate for governor, a  
14 candidate for attorney general, or a candidate for secretary of state and those  
15 candidates for presidential electors ~~or~~, governor, attorney general, or secretary of  
16 state received at least five percent of the total vote cast for presidential electors ~~or~~,  
17 the office of governor, attorney general, or secretary of state within this state at that  
18 election; and
- 19 2. Organized according to all requirements of this chapter; or
- 20 3. Filed a petition with the secretary of state as set forth in section 16.1-11-30.

21 **SECTION 14. AMENDMENT.** Section 16.1-05-01 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23 **16.1-05-01. Election officers.** At each primary, general, and special statewide or  
24 legislative district election, and at county elections, each polling place must have an election  
25 board in attendance. The election board must consist of an election inspector and at least two  
26 election judges. Counties utilizing polling places containing more than one precinct may  
27 choose to use one election board to supervise all precincts even if the precincts are within  
28 different legislative districts so long as each district chairman of each qualified political party is  
29 given the opportunity to have representation on the election board if desired.

- 30 1. The election inspector must be selected in the following manner:

- 1           a. Except as provided in subdivision b, in all precincts established by the  
2                   governing body of an incorporated city pursuant to chapter 16.1-04, the  
3                   governing body shall appoint the election inspectors for those precincts and fill  
4                   all vacancies occurring in those offices.

20                          places in which over one thousand votes are cast in any election, the

- 23          ~~3.~~ (2) The district party chair shall notify the county auditor of the counties in  
24                          which the precincts are located of the appointment of the election  
25                          judges at least forty days before the primary, general, or special  
26                          election. If this notice is not received within the time specified in this  
27                          section, the county auditor shall appoint the judges. If the county  
28                          auditor has exhausted all practicable means to select judges from  
29                          within the boundaries of the precincts within the polling place and  
30                          vacancies still remain, the county auditor may select election judges  
31                          who reside outside of the voting precinct but who reside within the

8 ~~4.~~ 3. If at any time before or during an election, it ~~shall be made to appear~~ appears to an  
9 election inspector, by the affidavit of two or more qualified electors of the precinct,  
10 that any election judge is disqualified under this chapter, the inspector shall remove  
11 that judge at once and shall fill the vacancy by appointing a qualified ~~person~~  
12 individual of the same political party as that of the judge removed. If the  
13 disqualified judge had taken the oath of office as prescribed in this chapter, the  
14 inspector shall place the oath or affidavit before the state's attorney of the county.

15 ~~5.~~ 4. ~~With the approval of the majority of the board of county commissioners, the county~~  
16 ~~auditor may appoint as many poll clerks as are necessary for the proper~~  
17 ~~administration of a polling place.~~ The election official responsible for the  
18 administration of the election, with the approval of the majority of the members of  
19 the applicable governing body, shall appoint the poll clerks for each polling place.  
20 However, no fewer than two poll clerks must be appointed for each polling place.  
21 Poll clerks must be appointed based on their knowledge of election matters,  
22 attention to detail, and on any necessary technical knowledge.

3 3. ~~Prior to~~ Before assuming ~~their~~ the duties, ~~all members~~ each member of the  
4 election board and ~~the~~ each poll ~~clerks~~ clerk severally shall take and subscribe an  
5 oath in substantially the following form:

6 I do solemnly swear (or affirm as the case may be), that I will perform the  
7 duties of inspector, judge, or clerk (as the case may be) according to law and  
8 to the best of my ability, and that I will studiously endeavor to prevent fraud,  
9 deceit, and abuse in conducting the same.

10 The oath may be taken before any officer authorized by law to administer oaths,  
11 and in case no such officer is present at the opening of the polls, the inspector or  
12 election judges shall administer the oath to each other and to the poll clerks. The  
13 ~~person~~ individual administering the oath shall cause an entry thereof to be made  
14 and subscribed by that ~~person~~ individual and prefixed to each pollbook.

15 4. ~~A person~~ An individual serving as a member of the election board ~~shall, prior to~~  
16 before each election, shall attend a period of instruction conducted by the county  
17 auditor or the county auditor's designated representative, provided that ~~such~~ the  
18 period of instruction has been conducted since the appointment of the election  
19 judges or election inspector.

20 5. If any member of the election board fails to appear at the hour appointed for the  
21 opening of the polls, the remainder of the board shall select ~~a person~~ an individual

23 of election judge ~~or clerk~~, the remainder of the board shall select ~~a person~~ an

29 business manager, as appropriate, for instructions and then orally elect a board as

- 13           1. One poll challenger appointed by the district chairman of each political party  
14 represented on the election board is entitled to be in attendance at each polling  
15 place. Individual poll challengers may be replaced at any time during the hours of  
16 voting, but no more than one poll challenger from each political party is entitled to  
17 be in attendance at each polling place at any one time.
- 18           2. Any member of the election board may challenge the right of an individual to vote if  
19 the election board member has knowledge or has reason to believe the individual  
20 is not a qualified elector. A poll challenger may request members of the election  
21 board to challenge the right of an individual to vote if the poll challenger has  
22 knowledge or has reason to believe the individual is not a qualified elector of the  
23 precinct. A challenge may be based upon any one of the following:

25 requirements.
- 26           b. The individual offering to vote has never voted in the precinct before, the  
27 name of the individual offering to vote does not appear in the pollbook  
28 generated from the central voter file, and the individual fails to provide  
29 reasonable evidence of residency in the precinct.
- 30           c. Except as provided in section 16.1-01-05, the individual offering to vote  
31 physically resides outside of the precinct.

- 1           d. The individual offering to vote does not meet the residency requirements  
2           provided in section 16.1-01-04.
- 3           e. The individual offering to vote fails or refuses to provide an appropriate form  
4           of identification as requested under subsection 3.
- 5           3. If after an election board member has requested that the individual offering to vote  
6           provide an appropriate form of identification to address any of the voting eligibility  
7           concerns listed in subsection 2 and the identification is not provided or does not  
8           adequately confirm the eligibility of the challenged individual, the challenged  
9           individual may not vote unless the challenged individual executes an affidavit,  
10          acknowledged before ~~the an~~ election inspector board member, that the challenged  
11          individual is a legally qualified elector of the precinct.
- 12          4. The affidavit must include:
- 13           a. ~~The name, present address, and any contact telephone number of the affiant~~  
14           ~~and the address of the affiant at the time the affiant last voted.~~
- 15           b. The address of the affiant.
- 16           c. The birth date of the affiant.
- 17           d. The contact telephone number of the affiant.
- 18           e. The address of the affiant at the time the affiant last voted.
- 19           f. The previous last name of the affiant if it was different when the affiant last  
20           voted.
- 21           g. The identification number and state of any state-issued identification  
22           regardless of the state in which the identification was issued, if available.
- 23          e- h. A recitation of the qualifications for voting as set forth in section 16.1-01-04  
24           and the rules for determining residence.
- 25          e- i. Notice of the penalty for making a false affidavit and that the county auditor  
26           may is required to verify the affidavit.
- 27           j. A notice indicating that the affidavit is not an open record, but that information  
28           identifying who voted after executing an affidavit is an open record as part of  
29           the pollbook, except for any individual listed as secured active in the central  
30           voter file under section 16.1-02-13.

- 1 e- k. A place for the affiant to sign and swear to the affiant's qualifications as a  
2 voter.
- 3 5. Written notice of the penalty for making a false affidavit and that the county auditor  
4 shall verify the affidavits must ~~also~~ be prominently displayed at the polling place in  
5 a form prescribed by the secretary of state. An individual who falsely swears in  
6 order to vote is guilty of a class A misdemeanor and must be punished pursuant to  
7 chapter 16.1-01.
- 8 6. In addition to the poll challenger, not more than two poll checkers appointed by the  
9 district chairman of each political party represented on the election board may be in  
10 attendance at each polling place, provided the poll checkers do not interfere with  
11 the election process or with the members of the election board in the performance  
12 of their duties. The poll challengers and poll checkers must be qualified electors of  
13 the district in which they are assigned.
- 14 7. No poll challenger or checker may be a member of the election board.
- 15 8. The district chairman shall notify the county auditor of each county contained in the  
16 legislative district before the third day before the day of the election of the names of  
17 individuals whom the district chairman has appointed to serve as poll challengers  
18 and poll checkers in the precincts in the legislative district.

19 **SECTION 18. AMENDMENT.** Section 16.1-09-02 of the North Dakota Century Code is

22 shall sign and file a the statement of interests as required by this chapter. In a year when a  
23 president and vice president of the United States are to be chosen, presidential and vice  
24 presidential candidates shall file with the secretary of state either a statement of interests as  
25 required by this chapter or a copy of the personal disclosure statement that is required by the  
26 federal election commission. Candidates for elective office who are required to file such  
27 statements shall do so with the filing officer for that election at the time of filing a certificate of  
28 nomination, a certificate of endorsement, a petition of nomination, or a certificate of write-in  
29 candidacy, pursuant to chapter 16.1-11, 16.1-12, or 40-21, as is appropriate. ~~A person~~ An  
30 individual who has filed a statement as the result of candidacy in a primary election need not  
31 refile before running in the following general election. A write-in candidate who is not required

1 to file a certificate of write-in candidacy shall file the statement of interests after the candidate's  
2 election at the time of filing the required oath of office. Every ~~person~~ individual who is  
3 appointed by the governor to a state agency, board, bureau, commission, department, or  
4 occupational or professional licensing board shall file a statement of interests as required by  
5 this chapter with the secretary of state simultaneously with announcement of the appointment.  
6 A filing officer may not include a candidate's name on the ballot if an error is discovered on the  
7 statement and the candidate is unable to or refuses to make the necessary correction before  
8 the sixtieth day before the election.

9 **SECTION 19. AMENDMENT.** Section 16.1-10-04.1 of the North Dakota Century Code  
10 is amended and reenacted as follows:

11 **16.1-10-04.1. Certain political advertisements to disclose name of sponsor -**  
12 **Name disclosure requirements.** Every political advertisement by newspaper, pamphlet or  
13 folder, display card, sign, poster, or billboard, website, or by any other similar public means, on  
14 behalf of or in opposition to any candidate for public office, designed to assist, injure, or defeat  
15 the candidate by reflecting upon the candidate's personal character or political action, or by a  
16 measure committee, or a corporation making a direct expenditure either for or against a  
17 measure, must disclose on the advertisement the name of the person, as defined in section  
18 16.1-08.1-01, or political party paying for the advertisement. If the name of a political party,  
19 association, or partnership is used, the disclaimer must also include the name of the chairman  
20 or other responsible ~~person~~ individual from the political party, association, or partnership. The  
21 name of the person ~~or political party~~ paying for any radio or television broadcast containing any  
22 advertising announcement for or against any candidate for public office must be announced at  
23 the close of the broadcast. If the name of a political party, association, or partnership is used,  
24 the disclaimer must also include the name of the chairman or other responsible ~~person~~  
25 individual from the political party, association, or partnership. In every political advertisement in  
26 which the name of the person ~~or political party~~ paying for the advertisement is disclosed, the  
27 first and last name of any named ~~person~~ individual must be disclosed. An advertisement paid  
28 for by an individual candidate or group of candidates must disclose that the advertisement was  
29 paid for by the individual candidate or group of candidates. The first and last name or names of  
30 the candidates paying for the advertisement are not required to be disclosed. This section does  
31 not apply to campaign buttons.

1           **SECTION 20. AMENDMENT.** Section 16.1-11-06 of the North Dakota Century Code is  
2 amended and reenacted as follows:

3           **16.1-11-06. State candidate's petition or political party certificate of endorsement**  
4 **required to get name on ballot - Contents - Filing.**

5           1. Every candidate for United States senator, United States representative, a state  
6 office except the office of state senator or state representative, and judges of the  
7 supreme and district courts shall present to the secretary of state, between the first

11           4. a. A The certificate of endorsement signed by the state chairman of any legally  
12 recognized political party containing the candidate's name, post-office  
13 address, and telephone number, the title of the office to which the candidate  
14 aspires, and the party which the candidate represents; or

15           2. b. A The nominating petition containing the following:

16           a. (1) The candidate's name, post-office address, and telephone number, and  
17 the title of the office to which the candidate aspires, the appropriate  
18 district judgeship number if applicable, and whether the petition is  
19 intended for nomination for an unexpired term of office if applicable.

20           b. (2) The name of the party the candidate represents if the petition is for an  
21 office under party designation.

22           e. (3) The signatures of qualified electors, the number of which must be  
23 determined as follows:

24           (4) (a) If the office is under party designation, the signatures of three  
25 percent of the total vote cast for the candidates of the party with  
26 which the candidate affiliates for the same position at the last  
27 general election. However, no more than three hundred  
28 signatures may be required.

29           (2) (b) If there was no candidate of a party for a position at the  
30 preceding general election, at least three hundred signatures.

10 may not serve on the board. When a member of the county canvassing board is a candidate or

12 daughter-in-law, brother, or sister, whether by birth or marriage, of the whole or the half-blood,  
13 of any candidate for any office for which that member canvasses the votes, the member must  
14 be removed from that portion of the canvass. If any of the members of the board other than the  
15 representatives of the two political parties are disqualified or cannot serve for any other reason,  
16 the county commissioners who would be qualified to serve on the board shall appoint alternates  
17 to serve in the place of those members of the board who are disqualified. If any of the  
18 representatives of the district committees of the two parties are disqualified or cannot serve for  
19 any other reason and if the party wishes to have representation, the district chairmen shall  
20 appoint an alternate from their respective district committees to act as a member of the county  
21 canvassing board. A majority of the confirmed members of the board or their duly appointed  
22 alternates constitute a quorum and may make the canvass provided for in this chapter and  
23 certify the results thereof.

24 **SECTION 24. AMENDMENT.** Section 16.1-15-34 of the North Dakota Century Code is  
25 amended and reenacted as follows:

26 **16.1-15-34. Member of state canvassing board - When disqualified.** A member of  
27 the state canvassing board who has anything of value bet or wagered on the result of the  
28 election may not serve on the board. When a member of the state canvassing board is a  
29 candidate or husband, wife, father, mother, father-in-law, mother-in-law, son, daughter,  
30 son-in-law, daughter-in-law, brother, or sister, whether by birth or marriage, of the whole or the  
31 half-blood, of any candidate for any office for which that member canvasses the votes, the

2 remaining members shall canvass the votes for that office. If a quorum does not exist, another  
3 state officer, summoned according to the authorization granted the state canvassing board in  
4 section 16.1-15-33, shall ~~be required to~~ canvass the votes for that office.

5 **SECTION 25. AMENDMENT.** Section 16.1-16-01 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **16.1-16-01. Election recounts.** A recount of any primary, special, or general election  
8 for nomination or election to a congressional, state, district, legislative, county, or city office, or  
9 for the approval or disapproval of any measure, question, or bond issue submitted to the  
10 qualified electors of this state or one of its political subdivisions must be conducted according to  
11 guidelines established by the secretary of state and as follows:

- 12 1. A recount must be conducted when:
  - 13 a. Any ~~person~~ individual failed to be nominated in a primary election by one  
14 percent or less of the highest vote cast for a candidate for the office sought.
  - 15 b. Any ~~person~~ individual failed to be elected in a general or special election by  
16 one-half of one percent or less of the highest vote cast for a candidate for that  
17 office.
  - 18 c. A question, measure, or bond issue submitted to the qualified electors has  
19 been decided by a margin not exceeding one-fourth of one percent of the total  
20 vote cast for and against the question at any election.
- 21 2. A demand for a recount may be made by any of the following:
  - 22 a. Any ~~person~~ individual who failed to be nominated in a primary election by  
23 more than one percent and less than two percent of the highest vote cast for a  
24 candidate for the office sought.
  - 25 b. Any ~~person~~ individual who failed to be elected in a general or special election  
26 by more than one-half of one percent and less than two percent of the highest  
27 vote cast for a candidate for that office.
- 28 3. A demand for a recount must be made within three days after the canvass of the  
29 votes by the county canvassing board in the case of county elections and city  
30 elections that are combined with the county and by the state canvassing board in  
31 the case of presidential, congressional, state, judicial district, multicounty district,

- 1 or legislative elections. The demand must be in writing, must recite one of the  
2 conditions in subsection 2 as a basis for the recount, must contain a bond in an  
3 amount previously established by the auditor or auditors doing the recount  
4 sufficient to pay the cost of the recount, and must be filed with:
- 5 a. The secretary of state when the recount is for a congressional, state, district,  
6 or legislative office.
- 7 b. The county auditor when the recount is for a county office or city office when a  
8 city election is combined with the county.
- 9 4. Within four days after the canvass of the votes by the state canvassing board in the  
10 case of presidential, congressional, state, judicial district, multicounty district, or  
11 legislative elections, the secretary of state shall notify all the county auditors to  
12 conduct recounts as required by subsection 1 and, when a timely recount demand  
13 is received and it is in proper form, as required by subsection 2. The secretary of  
14 state shall fix the date or dates of the recounts of legislative contests to be held  
15 within seven days after giving notice to the affected auditors that recounts must be  
16 conducted. The secretary of state shall fix the date or dates of the recounts of  
17 statewide races to be held within fourteen days after giving notice to the auditors  
18 that recounts must be conducted. Within four days after the canvass of votes by  
19 the county canvassing board or other political subdivision canvassing board, the  
20 county auditor or other political subdivision election official shall fix the date for  
21 recounts limited to the county, those cities within the county which combined the  
22 election with the county, or other political subdivision. The date must be within  
23 eight days after the canvass. In all recount proceedings, the county auditor or  
24 other election official, as appropriate, shall send notice of the date, place, and time  
25 of the recount to all candidates and petitioners involved by certified mail.
- 26 5. ~~Recount employees.~~ For recounts conducted by counties of federal, state, district,  
27 and county offices, measures, and questions, the county auditor must conduct the  
28 recount and may employ up to four qualified electors of the county to assist in the  
29 recount. The county auditor shall review all paper and electronic voting system  
30 ballots and associated records, whether the ballots were counted at the precinct or  
31 the county canvass, and all absentee ballots cast pursuant to section 16.1-07-09 to

1 determine which ballots were cast and counted according to the law, including that  
2 the ballots were properly initialed and that the initials found on the ballots are  
3 verified as those of the precinct election board members. The county auditor shall  
4 check the precinct count and the count of the county canvassing board. If the  
5 county auditor is a candidate involved in the recount, the county auditor is  
6 disqualified from acting thereon, and the county recorder shall perform the duties  
7 required of the county auditor by this section. For recounts conducted by political  
8 subdivisions other than counties of local offices, measures, and questions, the  
9 election officer in a political subdivision shall administer a recount in the same  
10 manner as is required under this subsection for counties with respect to political  
11 subdivision ballot measures, questions, or bond issues.

12 6. ~~a. Recount participants.~~ The ~~persons~~ individuals entitled to participate at the  
13 recount are:  
14 a. (1) Each candidate involved in the recount, either personally or by a  
15 representative.  
16 b. (2) A qualified elector favoring each side of a question if the recount  
17 involves a question or proposition submitted to a vote of the electorate.  
18 b. The ~~persons~~ individuals allowed to participate may challenge the acceptance  
19 or exclusion of any ballot. The ~~person~~ individual challenging a ballot must  
20 state the reason for the challenge based upon the law, and the county auditor  
21 or other political subdivision election official shall count the challenged ballot  
22 as the auditor or election official ~~deems~~ determines proper and ~~shall~~ then  
23 shall set the ballot aside with a notation that it was challenged and how it was  
24 counted.

25 7. ~~Recount board.~~ At the conclusion of the recount, the county auditor or other  
26 election official shall submit all challenged ballots to the recount board for decision.  
27 Except for political subdivision recounts other than counties, the recount board  
28 must be composed of the state's attorney of the county, the chairman of the board  
29 of county commissioners, and the county recorder. Unless otherwise specified by  
30 law, for a political subdivision other than a county, the governing body of the  
31 political subdivision shall appoint the recount board. ~~No person~~ An individual may

1            not serve on the recount board if the ~~person~~ individual has anything of value bet or  
2            wagered on the result of the election, is a candidate for the office being recounted,  
3            or is the husband, wife, father, mother, father-in-law, mother-in-law, son, daughter,  
4            son-in-law, daughter-in-law, brother, or sister, whether by birth or marriage, of the  
5            whole or the half-blood, of any candidate involved in the recount. If any of the  
6            members of the recount board are disqualified or cannot serve for any other  
7            reason, the members of the board of county commissioners or other political  
8            subdivision governing body who would be qualified to serve on the board shall  
9            appoint disinterested qualified electors of the county or other political subdivision to  
10           serve as alternates. The recount board shall review all challenged ballots and on  
11           majority vote shall decide how those ballots are counted. The recount board is  
12           authorized to initial all absentee ballots cast ~~pursuant to~~ under section 16.1-07-09  
13           that were not considered or counted at the various precincts in the county for the  
14           reasons provided in sections 16.1-07-11 and 16.1-07-12 or by the county  
15           canvassing boards as provided in section 16.1-15-19. The decision of the recount  
16           board is final, subject to the right to contest the election as provided in this chapter.  
17           If during the recount a recess is called, the county auditor or other political  
18           subdivision election official shall take appropriate steps to safeguard the ballots.

19           8. The county auditor or other election official shall certify the results of the recount no  
20           later than three days after the recount. The recount result is the official result of  
21           the election in the county or other political subdivision. The county auditor or other  
22           election official shall prepare a corrected abstract of the votes. In a recount limited  
23           to the county, city, or other political subdivision, if the corrected abstract shows no  
24           change in the outcome of the election, no further action may be taken. If the  
25           corrected abstract changes the outcome of the election, the county auditor or other  
26           election official shall issue certificates of nomination or election accordingly and  
27           shall certify the new result of a question submitted to the qualified electors. In the  
28           case of a city election that is combined with a county election, the county auditor  
29           shall certify the new results of the election to the city auditor who is responsible for  
30           issuing new certificates of election if applicable.

- 1           9. In presidential, congressional, statewide, judicial district, multicounty district, or  
2 legislative recounts, the county auditor ~~shall~~, no later than three days after the  
3 recount, shall send by certified mail a certified copy of the corrected abstract to the  
4 secretary of state. The secretary of state ~~shall~~ immediately shall assemble the  
5 state canvassing board, who shall canvass the corrected abstracts and certify the  
6 election results. The secretary of state shall issue certificates of election or  
7 nomination or record the approval or disapproval of a question submitted to the  
8 qualified electors accordingly.
- 9           10. The expenses incurred in a recount of a county election must be paid by the county  
10 on a warrant by the county auditor. The expenses incurred in a recount of a  
11 political subdivision other than a county election must be paid by that political  
12 subdivision. The expenses incurred in a recount of a city election must be paid by  
13 the city on a warrant by the city auditor. The expenses incurred in a recount of a  
14 presidential, congressional, state, judicial district, multicounty district, or legislative  
15 election must be paid by the state from the general fund upon approval by the  
16 secretary of state of a statement of expenses received from the county auditors.  
17 The expenses incurred in a recount demanded under subsection 2 of section  
18 16.1-16-01 must be paid by the secretary of state or county auditor from the bond  
19 submitted by the ~~person~~ individual requesting the recount.
- 20           11. This section also applies to city elections that are not combined with the county  
21 except the city auditor, to the extent applicable, shall perform the duties of the  
22 county auditor.

23           **SECTION 26. AMENDMENT.** Section 40-09-03 of the North Dakota Century Code is  
24 amended and reenacted as follows:

25           **40-09-03. Regulations governing election of commissioners.** The members of the  
26 board of city commissioners ~~shall~~ must be elected at large and not by wards. Each voter may  
27 vote for one of the candidates for the office of president of the board of city commissioners and  
28 for as many candidates for the office of city commissioner as there are commissioners to be  
29 elected. Candidates for the city commission may run for either the office of city commissioner  
30 or the office of president of the board of city commissioners but not both in the same election.  
31 A candidate may run for only one office in a city at any given election.

1           **SECTION 27. AMENDMENT.** Subsection 1 of section 40-21-02 of the North Dakota  
2 Century Code is amended and reenacted as follows:

3           1. Thirty days before the filing deadline for candidate names to be printed on the  
4 ballot, an official notice of this deadline along with a list of the offices to appear on  
5 the ballot must be published in the official newspaper of the city as provided by  
6 section 40-01-09.

7           **SECTION 28. AMENDMENT.** Section 40-21-07 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9           **40-21-07. Petition for nomination of elective official in cities - Signatures required**  
10 **- Withdrawal of petition - Contents.** A candidate for any public office in an incorporated city  
11 may be nominated by filing with the city auditor, at least sixty days and before four p.m. on the  
12 sixtieth day before the holding of the election, a petition signed by not less than ten percent of  
13 the number of qualified electors who voted for that office in the last city election. A candidate  
14 shall also file a statement of interests as required by section 16.1-09-02. If multiple candidates  
15 were elected to the office at the preceding city election at which the office was voted upon, the  
16 number of signatures must equal at least ten percent of the total votes cast for all candidates  
17 divided by the number of candidates that were to be elected to that office at that election.  
18 Qualified electors who sign a petition must reside within the ward or precinct in and for which  
19 that officer is to be elected, if the election is by wards, or within the corporate limits of the city, if  
20 the officer is elected at large. In cities operating under the commission system of government  
21 the required petition may be signed by the qualified electors at large residing within the city. If a  
22 petition is mailed, it must be in the possession of the city auditor before four p.m. on the sixtieth  
23 day ~~prior to~~ before the holding of the election. However, no more than three hundred  
24 signatures may be required and the signatures may be on separate sheets of paper. Petitions  
25 must meet the specifications of nominating petitions pursuant to section 16.1-11-16. If a city  
26 election is not combined with a state or county election according to section 40-21-02, a  
27 candidate may be nominated by filing the required petition with the city auditor at least sixty  
28 days and before four p.m. on the sixtieth day before the holding of the election. A candidate  
29 may withdraw the candidate's nominating petition at any time before the applicable deadlines  
30 for filing nominating petitions provided for in this section. Nominating petitions required by this  
31 section may not be circulated or signed more than ninety days before the date when nominating

1 petitions must be filed ~~pursuant to~~ under this section. Any signatures to a nominating petition  
2 obtained more than ninety days before that date may not be counted. ~~Candidates~~ A candidate  
3 for city council may run for either the office of mayor or council member but not both in the  
4 same election. ~~Candidates~~ A candidate for the city commission may run for either the office of  
5 city commissioner or the office of president of the board of city commissioners but not both in  
6 the same election. A candidate may run for only one office in a city at any given election.

7 **SECTION 29. AMENDMENT.** Section 44-08-21 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9 **44-08-21. Recall of elected officials of political subdivisions.**

- 10 1. An elected official of a political subdivision, except an official subject to recall  
11 ~~pursuant to~~ under section 10 of article III of the Constitution of North Dakota, is  
12 subject to recall by petition of electors equal in number to twenty-five percent of the  
13 voters who voted in the most recent election that the official sought to be recalled  
14 was on the ballot, not including other recall elections. An official who was  
15 appointed to fill a vacancy is subject to recall by petition of electors equal in  
16 number to twenty-five percent of the voters who voted in the most recent election  
17 that the office of the official sought to be recalled was on the ballot, not including  
18 other recall elections. The provisions of section 16.1-01-09.1, as they relate to  
19 signing and circulating recall petitions, apply to petitions under this section.
- 20 2. A recall petition must include a stated reason for the recall and be approved as to  
21 form ~~prior to~~ before circulation by the secretary of state. The secretary of state  
22 shall complete the review of the form of a recall petition in not less than five, nor  
23 more than seven, business days, excluding Saturdays. To be effective, a recall  
24 petition must be submitted to the appropriate filing officer within ninety days after  
25 the date the recall petition is approved for circulation by the secretary of state.
- 26 3. Once circulated, the recall petition must be filed with the filing officer with whom a  
27 petition for nomination to the office in question is filed unless that filing officer is the  
28 ~~person~~ individual subject to recall, in which case the petition must be filed with the  
29 secretary of state. The filing officer with whom the petition is filed shall pass on the  
30 sufficiency of a petition pursuant to section 16.1-01-09.1. Except as otherwise  
31 provided in this section, the filing officer shall call a special election to be held not

1           sooner than ~~eighty~~ ninety days nor later than ~~ninety one hundred~~ days following  
2           the date the filing officer certifies the petition valid and sufficient. No special  
3           election may be called if that date would be within ninety days of the next  
4           scheduled election. An elector's name may not be removed from a recall petition  
5           that has been submitted to and received by the appropriate filing officer.

6           4. The name of the official to be recalled must be placed on the ballot unless the  
7           official resigns within ten days after the filing officer certifies the petition is valid and  
8           sufficient. Other candidates for the office may be nominated in a manner provided  
9           by law and shall file nominating papers with the appropriate filing officer by the  
10          sixtieth day before the scheduled recall election. If the official resigns, the  
11          appropriate political subdivision governing body may call a special election or  
12          appoint ~~a person~~ an individual to complete the unexpired term of the office. When  
13          the election results have been officially declared, the candidate receiving the  
14          highest number of votes is elected for the remainder of the term. No official is  
15          subject to recall twice during the term for which the official was elected. An official  
16          whose office is on the ballot at a regularly scheduled election occurring within one  
17          year is not subject to recall.

18           **SECTION 30. AMENDMENT.** Subsection 2 of section 57-40.6-02 of the North Dakota  
19 Century Code is amended and reenacted as follows:

20          2. The question of the adoption of the fee must be submitted on a ballot on which the  
21          ~~ballot~~ petition title of the proposition includes the maximum monthly rate of the  
22          proposed fee authorized under subsection 1. The question of the adoption of the  
23          fee may be submitted to electors at a general, primary, or special election or at a  
24          school district election if the boundaries of the school district are coterminous with  
25          the boundaries of the governing body adopting the resolution proposing the  
26          adoption of the fee. The fee is not effective unless it is approved by a majority of  
27          the electors voting on the proposition. The ballot must be worded so that a "yes"  
28          vote authorizes imposition of the fee for an initial six-year period.
