1 A BILL for an Act to create and enact eleven new sections to chapter 61-24 of the North Dakota

2 Century Code, relating to authorizing revenue bonds for the Red River valley water supply

3 project; and to amend and reenact sections 61-24-01, 61-24-08, 61-24-19, 61-39-01, and

4 61-39-03 of the North Dakota Century Code, relating to the Garrison Diversion Conservancy

5 District.

## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7 SECTION 1. AMENDMENT. Section 61-24-01 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 61-24-01. Development and utilization of land and water resources declared a 10 public purpose - Declaration of intention - Interpretation. It is hereby declared that more 11 effective development and utilization of the land and water resources of this state, protection 12 and preservation of the benefits therefrom, opportunity for greater economic security, protection 13 of health, property and enterprise, and the promotion of the prosperity and general welfare of all 14 of the people of North Dakota involve, necessitate, and require the exercise of the sovereign 15 powers of the state and concern a public purpose, the accomplishment of which, among other 16 things, demands, and it is hereby declared necessary, that the Garrison diversion unit of the 17 Missouri River basin project as authorized by Act of Congress approved December 22, 1944 18 [58 Stat. 887], and acts amendatory thereof and supplementary thereto, be established and 19 constructed:

To provide for the future economic welfare and prosperity of the people of this
 state, and particularly of the people residing in the area embraced within the
 boundaries of the conservancy district created by this chapter.

23 2. To provide for the irrigation of lands within the sections of such district periodically
24 afflicted with drought, and to stabilize the production of crops thereon.

1	3.	To replenish and restore the depleted waters of lakes, the Red, Sheyenne, James,		
2		and other rivers, and streams in the district, and to stabilize the flow of these		
3		streams.		
4	4.	To replenish the waters, and to restore the level of Devils Lake, Stump Lake, Lake		
5		Williams, and Turtle Lake.		
6	5.	To make available within the district, or outside the district to the extent authorized		
7		by a joint powers agreement under chapter 54-40.3, waters diverted from the		
8		Missouri River for irrigation, domestic, municipal, and industrial needs, and for		
9		hydroelectric power, recreation, fish, wildlife, and other beneficial and public uses.		
10	<u>6.</u>	To study and provide for the water needs of eastern North Dakota communities		
11		and water districts and western Minnesota communities through a Red River valley		
12		water supply project.		
13	The provision	ons hereof shall not be construed to, in any manner, abrogate or limit the rights,		
14	powers, dut	ies, and functions of the state water commission, but shall be held to be		
15	supplement	ary thereto and an aid thereof. Nor shall this chapter be construed as limiting or in		
16	any way affe	ecting the laws of this state relating to the organization and maintenance of		
17	irrigation dis	stricts, flood irrigation districts, water resource districts, drainage districts, or		
18	watershed protection districts, nor as precluding the establishment of any such district wholly or			
19	in part within the boundaries of the district created by this chapter.			
20	SEC	CTION 2. AMENDMENT. Section 61-24-08 of the North Dakota Century Code is		
21	amended a	nd reenacted as follows:		
22	61-2	24-08. Powers and duties of the district board of directors. The board of		
23	directors of	the Garrison Diversion Conservancy District shall have the power:		
24	1.	To sue and be sued in the name of the district.		
25	2.	To exercise the power of eminent domain in the manner provided by title 32 for the		
26		purpose of acquiring and securing any right, title, interest, estate, or easement		
27		necessary to carry out the duties imposed by this chapter, and particularly to		
28		acquire the necessary rights in land for the construction of dams, reservoirs,		
29		canals, hydroplants, irrigation systems, pipelines, and any other device for the		
30		conservation, storage and use of water, and to secure the right of access to such		

1	works and the right of the public access to the waters impounding thereby or
2	emanating therefrom.

- To accept funds, property, and services or other assistance, financial or otherwise,
   from federal, state, and other public or private sources for the purpose of aiding
   and promoting the construction, maintenance, and operation of the Garrison
   diversion unit, or any part thereof.
- To cooperate and contract with the state, its agencies, or its political subdivisions,
  or any agency of the United States, in research and investigation or other activities
  promoting the establishment, construction, development, or operation of the
  Garrison diversion unit, or any part thereof.
- 5. To furnish assurances of cooperation and as principal and guarantor or either to
  enter into a contract, or contracts, with the United States of America, or any
  department or agency thereof, and with public corporations of North Dakota for the
  performance of obligations entered into with the United States for the construction,
  operation, or maintenance of works of the Garrison diversion unit of the Missouri
  River basin project as defined by Act of Congress, approved December 22, 1944
  [58 Stat. 887], and acts amendatory thereof or supplementary thereto.
- To construct separately or in cooperation with agencies of the United States, or the
   state of North Dakota, its agencies or political subdivisions, and to equip, maintain,
   and operate an office and principal place of business for the district, or other
   buildings or facilities to carry out activities authorized by this chapter.
- 7. To appoint and fix the compensation of such employees as the board shall deem
  necessary to conduct the business and affairs of the district.
- 8. To appoint from their number an executive committee and vest the same with such
  powers and duties as the board may from time to time delegate thereto, in order to
  facilitate the duties and work of the board in connection with the business affairs
  involved in the development, construction, operation, and maintenance of the
  Garrison diversion unit, or any part thereof.
- 9. In 1961 and each year thereafter to levy a tax of not to exceed one mill annually on
  each dollar of taxable valuation in the district for the payment of the expenses of
  the district, including, but not limited to, per diem, mileage and other expenses of

1 directors, technical, administrative, clerical, operating and other expenses of the 2 district office, and for the cumulation of a continuing fund through such levy for the 3 performance of obligations entered into with the United States of America in 4 connection with the construction, operation, and maintenance of works of the said 5 Garrison diversion unit of the Missouri River basin project. All moneys collected 6 pursuant to such levy shall be deposited in the Bank of North Dakota to the credit 7 of the district and shall be disbursed only as herein provided. The board may 8 invest any funds on hand, not needed for immediate disbursement or which are 9 held in reserve for future payments, in bonds of the United States, bonds and 10 mortgages or other securities the payment of which is guaranteed by the United 11 States or an instrumentality or agency thereof, or bonds or certificates of 12 indebtedness of the state of North Dakota or any of its political subdivisions. The 13 amount which may be levied in any one year for operating the district prior to 14 authorization by Congress of the Garrison diversion project shall not exceed ten 15 percent of the maximum permissible.

- 16 10. To enter into a contract or contracts for a supply of water from the United States 17 and to sell, lease, and otherwise contract to furnish any such water for beneficial 18 use to irrigation districts, persons, other public and private corporations, or limited 19 liability companies within <u>or outside</u> the district.
- To operate and maintain or to contract for the operation and maintenance of water
   supply and irrigation works serving lands and uses within <u>or outside</u> the district,
   and in connection therewith, to maintain a reserve fund to meet major unforeseen
   costs of operation and maintenance.
- 12. To accept, on behalf of the district, appointment of the district as fiscal agent of the
  United States and authorization to make collections of money for and on behalf of
  the United States in connection with the Garrison diversion unit.
- 13. To use navigable lakes and streams within the conservancy district for holding,
  impounding, and conveying water of the Garrison diversion unit.
- 14. To provide administrative aid and assistance in the relocation of buildings and the
   replacement of land to persons affected by the Garrison diversion development in

1		an effort to make certain that such persons are treated fairly and that they do not
2		suffer financial hardship due to the development of the Garrison diversion unit.
3	15.	To sell or exchange any and all real property purchased or acquired by the district.
4		All moneys received pursuant to any such sale or exchange shall be deposited in
5		the Bank of North Dakota to the credit of the district and may be disbursed only for
6		the payment of expenses of the district as specified in subsection 9.
7	<u>16.</u>	To borrow money as is provided in this chapter.
8	<u>17.</u>	To issue and sell revenue bonds to finance projects in an amount or amounts
9		determined by the board, including an amount for costs of issuance and financing,
10		and any necessary reserve funds, for the purpose of financing the cost of
11		constructing a project, purchasing bulk water, or otherwise making capital
12		payments required under a water purchase contract.
13	<u>18.</u>	To utilize some or all proceeds of its revenue bonds to acquire, construct,
14		reconstruct, or improve one or more projects, or any feasibility study or preliminary
15		economic, engineering, or legal work relating to any project.
16	<u>19.</u>	To refund and refinance its bonds from time to time as often as it is advantageous
17		and in the interest of the district.
18	<u>20.</u>	To pledge any and all income, profits, and revenues received by the district in
19		connection with the operation, lease, sale, or other disposition of all or any part of
20		a water project to secure the payment of bonds issued and sold to finance the
21		project or otherwise. Tangible real or personal nonrevenue property of the district
22		may not be liable to be forfeited or taken in payment of any bonds issued under
23		this chapter and debt on the general credit of the district may not be incurred in
24		any manner for payment of bonds under this chapter.
25	<u>21.</u>	To prescribe, revise, and collect rates, fees, tolls, or charges for the services,
26		facilities, or commodities furnished by the district and in anticipation of the
27		collection of the revenues of the district, issue revenue bonds to finance all or part
28		of the costs of the acquisition, construction, reconstruction, improvement,
29		betterment, extension, operation, or maintenance of a project.
30	<u>22.</u>	To pledge district revenues, grants, and any other project-related payments to the
31		punctual payment of principal and interest on bonds or water purchase contract

1		obligations. A pledge under this subsection applies to the revenues of
2		improvements, betterments, or extensions of the district which may be constructed
3		or acquired after the issuance of bonds, the revenues of existing systems, plants,
4		works, instrumentalities, and properties of any part of the district improved,
5		bettered, or extended, and the revenues received from payments made under
6		water sale contracts between the district and persons that contract to purchase
7		water from the district.
8	<u>23.</u>	To make all contracts, execute all instruments, and do all things necessary or
9		convenient in the exercise of its powers or in the performance of its covenants or
10		duties or in order to secure the payment of its bonds, but an encumbrance,
11		mortgage, or other pledge of tangible real or personal nonrevenue property of the
12		district may not be created by an such contract or instrument.
13	<u>24.</u>	To accept from any authorized federal agency loans or grants for the planning,
14		construction, acquisition, lease, or other provision of a project, and to enter
15		agreements with the agency respecting the loan or grants.
16	<u>25.</u>	To contract debts and borrow money and provide for payment of debts and
17		expenses of the district.
18	<u>26.</u>	To distribute water to western Minnesota cities that enter water service contracts
19		for water.
20	<u>27.</u>	To enter water service contracts with municipalities, water districts, or other
21		political subdivisions in this state and public utilities in Minnesota as part of the
22		Red River valley water supply project, regardless of whether the acquisition,
23		construction, or reconstruction of any Red River valley water supply project is
24		actually completed and whether water actually is delivered under the contracts.
25		These contracts with cities and water districts are authorized to be executed
26		without limitation on term of years notwithstanding any limitation to the contrary.
27	SE	CTION 3. AMENDMENT. Section 61-24-19 of the North Dakota Century Code is
28	amended a	and reenacted as follows:
29	61-	24-19. Easement granted for ditches, pipelines, canals, tramways, and
30	transmissi	ion lines on any public lands. In connection with the construction and
31	davalonmo	nt of the Garrison diversion unit of the Missouri River basin project, there is granted

1 over all the lands belonging to the state, including lands owned or acquired for highway 2 right-of-way purposes, a right of way for ditches, pipelines, or canals and for tunnels, tramways, 3 and telephone and electric transmission lines constructed as part of the Garrison diversion unit; 4 provided, however, that the director of the department of transportation, the board of county 5 commissioners, or the board of township supervisors must approve the plans of the bureau of 6 reclamation with respect to the use of any and all right of way of roads under their respective 7 control prior to such grant becoming effective. 8 **SECTION 4.** Eleven new sections to chapter 61-24 of the North Dakota Century Code 9 are created and enacted as follows: 10 Resolution authorizing the issuance of revenue bonds. 11 The issuance of revenue bonds or refunding bonds must be authorized by a 1. 12 resolution of the board adopted after appropriate notice by the affirmative vote of a 13 majority of the board. Unless otherwise provided in the resolution, the resolution 14 under this section takes effect immediately and need not be laid over, published, or 15 posted. 16 Each resolution providing for the issuance of bonds provided for in this chapter 2. 17 must contain the purposes for which the bonds are to be issued, the provisions for 18 payment of the bonds, and the revenues or other funds pledged to secure the 19 payment of the bonds. 20 **Provisions governing bonds.** The resolution authorizing the issuance of revenue 21 bonds or refunding bonds under this chapter or resolutions adopted after adoption of the 22 original resolution must prescribe: 23 The rates of interest, or if an interest rate is variable, the method for calculating the 1. 24 interest rate. 25 2. Whether the bonds will be in one or more series. 26 3. The dates the bonds will bear. 27 4. The times the bonds will mature. 28 5. The medium in which the bonds will be payable. 29 6. The places where the bonds will be payable. 30 <u>7.</u> The terms of redemption, if any, to which the bonds will be subject. 31 8. The manner in which the bonds will be executed.

1	<u>9.</u>	The terms, covenants, and conditions that the bonds will contain.			
2	<u>10.</u>	The form in which the bonds will be issued, either coupon or registered.			
3	<u>Sale</u>	e of bonds - When private sale authorized - Public sale and notice. Revenue			
4	bonds or re	funding bonds may be sold at public or private sale on any terms as the board			
5	deems app	ropriate.			
6	Not	es issued pending preparation of bonds - Negotiability. Pending the issuance			
7	<u>of bonds, b</u>	ond anticipation notes may be issued and sold in the form and with the provisions			
8	determined	by the district.			
9	Vali	dity of notes and bonds. Bond anticipation notes, revenue bonds, or refunding			
10	bonds bear	ing the manual or facsimile signatures of the appropriate officers who are in office			
11	on the date	of signing are valid and binding obligations notwithstanding that before the delivery			
12	and payment any or all of the individuals whose signatures appear on the notes or bonds have				
13	ceased to b	e officers of the issuing district. The resolution authorizing the notes or bonds may			
14	provide that the notes or bonds must contain a recital that they are issued under this chapter				
15	and the recital is conclusive evidence of their validity and of the regularity of their issuance.				
16	Notes and bonds exempt from taxation. Notwithstanding any other provision of law,				
17	the state ar	d all public officers, boards, and agencies, and political subdivisions and agencies			
18	of the state, all national banking associations, state banks, trust companies, savings banks and				
19	institutions, savings and loan associations, credit unions, investment companies, insurance				
20	companies, and other entities carrying on an investment business, and executors,				
21	administrate	ors, guardians, trustees, and other fiduciaries, may legally invest any sinking funds,			
22	moneys, or	other funds belonging to them or within their control in any bonds issued under this			
23	chapter, an	d the bonds are authorized security for public deposits. Notes and bonds, including			
24	refunding b	onds, issued under this chapter and their interest and income are exempt from all			
25	taxation by the state or by any political subdivision except inheritance, estate, and transfer				
26	taxes.				
27	Cov	renants and provisions that may be inserted in resolution authorizing bonds.			
28	<u>1.</u>	Any resolution authorizing the issuance of bonds under this chapter may contain			
29		covenants and provisions concerning:			
30		a. The rates, fees, tolls, or charges to be charged for the services, facilities, and			
31		commodities of a project.

1		<u>b.</u>	The use and disposition of all or a portion of the district's income, profits, and
2			revenues.
3		<u>C.</u>	The creation, maintenance, regulation, use, and disposition of reserves or
4			sinking funds.
5		<u>d.</u>	The purpose to which the proceeds of the sale of bonds may be applied and
6			the use and disposition of the proceeds.
7		<u>e.</u>	The events of default and the rights and liabilities arising upon default and the
8			terms and conditions upon which the holders of bonds issued under this
9			chapter may bring civil action on the bonds.
10		<u>f.</u>	The creation, priority, and enforcement of liens against the district's income,
11			profits, or revenues.
12		<u>g.</u>	The issuance of other or additional bonds or instruments payable from, or
13			constituting a charge against, the district's income, profits, or revenues.
14		<u>h.</u>	The creation and use of synthetic interest rate contracts, interest rate caps,
15			floors, and collars, and other techniques to lower the district's borrowing rate
16			or reduce its exposure to interest rate risk, or both.
17		<u>i.</u>	The keeping, inspection, and audit of books of account.
18		j.	The terms and conditions upon which any or all of the bonds become or may
19			be declared due before maturity and the terms and conditions upon which the
20			declaration and its consequences may be waived.
21		<u>k.</u>	The rights, liabilities, powers, and duties arising upon the breach by the
22			district of any covenants, conditions, or obligations.
23		<u>l.</u>	The vesting in a trustee of the right to enforce any covenants made to secure,
24			to pay, or in relation to the bonds, the powers and duties of the trustee, and
25			the limitations of liabilities of the trustee.
26		<u>m.</u>	The terms and conditions upon which the holders of the bonds, or the holders
27			of any proportion or percentage of them, may enforce any covenants made or
28			any duties imposed under this chapter.
29		<u>n.</u>	A procedure by which the terms of any resolution authorizing bonds or of any
30			other contract with bondholders, including an indenture of trust or similar
31			instrument, may be amended or abrogated, and the amount of bonds that

1			holders of which must consent to the resolution or contract, and the manner in
2			which the consent may be given.
3		<u>0.</u>	The subordination of the security of any bonds issued under this chapter and
4			the payment of principal and interest on those bonds, to the extent
5			determined feasible and desirable by the governing body, to other bonds or
6			obligations of the district issued to finance or refinance a project or that may
7			be outstanding when the bonds thus subordinated are issued and delivered.
8		<u>p.</u>	Provisions with respect to the district entering an agreement with a private
9			bond insurer, bank, or other liquidity or credit enhancer for bond insurance, a
10			guarantee, a letter or credit, or any other credit or liquidity enhancement that
11			the district may find to be advantageous or necessary to insure, guaranty, or
12			enhance the payment of the principal of or interest on or liquidity for some or
13			all of the bonds. The cost of the enhancement or liquidity may be paid from
14			bond proceeds or from other funds of the district available for this purpose.
15		<u>q.</u>	The insurance to be carried upon the project and the use and disposition of
16			insurance moneys.
17	<u>2.</u>	<u>Thi</u>	s section does not authorize the district to do anything in any manner or for any
18		pur	pose which would result in the creation or incurring of a debt or indebtedness or
19		<u>the</u>	issuance of any instrument which would constitute a debt or indebtedness
20		with	in the meaning of any provision, limitation, or restriction of the Constitution of
21		Nor	th Dakota relating to the creation or incurring of a debt or indebtedness or the
22		issu	ance of an instrument constituting a debt or indebtedness.
23	Lia	bility	of district for notes and bonds - Taxing power prohibited. Bond
24	anticipation	note	s, revenue bonds, and refunding bonds issued under this chapter may not be
25	payable fro	m or	charged upon any funds other than the revenue pledged to the bond's payment
26	and the dis	trict's	notes and bonds may not be subject to any pecuniary liability. The holder of
27	any of thes	e not	es or bonds may not enforce payment of the notes or bonds against any
28	tangible rea	al or p	personal nonrevenue property of the district. Notes and bonds issued under
29	this chapte	r do r	not constitute a charge, lien, or encumbrance upon any tangible real or personal
30	nonrevenue	e pro	perty of the district, other than the revenues pledged to their payments. Each

6			of the revenues, superior to the lien of the bonds or which might impair the

31	for the supp	bly and distribution of water to the people of eastern North Dakota for purposes,			

1 including domestic, rural water, municipal, livestock, light industrial, and other uses, with 2 primary emphasis on domestic, rural water, and municipal uses; and provide for the future 3 economic welfare and prosperity of the people of this state, and particularly the people of 4 eastern North Dakota, by the bulk purchase of water from the Garrison Diversion Conservancy 5 District delivered by the Red River valley water supply project for beneficial and public uses. 6 The Garrison Diversion Conservancy District may acquire, construct, improve, and own the 7 Red River valley water supply project and may enter water supply contracts with member cities 8 and water districts for the sale of water for consumption within or outside the district or the 9 state. Alternatively, the Lake Agassiz water authority may enter one or more contracts to 10 provide for the authority to acquire bulk water from the Garrison Diversion Conservancy District 11 and may enter water supply contracts with member cities and water districts for the resale of 12 this water for consumption within or outside the state. 13 The legislative assembly acknowledges that North Dakota and Minnesota communities

jointly use the Red River as a water resource. It is in the best interest of eastern North Dakota
also to study and possibly provide for the water needs of those Minnesota communities through
a Red River valley water supply project, particularly if that project maintains the use of the Red
River for North Dakota communities.

In furtherance of this public purpose, the state water commission may provide for the issuance of bonds in accordance with chapter 61-02 to finance the costs of any project to deliver water to eastern North Dakota. This chapter does not abrogate or limit the rights, powers, duties, and functions of the state water commission or state engineer, but is supplementary to those rights, powers, duties, and functions.

23 SECTION 6. AMENDMENT. Section 61-39-03 of the North Dakota Century Code is
24 amended and reenacted as follows:

61-39-03. Lake Agassiz water authority - Board of directors. The authority must be
 governed by a board of directors selected as follows:

- One member from a city with a population greater than forty thousand located east
   of state highway 1 and north of state highway 200.
- One member from a city with a population greater than forty thousand located east
   of state highway 1 and south of state highway 200.

18	the North Dakota league of cities and by the board of directors of the North Dakota rural water				
19	systems association. The initial city members shall serve until the annual meeting of the North				
20	Dakota league of cities in 2003 and the initial water district members shall serve until the				
21	annual meeting of the North Dakota rural water systems association in 2004. The initial				
22	Minnesota	city is Moorhead, as it is an associate member of the authority. Moorhead will serve

28	board. Notwithstanding the provisions of this section, within two years of the first delivery of				
29	water by the Red River valley water supply project, board members must be from a city or				
30	water distric	ct that has entered a water service contract with the Lake Agassiz water authority or			
31	the Garriso	n Diversion Conservancy District.
