ENGROSSED HOUSE BILL NO. 1023

1 A BILL for an Act to provide an appropriation for defraying the expenses of various state
2 departments and institutions; and to declare an emergency.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** There is appropriated out of any moneys in the
5 general fund in the state treasury, not otherwise appropriated, the sums as hereinafter provided
6 or so much of the sums as may be necessary. These sums increase the general fund authority
7 enacted by the sixtieth legislative assembly to the stated departments and institutions of the
8 state of North Dakota for the purpose of defraying their expenses, for the period beginning
9 January 1, 2009, and ending June 30, 2009, as follows:

22 **SECTION 2. EXEMPTION.** The sum of \$3,422,553 contained in subdivision 2 of
23 section 1 of this Act is not subject to the provisions of section 54-44.1-11 and any unexpended
24 funds from this appropriation are available during the biennium beginning July 1, 2009, and
25 ending June 30, 2011, for the purpose of providing state matching funds for public assistance
26 and disaster hazard mitigation.

27 **SECTION 3. UNSPENT APPROPRIATION AUTHORITY.** The appropriation in
28 subdivision 2 of section 1 of this Act includes \$1,400,000 for expenses incurred for the snow
29 emergency in January 2009. Any unexpended funds from this appropriation may not be spent
30 for other purposes and the appropriation authority must be canceled at the end of the biennium
31 ending June 30, 2009, in accordance with section 54-44.1-11.

1 **SECTION 4. UNSPENT APPROPRIATION AUTHORITY.** The appropriation in
2 subdivision 3 of section 1 of this Act is for paying the final university of North Dakota expenses
3 relating to the 1997 flood disaster. Notwithstanding any other provision of law, any
4 unexpended funds from this appropriation may not be spent for other purposes and the
5 appropriation authority must be canceled at the end of the biennium ending June 30, 2009, in
6 accordance with section 54-44.1-11.

7 **SECTION 5. EMERGENCY.** This Act is declared to be an emergency measure.
