The Senate convened at 9:00 a.m., with President Dalrymple presiding.

The prayer was offered by Dr. Keith Ritchie, Cornerstone Community Church, Bismarck.

The roll was called and all members were present except Senator Kilzer.

A quorum was declared by the President.

MOTION

SEN. CHRISTMANN MOVED that the Senate stand in recess until 9:10 a.m., at which time there will be a Joint Session in the House, and that the Senate will then stand in recess until 1:15 p.m., which motion prevailed.

REMARKS OF MAJORITY LEADER STENEHJEM

Each one of us here should feel blessed to be part of this Sixty-first Legislative Assembly. It is an honor and a privilege to serve the voters in our respective districts that had the faith to elect us to this chamber. But that comes with an enormous responsibility. As Senators, we must respond to the public trust with integrity, honesty and objectivity and be impartial in our decisions. We must at all times uphold the public trust and in a way that will hold up under the closest public scrutiny. We cannot allow our private interests to overshadow our public responsibility.

I am using a quote by Vaclav Havel which I have used before and sums up how I feel about politics, "Genuine politics - even politics worthy of the name - the only politics I am willing to devote myself to - is simply a matter of serving those around us: serving the community and serving those who come after us. Its deepest roots are moral because it is a responsibility expressed through action, to and for the whole."

At the end of this session we must be able to face our constituents, and all North Dakotans, and be able to honestly say that we have done our very best for the people of North Dakota.

REMARKS OF SENATE MINORITY LEADER O'CONNELL

First, I want to welcome all of the Senators back and to welcome the newly elected members of the Senate. Mr. President, I believe citizens want an ethical relationship with their government and public officials, one that consists of trust, honesty, integrity and commitment.
