### BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1. AMENDMENT.** Section 20.1-03-35 of the North Dakota Century Code is amended and reenacted as follows:

# 20.1-03-35. Social security number <u>or alternate unique identification</u> <u>number</u> to be furnished.

- The social security number or alternate unique identification number of an applicant for any license or permit issued under this chapter must be recorded on the application unless the applicant is a foreign national to whom no social security number has been issued. A social security number recorded under this section is confidential. Beginning on January 1, 2008,
- 2. As used in this section, "alternate unique identification number" means:
  - a. An operator's license number, nondriver photo identification card number, or instructional permit number issued to the applicant by the department of transportation;
  - b. A hunter education certificate number or other unique number issued to the applicant by the director, if the applicant's social security number is already on file with the director; or

<u>c.</u> <u>For</u> any application that is printed in paper form for a resident or nonresident fishing, hunting, or fur-bearer certificate <del>must be printed</del> in a manner so that only, the last four digits of the applicant's social security number are recorded on the application, and the first five digits of the applicant's social security number are not recorded on the application.

**SECTION 2. AGENCY DIRECTIVE.** The department of human services shall seek a federal exemption authorizing the state to implement section 1 of this Act.

**SECTION 3. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$150,000, or so much of the sum as may be necessary, to the game and fish department for the purpose of implementing section 1 of this Act, for the biennium beginning July 1, 2009, and ending June 30, 2011.

**SECTION 4. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$15,000, or so much of the sum as may be necessary, to the department of human services for the purpose of implementing section 1 of this Act, for the biennium beginning July 1, 2009, and ending June 30, 2011.

**SECTION 5. CONTINGENT EFFECTIVE DATE.** Sections 1, 3, and 4 of this Act become effective on the date the department of human services certifies to the game and fish department and the legislative council that the United States department of health and human services has granted the exemption requested in section 2 of this Act, or January 1, 2010, whichever is later."

### BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1.** A new chapter to title 17 of the North Dakota Century Code is created and enacted as follows:

**Definitions.** For purposes of this chapter, unless the context otherwise requires:

<u>1.</u> <u>"Biodiesel" means any non-petroleum-based diesel fuel made from a renewable resource such as vegetable oil or animal fat.</u>

- 2. <u>"E85 fuel" means a petroleum product that:</u>
  - a. Is a blend of agriculturally derived denatured ethanol and gasoline or natural gasoline;
  - <u>b.</u> <u>Typically contains eighty-five percent ethanol by volume but must at a minimum contain sixty percent ethanol by volume; and</u>
  - c. Complies with the American society for testing materials specification D 5798-96.
- 3. <u>"Motor fuel retailer" means a person that acquires motor vehicle fuel from a supplier or distributor for resale to a consumer at a retail location.</u>
- 4. "Retail location" means a site at which motor vehicle fuel is dispensed through a pump from an underground or aboveground storage tank into the supply tank of a motor vehicle.

Biofuel blender pump incentive fund - Continuing appropriation. There is created in the state treasury a special fund known as the biofuel blender pump incentive fund. All moneys transferred to the fund, interest on moneys in the fund, and payments to the fund are appropriated on a continuing basis for the purposes of this chapter. Any appropriation of moneys to the fund is not subject to section 54-44.1-11.

- Biofuel blender pump incentive fund Administration.
- 1. The department of commerce shall administer the biofuel blender pump incentive fund and use moneys in the fund to provide cost-share grants to motor fuel retailers for the installation of biofuel blender pumps and associated equipment at retail locations.
- 2. In determining eligibility for grant funds, the department shall establish by rule criteria governing:
  - <u>a.</u> <u>The verification of costs for biofuel blender pumps and associated equipment;</u>
  - b. The eligibility of grant recipients;
  - c. The application and grant award procedure; and
  - d. Reporting and accountability procedures for grant recipients.
- 3. The amount of incentives payable to any retail location under this chapter may not exceed two percent of the total amount appropriated or transferred to the biofuel blender pump incentive fund.

# Blender pumps - Requirements.

- 1. To qualify for a grant under this chapter, a retailer must obtain an ethanol blender pump that:
  - a. Dispenses at retail a blend of gasoline and ethanol in the ratio selected by the purchaser;
  - b. <u>Is manufactured to an industry standard and carries a warranty for</u> <u>compatibility with dispenser components;</u>
  - c. Has at least four hoses and dispenses the following:
    - (1) Either a blend of ten percent ethanol or the minimum blend percentage approved for all vehicles by the United States environmental protection agency;
    - (2) A blend of at least twenty percent ethanol; and
    - (3) <u>E85 fuel; and</u>

- <u>d.</u> <u>Complies with all alternative fuel, biofuel, and flexible fuel</u> requirements established by law.
- 2. In order to qualify for a grant under this chapter, a retailer must obtain a biodiesel blender pump that:
  - a. Dispenses at retail varying blends of biodiesel and mineral diesel in the ratio selected by the purchaser; and
  - b. Complies with all alternative fuel, biofuel, and flexible fuel requirements established by law.

Biofuel blender pump incentive fund - Administrative costs. The department may use up to five percent of any amount appropriated to the biofuel blender pump incentive fund for administration, the dissemination of information regarding the biofuel blender pump incentive program, and the dissemination of information regarding the benefits of biofuels.

Biofuel blender pump incentive fund - Alternative uses for moneys. If any moneys remain in the biofuel blender pump incentive fund after grants are made to all eligible recipients, the department may expend the moneys for renewable energy and energy conservation programs and initiatives.

**SECTION 2. AMENDMENT.** <u>Section 19-10-19 of the North</u> <u>Dakota Century Code is amended and reenacted as follows:</u>

19-10-19. Inspection fees. Every person licensed by the tax commissioner as a motor vehicle fuel or special fuels dealer shall pay to the tax commissioner an inspection fee of one-fortieth of one cent per gallon [3.79 liters] for every gallon [3.79 liters] of gasoline, kerosene, tractor fuel, heating oil, or diesel fuel, or alternative fuel sold or used during a calendar month except those gallons sold out of state or those gallons sold as original package sales as defined in chapters 57-43.1 and 57-43.2. The fee must accompany the monthly report required in the following section and is due no later than the twenty-fifth day of each calendar month for the preceding month. The tax commissioner shall forward all money collected under this section to the state treasurer monthly, and the state treasurer shall place the money in the general fund of the state. The tax commissioner shall make available annually a report by licensed dealer listing the number of gallons [liters] of motor vehicle fuel and special fuels upon which the inspection fee has been paid. The provisions of chapters 57-43.1 and 57-43.2 pertaining to the administration of motor vehicle fuel and special fuels taxes not in conflict with the provisions of this chapter govern the administration of the inspection fee levied by this chapter.

**SECTION 3. AMENDMENT.** <u>Section 19-10-20 of the North</u> <u>Dakota Century Code is amended and reenacted as follows:</u>

19-10-20. Report to tax commissioner of petroleum products - Contents - Fuels. No later than the twenty-fifth day of each calendar month, every person licensed by the tax commissioner as a motor vehicle fuel, special fuels, or liquefied petroleum wholesale dealer shall send to the tax commissioner a correct report of all purchases and sales of gasoline, kerosene, tractor fuel, heating oil, or diesel fuel, or alternative fuel during the preceding month. The report must include the same information as required in chapters 57-43.1 and 57-43.2 for motor vehicle fuel and special fuels tax collection purposes. Failure to send the report and inspection fee required by the preceding section to the tax commissioner constitutes a violation of the provisions of this chapter.

**SECTION 4. AMENDMENT.** <u>Section 19-10-21 of the North</u> Dakota Century Code is amended and reenacted as follows:

**19-10-21.** Bond may be required of Fuel dealer in petroleum products - Bond. The tax commissioner may require any

person licensed by the tax commissioner as a motor vehicle fuel, special fuels, or liquefied petroleum wholesale dealer to furnish a surety bond payable to the state of North Dakota in the sum of five hundred dollars, or twice the amount of inspection fees due for any calendar month, whichever amount is the greater, guaranteeing to the state true reports of purchases and sales of gasoline, kerosene, tractor fuel, heating oil, and diesel fuel, and alternative fuel and the payment of all inspection fees provided for in this chapter. The tax commissioner shall determine the sufficiency of the bond. A single bond may cover dealing in one or all of the petroleum products mentioned in this chapter. When any inspection fee is not paid within twenty days after it has become delinquent, the person bonding the delinquent may be called upon to make good upon the bond for such delinquent fees."

**SCR 4014:** A concurrent resolution recognizing October 15 as Pregnancy and Infant Loss Remembrance Day.

Was read the first time and referred to the Human Services Committee.

Sen. Mathern and Reps. Nelson, Zaiser introduced:

**SCR 4015:** A concurrent resolution directing the Legislative Council to study the potential cost impact of North Dakota Century Code Section 49-02-23 on the state's utility ratepayers and to the state's renewable electricity generation potential.

Was read the first time and referred to the Natural Resources Committee.

Sens. Potter, Krauter, Marcellais and Reps. Kilichowski, S. Meyer, Schmidt introduced:

**SCR 4016:** A concurrent resolution urging the Congress of the United States and the President to enact federal legislation promoting travel to the United States by overseas visitors, thereby promoting the economies of communities across North Dakota and the United States.

Was read the first time and referred to the **Transportation Committee.** 

Sens. Fiebiger, Fischer, Nelson and Reps. Hawken, Onstad introduced:

**SCR 4017:** A concurrent resolution directing the Legislative Council to study space and facility needs of state agencies to determine if efficiencies can be realized by constructing additional state-owned facilities.

Was read the first time and referred to the Government and Veterans Affairs Committee.

Sens. Wanzek, Miller, Taylor and Reps. D. Johnson, Nelson introduced:

- **SCR 4018:** A concurrent resolution recognizing the components of sustainable agriculture in this state.
- Was read the first time and referred to the **Agriculture Committee**.

Sens. Wanzek, Taylor and Reps. Brandenburg, Froelich introduced:

**SCR 4019:** A concurrent resolution urging Congress to examine carefully the known and potential impacts of implementing a national animal identification system.

Sens. O'Connell, Grindberg, Wardner and Reps. Berg, S. Meyer, Skarphol introduced:

**SCR 4020:** A concurrent resolution urging Congress to preserve the exemption of hydraulic fracturing from the provisions of the Safe Drinking Water Act and to not enact legislation that removes the exemption for hydraulic fracturing.

Was read the first time and referred to the **Agriculture Committee.** 

Sens. Krauter, Seymour and Reps. Amerman, Ekstrom, Wolf introduced:

**SCR 4022:** A concurrent resolution urging Congress and the President of the United States to enact federal legislation to repeal perverse federal tax subsidies to United States companies that move manufacturing operations and American jobs offshore.

Was read the first time and referred to the Industry, Business and Labor Committee.

Sens. Krauter, Schneider and Reps. Conrad, Delmore, Mock, Pinkerton introduced:

**SCR 4023:** A concurrent resolution supporting efforts to make prescription drugs more affordable and urging the Congress of the United States to take the necessary actions to improve access to affordable prescription drugs for all Americans.

Was read the first time and referred to the Human Services Committee.
