1 A BILL for an Act to create and enact a new subdivision to subsection 8 of section 26.1-04-03
2 and a new subsection to section 26.1-26-04 of the North Dakota Century Code, relating to
3 limitations on insurance rebates; and to amend and reenact sections 26.1-04-06 and 26.1-25-16
4 of the North Dakota Century Code, relating to limitations on insurance rebates.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1.** A new subdivision to subsection 8 of section 26.1-04-03 of the North Dakota
7 Century Code is created and enacted as follows:

8 Notwithstanding any other provision in this subsection, if the cost does not
9 exceed an aggregate retail value of twenty-five dollars per person per year, an
10 insurer, an employee of an insurer, or a producer may give a gift, rebate, bonus,
11 coupon, credit, prize, good, ware, merchandise, article, property, or any other
12 tangible item of monetary value directly or indirectly in connection with marketing
13 for the sale or retention of contracts of insurance.

14 **SECTION 2. AMENDMENT.** Section 26.1-04-06 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **26.1-04-06. Insured persons and applicants for insurance prohibited from accepting**
17 **rebates - Exception.**

18 1. An insurance producer or agent of any insurance or surety company, reciprocal,
19 benevolent society, or any other insurance organization or association, however
20 constituted or entitled, may not grant, and an insured person or party or applicant for
21 insurance, either directly or indirectly, may not receive or accept, or agree to receive or
22 accept, any rebate of premium or of any part thereof, or all or any part of any
23 insurance producer's commission thereon, or any favor or advantage, or any share in
24 any benefit to accrue under any insurance policy, or any other valuable consideration

1 or inducement other than such as may be specified in the policy, except as provided in
2 an applicable filing which is in effect under the provisions of the laws regulating
3 insurance rates or except as provided under subsection 2.

4 2. Notwithstanding subsection 1, if the cost does not exceed an aggregate retail value of
5 twenty-five dollars per person per year, an insurer, an employee of an insurer, or a
6 producer may give a gift, rebate, bonus, coupon, credit, prize, good, ware,
7 merchandise, article, property, or any other tangible item of monetary value directly or
8 indirectly in connection with marketing for the sale or retention of contracts of
9 insurance.

10 **SECTION 3. AMENDMENT.** Section 26.1-25-16 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **26.1-25-16. Rebates prohibited - Exception.**

13 1. No insurance producer may knowingly charge, demand, or receive a premium for any
14 insurance policy except in accordance with this chapter. No insurer or employee of an
15 insurer, and no broker or agent may pay, allow, or give, or offer to pay, allow, or give,
16 directly or indirectly, as an inducement to insurance, or after insurance has been
17 effected, any rebate, discount, abatement, credit, or reduction of the premium named
18 in an insurance policy, or any special favor or advantage in the dividends or other
19 benefits to accrue on the policy, or any valuable consideration or inducement
20 whatever, not specified in the insurance policy, except to the extent provided for in
21 applicable filing. No insured named in an insurance policy, nor any employee of the
22 insured, may knowingly receive or accept, directly or indirectly, any such rebate,
23 discount, abatement, credit, or reduction of premium, or any such special favor or
24 advantage or valuable consideration or inducement. This section does not prohibit the
25 payment of commissions or other compensation to licensed insurance producers, nor
26 any insurer from allowing or returning to its participating policyholders, members, or
27 subscribers dividends, savings, or unabsorbed premium deposits. As used in this
28 section, "insurance" includes suretyship and "policy" includes bond.

29 2. Notwithstanding subsection 1, if the cost does not exceed an aggregate retail value of
30 twenty-five dollars per person per year, an insurer, an employee of an insurer, or a
31 producer may give and an insured may accept a gift, rebate, bonus, coupon, credit,

1 prize, good, ware, merchandise, article, property, or any other tangible item of
2 monetary value directly or indirectly in connection with marketing for the sale or
3 retention of contracts of insurance.

4 **SECTION 4.** A new subsection to section 26.1-26-04 of the North Dakota Century Code is
5 created and enacted as follows:

6 Notwithstanding any other provision in this section, if the cost does not exceed an
7 aggregate retail value of twenty-five dollars per person per year, an insurer, an
8 employee of an insurer, or a producer may give to a customer or a potential customer
9 a gift, rebate, bonus, coupon, credit, prize, good, ware, merchandise, article, referral
10 fee, property, or any other tangible item of monetary value directly or indirectly in
11 connection with marketing for the sale or retention of contracts of insurance.
