- 1 A BILL for an Act to amend and reenact section 54-53-02 of the North Dakota Century Code,
- 2 relating to members of the advisory transportation council to the upper great plains
- 3 transportation institute.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Section 54-53-02 of the North Dakota Century Code is

6 amended and reenacted as follows:

7 54-53-02. Advisory transportation council - Composition.

- 8 <u>1.</u> There is established a transportation council that shall serve in an advisory capacity to
- 9 the upper great plains transportation institute. The director of the institute shall serve
 10 as the executive secretary of the council. The council shall elect its own chairman. The
- 11 council membership consists of one representative from and appointed by the 12 following:
- 13 <u>1.</u> <u>a.</u> The North Dakota chamber of commerce.
- 14 <u>2.</u> <u>b.</u> The North Dakota public service commission.
- 15 3. The North Dakota farm bureau.
- 16 4. <u>c.</u> The North Dakota farmers union.
- 17 <u>5.</u> <u>d.</u> The North Dakota grain growers association.
- 18 6. <u>e.</u> The North Dakota wheat commission.
- 19 7. <u>f.</u> The North Dakota department of commerce.
- 20 8. g. The North Dakota grain dealers association.
- 21 9. <u>h.</u> The North Dakota motor carriers association.
- 22 <u>10.</u> The North Dakota aeronautics commission.
- 23 <u>11.</u> <u>j.</u> The North Dakota department of transportation.
- 24 <u>12.</u> <u>k.</u> The North Dakota department of agriculture.

2 <u>14.</u> <u>m.</u> The North Dakota railway industry, appointed by the council.

- 3 <u>15.</u> <u>n.</u> The North Dakota primary sector of manufacturing, appointed by the council.

- 5 <u>17.</u> <u>p.</u> The North Dakota league of cities.
- 6 <u>18.</u> <u>q.</u> The lignite energy council.
- 7 <u>19.</u> <u>r.</u> A North Dakota member of the dakota transit association.
- 8 <u>s.</u> <u>The North Dakota corn council.</u>
- 9 <u>2.</u> Members of the council shall serve without pay, but they may receive reimbursement
- 10 for actual and necessary expenses incurred in the performance of their duties, if
- 11 authorized by the director.
- 12 <u>3.</u> The council shall consult with the institute in matters of policy affecting the
- 13 administration of this chapter and in the development of transportation in the state of
- 14 North Dakota. The council shall meet at the call of the chairman or director or upon the
- 15 written request of three or more members of the council.
