

**HOUSE BILL NO. 1350**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the highway patrol.

2 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

3 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
4 as may be necessary, are appropriated out of any moneys in the general fund in the state  
5 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
6 other income, to the highway patrol for the purpose of defraying the expenses of the highway  
7 patrol, for the biennium beginning July 1, 2011, and ending June 30, 2013, as follows:

18 The 2011-13 one-time funding amounts are not a part of the entity's base budget for the  
19 2013-15 biennium. The highway patrol shall report to the appropriations committees of the  
20 sixty-third legislative assembly on the use of this one-time funding for the biennium beginning  
21 July 1, 2011, and ending June 30, 2013.

22       **SECTION 3. SPECIAL FUNDS TRANSFER.** The less estimated income line item in  
23 section 1 of this Act includes the sum of ~~\$4,550,725~~\$4,849,220, or so much of the sum as may  
24 be necessary, from the state highway tax distribution fund which may be transferred at the  
25 direction of the superintendent of the highway patrol for the purpose of defraying the expenses  
26 of the highway patrol during the biennium beginning July 1, 2011, and ending June 30, 2013.

27       **SECTION 4. PAYMENTS TO HIGHWAY PATROL OFFICERS.** Each patrol officer of the  
28 highway patrol is entitled to receive from funds appropriated in section 1 of this Act an amount  
29 not to exceed \$200 per month for the biennium beginning July 1, 2011, and ending June 30,  
30 2013. The payments are in lieu of reimbursement for meals and other expenses, except  
31 lodging, while in travel status within the state of North Dakota or while at their respective home

- 1 stations. The amounts must be paid at the time and in the same manner as salaries are paid to
- 2 members of the highway patrol and may be paid without the presentation of receipts or other
- 3 memorandums.
