1 A BILL for an Act to amend and reenact ~~subsections~~subsection 5 ~~and 6~~ of section 10-04-10.1 of  
2 the North Dakota Century Code, relating to investment advisory contracts ~~and custody of~~  
3 ~~securities or funds.~~

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** ~~Subsections~~Subsection 5 ~~and 6~~ of section 10-04-10.1 of the  
6 North Dakota Century Code ~~are~~is amended and reenacted as follows:

- 7 5. ~~It~~Except as permitted by rule, it is unlawful for any investment adviser to enter into,  
8 extend, or renew any investment advisory contract unless it provides in writing that:
- 9 a. The investment adviser shall not be compensated on the basis of a share of  
10 capital gains, earnings, or capital appreciation of the funds or any portion of the  
11 funds of the client. This does not prohibit an investment advisory contract that  
12 provides for compensation based on the total value of a fund determined as of a  
13 definite date or averaged as of definite dates or over a definite period.
  - 14 b. An assignment of the investment advisory contract may not be made by the  
15 investment adviser unless the investment adviser notifies the client of the  
16 intended assignment and obtains the prior written consent of the client.
  - 17 c. The investment adviser shall provide written notice to the client within fifteen days  
18 of any change of ownership in excess of five percent.
  - 19 d. The investment adviser shall provide written notice to the client within fifteen days  
20 of a change of controlling interest of the investment adviser. The client may  
21 terminate the investment advisory contract without penalty by providing a written  
22 notice to the investment adviser within thirty days after the client's receipt of the  
23 notice of change of controlling interest. ~~The commissioner may by rule waive any~~  
24 ~~of the provisions of this subsection and may specify the contents of an~~

3     ~~6. It~~ ~~Except as permitted by rule, it is unlawful for any investment adviser to take or have~~  
4                    ~~custody of any securities or funds of any client unless the investment adviser acts as a~~  
5                    ~~fiduciary pursuant to duties as an executor, guardian, conservator, receiver, or trustee.~~  
6     e. The commissioner may specify by rule the contents of an investment advisory  
7                    contract that will comply with the requirements of this subsection.
