

HOUSE BILL NO. 1122

Introduced by

(At the request of the Department of Commerce)

1 A BILL for an Act to amend and reenact sections 54-34.4-03, 54-44.5-04, 54-60-02, 54-60-04,
2 54-60-16, and 54-60-25 of the North Dakota Century Code, relating to the state tourism policy,
3 division of community services, department of commerce, North Dakota economic development
4 foundation, North Dakota international business and trade office, and North Dakota rural
5 development council; to repeal sections 4-14.1-01.1 and 54-34.3-12 of the North Dakota
6 Century Code, relating to the definition of eligible facility and the value-added agriculture
7 promotion board; to provide an effective date; and to declare an emergency.

8 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

9 **SECTION 1. AMENDMENT.** Section 54-34.4-03 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **54-34.4-03. State tourism policy.**

- 12 1. The legislative assembly declares that:
- 13 a. This state is endowed with scenic beauty, historical sites, cultural resources, local
14 festivals, attractions, recreational facilities, and a population whose ethnic
15 diversity and traditions are attractive to visitors;
 - 16 b. ~~These human and physical resources should be preserved and nurtured, not only~~
17 ~~because they are appreciated by other Americans and by visitors from other~~
18 ~~lands, but because they are valued by the state's residents;~~
 - 19 e. Tourism contributes to economic well-being by creating job opportunities,
20 generating revenues for local businesses, and creating new wealth in the
21 economy;
 - 22 d. ~~Tourism is an educational and informational medium for personal growth which~~
23 ~~informs residents about their state's geography and history, their political~~
24 ~~institutions, their cultural resources, their environment, and about each other;~~

- 1 e.c. Tourism instills state pride and a sense of common interest among the state's
2 residents;
- 3 f.d. Tourism enhances the quality of life and well-being of the state's residents by
4 affording opportunities for recreation, new experiences, and relief from job stress;
- 5 g.e. Tourism advertising and marketing improves the image of North Dakota and
6 helps ~~expose and~~ educate and create awareness among residents and visitors
7 alike;
- 8 h.f. Tourism promotes international understanding and good will, and contributes to
9 intercultural appreciation;

- 17 l.g. The development of a strong and competitive state visitor industry depends upon
18 the availability of trained personnel, necessary infrastructure, and a receptive
19 climate for tourism investment; and
- 20 m.h. A comprehensive tourism policy is essential if tourism in the state is to grow in an
21 orderly manner.
- 22 2. The legislative assembly declares it is the policy of this state to:
- 23 a. ~~Encourage~~Promote and encourage the orderly growth and development of
24 tourism to, and within, the state;
- 25 b. ~~Promote the availability of public tourism training to increase the skills and~~
26 ~~productivity of the tourism labor force and to broaden access to employment~~
27 ~~opportunities and the visitor industry;~~
- 28 c. ~~Encourage a healthy competitiveness in the visitor industry;~~
- 29 d. Promote the availability of reliable public highways and transport services
30 between the state's principal tourism destinations and the main tourism
31 generating markets;

2 ~~the accommodation sector and reduce seasonal layoffs within the visitor and~~

5 visits to state historic sites, and promoting the preservation and restoration of
6 historic sites, trails, buildings, and districts;
- 7 g.d. Promote the mental, emotional, and physical well-being of the American people
8 by encouraging outdoor recreational activities within the state;

19 local tourism resources;
- 20 ~~m.~~ ~~Promote a better understanding among the state's residents of the social and~~
21 ~~economic importance of tourism through appropriate formal and informal learning~~
22 ~~experiences about tourism, and foster among all citizens the capacity for~~
23 ~~courtesy to visitors;~~
- 24 n.f. Encourage the holding of conventions, trade shows, and expositions throughout
25 the state;
- 26 ~~o.~~ ~~Promote tourism in a manner that fosters visitors' understanding and respect for~~
27 ~~native and religious beliefs, customs, and ethnic traditions of the state's~~
28 ~~residents;~~
- 29 ~~p.~~ ~~Monitor tourist impact on the basic human rights of the state's residents and~~
30 ~~ensure equal access by visitors and residents to public recreational resources;~~

- 1 e.g. Take measures to protect wildlife and natural resources in the preservation of
2 geological, archaeological, and cultural treasures in tourist areas;
3 f.h. Encourage, assist, and coordinate when possible the tourism activities of local
4 and area promotional organizations ~~and tribes; and~~
5 i. Provide hospitality training opportunities for frontline employees and
6 ~~encourage~~provide resources to law enforcement personnel, border security,
7 transportation security administration officials, and all state employees to assist,
8 ~~whenever possible, the traveling public by providing the traveling public with a~~
9 ~~hospitable reception and appropriate information~~the tourism industry in helping
10 visitors enjoy their North Dakota experience; and
11 s.j. Ensure that the tourism interest of the state is considered fully by state agencies
12 and the legislative assembly in their deliberations; and harmonize to the
13 maximum extent possible, all state activities in support of tourism with the needs
14 of the general public, the political subdivisions of the state, and the visitor
15 industry.

16 **SECTION 2. AMENDMENT.** Section 54-44.5-04 of the North Dakota Century Code is
17 amended and reenacted as follows:

18 **54-44.5-04. Division of community services - Powers and duties.**

19 The division of community services shall:

- 20 1. Provide relevant information on pertinent topics and issues which relate to public
21 policy development, interpretation, modification, and implementation.
22 2. ~~Research, analyze, and recommend public policy for the office of management and~~
23 ~~budget and the executive office.~~
24 3. ~~Coordinate public policy implementation within the state. Powers conferred upon~~
25 ~~departments, agencies, or instrumentalities of the state, counties, townships, or cities~~
26 ~~by any existing state or local law may not be derogated by this duty.~~
27 4. Develop state energy conservation policy and manage federal energy conservation
28 program activities between all levels of the public and private sectors regarding the
29 prudent and efficient use of energy resources.
30 ~~5.3.~~ Develop, implement, and administer federal categorical and block grant programs
31 assigned to the division.

1 ~~6.4.~~ Advise, coordinate, and assist cities, political subdivisions, and the state in all phases
2 of state and local planning for the physical development of the state.

3 ~~7.5.~~ Render financial assistance to any government planning agency within federal law or
4 regulation.

5 ~~8.6.~~ Advise, consult, coordinate, assist, and contract with or on behalf of the various
6 planning agencies in developing and harmonizing planning activities of the state.

7 ~~9.7.~~ Implement a state facility energy improvement program.

8 **SECTION 3. AMENDMENT.** Section 54-60-02 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **54-60-02. Department of commerce - Divisions.**

11 The North Dakota department of commerce is created. ~~All records, materials, supplies, and~~
12 ~~equipment used by the division of community services, department of economic development~~
13 ~~and finance, and the department of tourism are transferred to the department.~~

14 1. The department must consist of:

15 a. A division of community services;

16 b. A division of economic development and finance;

17 c. A division of tourism;

18 d. A division of workforce development; and

19 e. Any division or office the commissioner determines necessary to carry out this
20 chapter.

21 2. The commissioner shall appoint the director of each division of the department. Each
22 director appointed by the commissioner serves at the pleasure of the commissioner
23 and is entitled to receive a salary set by the commissioner within the limits of
24 legislative appropriations.

25 **SECTION 4. AMENDMENT.** Section 54-60-04 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **54-60-04. North Dakota economic development foundation - Executive committee -**
28 **Duties.**

29 The North Dakota economic development foundation is created.

30 1. The foundation is composed of a minimum of fifteen and a maximum of thirty
31 members appointed by the governor for two-year terms, except the governor shall

- 1 appoint approximately one-half of the initial foundation members to one-year terms in
2 order to initiate a cycle of staggered terms. Appointment of the foundation members
3 must ensure a cross section of business, tourism, and economic development
4 representation, and must ensure that at least one member represents rural concerns.
- 5 2. The foundation members shall elect an executive committee with a minimum of five
6 and a maximum of seven foundation members, which shall include a chairman, vice
7 chairman, secretary, treasurer, and up to three members at large.
- 8 3. The foundation shall seek funding for administrative expenses from private sector
9 sources and shall seek and distribute private sector funds for use in commerce-related
10 activities of the state. The private sector funds are not public moneys for any purpose
11 and are not subject to section 12 of article X of the Constitution of North Dakota.
- 12 4. The foundation shall:
- 13 a. Provide the governor advice and counsel in selecting the commissioner.
- 14 b. Serve in an advisory role to the commissioner.
- 15 c. Develop a strategic plan for economic development in the state and set
16 accountability standards, measurements, and benchmarks to evaluate the
17 effectiveness of the department in implementing the strategic plan.
- 18 d. ~~Develop a strategic plan for the development of value-added agriculture in the~~
19 ~~state.~~
- 20 e. Monitor ~~tourism~~ and economic development activities and initiatives of the
21 department.
- 22 f.e. Recommend state and federal legislation relating to strengthening the state's
23 economy and increasing the state's population.
- 24 g.f. Monitor state and federal legislation and initiatives that may impact the state's
25 economy and population.
- 26 h.g. Serve as a source of expertise for developing public and private initiatives to
27 strengthen the state's economy and increase the state's population.

28 **SECTION 5. AMENDMENT.** Section 54-60-16 of the North Dakota Century Code is
29 amended and reenacted as follows:

1 **54-60-16. (~~Effective through June 30, 2011~~) International business and trade office -**
2 **Advisory board.**

- 3 1. The commissioner shall administer the international business and trade office. The
4 purpose of the office is to assist North Dakota businesses expand exports to
5 international markets by:
- 6 a. Advocating for exporters;
 - 7 b. Offering export educational opportunities to North Dakota businesses;
 - 8 c. Researching and raising awareness of export opportunities, issues, and
9 challenges impacting North Dakota businesses;
 - 10 d. Assisting North Dakota businesses in identifying, developing, and cultivating
11 international markets for products; and
 - 12 e. Organizing and carrying out trade missions that seek to facilitate contact and
13 communication between North Dakota businesses and international markets.
- 14 2. The commissioner may designate a nonprofit corporation incorporated in this state
15 that has the primary purpose of assisting North Dakota exporters or contract with a
16 third party for the provision of services for the international business and trade office. If
17 the commissioner designates a nonprofit corporation or contracts with a third party
18 under this subsection, all data and data bases collected and created by the third party
19 in performing services for the office are the property of the department and the third
20 party.
- 21 3. The department may seek and accept any gift, grant, or donation of funds, property,
22 services, or other assistance from public or private sources for the purpose of
23 furthering the objectives of the international business and trade office.
- 24 4. The commissioner may establish an international business and trade office advisory
25 board with which the director may consult in administering the international business
26 and trade office. Each member of the advisory board created under this subsection is
27 entitled to receive per diem compensation at a rate established by the director not
28 exceeding sixty-two dollars and fifty cents and reimbursement of expenses as
29 provided by law for state officers, while attending meetings or performing duties
30 directly related to board membership, except that per diem compensation under this

1 section may not be paid to any member who receives compensation or salary as a
2 regular state employee or official.

5 1. ~~The commissioner shall administer the international business and trade office. The~~

17 ~~international business and trade office. If the commissioner contracts with a third party~~
18 ~~under this subsection, all data and data bases collected and created by the third party~~
19 ~~in performing services for the office are the property of the department and the third~~
20 ~~party.~~

21 3. ~~The department may seek and accept any gift, grant, or donation of funds, property,~~
22 ~~services, or other assistance from public or private sources for the purpose of~~
23 ~~furthering the objectives of the international business and trade office.~~

24 4. ~~The commissioner may establish an international business and trade office advisory~~
25 ~~board with which the director may consult in administering the international business~~
26 ~~and trade office. Each member of the advisory board created under this subsection is~~
27 ~~entitled to receive per diem compensation at a rate established by the director not~~
28 ~~exceeding sixty two dollars and fifty cents and reimbursement of expenses as~~

3 **SECTION 6. AMENDMENT.** Section 54-60-25 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **54-60-25. North Dakota rural development council - Composition.**

6 The North Dakota rural development council is created.

- 7 1. The North Dakota rural development council is composed of a minimum of nine and a
8 maximum of seventeen members. The commissioner is an ex officio voting member of
9 the council. The governor shall appoint council members for two-year terms, except
10 the governor shall appoint approximately one-half of the initial council members to
11 one-year terms in order to initiate a cycle of staggered terms. Appointment of the
12 council members must ensure representation from ~~eight~~four regions designated by the
13 commissioner. Members of the council serve at the pleasure of the governor.
- 14 2. The council shall select its own officers who shall serve for a term of two years
15 commencing on October first of each year.
- 16 3. The council shall have at least two meetings each year and such additional meetings
17 as the chairman determines necessary at a time and place to be fixed by the
18 chairman. Special meetings must be called by the chairman on written request of any
19 four members. A simple majority of the council constitutes a quorum and may act upon
20 any matter coming before the council. Members of the council are entitled to
21 reimbursement in the same manner and at the same rate provided by law for other
22 state officials.
- 23 4. The council, in cooperation with the rural development office, shall:
- 24 a. Facilitate collaboration among federal, state, local, and tribal governments and
25 the private and nonprofit sectors in the planning and implementation of programs
26 and policies that have an impact on rural areas of the state;
- 27 b. Monitor, report, and comment on policies and programs that address, or fail to
28 address, the needs of the rural areas of the state; and
- 29 c. Facilitate the development of strategies to reduce or eliminate conflicting or
30 duplicative administrative or regulatory requirements of federal, state, local, and
31 tribal governments.

1 **SECTION 7. REPEAL.** Sections 4-14.1-01.1 and 54-34.3-12 of the North Dakota Century
2 Code are repealed.

3 **SECTION 8. EFFECTIVE DATE.** Section 5 of this Act becomes effective on July 1, 2011.

4 **SECTION 9. EMERGENCY.** Sections 5 and 8 of this Act are declared to be an emergency
5 measure.
