## 6 School bullying prevention - Prohibition - Implementation - Immunity.

- 7 <u>1.</u> <u>As used in this section:</u>
- 8 <u>a.</u> "Bullying" means conduct occurring or received at school, including through
   9 <u>technology or electronic means:</u>
   10 (1) That is so severe, pervasive, or objectively offensive that it substantially

   interferes with or impairs a student's educational opportunities or

  - (2) That has the effect of substantially disrupting the orderly operation of the school; or
  - (3) That places a student in actual and reasonable fear of harm to the student's person or damage to the student's property.
- 17b."School" includes a classroom or other location on school premises, a18schoolbus or other school-related vehicle, a schoolbus stop, an activity or
- event sponsored by a school, whether or not it is held on school premises,
   and any other program or function where the school is responsible for the
   child.
- 22 <u>2.</u> <u>A person may not engage in bullying or reprisal or retaliation against a victim,</u>
   witness, or person who reports information about an act of bullying.

29	<u>4.</u>	This section may not be interpreted to prevent a victim from seeking redress		
30		pursuant to any other applicable civil or criminal law. This section does not create		
31		or alter any civil cause of action for monetary damages against any person or		

1	school district nor does it constitute grounds for any claim or motion raised by
2	either the state or defendant in any proceedings. A school employee, volunteer, or
3	student, or a student's parent or guardian who promptly, reasonably, and in good
4	faith reports an incident of bullying to the appropriate school official designated by
5	the school district or accredited nonpublic school is immune from civil or criminal
6	liability relating to such report and to participation in any administrative or judicial
7	proceeding resulting from or relating to the report.
