1 A BILL for an Act to create and enact a new subsection to section 11-37-02 and a new

2 subsection to section 11-37-07 of the North Dakota Century Code, relating to joint powers

3 entities and commerce authorities; to amend and reenact subsection 2 of section 11-37-03,

4 sections 11-37-04 and 11-37-06, and subsection 1 of section 11-37-08 of the North Dakota

5 Century Code, relating to conversion of joint powers entities to commerce authorities and

6 additional powers of commerce authorities; and to declare an emergency.

## 7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

8 **SECTION 1.** A new subsection to section 11-37-02 of the North Dakota Century Code is

9 created and enacted as follows:

Provide a method to convert an existing joint powers entity to a commerce authority for
the purpose of achieving status as a political subdivision.

SECTION 2. AMENDMENT. Subsection 2 of section 11-37-03 of the North Dakota Century
Code is amended and reenacted as follows:

- 14 2. Two or more political subdivisions, whether in this state or in an adjoining state
- 15 provided that at least one political subdivision is in this state, may create by execution
- 16 of a joint agreement authorized by resolution of the governing body of each
- 17 participating subdivision, a commerce authority that may exercise its functions upon
- 18 the issuance by the secretary of state of a certificate of incorporation. <u>Two or more</u>
- 19 political subdivisions, who are parties to a joint powers agreement under chapter
- 20 <u>54-40 or 54-40.3, may convert an existing joint powers entity to a commerce authority</u>

21 by execution of a joint agreement authorized by resolution of the governing body of

- 22 <u>each participating political subdivision.</u> The governing bodies of the participating
- 23 political subdivisions shall appoint, pursuant to the joint agreement, no fewer than five
- 24 persons as commissioners of the commerce authority.

1	SECTION 3. AMENDMENT. Section 11-37-04 of the North Dakota Century Code is		
2	amended and reenacted as follows:		
3	11-37-04. Filing of agreement and resolutions - Certificate of incorporation -		
4	Beginning of corporate existence.		
5	The	joint agreement, if applicable, and a certified copy of the resolution of each political	
6	subdivis	ion creating or agreeing to participate in a commerce authority, or converting an existing	
7	joint powers entity to a commerce authority, must be filed with the secretary of state. If the		
8	agreement and resolutions conform to the requirements of section 11-37-03, the secretary of		
9	state shall issue a certificate of incorporation that states the name of the commerce authority		
10	and the date of incorporation. The existence of the commerce authority as a political subdivision		
11	of this state begins upon the issuance of the certificate of incorporation. The certificate of		
12	incorporation is conclusive evidence of the existence of the commerce authority.		
13	SEC	CTION 4. AMENDMENT. Section 11-37-06 of the North Dakota Century Code is	
14	amended and reenacted as follows:		
15	11-37-06. Powers of political subdivisions in aid of a commerce authority.		
16	A political subdivision creating or participating in a commerce authority may:		
17	1.	Lend or donate money to the commerce authority.	
18	2.	Provide that all or a portion of the taxes or funds available to the political subdivision	
19		for economic development purposes be transferred or paid directly to the commerce	
20		authority.	
21	3.	Cause water, sewer, drainage, or any other facilities that the political subdivision is	
22		authorized to provide to be furnished adjacent to or in connection with a project.	
23	4.	Dedicate, sell, convey, or lease any of the political subdivision's interest in any	
24		property or grant easements, licenses, or any other rights or privileges therein to the	
25		commerce authority.	
26	5.	Plan, dedicate, close, pave, install, grade, or regrade, to the extent allowed by title 24,	
27		streets, roadways, and walks from established streets or roads to a project.	
28	6.	Aid and cooperate with the commerce authority in the planning, construction, or	
29		operation of a project.	
30	7.	Enter agreements with the commerce authority regarding action to be taken by the	
31		political subdivision under this section.

1	8.	Establish the geographical boundaries of the commerce authority within or	
2		coextensive with the geographical boundaries of one or more of the participating	
3		political subdivisions, or coextensive with the geographical boundaries of the area to	
4		be served by the commerce authority.	
5	9.	Establish the extent to which the financial incentives provided under this chapter will	
6		apply to the commerce authority.	
7	<del>10.</del>	Acquire property to carry out the purposes of this chapter by condemnation and the	
8		exercise of eminent domain in the manner provided in chapter 32-15 and other laws	
9		applicable to political subdivisions in exercising the right of eminent domain.	
10	SEC	CTION 5. A new subsection to section 11-37-07 of the North Dakota Century Code is	
11	created and enacted as follows:		
12		Exercise the power of eminent domain in the manner provided by title 32 for the	
13		purpose of acquiring and securing any rights, titles, interests, estates, or easements	
14		necessary or proper to carry out the duties imposed by this chapter, or under the joint	
15		agreement filed pursuant to section 11-37-04, and particularly to acquire the	
16		necessary rights in land for the construction of appurtenant facilities used in	
17		connection with the authority, or any part thereof provided, however, that when the	
18		interest sought to be acquired is a right of way for any project authorized by this	
19		chapter, the authority, after making a written offer to purchase the right of way and	
20		depositing the amount of the offer with the clerk of the district court of the county	
21		wherein the right of way is located, may thereupon take immediate possession of the	
22		right of way, as authorized by section 16 of article I of the Constitution of North Dakota.	
23		Within thirty days after notice has been given in writing to the landowner by the clerk of	
24		the district court that a deposit has been made for the taking of a right of way as	
25		authorized in this subsection, the owner of the property taken may appeal to the	
26		district court by serving a notice of appeal upon the acquiring agency, and the matter	
27		must be tried at the next regular or special term of court with a jury unless a jury be	
28		waived, in the manner prescribed for trials under chapter 32-15.	
29	SEC	CTION 6. AMENDMENT. Subsection 1 of section 11-37-08 of the North Dakota Century	
30	Code is amended and reenacted as follows:

1	1.	A commerce authority may borrow money and issue bonds, including refunding bonds,
2		in the form and upon the terms as it may determine, payable out of any revenues of
3		the commerce authority. If a commerce authority is formed by conversion of a joint
4		powers entity to a commerce authority pursuant to subsection 2 of section 11-37-03,
5		the commerce authority may borrow money and issue bonds to refinance existing
6		obligations of the participating political subdivisions as long as such existing
7		obligations were incurred by the participating political subdivision for the benefit of the
8		converted joint powers entity.
9	SEC	CTION 7. EMERGENCY. This Act is declared to be an emergency measure.
