 6 ~~legislative intent; and to provide an effective date.~~

7 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

8 **SECTION 1.** A new section to chapter 54-03 of the North Dakota Century Code is created
 9 and enacted as follows:

10 **Legislative districts.**

11 Each legislative district is entitled to one senator and two representatives. The legislative
 12 districts of the state are formed as follows:

- 13 1. District 1 consists of that part of the city of Williston and Stony Creek and Williston
 14 Townships in Williams County bound by a line commencing at the point where the
 15 centerline of thirty-second avenue intersects the centerline of United States highway 2,
 16 then south on thirty-second avenue and an extended straight line to the shoreline of
 17 Lake Sakakawea, then east on the shoreline of Lake Sakakawea until its intersection
 18 with the centerline of the Little Muddy Creek, then north on the Little Muddy Creek until
 19 its intersection with the extended centerline of forty-second street, then west on
 20 forty-second street until its intersection with the centerline of frontage road west, then
 21 south on frontage road west until its intersection with the southern property line of the
 22 sloulin field international airport, then west and south on the southern property line of
 23 the sloulin field international airport until its intersection with the centerline of
 24 twenty-sixth street, then west on twenty-sixth street until its intersection with the

1 centerline of seventeenth avenue, then north on seventeenth avenue until its
2 intersection with the centerline of thirty-second street, then west on thirty-second
3 street until its intersection with the centerline of pheasant run parkway, then south on
4 pheasant run parkway until its intersection with the centerline of twenty-sixth street,
5 then west on twenty-sixth street until its intersection with the centerline of one hundred
6 thirty-eighth avenue northwest, then south on one hundred thirty-eighth avenue and
7 an extended line to the point of beginning.

8 2. District 2 consists of all of Burke County and Divide County; all of Williams County
9 except that portion contained in District 1; and Bicker, Powers Lake, Powers,
10 Lostwood, White Earth, Sorkness, Cottonwood, James Hill, Myrtle, Manitou, Ross, and
11 Idaho Townships in Mountrail County.

12 3. District 3 consists of New Prairie, Sundre, and Surrey Townships in Ward County; and
13 that part of the city of Minot and that part of Nedrose Township in Ward County bound
14 by a line commencing at the intersection of the centerline of eleventh avenue and the
15 centerline of north roadway, then south on roadway until its intersection with the
16 centerline of burdick expressway, then east on burdick expressway until its
17 intersection with the centerline of third street, then south on third street until its
18 intersection with the centerline of eleventh avenue southeast, then east on eleventh
19 avenue until its intersection with the centerline of seventh street, then south on an
20 extended line from seventh street until its intersection with the centerline of sixteenth
21 avenue southeast, then east on sixteenth avenue until its intersection with the
22 centerline of thirteenth street southeast, then south on thirteenth street until its
23 intersection with the south boundary of Nedrose Township, then east on the south
24 boundary of Nedrose Township until its intersection with the southeast corner of
25 Nedrose Township, then north on the east boundary of Nedrose Township until its
26 intersection with the northeast corner of Nedrose Township, then west on the north
27 boundary of Nedrose Township until its intersection with the centerline of
28 twenty-seventh street, then south on twenty-seventh street until its intersection with
29 the extended centerline of nineteenth avenue, then west on the extended centerline of
30 nineteenth avenue and on nineteenth avenue until its intersection with the centerline of

1 third street, then south on third street until its intersection with the centerline of
2 eleventh avenue, then west on eleventh avenue to the point of beginning.

3 4. District 4 consists of all of Mountrail County except that portion contained in District 2;
4 all of Ward County except those portions contained in Districts 3, 5, 38, and 40; those
5 portions of McKenzie County and Mercer County within the Fort Berthold reservation;
6 all of McLean County except that portion contained in District 8; and that part of Dunn
7 County bound by a line commencing at the intersection of the Fort Berthold
8 reservation boundary and the north boundary of Dunn County, then south on the
9 reservation boundary until its intersection with the centerline of the Little Missouri
10 River, then south and east on the centerline of the Little Missouri River until its
11 intersection with the west boundary of Township 147-94, then south on the west
12 boundary of Townships 147-94, 146-94, and 145-94, then east on the south boundary
13 of Township 145-94 to the west boundary of Township 144-94, then south on the west
14 boundary of Townships 144-94 and 143-94, then east on the south boundary of
15 Townships 143-94, 143-93, 143-92, and 143-91 to the east boundary of Dunn County,
16 then north, west, and south on the boundary of Dunn County to the point of beginning.

17 5. District 5 consists of that part of the city of Minot and Harrison Township in Ward
18 County bound by a line commencing at the intersection of the centerline of the
19 burlington northern santa fe railway right of way and the centerline of north Broadway,
20 then south on Broadway until its intersection with the centerline of Burdick Expressway,
21 then east on Burdick Expressway until its intersection with the centerline of Third Street,
22 then south on Third Street until its intersection with the centerline of Eleventh Avenue
23 southeast, then east on Eleventh Avenue until its intersection with the centerline of
24 Seventh Street, then south on an extended line from Seventh Street until its intersection
25 with the centerline of Sixteenth Avenue Southeast, then east on Sixteenth Avenue until
26 its intersection with the centerline of Thirteenth Street, then south on Thirteenth Street
27 until its intersection with the centerline of United States Highway 2, then west on
28 United States Highway 2 until its intersection with the centerline of United States
29 Highway 83, then south on United States Highway 83 until its intersection with the
30 centerline of Thirty-Seventh Avenue Southwest, then west on Thirty-Seventh Avenue until
31 its intersection with the centerline of Thirtieth Street, then north on Thirtieth Street until

1 its intersection with the centerline of twentieth avenue, then west on twentieth avenue
2 until its intersection with the centerline of thirty-third street, then north on thirty-third
3 street until its intersection with the centerline of United States highway 2, then east on
4 United States highway 2 until its intersection with the centerline of United States
5 highway 83 bypass, then north on the United States highway 83 bypass until its
6 intersection with the centerline of the canadian pacific railway right of way, then east
7 on the canadian pacific railway right of way until its intersection with the centerline of
8 sixteenth street, then north on sixteenth street until its intersection with the centerline
9 of fourth avenue, then east on fourth avenue until its intersection with the centerline of
10 tenth street, then south on tenth street until its intersection with the centerline of first
11 avenue northwest, then east on first avenue until its intersection with the centerline of
12 eighth street northwest, then south on eighth street until its intersection with the
13 centerline of central avenue, then east on central avenue until its intersection with the
14 centerline of sixth street, then south on sixth street until its intersection with the
15 centerline of the burlington northern santa fe railway right of way, then north and east
16 on the burlington northern santa fe railway right of way to the point of beginning.

17 6. District 6 consists of all of Bottineau County, McHenry County, and Renville County.

18 7. District 7 consists of all of the city of Lincoln in Burleigh County and that part of the city
19 of Bismarck and Apple Creek, Gibbs, and Hay Creek Townships in Burleigh County
20 bound by a line commencing at the intersection of interstate highway 94 and the
21 centerline of the Missouri River, then north and west on the Missouri River until its
22 intersection with the north boundary of Hay Creek Township, then east on the north
23 boundary of Hay Creek Township until its intersection with the centerline of United
24 States highway 83, then south on United States highway 83 until its intersection with
25 the centerline of seventy-first avenue, then east on seventy-first avenue until its
26 intersection with the centerline of eightieth street, then south on eightieth street until its
27 intersection with the centerline of lincoln road, then west on lincoln road until its
28 intersection with the centerline of bluejay avenue, then south and west on bluejay
29 avenue until its intersection with the centerline of sandpiper avenue, then west on
30 sandpiper avenue until its intersection with the centerline of dove street, then south on
31 dove street until its intersection with the centerline of roadrunner avenue, then west on

1 roadrunner avenue until its intersection with the centerline of sixty-sixth street
2 southeast, then south on sixty-sixth street until its intersection with the centerline of
3 forty-eighth avenue southeast, then west on forty-eighth avenue until its intersection
4 with the centerline of fifty-second street southeast, then north on fifty-second street
5 until its intersection with the Lincoln city limit, then west, north, and east on the Lincoln
6 city limit until its intersection with a straight line extended from the centerline of
7 fifty-second street, then north on the straight line extended from fifty-second street
8 until its intersection with the centerline of old highway 10, also identified as apple
9 creek road, then west on old highway 10 until its intersection with the centerline of
10 fifty-second street, then north on fifty-second street until its intersection with the
11 centerline of county highway 10, then west on county highway 10 until its intersection
12 with Bismarck expressway, then north on Bismarck expressway until its intersection
13 with the centerline of interstate highway 94, then west on interstate highway 94 until its
14 intersection with the centerline of United States highway 83, then north on United
15 States highway 83 until its intersection with the centerline of forty-third avenue, then
16 west on forty-third avenue until its intersection with the centerline of washington street,
17 also identified as third street northwest, then north on washington street until its
18 intersection with the centerline of fifty-seventh avenue northwest, then west on
19 fifty-seventh avenue and an extended straight line until its intersection with the
20 centerline of state highway 1804, then south on state highway 1804 and river road
21 until its intersection with the centerline of interstate highway 94, then west on interstate
22 highway 94 to the point of beginning.

- 23 8. District 8 consists of Andrews, Otis, Butte, Dogden, Greatstone, Horseshoe Valley,
24 Aurena, Byersville, St. Mary, Snow, Malcolm, Medicine Hill, Victoria, Turtle Lake, Lake
25 Williams, Wise, Longfellow, and Mercer Townships in McLean County; that part of
26 Township 147-85 within McLean County; Township 148-84 in McLean County,
27 including the city of Garrison; south McLean unorganized township in McLean County,
28 including the city of Washburn; Underwood unorganized township in McLean County,
29 including the cities of Riverdale and Underwood; east McLean unorganized township
30 in McLean County; Wilson, Steiber, Schrunk, Florence Lake, Hazel Grove, Grass
31 Lake, Estherville, Canfield, Richmond, Phoenix, Painted Woods, Ecklund, Ghylin,

1 Rock Hill, Wing, Harriet-Lien, Glenview, Crofte, Cromwell, Trygg, Lyman, Burnt Creek-
2 Riverview, Naughton, Francis, Sibley Butte, Christiania, and Clear Lake Townships in
3 Burleigh County; and that part of Hay Creek, Gibbs, and Apple Creek Townships in
4 Burleigh County bound by a line commencing at the intersection of the north boundary
5 of Hay Creek Township, also identified as eighty-fourth avenue northeast, and United
6 States highway 83, then south on United States highway 83 until its intersection with
7 the centerline of seventy-first avenue, then east of seventy-first avenue until its
8 intersection with the centerline of eightieth street, then south on eightieth street until its
9 intersection with the centerline of lincoln road, then east on lincoln road until its
10 intersection with the east boundary of Apple Creek Township, also identified as
11 one hundred thirty-second street southeast, then north on the east boundary of Apple
12 Creek Township and the east boundary of Gibbs Township until its intersection with the
13 north boundary of Gibbs Township, also identified as eighty-fourth avenue northeast,
14 then west on the north boundary of Gibbs Township and the north boundary of Hay
15 Creek Township to the point of beginning.

16 9. District 9 consists of all of Rolette County.

17 10. District 10 consists of all of Cavalier County and Pembina County; and all of Walsh
18 County except that portion contained in District 19.

19 11. District 11 consists of that part of the city of Fargo in Cass County bound by a line
20 commencing at the intersection of an extended line from the centerline of thirteenth
21 avenue south and the centerline of the Red River, then west on thirteenth avenue until
22 its intersection with the centerline of tenth street, then north on tenth street until its
23 intersection with the centerline of ninth avenue south, then west on ninth avenue until
24 its intersection with the centerline of twenty-fifth street, then north on twenty-fifth street
25 until its intersection with the centerline of business interstate highway 94, also
26 identified as main avenue, then west on business interstate highway 94 until its
27 intersection with the centerline of interstate highway 29, then south on interstate
28 highway 29 until its intersection with the centerline of seventeenth avenue south, then
29 east on seventeenth avenue until its intersection with the centerline of twenty-fifth
30 street, then south on twenty-fifth street until its intersection with the centerline of
31 eighteenth street, then southeast on eighteenth street until its intersection with the

1 centerline of twenty-fifth avenue south, then northeast and east on twenty-fifth avenue
2 until its intersection with the centerline of United States highway 81, also identified as
3 university drive, then north on United States highway 81 until its intersection with the
4 centerline of interstate highway 94, then east on interstate highway 94 until its
5 intersection with the centerline of the Red River, then north on the Red River to the
6 point of beginning.

7 12. District 12 consists of that part of the city of Jamestown and Bloom Township in
8 Stutsman County bound by a line commencing at the intersection of the centerline of
9 United States highway 281 and the centerline of seventeenth street southwest, also
10 identified as louis l'amour lane, then north and east on United States highway 281 until
11 its intersection with the centerline of the James River, then west and north on the
12 James River until its intersection with the centerline of the Pipestem Creek, then north
13 and west on the Pipestem Creek until its intersection with the Jamestown city limit and
14 the centerline of seventeenth avenue southwest, then north and east following the city
15 limit until the city limit intersects the centerline of fourth avenue northwest, then north
16 on fourth avenue until its intersection with an extended straight line from the south
17 shoreline of the Jamestown reservoir, then north on the centerline of the Jamestown
18 reservoir until its intersection with an extended straight line of the centerline of thirtieth
19 street southeast, then east on thirtieth street until its intersection with the centerline of
20 state highway 20, then south on state highway 20 until its intersection with the
21 Jamestown city limit, then east, south, and west on the Jamestown city limit until its
22 intersection with the centerline of twenty-seventh avenue southeast, then south on
23 twenty-seventh avenue until its intersection with the Jamestown city limit, then south,
24 west, east, and southwest on the city limit and south on the centerline of eighty-fifth
25 avenue until the intersection of eighty-fifth avenue with the centerline of twenty-ninth
26 street, then west on twenty-ninth street until its intersection with the centerline of
27 twelfth avenue southeast, then north on twelfth avenue until its intersection with the
28 Jamestown city limit, then west on the city limit until its intersection with the extended
29 centerline of fourth avenue, then north on fourth avenue until its intersection with the
30 centerline of seventeenth street southwest, then west on seventeenth street to the
31 point of beginning.

- 1 13. District 13 consists of that part of Barnes and Mapleton Townships and the city of West
2 Fargo in Cass County bound by a line commencing at the intersection of the extended
3 centerline of twelfth avenue northwest and the centerline of the Sheyenne River, then
4 west on twelfth avenue until its intersection with the centerline of thirty-eighth street,
5 then south on thirty-eighth street until its intersection with the centerline of interstate
6 highway 94, then east and southeast on interstate highway 94 until its intersection with
7 the east boundary of Mapleton Township, then south on the east boundary of
8 Mapleton Township until its intersection with the centerline of twenty-first avenue west,
9 then east on twenty-first avenue and an extended straight line until its intersection with
10 the centerline of sheyenne street, then north on sheyenne street until its intersection
11 with interstate highway 94, then east on interstate highway 94 until its intersection with
12 the centerline of ninth street, then north on ninth street until its intersection with the
13 centerline of thirteenth avenue east, then east on thirteenth avenue until its
14 intersection with the centerline of seventeenth street, then north on seventeenth street
15 until its intersection with the centerline of fourth avenue east, then west on fourth
16 avenue until its intersection with the centerline of ninth street, then north on ninth
17 street until its intersection with the centerline of business interstate highway 94, then
18 west on business interstate highway 94 to the centerline of the Sheyenne River, then
19 north on the Sheyenne River to the point of beginning.
- 20 14. District 14 consists of all of Kidder County, Pierce County, Sheridan County, and Wells
21 County; and Pleasant Lake, Knox, York, Leeds, Irvine, Iowa, Twin Lake, Beaver, Lake
22 Ibsen, Normania, Impark, Broe, Butte Valley, McClellan, Riggin, Esmond, Isabel,
23 Albert, Eldon, Rich Valley, Hesper, North Viking, Aurora, East Fork, Arne, South
24 Viking, and West Antelope Townships in Benson County.
- 25 15. District 15 consists of all of Ramsey County and Towner County.
- 26 16. District 16 consists of that part of Barnes Township and the cities of Fargo and West
27 Fargo in Cass County bound by a line commencing at the centerline of business
28 interstate highway 94, also identified as main avenue, and the centerline of
29 forty-second street in Fargo, then west on business interstate highway 94 until its
30 intersection with the centerline of ninth street, then south on ninth street until its
31 intersection with the centerline of fourth avenue east, then east on fourth avenue until

1 its intersection with the centerline of seventeenth street, then south on seventeenth
2 street until its intersection with the centerline of thirteenth avenue east, then west on
3 thirteenth avenue until its intersection with the centerline of ninth street, then south on
4 ninth street until its intersection with the centerline of interstate highway 94, then west
5 on interstate highway 94 until its intersection with the centerline of sheyenne street,
6 then south on sheyenne street until its intersection with the centerline of an extended
7 straight line from twenty-first avenue west, then west on that line and twenty-first
8 avenue until its intersection with the east boundary of Mapleton Township, then south
9 on the east boundary of Mapleton Township until its intersection with the centerline of
10 thirty-second avenue, then east on thirty-second avenue until its intersection with the
11 centerline of one hundred seventieth avenue southeast, also identified as sheyenne
12 street, then south on one hundred seventieth avenue until its intersection with the
13 centerline of fortieth avenue east, then east on fortieth avenue until its intersection with
14 the centerline of veterans boulevard, then north on veterans boulevard until its
15 intersection with the centerline of thirty-second avenue, then east on thirty-second
16 avenue until its intersection with the centerline of forty-fifth street, then north on forty-
17 fifth street until its intersection with the centerline of thirteenth avenue south, then east
18 on thirteenth avenue until its intersection with the centerline of forty-second street,
19 then north on forty-second street to the point of beginning.

20 17. District 17 consists of all of Brenna Township in Grand Forks County; and that part of
21 Grand Forks Township and that part of the city of Grand Forks in Grand Forks County
22 bound by a line commencing at the intersection of an extended straight line of the
23 centerline of lanark avenue and the centerline of the Red River, then southwest on
24 lanark avenue until its intersection with the centerline of lincoln drive, then west on
25 lincoln drive and eighth avenue south until the intersection of the centerline of eighth
26 avenue south and the centerline of belmont road, then south on belmont road until its
27 intersection with the centerline of tenth avenue south, then west on tenth avenue until
28 its intersection with the centerline of cottonwood street, then south on cottonwood
29 street until its intersection with the centerline of fifteenth avenue south, then west on
30 fifteenth avenue until its intersection with the centerline of cherry street, then south on
31 cherry street until its intersection with the centerline of fifteenth avenue south, then

1 west on fifteenth avenue until its intersection with the centerline of washington street,
2 then south on washington street until its intersection with the centerline of
3 thirty-second avenue south, then west on thirty-second avenue until its intersection
4 with the centerline of forty-second street, then north on forty-second street until its
5 intersection with the centerline of the burlington northern santa fe railway right of way,
6 then west on the burlington northern santa fe railway right of way until its intersection
7 with the centerline of fifty-fifth street, then north on fifty-fifth street until its intersection
8 with the centerline of gateway drive, then west on gateway drive and United States
9 highway 2 until its intersection with the northwest corner of Brenna Township, then
10 south on the west boundary of Brenna Township to the southwest corner of Brenna
11 Township, then east on the south boundary of Brenna Township and the south
12 boundary of Grand Forks Township to the centerline of the Red River, then north on
13 the Red River to the point of beginning.

14 18. District 18 consists of Blooming, Falconer, and Rye Townships in Grand Forks County;
15 and that part of the city of Grand Forks and Mekinock Township in Grand Forks
16 County bound by a line commencing at the intersection of an extended straight line of
17 the centerline of lanark avenue and the centerline of the Red River, then southwest on
18 lanark avenue until its intersection with the centerline of lincoln drive, then west on
19 lincoln drive and eighth avenue south until the intersection of the centerline of eighth
20 avenue south and the centerline of belmont road, then south on belmont road until its
21 intersection with the centerline of tenth avenue south, then west on tenth avenue until
22 its intersection with the centerline of cottonwood street, then south on cottonwood
23 street until its intersection with the centerline of fifteenth avenue south, then west on
24 fifteenth avenue until its intersection with the centerline of cherry street, then south on
25 cherry street until its intersection with the centerline of fifteenth avenue south, then
26 west on fifteenth avenue until its intersection with the centerline of washington street,
27 then south on washington street until its intersection with the centerline of library circle,
28 then west and northwest on library circle until its intersection with the centerline of
29 twentieth avenue south, then west on twentieth avenue until its intersection with the
30 centerline of twentieth street, then north on twentieth street and an extended straight
31 line until its intersection with the centerline of the burlington northern santa fe railway

1 right of way, then east on the centerline of the burlington northern santa fe railway right
2 of way until its intersection with the centerline of sixteenth street, then north on
3 sixteenth street until its intersection with the centerline of sixth avenue north, then west
4 on sixth avenue until its intersection with the centerline of twentieth street, then north
5 on twentieth street until its intersection with the centerline of gateway drive, then west
6 on gateway drive and United States highway 2 until its intersection with the south
7 entrance of the Grand Forks air force base, known as eielson street, then north on
8 eielson street until its intersection with the centerline of seventh avenue, then east on
9 seventh avenue until its intersection with the centerline of j street, then south on
10 j street until its intersection with the centerline of juniper avenue, then east on juniper
11 avenue until its extended centerline intersects the west boundary of Blooming
12 Township, then north on the west boundary of Blooming Township to the northwest
13 corner of Blooming Township, then east on the north boundary of Blooming Township,
14 Rye Township, and Falconer Township to the centerline of the Red River, then south
15 on the Red River to the point of beginning.

16 19. District 19 consists of Glenwood, Farmington, Martin, St. Andrews, Fertile, Grafton,
17 Oakwood, Acton, Vernon, Rushford, Prairie Centre, Walsh Centre, Harriston, Pulaski,
18 Medford, Eden, Ops, Forest River, Ardoch, and Walshville Townships in Walsh County;
19 and Elkmount, Inkster, Strabane, Johnstown, Levant, Turtle River, Plymouth, Agnes,
20 Wheatfield, Gilby, Lakeville, Manvel, Niagara, Elm Grove, Hegton, Moraine, Larimore,
21 Arvilla, Logan Center, Grace, Avon, Loretta, Lind, and Northwood Townships in Grand
22 Forks County.

23 20. District 20 consists of all of Traill County; all of Grand Forks County except those
24 portions contained in Districts 17, 18, 19, 42, and 43; and Dows, Hunter, Bell, Kinyon,
25 and Noble Townships in Cass County.

26 21. District 21 consists of that part of the city of Fargo in Cass County bound by a line
27 commencing at the intersection of an extended line from the centerline of thirteenth
28 avenue south and the centerline of the Red River, then west on thirteenth avenue until
29 its intersection with the centerline of tenth street, then north on tenth street until its
30 intersection with the centerline of ninth avenue south, then west on ninth avenue south
31 until its intersection with the centerline of twenty-fifth street, then north on twenty-fifth

1 street until its intersection with the centerline of business interstate highway 94, also
2 identified as main avenue, then west on business interstate highway 94 until its
3 intersection with the centerline of interstate highway 29, then north on interstate
4 highway 29 until its intersection with the centerline of twelfth avenue north, then east
5 on twelfth avenue until its intersection with the centerline of United States highway 81,
6 also identified as university drive, then south on United States highway 81 until its
7 intersection with the centerline of seventh avenue north, then east on seventh avenue
8 until its intersection with the centerline of tenth street, then south on tenth street until
9 its intersection with the centerline of sixth avenue north, then east on sixth avenue
10 until its intersection with the centerline of Broadway drive, then south on Broadway
11 drive until its intersection with the centerline of the Burlington Northern Santa Fe Railway
12 right of way, then east on the Burlington Northern Santa Fe Railway right of way until its
13 intersection with the centerline of the Red River, then south on the Red River to the
14 point of beginning.

15 22. District 22 consists of all of Cass County except those portions contained in
16 Districts 11, 13, 16, 20, 21, 24, 25, 27, 41, 44, 45, and 46.

6 then west on the burlington northern santa fe railway right of way until its intersection
7 with the centerline of fifty-fifth street, then north on fifty-fifth street to the point of
8 beginning.

9 43. District 43 consists of that part of Grand Forks Township and that part of the city of
10 Grand Forks in Grand Forks County bound by a line commencing at the intersection of
11 the centerline of washington street and the centerline of thirty-second avenue south,
12 then west on thirty-second avenue until its intersection with the centerline of forty-
13 second street, then north on forty-second street until its intersection with the centerline
14 of the burlington northern santa fe railway right of way, then east on the burlington
15 northern santa fe railway right of way until its intersection with an extended line from
16 the centerline of twentieth street, then south on twentieth street until its intersection
17 with the centerline of twentieth avenue south, then east on twentieth avenue until its
18 intersection with the centerline of library circle, then south and east on library circle
19 until its intersection with the centerline of washington street, then south on washington
20 street to the point of beginning.

21 44. District 44 consists of that part of the city of Fargo in Cass County bound by a line
22 commencing at the intersection of the extended centerline of thirty-second avenue
23 north and the centerline of the Red River, then west on thirty-second avenue until its
24 intersection with the centerline of eighth street, then south on eighth street until its
25 intersection with the centerline of twenty-eighth avenue north, then west on
26 twenty-eighth avenue until its intersection with the centerline of ninth street, then south
27 on ninth street until its intersection with the centerline of nineteenth avenue north, then
28 west on nineteenth avenue until its intersection with the centerline of tenth street, then
29 south on tenth street until its intersection with the centerline of seventeenth avenue
30 north, then east on seventeenth avenue until its intersection with the centerline of ninth
31 street, then south on ninth street until its intersection with the centerline of thirteenth

1 avenue north, then west on thirteenth avenue until its intersection with the centerline of
2 United States highway 81, also identified as university drive, then south on United
3 States highway 81 until its intersection with the centerline of seventh avenue north,
4 then east on seventh avenue until its intersection with the centerline of tenth street,
5 then south on tenth street until its intersection with the centerline of sixth avenue north,
6 then east on sixth avenue until its intersection with the centerline of Broadway drive,
7 then south on Broadway drive until its intersection with the centerline of the Burlington
8 Northern Santa Fe Railway right of way, then east on the Burlington Northern Santa Fe
9 Railway right of way until its intersection with the centerline of the Red River, then north
10 on the Red River to the point of beginning.

11 45. District 45 consists of Berlin, Gardner, Harwood, and Wisner Townships and that part of
12 the cities of Fargo and West Fargo and Reed Township in Cass County bound by a
13 line commencing at the intersection of the extended centerline of thirty-second avenue
14 north and the centerline of the Red River, then west on thirty-second avenue north
15 until its intersection with the centerline of eighth street, then south on eighth street until
16 its intersection with the centerline of twenty-eighth avenue north, then west on
17 twenty-eighth avenue until its intersection with the centerline of ninth street, then south
18 on ninth street until its intersection with the centerline of nineteenth avenue north, then
19 west on nineteenth avenue until its intersection with the centerline of tenth street, then
20 south on tenth street until its intersection with the centerline of seventeenth avenue
21 north, then east on seventeenth avenue until its intersection with the centerline of ninth
22 street, then south on ninth street until its intersection with the centerline of thirteenth
23 avenue north, then west on thirteenth avenue until its intersection with the centerline of
24 United States highway 81, also identified as university drive, then south on United
25 States highway 81 until its intersection with the centerline of twelfth avenue north, then
26 west on twelfth avenue until its intersection with the centerline of interstate
27 highway 29, then south on interstate highway 29 until its intersection with the
28 centerline of business interstate highway 94, also identified as main avenue, then west
29 on business interstate highway 94 until its intersection with the centerline of the
30 Sheyenne River, then north on the Sheyenne River until its intersection with the
31 centerline of twelfth avenue northwest, then west on twelfth avenue until its

1 intersection with the west boundary of Reed Township, also identified as fourteenth
2 street, then north on the west boundary of Reed Township to the north boundary of
3 Reed Township, also identified as seventy-sixth avenue and Cass County highway 22,
4 then east on the north boundary of Reed Township until its intersection with the
5 centerline of the Red River, then south on the Red River to the point of beginning.

6 46. District 46 consists of that part of the city of Fargo and Stanley Township in Cass
7 County bound by a line commencing at the intersection of the extended centerline of
8 sixty-fourth avenue south and the centerline of the Red River, then west on sixty-fourth
9 avenue until its intersection with the centerline of Cass County drain number fifty-
10 three, then north on Cass County drain number fifty-three until its intersection with the
11 centerline of fifty-second avenue south, then east on fifty-second avenue until its
12 intersection with the centerline of twenty-fifth street, then north on twenty-fifth street
13 until its intersection with the centerline of thirty-second avenue south, then east on
14 thirty-second avenue until its intersection with the centerline of twenty-second street,
15 then north on twenty-second street until its intersection with the centerline of thirtieth
16 avenue south, then east on thirtieth avenue until its intersection with the centerline of
17 eighteenth street, then north on eighteenth street until its intersection with the
18 centerline of twenty-fifth avenue south, then east on twenty-fifth avenue until its
19 intersection with the centerline of United States highway 81, also identified as
20 university drive, then north on United States highway 81 until its intersection with the
21 centerline of interstate highway 94, then east on interstate highway 94 to the
22 centerline of the Red River, then south on the Red River to the point of beginning.

23 47. District 47 consists of that part of the city of Bismarck and that part of Hay Creek
24 Township in Burleigh County bound by a line commencing at the intersection of the
25 centerline of state highway 1804, also identified as river road, and the centerline of
26 interstate highway 94, then east on interstate highway 94 until its intersection with the
27 centerline of divide avenue, then south and east on divide avenue until its intersection
28 with the centerline of washington street, then north on washington street until its
29 intersection with the centerline of interstate highway 94, then east on interstate
30 highway 94 until its intersection with the centerline of United States highway 83, then
31 north on United States highway 83 until its intersection with the centerline of forty-third

1 avenue, then west on forty-third avenue until its intersection with the centerline of
2 washington street, also identified as third street northwest, then north on washington
3 street until its intersection with the centerline of fifty-seventh avenue north, then west
4 on fifty-seventh avenue and an extended straight line until its intersection with the
5 centerline of state highway 1804, then south on state highway 1804 until the point of
6 beginning.

7 **SECTION 2.** A new section to chapter 54-03 of the North Dakota Century Code is created
8 and enacted as follows:

9 **Staggering of terms of members of the legislative assembly.**

- 10 1. A senator and two representatives must be elected from each even-numbered district
11 in 2012 for a term of four years.
- 12 2. A senator and two representatives must be elected from each odd-numbered district in
13 2014 for a term of four years. However, a senator and two representatives from district
14 seven must be elected in 2012 for a term of two years.
- 15 3. Except as provided in subsection 4, the term of office of a member of the legislative
16 assembly elected in an odd-numbered district in 2010 for a term of four years and who
17 as a result of legislative redistricting is placed in an even-numbered district terminates
18 December 1, 2012.
- 19 4. A member of the legislative assembly who was elected from an odd-numbered district
20 in 2010 for a term of four years and who as a result of legislative redistricting is placed
21 in an even-numbered district may continue to serve the remainder of the term for
22 which the member was elected beyond December 1, 2012, if the member changes the
23 member's place of residence to a location in the odd-numbered district which is within
24 the geographic area of the odd-numbered district from which the member was elected
25 by March 15, 2012, and certifies in writing to the secretary of state and the chairman of
26 the legislative management that the member has established a new residence in that
27 district as determined by section 54-01-26. If the member does not establish residency
28 within the district from which the member was elected by March 15, 2012, the term of
29 office of that member terminates on December 1, 2012.
- 30 5. The term of office of a member of the legislative assembly in an odd-numbered district
31 with new geographic area that was not in that member's district for the 2010 election

1 and which new geographic area has a 2010 population that is more than twenty-five
2 percent of the ideal district population terminates on December 1, 2012.

3 6. Notwithstanding section 16.1-13-10, a vacancy caused in an odd-numbered district as
4 a result of legislative redistricting must be filled at the 2012 general election by electing
5 a member to a two-year term of office.

6 **SECTION 3. REPEAL.** Sections 54-03-01.8 and 54-03-01.10 of the North Dakota Century
7 Code are repealed.

8 **SECTION 4. SECRETARY OF STATE TO MODIFY ELECTION DEADLINES AND**
9 **PROCEDURES.** If, as a result of a delay in implementation of this Act, it becomes necessary to
10 modify election deadlines and procedures for the conduct of the 2012 primary election, the
11 secretary of state, in consultation with city and county election officials, shall adopt modified
12 election deadlines and procedures to allow the conduct of the 2012 primary election as
13 scheduled. The modified deadlines and procedures may address filing and publishing deadlines
14 and any other matters necessary to accommodate the conduct of the primary election.

15 **SECTION 5. LEGISLATIVE INTENT - BOUNDARIES.** It is the intent of the legislative
16 assembly that although this Act is effective on November 25, 2011, the members of the
17 legislative assembly elected under the redistricting plan effective on November 24, 2011, shall
18 continue to serve until implementation of this Act. Any reference in the legislative district
19 descriptions to a city limit or the Fort Berthold reservation boundary as a boundary line refers to
20 the limit or boundary as it existed on January 1, 2010, as shown on the 2010 census maps. A
21 legislative district boundary using the Fort Berthold reservation or city limit lines does not
22 migrate as the Fort Berthold reservation boundary or city limits migrate. For purposes of
23 legislative district descriptions, unless cities are otherwise specifically named, townships
24 encompass all the territory within their outer boundaries.

25 **SECTION 6. EFFECTIVE DATE.** This Act becomes effective on November 25, 2011.
