## 6 Behavioral health data repository - Required reporting.

- 7 The department of human services shall establish and maintain a central repository of
- 8 persons with behavioral health issues. The repository must identify:
- 9 <u>1.</u> <u>The total number of clients served;</u>
- 10 <u>2.</u> <u>Referral source;</u>
- 11 <u>3.</u> <u>Client gender;</u>
- 12 <u>4.</u> <u>Client age;</u>
- 13 <u>5.</u> <u>Primary drug used or presenting problem;</u>
- 14 <u>6.</u> Primary diagnosis;
- 15 <u>7.</u> <u>Military involvement;</u>
- 16 <u>8.</u> <u>Client living arrangement;</u>
- 17 <u>9.</u> <u>Client employment status;</u>
- 18 <u>10.</u> <u>Client criminal justice involvement;</u>
- 19 <u>11.</u> <u>Client social connection:</u>
- 20 <u>12.</u> <u>Client hospitalization occurrences; and</u>
- 21 <u>13.</u> Evidence-based programs provided.
- 22 Licensed psychologists, licensed social workers, licensed addiction counselors, and licensed
- 23 counselors in the state shall report to the department any information requested by the
- 24 department in accordance with this section within seven days after providing mental health or

- 1 addiction treatment services to any individual. The state board of psychologist examiners, the
- 2 North Dakota board of social work examiners, the board of addiction counseling examiners, and
- 3 the board of counselor examiners shall assist the department of human services in the
- 4 gathering of the information required in this section.

#### 5 SECTION 2. APPROPRIATION - DEPARTMENT OF HUMAN SERVICES - BEHAVIORAL

# 6 HEALTH DATA REPOSITORY - REPORT TO THE LEGISLATIVE MANAGEMENT. There is

- 7 appropriated out of any moneys in the general fund in the state treasury, not otherwise
- 8 appropriated, the sum of \$\_\_\_\_\_, or so much of the sum as may be necessary, to the department
- 9 of human services for the purpose of establishing and administering a behavioral health data
- 10 repository for the biennium beginning July 1, 2015, and ending June 30, 2017. The department
- 11 of human services shall report to the legislative management on the use of the funds under this
- 12 section by July 1, 2016
