- 1 A BILL for an Act to amend and reenact subsection 1 of section 57-51.1-07 of the North Dakota
- 2 Century Code, relating to state water commission use of funding from the resources trust fund.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Subsection 1 of section 57-51.1-07 of the North Dakota
Century Code is amended and reenacted as follows:

- 6 Twenty percent must be allocated and credited to the sinking fund established for 1. 7 payment of the state of North Dakota water development bonds, southwest pipeline 8 series, and any moneys in excess of the sum necessary to maintain the accounts 9 within the sinking fund and for the payment of principal and interest on the bonds must 10 be credited to a special trust fund, to be known as the resources trust fund. The 11 resources trust fund must be established in the state treasury and the funds therein 12 must be deposited and invested as are other state funds to earn the maximum amount 13 permitted by law which income must be deposited in the resources trust fund. Five 14 percent of the amount credited to the resources trust fund must be transferred no less 15 than quarterly into the renewable energy development fund, not to exceed three 16 million dollars per biennium. One-half of one percent of the amount credited to the 17 resources trust fund must be transferred no less than guarterly into the energy 18 conservation grant fund not to exceed one million two hundred thousand dollars per 19 biennium. The principal and income of the resources trust fund may be expended only 20 pursuant to legislative appropriation and are available to: 21 The state water commission for planning for and construction of water-related a.
