- 1 A BILL for an Act to amend and reenact sections 61-02-04 and 61-02-05 of the North Dakota
- 2 Century Code, relating to the state water commission; and to authorize the legislative council to
- 3 replace certain statutory references to the water commission and state engineer.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Section 61-02-04 of the North Dakota Century Code is

- 6 amended and reenacted as follows:
- 7 61-02-04. State water commission Members Terms Qualifications.

8 The state water commission shall consist of the governor, agriculture commissioner, and 9 seven other members to be appointed by the governor who shall take into account reasonable 10 acographic considerations in making such appointments. Each river basin commission shall 11 forward the names of two of its members to the governor. The governor shall appoint one 12 individual from the recommendations of each river basin commission. The governor shall 13 appoint one member of the water commission at large. The governor or the agriculture 14 commissioner, or both, may appoint a representative to serve in that official's capacity at such 15 meetings as that official may be unable to attend. The seven appointive members of the 16 commission must be appointed for a term of sixfour years each with their terms of office so 17 arranged that two at least three terms and but not more than three four terms expire on the first 18 day of July of each odd-numbered year. Each appointive member may not serve for more than 19 two full, successive terms. Each appointive member must be a qualified elector of the state and 20 is subject to removal by judicial procedure. In case of a vacancy, the vacancy must be filled by 21 appointment by the governor for the remainder of the unexpired term. Before entering upon the 22 discharge of official duties, each appointive member shall take, subscribe, and file with the 23 secretary of state the oath prescribed for civil officers.

1	SECTION 2. AMENDMENT. Section 61-02-05 of the North Dakota Century Code is	
2	amended and reenacted as follows:	
3	61-02-05. Chairman of commission.	
4	The governor shall be the chairman of the commission. The governor shall designate a vice	
5	chairman who shall be a member of the commission. The state engineercommissioner of the	
6	department of water resources shall be the secretary of the commission.	
7	For purposes of this section, the state is divided into six hydrologic basinsupper Missouri	
8	River basin, lower Missouri River basin, Red River basin, Devils Lake basin, Sheyenne-James	
9	River basin, and Mouse River basin, each as delineated by the commissioner of the department	
10	of water resources.	
11	A river basin commission consisting of a representative from the following entities is	
12	established in each basin:	
13	<u>1.</u>	Water resource districts:
14	<u>2.</u>	Rural water systems;
15	<u>3.</u>	Municipalities:
16	<u>4.</u>	Tribal governments;
17	<u>5.</u>	Irrigation districts; and
18	<u>6.</u>	Other entities as deemed appropriate by the river basin commission.
19	Each river basin commission may organize, prioritize, and implement water resource	
20	projects in accordance with a basin water management plan. The prioritization process must	
21	include an economic analysis that is equal in complexity to the proposed project.	
22	Each river basin commission may elect a chairman and vice chairman and may hire a	
23	coordinator as it deems appropriate.	
24	SECTION 3. LEGISLATIVE COUNCIL TO REPLACE REFERENCES TO WATER	
25	COMMISSION AND STATE ENGINEER. Except with respect to North Dakota Century Code	
26	sections 61-02-04, 61-02-04.1, 61-02-05, 61-02-07, 61-02-08, 61-02-09, 61-02-10, 61-02-11,	
27	and 61-02-12, and sections relating to financing projects, the legislative council shall replace	
28	"state water commission" or "water commission" or any derivatives of those terms, which when	
29	used in context indicate an intention to refer to those terms, wherever they appear in the North	
30	Dakota Century Code or legislation enacted by the sixty-third legislative assembly of North	
31	Dakota	with references to "department of water resources" or "department", as appropriate. The

- 1 legislative council shall replace "state engineer" or any derivative of the term, which when used
- 2 in context indicates an intention to refer to this term, wherever it appears in the North Dakota
- 3 Century Code or legislation enacted by the sixty-third legislative assembly of North Dakota with
- 4 references to "commissioner of the department of water resources" or "commissioner", as
- 5 appropriate.
